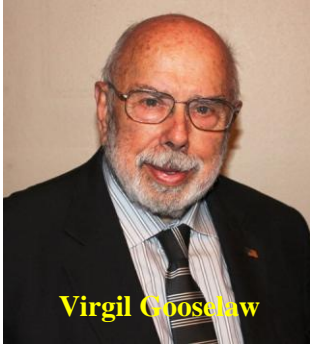

Letter From The President

2016 Convention - September 21 -24 ~ Ron Bertacini, VP of Conventions reported that the Seattle Convention has been a great success with 317 participants renewing old friendship and making new ones as well. The hotel goal for room nights was 600 and we had 640. The 6 tours were well planned and held their own financially. Congratulations to Ken Storey, Convention Chair and his hard working team. Thank you to the Treasurer, Shirley Claggett and Registrar, Ron Paluch. Recognition was also given to our previous Treasurer/Registration team, Ginny & Frank Rockenhauser.

Virgil's report:

- Denver office will be downsizing and moving to a temporary location some time later this year. There will be no interruption to service.
- Virgil has the approval of the board of Directors to proceed exploring our possibility of obtaining a 501C3 status. Having a tax free status will assist us with our expenses.
- Our Website provides many opportunities to serve the members with the Newsletter and blast e-mail messaging to name a few. The ability to accept credit cards is a real plus. That information is secure

and available only to the Webmaster. Jim Sommerfield, Website Mgr. pointed out that there are 38 functions available that can be accessed from the Home Page.

- Members are encouraged to use their Directors, Corporate and Airline Liaisons for question and assistance. All current Directors were acknowledged as well as past presidents; Zelma Kibler, Jim Fauber and Ron Bertacini.
- The Treasurer and VP of Conventions will serve a 3 year term, on a one time basis, so that officer's positions are not all expiring the same year.

Pam Ziebarth, Treasurer's report

Pam assured us that RUAEA is solvent. Our largest expense is the Newsletter but we are coming in under the projected budget thus far this year. Income from dues is lower due to fewer members. We will be adding \$15,000 to a \$10,000 CD making it a \$25,000/four year CD. Our current balance (in CD's, Savings, and Checking) is \$171,000.00.

Welcome to LAX, automated screening



In collaboration with the TSA, United made the airport screening process more efficient and more convenient for its customers at LAX. United installed several automated screening lanes in LAX, which can improve TSA screening times by as much as 30 percent. The first two lanes opened for operational use late last week at United's B checkpoint, a temporary location.

The new lanes will enable up to five customers to fill their individual bins simultaneously and move through the screening process more quickly, even if TSA agents need to perform additional screening on a customer farther ahead in the queue. The lanes also use a parallel conveyor system that automatically returns empty bins to the front of the queue.

“We are committed to making every step of our customers’ journeys as reliable and enjoyable as possible,” Airport Operations SVP Jon Roitman said. *“This investment in state-of-the-art technology will improve the travel experience for our customers.”*

The first half of United’s LAX security screening checkpoint will have seven lanes - five automated screening lanes and two standard screening lanes, and it will be completed in two phases. United expects to have both phases completed by the end of the year.

United will open automated lanes at ORD and EWR later this year.

United announces organizational changes in management structure



In a letter to management and administrative employees, Oscar previewed several changes to United’s organizational structure that will help the company execute its strategy to make United the world’s best airline.

“We will not impact front-line employees or direct front-line field supervisors related to this effort,” Oscar said. *“In fact, in the year ahead as we shift to more mainline flying, we expect to add hundreds of front-line jobs.”*

One key change Oscar highlighted is that United’s customer service delivery roles - Contact Centers, Customer Experience, Food Services, Inflight Services and Airport Operations - will be aligned under a single officer who will be responsible for ensuring a consistent, integrated and positive experience across every customer interaction. Another change will be in Finance, where United will reorganize to provide dedicated support to the commercial and operations groups as the company sensibly manages costs while also evaluating and investing in strategic business initiatives.

United plans to announce more about its new management structure and the resulting leadership changes at the officer level beginning in the coming days, and the next step will be for EVPs and officers to further define their own organizational structures.

United reports third-quarter 2016 performance



United reported its third-quarter 2016 financial results. It is the best third-quarter and best year-to-date on-time performance in company history.

Flight attendants ratified a joint contract and United reached a tentative agreement with technicians and related employees for a joint contract.

Excluding special items, United reported third-quarter net income of \$997 million, diluted earnings per share of \$3.11 and pre-tax earnings of \$1.6 billion.

Including special items, United reported second-quarter net income of \$965 million, diluted earnings per share of \$3.01 and pre-tax earnings of \$1.5 billion.

During the third quarter of 2016, United purchased \$255 million of its common shares, representing 1.5 percent of shares outstanding. Since United’s initial repurchase announcement in July 2014; the company has purchased \$4.0 billion of its common shares, representing approximately 20 percent of shares outstanding. As of Sept. 30, 2016, United had \$2.0 billion remaining to purchase shares under its existing share repurchase authority.

United insources more work at LAX and SFO



The SFO team recently took over ground services for United Express aircraft operated by Skywest Airlines (OO) at the SFO airport. United team now manages all ground services, including Ramp Service roles - water, fueling and commissary provisioning for these regional aircraft - previously managed by OO. This also comes on the heels of the LAX team celebrating the first month of successfully insourcing above and below-the-wing operations previously completed by OO.

To help support the roughly 100 flights a day at SFO and 50 flights at LAX, United has trained hundreds of Ramp Service employees and hired more than 350 new employees across the two hubs.

“As with all things, there were some bumps along the way,” said SFO Ramp Service Trainer Dave Schmiedeler. “But the way everyone is stepping up and going that extra mile to make this transition go as smoothly as possible is incredible.”

This marks a key milestone as part of the contract with employees represented by the International Association of Machinists and Aerospace workers, which was ratified earlier this year.

Congratulations to the SFO and LAX teams for all of their hard work and making this transition a success in such a short amount of time - seven months before the deadline.

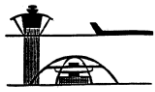

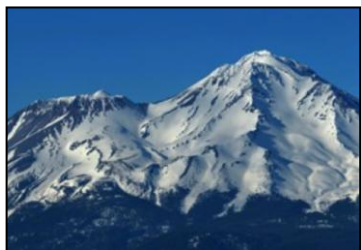
Joseph Leather distributed an interesting and timely medical bulletin on recognizing the symptoms of a stroke with advice on how to obtain immediate assistance.

The occupants on the farm are cows, pigs, and lambs. Dr. Wachholz explained the milking, breeding, special feeding of the cows, plus so much more. Too many things to mention.

That afternoon, an employee of the "The Little Free Library" came to our hotel. He told us about the history of how Little Free Library got its start. It is an amazing project open to anyone who is interested in either buying a Little Library or buying a kit to make one. The premise of the library is to have free reading material for anyone who is interested in reading books or providing books that are no longer wanted or needed. The rule of thumb is "take a book, bring a book". There is no need to bring back the book that was taken, just replace it with something else. Children's books, craft magazines, novels of good taste, etc.

Eric, the owner, showed us the many different lasers that they use for various jobs. The Fiber Optic Laser is used for marking materials such as plastics and metals. The YAG Laser has remarkable effects on brass, pewter, acrylic, plastics, and other materials. The CO2 laser is best used to etch organic materials, such as wood, acrylics, plastics, glass, marble, rubber, paper and fabrics.

Our next stop was Empire Buckets. We learned about the shovels/buckets on big machines and construction equipment. We toured their warehouse and saw the machinery and equipment used to make their products. They make excavator, sand, and ditch buckets, as well as custom fabrications.

Our last tour was to "Plantables". Owners Jim Schreiber and Karen Klyczek wanted to open a workplace for adults with disabilities, thus the formation of Plantables. Workers of all abilities, and volunteers work together to create products for your garden and the environment. They make plantable greeting cards, (they have seeds in the paper card). 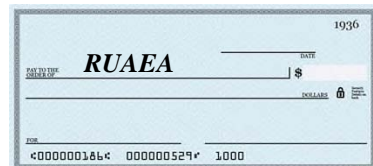

On August 6, 1964 United began flying Boeing 727's between San Francisco and Denver with the eastbound flight making a stop in Salt Lake City. About March 1 service was added to additional cities.

was on the left side. The coat-room could be exchanged for 2 additional seats, giving the undivided "One-Class service" plane 92 seats in the summer. Since the 727 was smaller than either the 720 or the DC-8 only one galley is needed and is located in mid-cabin on the right side.

Oscar hosted retiree summit

Recently, leaders of seven retiree organizations attended a summit at the Chicago Corporate Support Center. Oscar hosted the meeting to find better ways to engage with retirees, listen to their opinions and ideas, and thank them for the role they played in making United the great airline that it is today.

"My job is to let you know that I care," Oscar said, "and that I am focused on building trust with not only our current employees, but our retirees as well." The attendees included leaders from the Retired United Pilots Association (RUPA), the Retired Association of Flight Attendants (RAFA), Golden Eagles, Clipped Wings, the Association of Retired Employees of Continental Airlines (ARECA), the United Airlines Historical Foundation (UAHF) and the Retired United Airlines Employees Association (RUAEA).

Throughout the meeting, the representatives spoke of how much they appreciated their time at United, and several said their fellow retirees wanted to give back to the company in some way, whether as ambassadors or by offering guidance. Oscar embraced the offer, saying, *"I value your wise counsel and your history with the company. Our retirees' legacy should be to pass on that wisdom."* Participants brought their suggestions about pass travel; for instance, **Captain Cort de Peyster** of the Retired United Pilots Association recommended implementing a system where pass travel priority is determined solely by years of service among active employees and retirees. Oscar agreed to consider all options, while reiterating that vacation passes - something that no other airline offers - are valuable to retirees, providing them an equal opportunity to enjoy pass travel.

Pensions were also discussed in an honest and frank way, with Oscar promising to maintain a dialogue and touching on some of the legal and financial barriers that prevent the company from revisiting past decisions. Overall, the sentiment coming out of the summit was positive. **Virgil Gooselaw** of the Retired United Airlines Employees Association said, *"This meeting is a high point."* Oscar agreed, saying, "This is just a start, but this shows you where we're going." The next meeting is planned for the first quarter of 2017.
