Retiree? Unable to Use Computer to Book Space Available Travel?

United has confirmed to RUAEA's Corporate Liaison, **Ed Tolle** that United will waive the booking service fee for retirees who are not able to use a computer to book space available travel. You can now call the ePass Line 1-866-359-3727 and book without the \$25.00 fee. You must state your inability to use a computer and ask for the fee to be waived.

Pass Travel Survey

United is planning another pass travel survey for both employees and retirees. We think it will again be online only. At this time, we do not know when it will start or end. An alert will be posted on the RUAEA website as soon as we know. Please check the website frequently and share the information as soon as you know it. Pass Travel Report for retirees not working?

Due to security restrictions with various browsers, the "Pass Travel Report" in My Info/All About Me requires the use of Internet Explorer 9.0 or below. Browsers such as Google Chrome, Firefox, or Safari are not compatible with this report. Users with IE 11 should follow the instructions in the ALERT message on Flying Together. Users with IE 9.0 or below who are receiving errors related to JavaScript or Cookies, see instructions at the end of this article. **Everyone else** can obtain a Pass Travel Report via email by following these steps:

1. Go to employeeRES>Quick Links> Feedback
2. The feedback form will already have your Employee ID and email address populated.
3. For the Subject field, choose "Question".
4. In the comments box state you want a copy of your 2013 Pass Travel Report.
5. Click on the "Submit feedback" button.
6. Allow several days to receive your report, at this time of year they are quite busy.

7. OR...find a friend who has IE9 or below on their computer and generate the report online.

Notes about your Pass Travel Report:

1. The PDF is laid out by pay period, scroll down to go thru the year.
2. The "Pass Tax Value" is listed on the left side under each ticket coupon number.
3. Retirees can ignore the "Payroll Deduct" amounts on the far right side. They apply to active employees only.
4. The report does not calculate the total pass tax values for all trips, but if you add the values for trips flown between 11/1/2012 and 10/31/2013 it should equal the amount on the 1099 form United will send you in early 2014.
5. If the total of all "pass tax values" flown between 11/1/2012 and 10/31/2013 is less than \$600, you will not receive a 1099 from United and do not need to declare the pass tax value on your IRS forms.

What is the Pass Travel Report? A record of all pass travel by you and your pass riders for the year. For 2013, that will include pass travel flown from 11/1/2012 thru 10/31/2013.

Why do you want it? The report shows the "pass tax value" for each segment your "taxable pass riders" flew during the 2013 period. Retirees should check their Pass Travel Report for accuracy. If your "taxable pass riders" accrue over \$600 of "pass tax value", then United must send you a 1099 form to be declared on your 2013 IRS tax return. Last year United mailed Pass Travel Reports to retirees who received a 1099, but for 2013 they will only mail the 1099s (early in 2014), retirees must access their own Pass Travel Report online.

What if your report is wrong? If you find a discrepancy, email epc@united.com and put "2013 1099" in the subject line and include the following in the body of the email: retiree name, retiree ID number, ticket details (coupon #, date of travel, passenger name) and any questions.

How do you obtain the report online? Go to My Info/All About Me (in the left column of the Employee Services page on Flying Together) and click on "Pass Travel Report" under the "Travel" heading. Fill out the form with a start date of 11/1/2012 and an end date of 12/31/2013 (some travel ending on October 31, 2013 may not be posted until December). If your report doesn't generate, fill out the feedback form on employeeRES>QuickLinks>Feedback as described above.

Who are a retiree's "taxable pass riders"? Travel by your domestic partner, enrolled friends, non-dependent children 18-26 years old and same gender parents is taxable. Travel by other eligible pass riders, including the retiree and spouse, is NOT taxable.

Who pays the IRS? You do (the retiree/employee, not your pass riders).

How is "pass tax value" calculated? It is 10% of the economy class fare, minus any service charges paid**. Since United's economy fares change daily, the "pass tax value" will vary by date flown.

How much tax will you have to pay? It depends on your tax bracket, tax rates, and how the income is declared on your tax return.

** Retirees with less than 25 years of service, and their pass riders, pay service charges for travel in premium cabins at the time of listing. To determine the "pass tax value" of each segment flown, any service charges that were paid are deducted from 10% of the fare. Note that pre-paid departure taxes/fees are not deducted to compute the "pass tax value". Retirees with 25 or more years of service, and their eligible pass riders, do not pay any service charges.

If you are currently using Internet Explorer 9.0 or below and are receiving errors related to Java Script and/or Cookies please follow the below instructions:

To enable cookies:

1. Click the Tools icon in the browser toolbar
2. Choose Internet Options
3. Click the Privacy tab
4. Go to Select a setting for the Internet zone area
5. Slide the settings button down to Accepts All Cookies or Low
6. Click Apply, and then OK

To enable java script:

1. Click the Tools icon in the browser toolbar
2. Choose Internet Options, and then click the Advanced tab
3. Scroll down the list until you see the Java category

5. Click OK to save your preference and Re-start your computer

Here's what you can expect in 2014



MileagePlus program changes: Starting in January 2014, US members must meet a minimum annual spending level to qualify for Premier status.

Unaccompanied minor changes: United no longer accepts unaccompanied minors aged 5 to 11 on itineraries that involve connections for all tickets booked on or after December 5.

Award seat redemption: United adjusted miles required for first- and business-class awards on United and its partner carriers. Most economy-class tickets will remain at their current levels, though some - like a flight to Hawaii - will rise slightly. United has invested hundreds of millions of dollars to improve its business- and first-class cabins in the past five years and have flat-bed seats on nearly every long-haul international flight. The company also considerably improves its in-flight entertainment. The value that customers assign to United's international premium cabin product is significantly higher today than it was in 2008, the last time that United had an increase in award mileage levels. Customers who book award seats on United rather than on partner airlines will see smaller increases in the number of miles required to book a ticket.

Taxes: The U.S. budget bill signed by the president raises the 9/11 fee from \$2.50 per segment to \$5.60 per one-way journey, resulting in more than \$3 billion in additional taxation on the industry over the next decade. Read Jeff's Journal from December 11 to learn more.

TSA pre-check: The TSA will continue to increase the number of airport with TSA Pre✓™ expedited security lane. TSA ultimately plans to operate more than 300 application centers across the country. In late December, TSA extended TSA Pre✓™ screening benefits to all US Armed Forces service members, including those serving in the US Coast Guard, Reserves and National Guard.

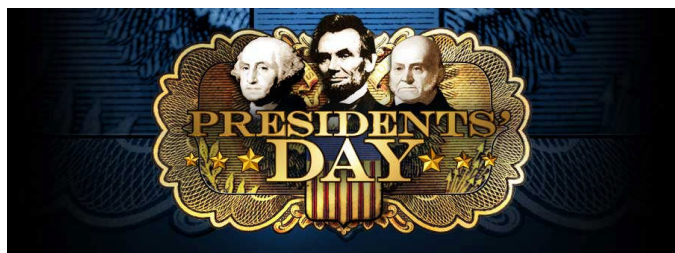

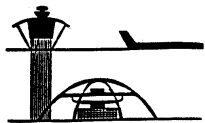

Within a few weeks he was asked to work as a temporary Supervisor in B-29. He worked several other areas which broadened his experience and continued to work in Line Maintenance Control or SAMC.

United then grew with the purchase of routes from PAN AM. United also purchased several Lockheed L-1011 Aircraft. Not many had exposure to that fleet with the exception of a hand full of ex PAN AM and TWA new hires. Mike had the experience and joined the Pacific Expansion team and went off to Manila. He spent the next six months supporting the local ex PAN AM team.

Upon returning to San Francisco, he went to work in Line Maintenance SFOMM working several management positions over the next few years. Then an opportunity came at SFOOV to work as operating manager and then a Manager before another re-organization came about. He then returned to SFOMM and worked as the Business Coordinator overseeing the business aspect of the organization. 1997 brought on a move to Hong Kong where he lived and worked for the next two and one half years as the Area Manager responsible for Beijing, Shanghai and Hong Kong. During this assignment United moved to the new CLK airport in Hong Kong.

Returning to SFO, Mike was then responsible for the Pacific Operation for line Maintenance. He spent the next few years traveling from Auckland and that part of the world to New Delhi and in between. His team moved into a new terminal in PEK and new airport in PVG and introduced the B-777 to several new stations for that fleet in the Pacific. Mike says he wore out three suitcases and was confused when he woke up more than once in a hotel not certain which city he went to sleep in but enjoyed himself and met many new friends.

Mike then accepted a position in the engine shop to manage the PW 2000 and F-117 engine repair and overhaul including the operation in Charleston, South Carolina. Then he was asked to move over to manage the PW 4000 group. In the fall of 2008 he assumed the responsibility of overseeing the heavy maintenance United out-

sourced to vendors for the B-777, 747, 757 and airbus fleets. This took him back to traveling to China, South Korea and North Carolina as well as Florida.

June 1st 2009, Mike retired after achieving his goal of working for United for 25 years. After 42 years in the industry, he felt it was time to move on and look for fun things to get involved with. He is now living in Paradise, California with his lovely wife and trying to do some local traveling.

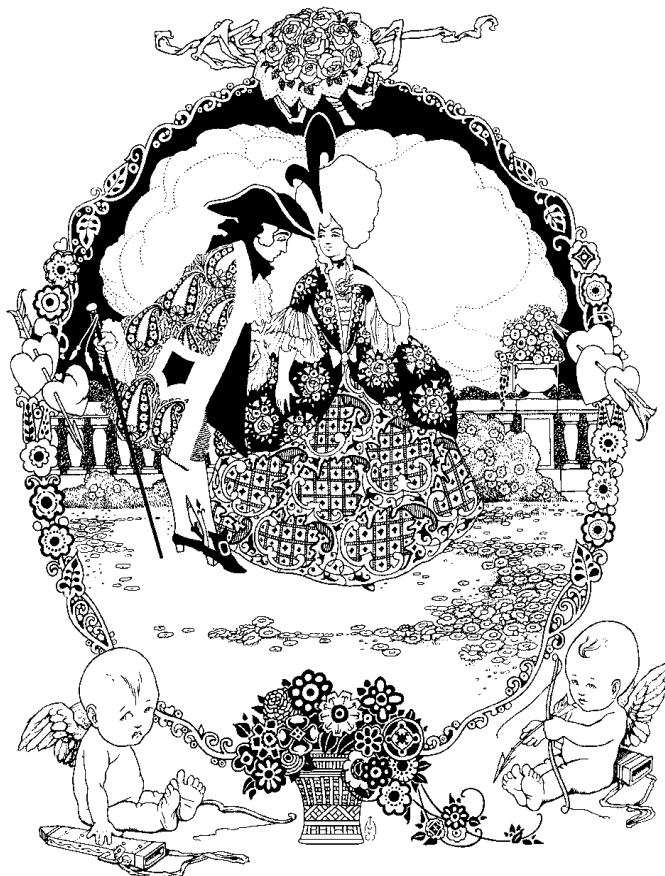


With the year 2013 behind us, we would once again like to say Happy New Year to all members and friends of RUAEA.

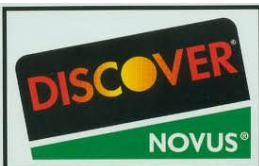
