Travel Desk volunteers will list you & your eligible for NRSA travel, as well as give you schedules & actual load information.

Travel Desk hours of operation are Mon, Wed, & Fri from 10:00 to 14:00 hours, Pacific Time. For tracking purposes, please tell the volunteer who takes your call that you are calling on the (888) number.

## **RETIREE TRAVEL DESKS**

Dear Retirees,

The National RUAEA has set up an experimental 800 number for the PDX Travel Desk. If this is a success, (and it is expected to be) RUAEA will also establish an 800 number for SEA sometime this summer.

Currently the two system Travel Desks are:

- SEA Retiree Travel Desk is open Mon., Tues., Wed, & Thurs. 10:00am - 2:00pm. Telephone (206) 433-4218 (2 lines).
- PDX Travel Desk is open Mon., Wed., & Fri. 10:00am - 2:00pm. Telephone (503) 249-4142 & 4143 (continue locally). New 1-888-278-7038 National Toll Free (in service NOW).

**Note:** These times are Pacific Time 10:00am - 2:00pm  
Eastern time: 1:00pm - 5:00pm

Central time: 12:00 noon - 4:00pm  
Mountain time: 11:00am - 3:00pm  
Hawaiian time: 8:00am - 12:00 noon

This gives you 5 days of service for the Volunteers to be a "live Friendly voice" at the other end of the line to answer your questions, help with routing, passenger counts, listing or changing flights, even helping with referring other UAL telephone numbers, discounts & rules on other reciprocal airlines.

If you have not traveled in that last year, there are a number of new more efficient procedures, ask your questions & get an answer here.

National RUAEA certainly is helping our members with these services for those without computers, or talking to a computer on Activated Voice Recognition; an added help for those with speaking problems, accents or airport background noise. Imagine needing information if you are stuck at some intermediate airport on your travels - clip this message with the telephone numbers for your purse or wallet. That new PDX toll free number 1-888-278-7038 will come in mighty handy.

The SEA Travel Desk, upon request & if listing 7 or more days in advance, will print out your PNR (Passenger Name Record) & the Passenger Counts (PXC) for the entire Flight segments on the days you travel (convenient if you miss a Flt.) & MAIL this to you. Do remember to give the Volunteer your address! We do have a postage fund for this & know you will enjoy having the information printed out.

Note: A Costco, MCI calling card will let you call us for \$.03 a minute.

### **UNITED LAUNCHES NEW SERVICE TO SUNNY DESTINATIONS**

Beating the winter blues is easier this season, with United's new & expanded service from its hubs to sun-drenched destinations in Latin America & the Caribbean. United & Ted will launch 13 new routes to popular south-of-the-border vacation spots: 5 from CHI, 3 from SFO, 4 from DEN, & 1 from LAX. Existing service from Washington Dulles & these hubs to several island & beach destinations will increase.

New service from CHI will be to Cozumel, Montego Bay, Punta Cana, San Jose (Costa Rica), & St. Maarten. Frequency on existing annual routes to Caribbean Aruba & St. Thomas will increase for the winter months.

Travelers from SFO may enjoy United's new seasonal daily service to Puerto Vallarta, Los Cabos, & weekly service to Cancun.

DEN vacationers will have the option of flying direct to Puerto Vallarta or Cancun on United's new daily service, or to Los Cabos or Ixtapa/Zihuatanejo on new weekly routes.

Regular seasonal routes from Washington Dulles to Aruba, San Jose, San Juan, & St. Thomas will continue.

Southern Californians can fly United's new weekly service from LAX to Ixtapa/Zihuatanejo, & a daily non-stop service to San Jose, Costa Rica, continues.

### **UNITED EXPRESS OFFERS NEW HUB FLYING TO 3 POPULAR VACATION SPOTS**

Beginning Feb. 15, United Express will launch daily nonstop service to Colorado Springs, Myrtle Beach & RNO from hub airports. As part of the new service, United Express will introduce 2 daily nonstop flights between SFO & Colorado Springs, CO, providing the only daily nonstop service in this market.

The new service includes 2 daily nonstop flights between LAX & RNO, a seasonal increase from weekend service; 2 daily nonstop flights between CHI & Myrtle Beach, S.C.; & 4 daily flights between Washington Dulles & Myrtle Beach.

### **EASYCHECK-IN NO LONGER REQUIRES USE OF A CARD**

As part of the company's continuous effort to enhance United EasyCheck-in services, customers can now begin their check-in transaction using a self-service check-in kiosk or at [www.united.com](http://www.united.com) by entering their E-ticket number, reservation confirmation number or Mileage Plus number. These options will also be available to employees in April 2005.

Currently customers check-in by inserting a credit, debit or Mileage Plus Premier card into a kiosk for identification purposes or by inputting the credit card number used to purchase the E-ticket to initiate check-in at [www.united.com](http://www.united.com). Also, customers who are already checked in can now use the kiosks to reprint their boarding passes, regardless of where they originally checked in, receive a new boarding pass during irregular operations; request or change seat assignments; request or redeem an upgrade; add their Mileage Plus number to the reservation; print an E-ticket receipt; & check bags at designated kiosks.
