LETTER FROM THE PRESIDENT (1/2/08)

In this, the February Newsletter, we each year publish the detailed information for our annual convention. You are encouraged to give strong consideration to the plans set forth for you by the local convention committee. I think you will find that the Pittsburgh '08 activities will provide you with enjoyable entertainment and social interaction with your retiree peers. Come and join us! It will not be the same if you are not there.

I also want to take the opportunity to relate a couple of questions which have come up concerning procedures of our retiree travel benefits. The first concerns first class service charge billings in the event you are boarded first class and subsequently moved back to economy class. UA procedures provide that you are not to be billed first class in that event. Mistakes, however, do happen. If it should occur to you, make sure that the following takes place:

- 1. If the CSR makes the change, a correction should be made to ACI on the gate computer and you would not be billed first class.
- 2. If the Flight Attendant makes the change after the CSR leaves the airplane, a Flight Attendant Trip Report is to be filled out and a copy PROVIDED TO YOU. In this instance you may be billed erroneously but a copy of the Trip Report to Revenue Accounting will remove the charge. Make sure you get that copy; if you don't, it probably will be difficult, if not impossible, to prove that the seating change occurred.

The second question arose concerning the selection of seating choice when called by the gate agent. Procedures are, and have been in place for years, that you must be listed first class in order to be assured of a seat there or in economy class if a first class seat is unavailable. If you list economy, you will not be considered for a move up to first class if economy fills up. Of course, in all events, seating options are dictated by availability, boarding priority and employment date.

UNITED & UNITED EXPRESS LAUNCHED NEW & SEASONAL SERVICED ON DECEMBER 15

United launched a new non-stop service from Los Angeles to Frankfurt on December 15 as well as a number of seasonal services.

- (With the introduction of the LAX-FRA service, United will serve Frankfurt eight times daily from four of our International Gateways, twice daily from San Francisco and Chicago; and three times daily from Washington, D.C.
- (The Chicago to Jackson Hole, WY service, which has previously been a summer market for United Express, will operate using mainline aircraft for the ski season. Additionally, United Express is adding a new daily service from Chicago to Steamboat Springs, CO
- (United will resume seasonal service from Chicago to Cozumel, Mexico, operating one flight a week from December 15 through April 22, 2008.
- Other seasonal routes beginning on December 15 include:
 - o Chicago to Aspen, Liberia, Montego Bay and Punta Cana
 - o **Denver** to Ixtapa/Zihuatanejo and Maui
 - o Washington Dulles to West Palm Beach, Montego Bay and Punta Cana
 - o Los Angeles to Aspen, Ixtapa/Zihuatanejo and Jackson Hole
 - o San Francisco to Aspen

UNITED EXPANDS EMPLOYER DISCOUNT 20 PROGRAM TO INCLUDE UNITED EXPRESS TICKETS

Effective immediately, travel-eligible United and Mileage Plus employees and their travel dependents, including parents, receive a 20% discount off all future revenue travel on United Express. **Retirees** who are travel-eligible are also offered this discount. This is an expansion of the existing discount program already available on United and Ted.

The interactive voice response line, 1-800-UAL-LIST, may be used to book and ticket this travel. The fully automated process requires a credit card for payment. The discount is available on most published fares.

As announced in NewsReal November 13, fare information based on price or schedule may be accessed through UAL-LIST to receive the lowest discounted fare. Employees can either ticket immediately or place the reservation on hold for ticketing within the designated time limit.

"We are delighted to extend our 20% discount program for revenue tickets on United Express flights, in addition to United and Ted flights," says Todd Arkenberg, VP - Employee Experience. "In addition, our employees can look forward to more improvements in the UAL-LIST functionality next year, including speech recognition upgrades and reductions in background noise sensitivity."

NEW ZED AGREEMENT SIGNED WITH FOUR CARRIERS

United recently implemented new Zonal Employee Discount (ZED) agreements with four carriers - **Aloha Airlines**, **Kuwait Airways**, **Pluna** and **Era Aviation**. These carriers join other airlines we have added to our ZED portfolio in 2007, including Aer Lingus, Air Canada and US Airways.

"We constantly evaluate the possibility of new partnerships and improvements to existing agreements to ensure our Employee Offline Travel Privilege Program remains competitive and brings value to employees," says Peter Hammer, Managing Director - Worldwide Sales. "These new agreements enhance the services available to all employees in our already robust program."

- (Aloha Airlines offers extensive service within the Hawaiian Islands and between Hawaii and the West Coast of the United States.
- (Kuwait Airways is the national airline of Kuwait and operates scheduled international services in Europe, Asia, the Middle East and North America.
- (Pluna, based in Uruguay, operated scheduled services within South America and between Uruguay and Madrid.
- (Era Aviation is based in Anchorage, Alaska, and serves a network of destinations throughout the state.

We make updates to the carrier eligibility requirements and restrictions as new agreements are reached.

The ZED discount is a service-charge structure based on the mileage between a point-to-point origin and destination.

2008 INTERNATIONAL TRAVEL EMBARGO SCHEDULE

United embargos pleasure travel on international flights that have left large numbers of space-available, non-revenue pleasure travelers stranded for several days due to heavy flight loads or weight restrictions. Embargos apply to United sponsored unaccompanied companions and to employees and their sponsored travelers of other airlines, United Express and are not applicable to United employees/retirees, their travel eligibles or accompanied companions.

An upcoming embargo applies for travel to and from Sydney and Melbourne January 1 - 15, 2008. An updated embargo date and destination list for 2008 is available in SkyNet's travel section. Travel by an unaccompanied companion or other airline employee/retiree/travel eligible during an embargo is against company policy.

Embargos do not apply to United or other airline employees who are traveling on company business; however, employees should carefully evaluate if company business travel can be avoided during a scheduled embargo period due to heavy passenger/freight loads.

When extending a travel pass, it is a good idea to remind all space available pleasure travelers that their space on flights is not guaranteed. Also, travelers should plan outbound travel appropriately when return travel is embargoed.

OTHER CONVENTION NEWS

<u>Getting Around Pittsburgh</u>: Pittsburgh presents the profile of a bustling city, but in a size and scale that is easy to grasp and maneuver. We just don't have city "blocks" here. Downtown Pittsburgh is even laid out in a triangle shape, as it sits right at the point where the Allegheny and Monongahela rivers meet to form the Ohio.

An easy way to learn the geography of Pittsburgh is to divide Pittsburgh into four sections: the North and South Sides and the East and West Ends, with downtown positioned conveniently right in the center of it all.

Tucked into the nooks and crannies of the four sections are 88 distinctive neighborhoods which make up Pittsburgh, linked by winding streets, steep stairways and even a few inclines.

<u>Pittsburgh's Golden Triangle</u>: Downtown Pittsburgh occupies a compact 50-acre area bordered by Grant Street to the east, Penn Avenue to the north and Boulevard of the Allies to the south. You are never more than a few blocks to your destination. Downtown is easy to walk and nice for pedestrian enjoyment, with parks and plazas spaced conveniently between office towers and retail.

Public Transportation - Including subway, inclines and bus transportation:

- Subway The "T" Pittsburgh is a small but clean and safe 25.2 mile subway and light rail system, the "T" serves downtown Pittsburgh with a four-stop loop including stops at Steel Plaza at Grant Street, Gateway Center Plaza (Liberty Ave and Stanwix Street), Wood Street, and the First Avenue Parking Garage. Underground, the music is classical, art whimsical and travel within downtown Pittsburgh is free. The subway will also deliver you across the river to Station Square on the South Side with the for a minimum \$1.00 fare. (Station Square and South Side Works would be great and wonderful places also to visit and tour). After traveling under the Monongahela River, the "T" runs above ground along three different lines into Pittsburgh's south suburbs.
- (Public Bus System PAT multiple bus routes connect downtown Pittsburgh to cultural and other attractions which many of you will be using.

TRAVEL TIPS BY BOB

I recommend considering travel assistance programs offered (for a price in most cases) from organizations such as **AAA**, **Good Sam Club** and etc. There is nothing more discouraging than experiencing vehicle problems when you are on a trip. The assistance packages that some travel oriented organizations provide will prove to be a real plus for you because help arrives shortly and you are on your way.

Also, some of these organizations offer discounts at various hotels, shuttle services, parking facilities, taxi cab and limousine fares and even businesses like UPS (since FedEx doesn't offer discounts to retirees). If you are interested in assistance programs like this, do some shopping around and ask questions, you might be surprised what is available. And, it's been my experience that, in some cases, the discounts offered exceeds the normal "Senior or Military" discounts. Again, if you are interested, do some shopping.

And, don't forget that **SkyNet** is a good place to search for discounts on many products such as luggage, Starbucks Coffee, and See's Candies at holiday time for a number of enticing items. It's wise to check **SkyNet** before travel, even if you are not flying.

How I connected with UAL and how I hope to reach my 100 Birthday.

How I connected with UAL is the beginning of my story. In 1936 I was in Chicago, and had a very undesirable job. It involved cleaning used machine parts with a caustic solution and required the use of rubber gloves and a protective apron. While so employed I applied for jobs with TWA, American and United, all of which were headquartered in Chicago at the time. One day I received a phone call from United requesting that I come in for a job interview the following day. I was told that they planned to hire seven agents, all of whom would be placed in positions west of Chicago. I interviewed with four United Airlines staff members that day. They asked me to report again the following day at the same time for additional interviews. Again, I requested time off from my less than desirable job, so I would be able to attend the second day of interviews with United. The second day of interviews ended with me being told that the final interviews would be held on a third day. When 1 arrived on the third day, I found myself to be one of about 12 final job applicants for the seven available positions. The final interviews lasted all day, finishing up at quitting time around 5:00 pm. During the process, one of the UAL staff members by the name of **Knickerbocker**, announced that he was leaving for the day to go to his club. I was under the impression that he was the one to make the final decision, but I decided to sit tight and wait, until I was advised otherwise. Shortly after 5:00 pm, a man by the name of **Ben Voight** returned to his office, which was in my view from the where I was waiting. He lit his pipe and stared out his window for a number of minutes without saying a word. He then signaled me to come into his office. He told me, "Well you are one of the lucky ones." I thanked him and told him that I was looking forward to working for United and to be leaving a job that I disliked. He told me that within three days all seven of the successful job applicants would be leaving Chicago to be posted in the west. At that time, United had exclusive operations in Burbank, CA and Reno, NV. When Mr. Voight asked me if I had a preference, I told him that I would prefer the Burbank location. When I arrived at the Chicago airport expecting to fly to Burbank, I learned that my flight pass was to Salt Lake City, not Burbank. Before departing, I was told that for the first six months, I would be employed on a trial basis, and during that period of time it would be decided whether or not I would become a permanent employee. The way it was expressed to me was that "after six months, it would be decided if they liked me, and I liked them." At the end of my trial period, I was called into the office of my boss, **Paul Woelfel**. He told me that he was pleased to inform me that I was to become a permanent employee.

After spending three years in Salt Lake City, I was transferred to Seattle, WA. From there, I was later transferred to Reno, NV, where I had my first supervisory position. Later I moved from there to Oakland, CA, then later on to the headquarters in Chicago. After a time there, I was again transferred to Omaha, NE and then back to Chicago. After a time there, I was moved again, this time to Cleveland, OH. I was in Cleveland far longer than any other posting from 1945 until 1962. Shortly after United merged with the ailing Capitol Airlines, I was relocated one final time to Youngstown, OH, where I eventually retired from United Airlines.

My goal is to reach my 100th birthday on January 4, 2008. By the time this becomes a published article, this should have become a reality. In the 36 years and 9 months I worked for United, I never had to take a day off or a single sick day. This fact once came out at a meeting in Denver, when I was still stationed in Cleveland. My boss at the time, a fellow by the name of **O.C. "Bud" Enge**, asked me how I would like to take three days off as a bonus, for my perfect job attendance record. I believe my reply to him was. "Now how can anyone refuse such an offer?"

BOEING (Continued)



May 15, 1930 the airline industry's first Stewardesses began flying onboard BAT's Boeing 80As on the San Francisco to Chicago route.

In 1926, Stout Air Services had hired young men as America's first in-flight personnel. They were known as "aerial couriers". In 1929, Pan American Airways had hired young men as "stewards".

One evening during a slightly-delayed flight from Reno to San Francisco, Steve Stimpson, Boeing Air Transport Pacific Coast Traffic Manager, had noticed the BAT passengers looking out the windows, searching for landmarks and repeatedly glancing at their watches.

Entering the cockpit, Stimpson checked with the two pilots regarding their location and the estimated time of arrival. He passed this information along to the passengers and then adjusted the heating system.

After noticing the collective sigh-of-relief among the passengers, he recalled how steamship stewards had impressed him with their service and attention to ship passengers. He wondered if male air stewards would make the same impression on BAT's passengers.

Stimpson received permission from the company to hire the stewards and had hired three young men when Ellen Church stopped by the Stimpson's office and suggested hiring female nurses instead.

Ellen had previously visited Stimpson's office, intrigued by the airline advertising in the window. She was a nurse at the nearby San Francisco French Hospital and wanted to fly, even to be a pilot.

Boeing managers initially rejected the idea of hiring female nurses, but W. A. "Pat" Patterson assistant to the BAT company president, finally gave his permission for the stewardess program on a three-month trial basis.

Stimpson then hired Ellen and gave her the title of chief Stewardess. She quickly recruited seven more nurses from San Francisco and Chicago. These eight Stewardesses became known as the "Original Eight".
