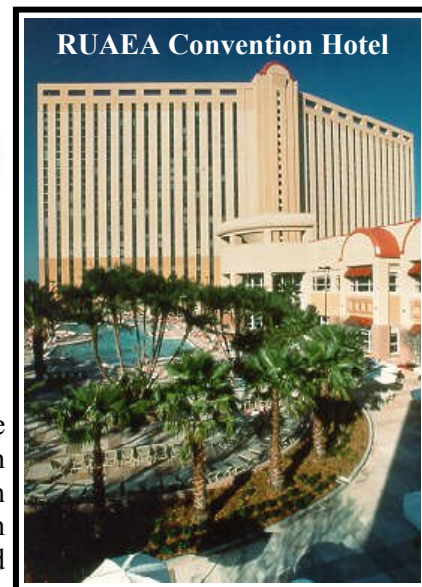

### The Writers Column – Beryl Cheney By Lee Francis



United Airlines recruited **Beryl Cheney** from the LDS Hospital in Salt Lake City in 1932. Beryl flew Boeing 80A's and 247's between SLC and OAK/SFO until she grounded herself in 1935 by marrying **Ken Francis** from Morgan, Utah. Their son, **Lee Francis** was a pilot for United from 1966 until 2002, flying out of SFO before he retired as a Captain. Lee married a United stewardess, **Shirley Gates**, in 1973. Shirley's flight attendant career lasted 29 years from 1967 to 1996. Beryl was able to fly to Hawaii on a 747 before her passing in 1979.

**Lee & Shirley Francis** are members of RUAEA and the Sacramento Gold Diggers, and Shirley is a member of the Sierra Mountain Foothills Chapter of Clipped Wings. Lee proudly sends along some uniform pins that belonged to his mother who was a UAL stewardess from 1932 to 1935. Lee feels that two of the pins might be Boeing Bug pins referred to on the Historical Foundation wish list. He has had these displayed in a shadow box, with a green background because the uniforms were green, for a number of years. Lee would like for the items to be displayed and enjoyed by people who like this type of memorabilia, for years to come. And we are very appreciative and thankful to receive Lee's story about his mother, **Beryl Cheney**, and her days as a United stewardess.



From the Salt Lake Telegram, March 9, 1934: *Miss Beryl Cheney never had a serious mishap in her career. Centerville – "They tell me I'm a good luck charm," says petite Miss Beryl Cheney, United*

*Air Lines hostess, "and it must be true, for I have already flown 250,000 miles without the slightest mishap. Sometimes we've been delayed for several days by storms in the Sierra Nevada Mountains, but otherwise*

*things have gone smoothly. Anyway, I'm a fatalist."*

Miss Cheney, whose home is in Centerville, is the only girl in Davis County to enjoy the distinction of being an air hostess. She is a graduate nurse, one of the chief qualifications. Other requirements of a stewardess are that she is single, weighs not more than 120 pounds, is attractive and has a pleasing personality. The pretty hostess very modestly asserted that she couldn't see how she passed the last requirement.

"Oh, I just got tired of nursing," Miss Cheney said when asked why she chose to work in the air. "Once you become accustomed to flying it is hard to stay down. The only time I've missed a trip during my six months on the job was when I had to undergo an Appendicitis operation. Even then, when a plane flew over the hospital and I heard the roar of its engine, I was anxious to get back to work. In fact, I missed only 15 days."

Among the prominent passengers Miss Cheney has served are Governor Rolph of California, Elliott Roosevelt, Douglas Fairbanks Jr., Alice White, Mary Brian, Will Rogers, Wallace Beery and Ian Keith. "Recently," she said, "we had a 76 year old passenger who had crossed the plains by ox team, and he was certainly amazed. Occasionally we carry dogs. We once carried a dog from San Francisco to Chicago, which was sent as a gift to President Roosevelt.". One of her ambitions is a flight to the Hawaiian Islands.

### Other Convention News

It is Convention time again! We hope as many of you as possible can share this time of remembrance of the "good ole days". The camaraderie of RUAEA retirees at Convention is priceless.

Following are some methods we can use to get to Convention or for that matter, anywhere else! To find individual airline agreements, go to SkyNet. On the header line to the right side, you will find **Travel**. When you click on this, it will bring up the **Travel** page.

On the right side of this page there is a box headed **Travel Programs**. Within the box, you will find **Interline Travel Privileges**. When you click on it, you will be taken to the **Interline Travel** page. On the left side of that page, you will find a box with several items in it. One item is **Individual Carrier Agreements**, another is **Interline pass Benefits**.

When you click on **Individual Carrier Agreements**, a new page will come up with a box in the middle with an arrow to scroll down to the specific airline you want to know about. On the left under **Travel Tools**, you will find **Zed Fares Calculator**.

At the present time, **ZED** fares (Zonal Employee Discount) are available on many carriers. Current domestic carriers are Air Canada, American, Continental, Delta, Frontier, Great Lakes, and US Airways and these

fares are ticketed at the UAL ticket counter by our UAL agents. JetBlue also offers us a Zed fare **BUT** all ticketing is done at JetBlue's ticket counter.

Most other airlines offer **ID95 and ID90** discounts.

To obtain offline tickets, you can call the Employee/Retiree Interline Travel Desk at DTWRR 1-888-874-1581. Their hours are 8am to 10pm CT Mon. through Fri., 8am to 8pm CT Sat. and Sun. You may charge these tickets on a credit card. You usually have the option of having the tickets mailed to you (book 14 days in advance) or you may pick them up at the airport, in which case they will give you a Record Locator. If you are looking for positive space travel, United does offer a 20% discount on most published fares. **This offer applies only to United and United Express travel. It excludes Star Alliance carriers and Code Share carriers.** When you are booking, tell the reservations agent the reference code is **S\*PMO/EMP20**.

Southwest Airlines and Spirit Airlines travel benefits are different. Both offer retirees the following: \$25 OW and \$50 RT plus taxes. To obtain these tickets you must get a letter from United, which in turn you give to the respective airline when you purchase your tickets. To obtain the letter, call the Benefits Center at 1-888-825-0188. They generally send you five copies of the letter, stating your name file number and spouse's name if applicable. When you purchase the ticket, at their ticket counter, they will want to see your United ID and a driver's license, along with the letter. Spirit accepts cash or check. Southwest only accepts cash and has a special phone number for non-revenue listing. Call 1-866-359-7967. We have found them to be very helpful, giving seats available and recommending other choices. Also, when checking availability and fares, if the Senior Fare shows available, there are usually at least 20 open seats on the flight.

And lastly, Southwest Airlines offers Senior Fares on most of their flights. It is a confirmed fare and is refundable, exchangeable, with no penalty. You must be age 65 or older. Go to [southwest.com](http://southwest.com).

### **TSA Update**

**United Teams Step Up to Keep the Focus on Service and Performance** - In an industry where "fast paced" is the norm, and multiple challenges from weather to Air Traffic Control issues to increased secu-

rity requirements are part of the everyday business, the people of United always come through.

*"We can't ignore the added impact the Transportation Safety Administration's pre-boarding screening requirements have had on our reliability performance, particularly for our colleagues in London, Toronto and Calgary,"* says Scott Dolan, SVP-Airport Operations, Cargo and UAX, *"but we are seeing the intensity of the delays coming down, with less impact on arrival performance"*.

Recently, United beat goal on Arrival :14, (A :14) performance and completions and remain No. 1 among the other legacy network carriers for the month to date. *"This is especially impressive given load factors in the 90 percent range at all of our hubs and a great number of other stations through the holiday travel season,"* Scott adds.

United is also doing well taking care of its customers and ensuring they don't feel overly inconvenienced. United's international United Promoters (UP) score recently was 25.8, which is outpacing its fourth quarter and year-to-date 2008 ratings.

UP score for those flights in which the IFE system was turned off during the early stages of the new security directives in order to meet the TSA's mandate to disable the GPS, or map-tracking, feature, was approximately 20. Good communication by United's flight attendants and the fact that the maintenance teams were able to reprogram the IFE systems quickly, helped in not dragging down the scores.

*"All of our teams who have been hard at work these past several days are to be congratulated, not only for meeting the TSA's requirements, but maintaining our focus on safety, customer service and the integrity of our operations -- especially given the very high load factors during this period,"* Scott says.

### **Mission Accomplished - Former Ted Planes All Converted to Popular New Mainline Configuration**

The last of 56 Airbus A320s with the Ted single-class interior has been completed with the conversion back to mainline use at the San Francisco Maintenance Center. The plane, with a new nose number, 4107, returned to service on Dec. 22.



Airframe Maintenance crews started the conversions in the spring after winning a competitive bid to install new interiors featuring United First(R) sections and leather seating throughout the cabins.

All the former Ted planes have been repainted in the new United livery, and all traces of the former brand have been removed from stations it served.



This large project finished overall on schedule, under budget and with full scope implementation due to the cross-divisional program team, said Senior Project Manager Patsy Di Domenico.

Team members representing the 22 United departments involved in the conversions were recognized this month for their roles in making this project successful.

Mark Miner, managing director - Maintenance Planning, told United Services employees who led the project that their performance *"really demonstrated the high caliber of work product that we can produce while simultaneously addressing challenges that surfaced along the way."*

*"This is a great example of how the people of United working as a team towards a common goal can not only meet performance expectations but significantly exceed those expectations,"* said Robert Madigan, managing director - Airframe Maintenance.

The converted A320s have 144 leather-trimmed seats - 12 United First(R), 42 Economy Plus(R) and 90 United Economy(R). They have been receiving much higher United Promoters ratings from passengers compared with the existing mainline A320s.

For November, workability scores have been 15.9 for the converted A320s, compared to 10.4 for the older interiors. Cleanliness scores are nearly doubled for the converted planes, 21.5 to 11.9, and condition scores are dramatically higher - 12.2 for the former Ted planes, and 1.8 for the older A320s.

In addition to the immediate impact their work has had on customer satisfaction, the experience of converting the A320s has set the stage for another successful project in 2010. The same Airframe Maintenance crews that handled these 56 airplanes will be installing the new International Premium Travel Experience interiors in 32 of United's 46 international B777 planes, starting with the first prototype in February.

### **Added GPS to Enhance Navigation Capabilities**



As part of the fleet modernization program, United plans to begin an ambitious effort this spring to upgrade the navigation capability of its entire Airbus fleet with the latest in flight management computers and GPS installations for precision timing and navigation.

While approximately half of the Airbus aircrafts, as well as its entire Boeing fleet, already have GPS installations, it's critical that United enables the entire fleet with such technology as part of the overall Next Generation - or "NextGen" - requirements, according to Cap-

tain Joe Burns, managing director - Flight Standards and Technology, who is heading the initiative.

*"NextGen is actually here and now, and it's a pivotal period in what we like to call NowGen,"* says Joe Kolshak, SVP - Operations. *"The enhanced GPS technology will allow for reduced block times and more reliable operations into and out of all airports with Area Navigation and Required Navigation Performance procedures. The precision tracking and timing capability of GPS-equipped aircraft will allow for more automated navigation and tighter path operations - allowing us to safely achieve tighter spacing in busy airspace such as around Chicago O'Hare,"* Joe adds.

The flight management computer upgrades will be completed in 2010, while the GPS installations on the Airbus fleet will be done by mid 2011.

Captain Burns is a member of the Presidential Commission on Position, Navigation and Timing and represents the airline industry on all things related to GPS. In this role, Joe ensures that United and the airline industry are represented in discussions about the needs and future growth and stability of the GPS system that is operated by the U.S. Air Force for the Department of Defense.

### **United Launches \$500 Million Senior Secured Note Offering**

United announced recently in a press release that it plans to offer \$500 million aggregate principal amount of senior secured notes due 2013 in a private offering.



The offering, which is contingent on market and other conditions, is part of United's ongoing effort to enhance its liquidity and actively manage its debt obligations. Once additional details on the offering are finalized, updates will be provided.

### **United Applauds Open Skies Agreement With Japan**



United applauds a bilateral agreement reached Friday between Japan and the United States that would ease restrictions that currently exist on air transportation between the United States and Japan and would further enhance United's Pacific network.

The agreement caps more than 10 years of efforts to revamp - for the first time in more than half a century - the rules under which airlines can fly between the two

nations and beyond. The previous agreement between the two countries dated back to just after World War II.

*"We congratulate the U.S. and Japanese delegates for reaching this historic agreement, as we have long advocated for Open Skies with Japan because it will benefit our customers, our employees and our investors as we strengthen our Pacific network,"* said Glenn Tilton, UAL president, chairman and CEO. *"We have the right partners and look forward to forming a joint venture across the Pacific with our longtime partner All Nippon Airways and Continental, which joined the Star Alliance in October, providing our customers with access to more destinations and convenient schedules."*

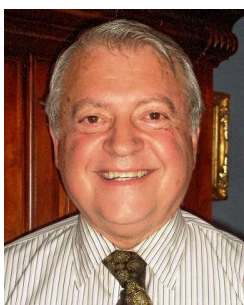
ANA is Japan's second largest airline, with hubs in Tokyo, Narita, Kansai and Osaka. It has been a member of the Star Alliance since 1999.

United expects to file an application with the Department of Transportation for anti-trust immunity across the Pacific with Continental and ANA shortly. Earlier in 2009, the Department of Transportation awarded anti-trust immunity to United, Continental, Lufthansa and Air Canada for its joint venture across the Atlantic.

An immunized alliance would substantially expand the global reach of the carriers' networks, providing customers access to larger inventories of seats and cargo capacity, serving more destinations, offering a greater selection of routings, and providing consumers a wider range of competitive fare and service options.

United recently announced that it will be purchasing 50 next-generation widebody aircraft, including 25 Airbus A350 and 25 Boeing 787 Dreamliners, both of which would be used to serve its Pacific network.

### **Ask The Doctor – How To Cut Health Care Costs**

The June 28, 2009 issue of TIME magazine featured several articles on Health. In this very contentious period in our country, there is no subject that can cause more controversy than the one about Health Care. The articles in TIME described many of the areas of medicine that are near and dear to my heart. - PREVENTION is the KEY.

TIME begins its coverage with this very appropriate opening: One way to cure illness is with pills and procedures. Another is not to get sick in the first place. The great thing about the latter: it's cheaper, easier and more likely to save your life. I wish I had said that. That is the basic tenet behind my specialty - Prevention is the answer. But, it will require a total commitment from all of us. As TIME said, that means ditching bad

habits, eating right, exercising, and spotting danger signs early. WOW!! That is what I have spent my entire medical career emphasizing and advising patients to do. Now, the public media is finally addressing this as the way to curb the horrendous cost of medical care. It is about time the media got the message and began spreading the word.

The issue of TIME has some excellent discussions about every phase of leading a healthy lifestyle. Smoking cessation, weight loss, exercise programs, and alternative cooking methods are just some of the subjects discussed. Nothing about this is new. Those of us in the field of Preventive Medicine have been advocating these guidelines for years and years. It is only now that our message is finally getting across. The foundation of medicine must switch from one of RE-acting to a medical problem to taking ACTION to prevent the problem in the first place.

It was not long ago that many of the tests we now take for granted were NOT covered by the major health plans. The procedures that immediately come to mind are PAP smears (one of the first tests covered by insurance), mammograms (in some cases, it took State law to cover this test), sigmoidoscopy/colonoscopy (just recently covered), and the PSA test for prostate cancer. It was not long ago that NONE of these were covered. Many physicians would "cheat" to a certain extent when requesting these procedures or tests so that insurance plans would cover them. Interestingly, most insurance companies looked the other way when a physician sent them a request. Now, everyone has finally realized that any of these procedures/tests are very cheap compared to the costs to treat the major medical conditions the screening tests evaluate. I knew this 15-20 years ago, but like my peers, we did not have a suitable way to prove the value of prevention. We all could describe anecdotal cases, but could not convince the bean counters that prevention was the key to minimizing health care costs.

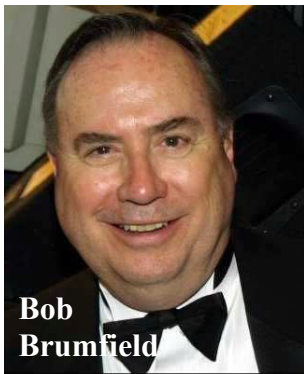
TIME did a very useful thing in this special issue. In a brief but succinct way, they discuss the health guide for all age groups: 0-12 years, 13-18 years, 19-35 years, 36-59 years, and 60+ years. For each of these age groups, TIME gives brief discussions of the subjects - At the Doctor's Office, Diet and Nutrition, Physical Fitness, and Behavior and Mood. Although we are all in the 60+ group, most of us have children and grandchildren that are in the other groups. It is worth reading this issue of TIME so that you can get a good layman's discussion of the health issues you need to understand, and your family needs to address.

It gives me a sense of relief to know that the area of medicine I have practiced for 40+ years is finally getting the recognition it truly deserves. The key, my friends, is your mind set. PREVENTION IS THE ANSWER!

It's timely to mention security changes that are sure to take effect soon because of the Christmas Day incident on Delta/Northwest Airlines. Passengers flying into the United States from abroad can expect to see additional security measures at International Airports, such as increased gate screening including pat-downs and bag searches.

As an example, the Canadian Minister of Transport announced new restrictions for flights originating in Canada, specifically a ban on any carry-on baggage. However, guests may have one personal item such as small purses, cameras, coats, items for care of infants, laptop computers, diplomatic or consular bags, crutches, canes, walkers, containers carrying life-sustaining items, medication or medical devices, musical instruments and special-needs items.

The added security measures will be in addition to existing measures. We are told that in time, there will be adjustments in an effort to eliminate the extraneous and properly implement what is required.

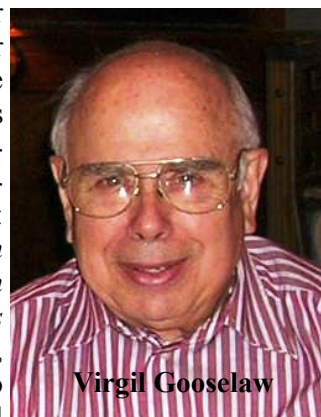
At this point, we should not let this discourage us from traveling but rather learn how to accommodate with the least amount of confusion. Another matter that has come to my attention that needs to be discussed is purchasing revenue tickets on a flight that we are already listed on as a NRSA. Doing this in essence removes the seat/s from inventory and is really frowned upon by the company. In fact it is considered fraudulent and may result in removal of pass privileges. 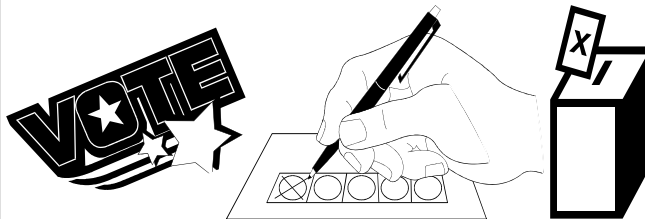

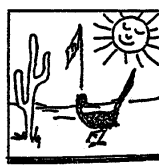

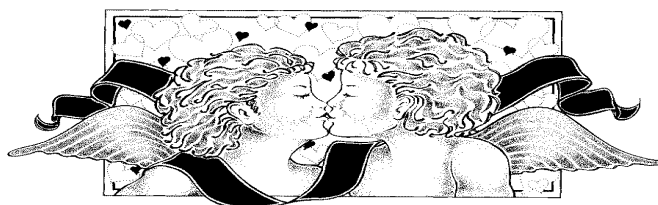
Raffle Drawing was conducted by **Frank & Angie Dellinger** with many items to choose from.

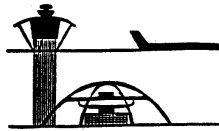
It was announced that money raised in our Charity Fund in the amount of \$900 this year went to five non-profit agencies in Sonoma and Marin counties.

She suggested we ask for a free energy survey that is available and also explained the On Call program that gives a monthly credit to participants so that FPL can meet the energy needs during peak times. Typically, this program saves one month of costs. Many were not aware of that offered program. She was very knowledgeable and answered many questions for us. 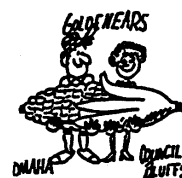

Additional safety features for the flight included a switch in the flight deck that could be flipped in an emergency to blow out eight windows to depressurize the plane, and another switch to detonate a charge to

blow off an exit door behind the right wing. These steps would make it possible for the crew to jump from the plane if necessary. Fortunately none of these measures came into play as the test flight of 3 hours was a big success. The 787 departed from Paine Field in Everett, 23 miles north of Seattle, flew an extended spaghetti-like pattern over the area and ended with the landing at Boeing Field, 6 miles south of Seattle. Crowds of people at both locations cheered the plane as it departed and landed. The flight was also broadcast live on the major TV channels in Seattle. This particular 787 was Dreamliner No. 1 and there are 5 other Dreamliners in the test fleet, all to be flown by 3 dozen test crews over the next year. The first customer delivery will be to ANA at the end of 2010. United has 25 787s on order, with delivery expected during the 2016 – 2019 time frame.

**Kent & Carol Soffel** sailed their 58-foot boat the WINDY-i in the 2009 parade of Christmas ships in the Puget Sound area waters on several nights over the holidays. This event is a 59-year tradition in the Northwest. The WINDY-i was brightly decorated in Christmas colors and the guests on board were provided Santa hats to wear during the cruise. Also featured were delicious hors d'oeuvres and refreshing beverages to complement the singing and fellowship onboard. In 2007 and 2008, the WINDY-i won the prize of "Best Decorated Boat," but the 2009 competition was very stiff, and the judges decided to give another boat the award this year. 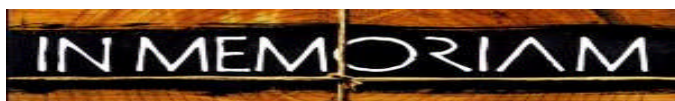

I am Bob Andrews, 30919, Life. I was hired as a dishwasher in 1938 in the Midway Kitchen under Chef John Neider. I transferred to CYX as an agent and Overhaul Guide and supply man (1 month), then to DENPS as a supply man to keep track of OS equipment (as we were losing it there), then as a station agent, then to PDX Dispatch as a Dispatch Clerk. I was on duty the night Pearl Harbor was bombed. The FAA shut off the ranges, we had several DC-3s approaching for which the FAA turned on and they landed ... safely. The next day I volunteered for submarine service. No go - I wore glasses. I waited to be drafted and would end up as an "operations clerk" since I had a restricted 3<sup>rd</sup> class radio license.

Anyhow, I ended up in England, at Honington Air Base as an Operations Clerk (from private to Tech Sgt.), later promoted directly to 2<sup>nd</sup> Lt - field commission! At the base, we repaired B-17s and serviced P-38s and P-51s operationally. 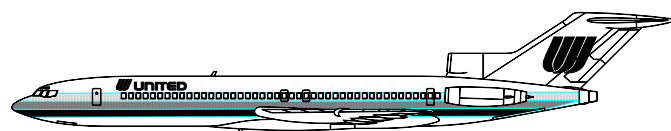

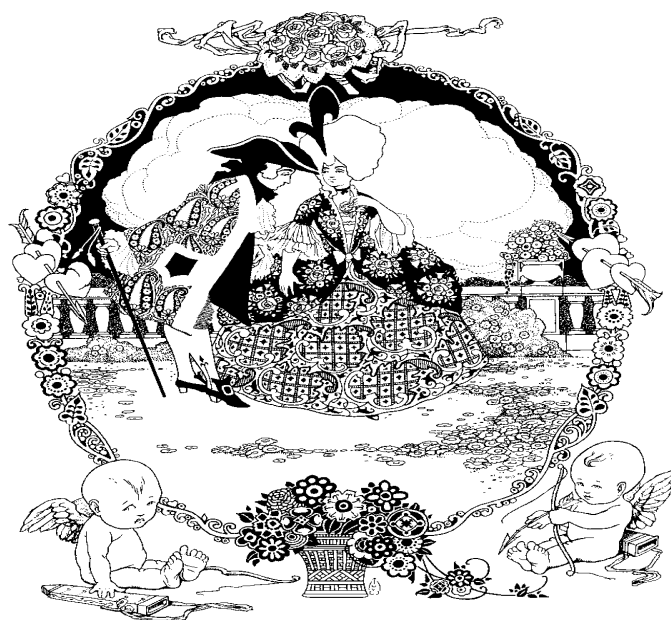

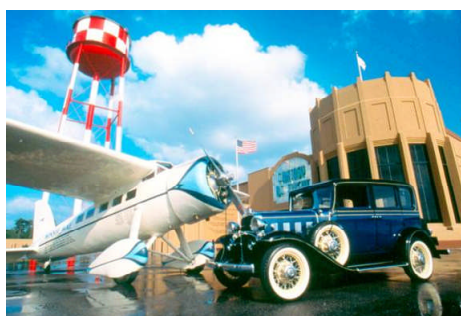
# RUAEA 2010 CONVENTION TOUR DESCRIPTIONS

### Tour #2 – Gatorland

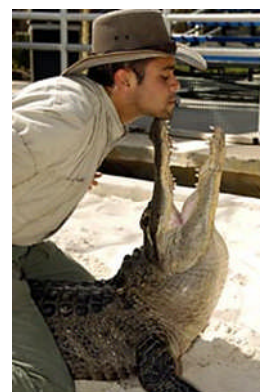

### Tour #3 – St. Augustine

Wednesday, May 26 (9:00AM -6:00PM), \$75.00 P/P Based on a minimum of 40 people

Few historic statements are questioned more than St. Augustine's claim to the title "*the nation's oldest city*." It is indeed the oldest permanently established settlement and more importantly, it is Spain's Colonial Capital. You will see the ***Mission of Nombre de Dios/La Leche Shrine*** and hear about this most historic and sacred area in St. Augustine, the landing place of Pedro Menendez de Aviles, our city's founding father. We'll make a brief stop at the ***Castillo de San Marcos National Monument*** (remain on coach) for the story of the constructing of this fortress of coquina (a native stone) and the

battles and struggles surrounding the fort. Traveling past the beautiful bay front and through the heart of the Old City by the ***Plaza de la Constitucion***, you will then debark for a memorable view of the ***Flagler Memorial Presbyterian Church***. This church was built by Henry Flagler, the east coast railroad baron and "Father of Florida Tourism". Henry Morrison Flagler's magnificent hotels are next on the agenda. The ***Ponce de Leon Hotel*** (present day Flagler College) is where many presidents and elite men and women stayed during their visits to St. Augustine.



After the bus tour you will be treated to a Flagler Era Walking Tour. Henry Morrison Flagler developed St. Augustine as the "Riviera of the South" for the rich and famous after arriving in 1884 to celebrate his honeymoon.

After the sightseeing tour, you will be able to tour St. Augustine on your own and experience the unique city! A must-see is St. George's Street which features many different shops and eatery places for everyone to enjoy.

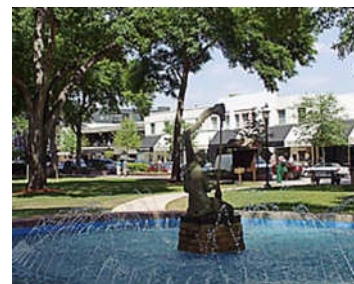
#### **Tour #4 – Winter Park Cultural Tour**

### **Tour #6 – Alligator Airboat Adventure**

Imagine seeing the world in a whole new light. This educational excursion takes you into the seldom visited heart of natural Florida. You will see natural, protected wetland hammocks, walk through ancient Flatwoods, and travel by airboat into sections of fresh water marshes and upriver, into the bald cypress swamp - home of the Florida alligator, American bald eagle, and a myriad of wildlife. ## United Airlines Historical Foundation

*During WWII, 36 of United's 69 DC-3 airplanes were turned over to the Government's ATC and were soon painted in Armed Forces "war-time livery".*

Late in 1941, the U.S. Airlines were warned by Edgar Gorrell, president of the Air Transport Association, that in the event of war they would be "taken-over" by the government if they didn't join together and create a plan for their war-effort.

Gorrell wanted to be able to offer the plan to President Roosevelt thereby preventing the complete seizure of the nation's airlines for the duration of the war.

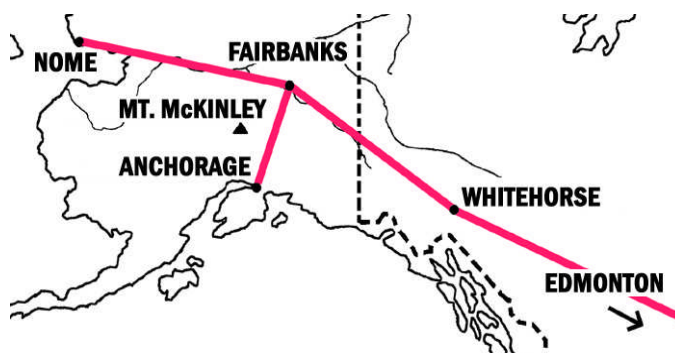
Immediately following the attack on Pearl Harbor, Gorrell and General "Hap" Arnold, chief of the Air Force, were called to the White House. Gorrell and Arnold convinced F.D.R. that by following the airlines plan for an Air Transport Command, they would be able to begin flight operations immediately, whereas a government seizure would take weeks to organize.

In April 1942, following the Japanese naval movement into the Northern Pacific area, Gorrell asked Pat Patterson to make a "survey flight" to Nome, Alaska. On the flight from Salt Lake City were United pilots R.T. Freng, Bert Lott and R.J. Johnson and United weatherman Henry T. Harrison, SLC station manager Ted Johnson and some expert communications technicians.

The survey crew flew over 7000 ft. mountain

passes flanked by lofty peaks (including Mt. McKinley). While finding the available maps inadequate and landing fields few (and short), they did find the radio navigation aids better than expected.

United's proposed ATC route was from Dayton, Ohio to Calgary to Whitehorse to Fairbanks and Nome. United ATC crews launched operations between Dayton and Alaska on May 15, 1942. The Japanese attacked the Aleutian Islands of Attu and Kiska on June 3, 1942.



A second route between Ogden, Edmonton and Alaska started in early June 1942. By mid-June, 41 planes were being flown by 6 airlines rushing troops and supplies to Fairbanks and Anchorage using the most rapid turn-around schedules and routes possible.
