Please continue your efforts in your respective chapters, to recruit members for your local chapters as well as recruiting for RUAEA.


My plans are to attend the all Florida meeting in February and the All Arizona Picnic in March.

#### **Change to Employee MileagePlus Explorer Card Offer**



As we have mentioned in past issues, things are always changing. In January, we wrote about the United MileagePlus Explorer Card rebate form. Well, it appears that has already changed. Please read the latest below. It is posted on Flying Together in Employee Discounts.

Beginning January 1, 2013: If you are a United employee who is the primary Cardmember of the United MileagePlus Explorer Card, you are eligible to receive an annual \$80 statement credit from Chase. There are no forms to submit to receive this credit. The

credit will be applied by Chase automatically to your April credit card statement each year this offer is in effect; please allow an additional month for the credit to be reflected on your paper statement.

To be eligible for the \$80 statement credit in 2013, you must be an active United employee and a primary Cardmember of the MileagePlus Explorer Card effective February 15, 2013. If you currently have another MileagePlus credit card from Chase, and would like to take advantage of this offer, please contact Chase at the number on the back of your credit card to see if you are eligible to get the Explorer Card. All former rebate offers provided by Chase to United employees and retirees have been discontinued as of December 31, 2012.

#### Webinars, A New Year, New Terminology



FlyingTogether now offers Webinars, or WebEx sessions and we thank **Jim Morehead**, RUAEA and RUPA member for writing this article to introduce us to this new information format.

The WebEx sessions are now available in three locations on the Travel tab:

The above links require you to sign in to Flying Together to access them. It will lead you to 6 WebEx or Webinar sessions. Of greatest importance are #1, #2, and #6. #4 could have some interest to cancel a PNR or to change a PNR. Canceling a PNR is simple and you should cancel if not going to travel or your trip is delayed. If using a Vacation Pass, it puts it back into your bank if the trip was not started. Changing a PNR or Travel Plan happens if changes are necessary. I found that, since listings do not roll over to the next day, if you need to change because you missed a flight later in the day, you can do so. It is especially important to use CHANGE SEGMENT if a route has just one flight per day and you could not be boarded to preserve the vacation pass status. Take the example of an ORD-MUC flight which runs daily and you misconnect or can't get on. Had you used the VP on the first segment of a multi leg trip, you have already used the VP. To preserve its value, you will need a change segment to list for the next day if that is your goal to continue trying. Remember, in a hub (10 of them), you have 72 hours in which to pass in/out of a hub and then it is still considered one pass and even for your entire group if you stay together. If you break it up segment by segment or day by day, the computer can not understand your wishes and you'll be charged for more than one. You'll need a good explanation for the people at ETC!

Retirees do not get Positive Space nor Buddy Passes, so two of these Webinars would not be of interest unless you have lots of spare time on your hands!

The Webinars walk you through step by step and you will only learn a lot by trial and error in the system. It is far different than the old Weblist and even the new Website is different for former Continental Employees. You'll find where you would stand on the Standby List with or without a VP before you list. After you list, it will tell you exactly where you are. Remember that the listings in this website include Positive Space People at the top and Flight Attendant Jumpseat riders at the bottom. That's why sometimes you will see someone that appears to be listed twice when in fact they wish to list for the passenger cabin and the F/A jumpseat. It is perfectly legal and just the way it was carried over into the merged system. Remember, too, that PS people already have a coach or business seat (whether 2 or 3 class airplane) and really will be no factor except they'll be upgraded first, over a pleasure pass rider. Of course domestically, they upgrade their Premium customers first anyway, so a Premium class is hard to achieve domestically except for very early morning, late at night, or holiday flights.

#6 is how to travel on interline Other Airline (OA) ZED/90% tickets. Always check the OA directory to make sure how each carrier does it. While many are the ID90T in the Webinar, the next most popular listing system is one called MYIDTRAVEL and it has its own website. OA travel is complicated often because there are so many combinations. There are some carriers that have their own websites. Some are e-tickets and e-listings. Some require PAPER tickets acquired through the ETC after approval and a PNR and subsequent paper ticket pickup physically at the airport or City Ticket Office. Not all airports can write tickets, so this takes

preplanning. Some require the actual ticket NUMBER which will start with United's 016 code, otherwise you can't list.

I don't wish to make this too long, but there are so many passwords and some vary if you were former United or former Continental. In the case of many of them, you'll be paying in advance and picking an exact flight and date for which to list. Some find that helpful and some don't. Refunding is hard and far too lengthy to discuss here, so do your homework and hopefully you'll get on your desired flight and day.

Some still use paper tickets with an e-listing like Delta. As you get into it, this is one where you need the actual ticket number and then a listing electronically making it a two step process. You'll get into their particular flights and as you pick a particular flight, it will have a Smiley Face or Frown to give you the load and your chances to be boarded. Remember paper tickets are good for 90 days (some carriers enforce it more than others) and have 1 year to actually submit it to get your money refunded back, generally on a credit card. They can be mailed back in for refunds.

#### **UAL** exits several unprofitable markets



- → IAH-CID (Cedar Rapids, Iowa)
- → LAX-TUL (Tulsa, Okla.)

On January 12, UAL will load schedule changes that reflect its decision to exit several unprofitable markets in April. As a result, United will cease service to PAP (Port-au-Prince, Haiti), CUR (Willemstad, Curacao) and DRT (Del Rio, Texas). The company is also eliminating flights in the following markets, although it will continue to serve the spoke cities shown below from other hub markets.

- → EWR-PHL (Philadelphia)
- → ORD-SJU (San Juan, Puerto Rico)
- → IAD-MHT (Manchester, N.H.)
- → IAD-PNS (Pensacola, Fla.)

In general, UAL is making the changes due to the financial performance of the flights and its continuing efforts to put the right aircraft in the right market to meet customer demand.

#### **UAL** begins and announces new routes from hub cities



On December 19<sup>th</sup>, UAL launched new service between ORD and MTY (Monterrey, Mexico) and IAD and SAL (San Salvador, El Salvador). United Express operates the ORD-MTY service with Canadair CRJ700 regional jet aircraft. UAL currently offers service to 28 Mexican destinations - more than any other airline from the U.S. It also serves MTY seven times daily from IAH. UAL operates the IAD-SAL service with Boeing 737-800 aircraft. It also offers twice-daily flights to SAL from IAH.

United also recently announced new nonstop routes from its hub cities to destinations in Latin America, Canada and the U.S.:

Latin America - GUA and SJO

IAD and ORD – On April 13, UAL will begin weekly year-round service between IAD and both GUA (Guatemala City, Guatemala) and SJO (San Jose, Costa Rica) subject to government approval and United also offers weekly year-round service between ORD and SJO, subject to government approval. UAL will operate Boeing 737-800 aircraft. The new flights complement its existing service to GUA and SJO from EWR and IAH.

Canada – YEG, YVR and YMM

EWR – New flights to YEG (Edmonton, Canada) begin on May 1, 2013. UAL will operate the flights six times weekly using Airbus A319 aircraft. ORD, DEN, IAH, and SFO currently serve YEG.

IAD – New service to YVR (Vancouver) begins on June 8, 2013, using Boeing 737-800 aircraft operating on Saturdays and Sundays through August 25, 2013. UAL serves YVR year-round from ORD, DEN, IAH, LAX and SFO and seasonally from EWR.

DEN – UAL will start service to YMM (Fort McMurray, Canada) on June 6, 2013, the only nonstop service between the airport and the U.S. SkyWest Airlines will operate the daily flights using 66-seat Canadair CRJ-700 regional jets. YMM is United's 18<sup>th</sup> destination in Canada. The company offers more flights to more destinations in Canada than any other U.S. airline.

U.S. – FAI, SAF, ICT, FLL and GRR

ORD – Daily flights to FAI (Fairbanks, Alaska) begin on June 6, 2013, using Boeing 737-800 aircraft. UAL also operates flights between DEN and FAI.

DEN – Twice-daily United Express service to SAF (Santa Fe, N.M.) begins on May 1, 2013. ExpressJet will operate the flights using 50-seat Embraer regional jet aircraft.

LAX – New United Express service to ICT (Wichita, Kan.) begins on May 1, 2013. SkyWest Airlines will operate the daily flights using 66-seat Canadair CRJ-700 regional jets. These flights are in addition to United's existing service to ICT from ORD, DEN and IAH.

IAD – United will add daily United Express service between IAD and GRR (Grand Rapids, Mich.) beginning May 1, 2013. ExpressJet will operate the flights with 50-seat Embraer regional jet aircraft. United currently serves Grand Rapids from ORD, CLE, DEN, IAH and EWR.

SFO – On April 9, 2013, United will begin daily service to FLL (Fort Lauderdale, Fla.). It also serves FLL from IAD.





As UAL prepares its Boeing 787 Dreamliners for international service, it is delaying plans to fly to some international destinations so that the company can focus resources on its LAX-NRT service scheduled to start on January 3. By focusing on this route, United expects to provide consistent, reliable service to customers with this new fleet.

UAL now plans to start using 787s on its IAH-LOS (Lagos, Nigeria) route in late January, instead of January 3, continuing to operate a Boeing 777 in the interim. UAL plans to temporarily use Dreamliners on its IAH-LHR (London-Heathrow) service beginning March 1 instead of February 4. It also plans to start

temporary IAH-AMS (Amsterdam) service on February 24 as well as regular service between DEN-NRT and LAX-PVG (Shanghai) in late March.

By delaying the LOS and LHR service, UAL will use this additional time to work with Boeing to continue to improve the reliability of the aircraft.

From the start of regular service in November to December 23, United's Dreamliners have carried about 43,000 customers over more than 800 hours for 330,000 miles – the equivalent of 10 trips around the world.





Starting in April of 2013, UAL will consolidate most of its Boeing 747s flying out of SFO to capitalize on the parts, tooling and spares that are concentrated at the hub. In addition, all of the aircraft will undergo a special check designed to address some of the chronic issues United has experienced with the fleet over the past several years. All of the aircraft will undergo these special checks prior to the summer travel season.

These steps will position United to have a more reliable 747 fleet this summer, said SFO Line Maintenance Managing Director Chris Carrick. "These changes will allow us to more effectively utilize aircraft downtime, and we have full inventory support

through the maintenance base warehouse and support shops."

Line Maintenance Planning Managing Director Barry Beacher said the changes also improve United's ability to service international 767s and 777s at ORD, using resources previously deployed on 747 overnight checks and recovery.

"These moves, along with other fleeting changes, give us the ability to focus resources where they can do more to support reliability across all of our fleets," Barry said.

Effective January 3, United replaced 747 aircraft with three-class 777 aircraft on its nonstop between ORD and NRT, and in March, on its nonstop between ORD and HKG (Hong Kong) with continuing service to SIN (Singapore). As the company redeploys those 747s to SFO, it will upgrade select 777 flights on a seasonal basis in 2013, including SFO-FRA (Frankfurt, Germany), SFO-LHR (London-Heathrow), SFO-KIX (Osaka, Japan), NRT-HNL (Honolulu) and, starting next October, its new nonstop service between SFO and TPE (Taipei, Taiwan). LAX will continue to see 747s for the SYD (Sydney) nonstop.

With the new changes, Line Maintenance Operational Planning Manager Bruce Fullerton noted, United will enhance "repeatability and exposure," as the same planes come through SFO with greater predictability.

#### United We Care gives more than \$1 million in 2012



The United We Care Employee Relief Fund surpassed last year's total fundraising, raising nearly \$258,000 before a \$100,000 company match UAL instituted after Super storm Sandy and former Continental CEO Gordon Bethune's \$500,000 donation. In 2012, United We Care awarded \$484,529.69 to 235 co-workers and \$568,300 in emergency funds to more than 1,400 Super storm Sandy victims for a total of \$1,052,829.69 in grants.

Co-workers thought of many creative ways to support the fund, including bake sales, pizza parties, golf tournaments, a dunk tank fundraiser and more. In addition, co-workers donated funds

through the Perfect Attendance program. During 2012, 24,329 co-workers were recognized for six consecutive months of perfect attendance, and 616 of those chose to donate their six-month awards to the relief fund, raising almost \$31,000.

Please keep in mind that United We Care provides assistance not only in times of natural disasters. The fund provides confidential, timely, short-term crisis relief to those in the United family needing basic assistance unavailable through other resources. The assistance is to pay for basic necessities such as rent, clothing, medicine and food during unexpected emergencies such as floods, fires and personal illness.

#### Centralized parts coordination and better communication improving UAL's metrics



An improved process has reduced deferrals of United's MEL (minimum equipment list), CDL (configuration deviation list) and interior items on the Airbus fleet by 23 percent since mid-October, and United now has expanded this logic to other fleets.

Deferral Management Director Sal Lagreca said United has centralized parts coordination by working more closely with the AOG (aircraft on ground) team and aircraft routing to ensure that if re-routes occur the parts shipments are also re-routed.

"This sets us up for success," Sal said. "When our AMTs are assigned their work, all parts and tooling are available so they can concentrate on clearing our deferrals, making our product second

to none for both our external and internal customers."

Warehousing and Distribution/AOG Director Jody Herrera said that because the changes to how deferrals are handled is working well for the Airbus fleet, United will begin phasing in the other fleets in the first quarter of 2013.

United is replicating the same procedure for planned maintenance. The goal, said Line Maintenance Planning Managing Director Barry Beacher, is to "get the parts to where the aircraft are going to be and have sufficient ground time to accomplish the work."

Barry and Jody said numerous co-workers in Tech Ops and in the Network Operations Center contributed to the improved procedures. The two divisions have been working much more closely lately to coordinate and communicate in areas such as aircraft routing (see Oct. 23 United Daily).

#### Forbes: United ups the ante on premium services
