TSA Pre✓™ expansions may simplify holiday travel

 TSA aims to ease airport congestion during the busy U.S. holiday travel season by increasing the number of airports with TSA Pre✓™ expedited security lanes and by allowing certain trusted travelers to use the lanes even though they have not previously enrolled in the TSA Pre✓™ program.

TSA Pre✓™, which features separate security lines for trusted travelers, is now available at about 100 U.S. airports. Customers using the TSA Pre✓™ lines may breeze through security without removing computers, 3-1-1 quart bag, belts, light coats and shoes. The administration hopes that by the end of 2013, 25 percent of U.S. travelers will use some form of expedited security screening.

“People in TSA Pre✓™ lanes tend to get through security at least twice as fast as people in the general

security lines,” said Global Aviation Security Director Missy Sraga. *“This is a big step toward easing some of the stress associated with holiday travel.”*

Additionally, TSA has begun selecting travelers for TSA Pre✓™ based on information they provide when making flight reservations. If you see a TSA Pre✓™ logo on your boarding pass, it means you may use the expedited security lane. As a reminder, TSA will always incorporate random and unpredictable security measures throughout the airport. No individual will be guaranteed expedited screening. Enhanced technology with eTicketing has considerably reduced the demand at the staff travel offices in IAH, EWR and CLE, which were originally opened to support United’s paper ticket process. Now these offices issue fewer than 10 tickets per day, on average. United will close these offices on Jan. 1, 2014, and those co-workers will begin serving revenue customers. United encourages co-workers and retirees to use the many helpful resources on Flying Together for booking interline travel.

Go to Flying Together > Travel > Other Airline/Interline Travel for a variety of resources. Click on “ID90T’s Other Airline Itinerary and Calculator tool” to see other airlines’ routes and obtain ZED fare information. Select an interline agreement from the drop-down menu to view eligibility and validity information for a specific carrier. Depending on the carrier you have chosen, you will see instructions for obtaining a paper ticket or eTicket. On that page, you’ll also find a recorded webinar that walks you through the process of using ID90T. And if you have questions, use the Ask Alex feature.

Handheld devices help flight attendants boost in-flight sales

The handheld devices (HHDs) that United’s flight attendants use to take credit card payments for food and



other items and services have helped drive a 5.5 percent increase this year in the revenue United earns from sales of food and beverage. For United's customers, HHDs enable flyer-friendly conveniences like easy payment and upgrades to Economy Plus from economy seats.

The role HHDs now play in United's mainline and express cabins has expanded greatly since the company introduced them to cabins in 2009. Back then, United used HHDs mainly to facilitate credit card payments for products during flights. These days, they track in-flight inventory, help predict customer demand for products and even communicate information about sales promotions to flight attendants in the air. Flight attendants also use HHDs to report information about long tarmac delays to United's Network Operations Center.

"HHDs have helped us modernize our cabins and improved the way we collect revenue," said Food Services Retail Director Todd Traynor-Corey. "They also help us manage costs by tracking our inventory and ensuring we have the right amount of a particular product on each flight. This is especially useful to us as we stock our planes with perishable items that must be discarded if they go unsold."

Flight attendants and customers both prefer the convenience of credit cards over cash. In 2012, United's cabins became completely cashless, when United stopped accepting cash on flights in Chinese markets.

In April of this year, Food Services combined the HHD software from subsidiary United and Continental to create a standardized application that allowed United to use the devices across the entire fleet.

GuestLogix provides the HHD hardware and software that many airlines, including United, use. GuestLogix recently declared United the 2013 POSie Award winner for the category of Best Onboard Merchandising Strategy at its fifth annual User Group Conference in London. POSie Awards honor the year's best in in-flight retail innovation and excellence, and United won in a category for creating new retail initiatives that have made a significant impact to its business.

Improved p.s. fleet puts United ahead of its competitors for transcontinental flights

United has completed improvements to all 15 Boeing 757-200s that fly the p.s. "Premium Service" routes between JFK (New York-Kennedy) and SFO and between JFK and LAX, making the company the first and only airline to offer customers premium-cabin, flat-bed seats on every scheduled flight in these premium transcontinental markets.



The revamped p.s. aircraft offer 28 180-degree flat-bed United BusinessFirst seats, 42 Economy Plus seats and 72 Economy seats. Designed to give customers an experience

comparable to long-haul, international flights, these p.s. aircraft also offer inflight Wi-Fi; personal, on-demand entertainment; power outlets and USB ports at every seat; and two additional inches of legroom in United Economy Plus compared to Economy Plus legroom on pre-renovation p.s. service.

FAA issues Airworthiness Directive for 787s

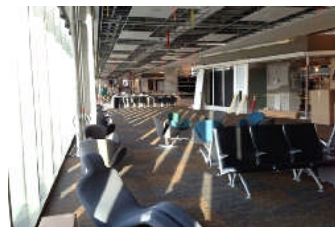


The FAA issued an engine icing Airworthiness Directive (AD) for Boeing 787s powered by GE's GENx engines. Boeing issued a notice recommending that airlines fly the affected aircraft at least 50 nautical miles from thunderstorms that may contain ice crystals.

United's investment in SFO's Boarding Area E adds luxury, innovative technology to airport experience



Beginning Jan. 28, 2014, United will operate from 10 gates in SFO's Boarding Area E, the first phase of Terminal 3's renovation. The renovation includes a 150,000-square-foot concourse connecting to Boarding Area F, as well as a new 8,300-square-foot Flight Operations base on the ramp level of the new Boarding Area E facility that will open with the new terminal. The new boarding area will be able to accommodate customers on more than 50 arrivals and 50 departures each day. United plans to operate primarily mainline service out of Boarding Area E.

Boarding Area E will offer more spacious waiting areas and natural lighting. Amenities include unique local retail and dining options; art by California artists; modern, functional furnishings; and SFO's second yoga room. Boarding Area E is designed and built to achieve

LEED® Gold certification, with features that reduce carbon emissions while creating a more healthful environment for customers and employees. Other features include:

- Nine state-of-the-art work stations and access to more than 375 power outlets;
- Interactive kids' play area;
- Spacious restrooms with private dressing areas;
- Private nursing area with comfortable loungers for mothers and children; and
- A 23-foot-high window wall with views of the airfield and the Bay Area.

As part of the project, United plans to open a new Global Services reception area and new United Club in Terminal 3. United will operate a temporary United Club in Terminal 3 beginning in May 2014 until the new club opens in July 2015.

Torgy's Travel Tips



Having just returned from a wonderful trip to Europe, I thought I would pass along some travel tips that you might find helpful for your next trip - be it to Europe, Asia or just a quick getaway somewhere much closer.

Having a plan but also remaining flexible was the key to success for our recent trip.

Since our itinerary was centered upon a 12 day cruise from Rome departing in early November, we took a calculated risk that pass travel would be favorable at that time of year. But the risk was minimized because we planned on arriving early. Some people we met on our cruise, however, did not have such a plan.

One couple booked their YYZ-PHL-ROM flight (revenue tickets) to arrive the morning of the ship's departure. A delay in their outbound flight from YYZ caused them to misconnect in PHL. They were hurriedly rerouted via AMS and then to ROM on Alitalia and barely made it to the ship on time. Their bags did not. Upon arrival in Rome, Alitalia refused to open a lost bag report because the passengers did not have their bag claim checks. Later, US Air refused to open a claim stating the rule that only the transporting carrier to the final destination is responsible for that action. So where were those bag claim checks, you ask? They were attached to the back of the original boarding passes which

were taken away when US Air issued new ones for the PHL-AMS flight. End result ~ the customers never received their luggage throughout the entire 12 day cruise!

Another situation we heard about concerned medications packed in checked luggage which, again, did not make it to the ship. The individual was lucky enough to have brought a copy of his prescriptions which were filled at an Italian pharmacy on one of the port calls, but he forfeited his shore excursion in order to take care of this.

And how about those travelers you see dozing off on the sightseeing bus while the 7 Wonders of the Ancient World pass by the window? Those were the folks who did not think about how time-zone differences affect their body clock. Why not get the best out of your dream vacation by spending a few extra dollars acclimating to the local time before you begin the structured part of the trip?

The lessons we can all take away from these true-life scenarios are:

- ✓ Arrive early!
- ✓ Keep your bag claim checks with your wallet or passport, not stuck to the back of your boarding pass.
- ✓ Never pack medications in checked baggage
- ✓ Bring copies of prescriptions with you
- ✓ Be aware of the affects of time-zone differences

One last topic for this issue concerns buying wheeled luggage. The current rage is The Spinner – luggage with 4 vs. 2 wheels, allowing you to maneuver the bag without a telescoping handle. These bags are extremely popular in Asia and you may have seen people guiding these sometimes very large bags through the terminals both here and abroad. I would urge caution before purchasing this type of bag. Not only do these bags “have a mind of their own” when pushed over uneven surfaces such as sidewalks and cobblestones, the fact that the wheels are not encased into the bag make them the extremely vulnerable to breakage – especially when used as checked baggage. Because the wheels stick out at least 2 inches unprotected from the bottom of the suitcase, they tend to break if hit by other bags on conveyor belts or in containers. Don't try to file a damaged bag claim because airlines are not responsible for broken handles, zippers or wheels, according to the contract of carriage.

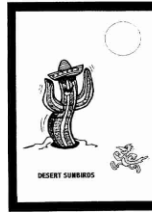

We did not have a report from Barney as he was unable to attend this month.

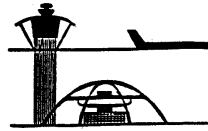
