Dave Simmon, retired from Flight Operations, was instrumental in drafting this summary. The source of this information is the PBGC. (This article is also on the RUAEA website.)

I value questions & comments I receive from you. I do respond to each. I will write articles in future newsletters on those items of a general nature & interest.

# FROM THE EXECUTIVE VICE -PRESIDENT

On Nov. 18, RUAEA President Marlin Lade, Corporate Relations Representative Ed Tolle & I met with UA CEO Glenn Tilton & Sr. VP - Human Resources Sara Fields. Much of what we discussed has been reported in the media but, to close the loop, we are reporting on the answers received to our questions.

First, we asked the status of the company's exit from bankruptcy. We were told that arrangements for refinancing had been completed with financial institutions which enable the company to meet its debt covenants through Jan. 2005, & that the arrangements had been approved by the applicable Creditors Committees. The company's revised business plan will be presented to the court in Jan. It has undergone comprehensive reviews by the financial institutions, all of the Creditors Committees (including the unions & the PBGC), also by the firm specializing in restructuring & reorganization designated jointly by United & the

AFA/IAM. Each of these groups has also involved their financial & legal advisors. At this point there was no suggestion that any of these groups were characterizing the plan as unsound or would offer alternatives. Among other items included in the business plan and discussed with each group are termination of the defined benefit pension plans (with the PBGC), revisions to union contract compensation provisions & work rules (being negotiated with each union), plus renegotiation of all United Express contracts (with all potential carriers). The company's plan modifies structure & infrastructure to grow in the international arena and to decrease in the domestic. It emphasizes profitable routes & shifts less profitable routes to United Express. It is based on the development & implementation of operational efficiencies. All of these are projected without changing United's hub and spoke system or emulating the Low Cost Carriers. Overall, the premise is that the assets/ advantages of continuing United as a viable carrier/ company far outweigh the liquidation value of its assets. (Subsequent to this discussion the trustee for the pension plans filed a petition before the court to include this year's required contributions to the plans as administrative expenses, essentially giving them a priority status for payment; the committee controlling leases for 170 aircraft has attempted to foreclose on 14 of them which would cause significant problems in Asian market service. A U.S. District court has reversed the bankruptcy court's ruling on the SFO airport lease that the company would be able to pay less than the full dollar cost. If upheld, that decision would also apply to CHI & LAX airport leases. Each of these if upheld would have a significant impact on United's business plan.

Second, we asked whether the new business plan assumed any changes to other retiree benefits. We were told that the business plan did not include any changes to the previous agreement on retiree medical benefits, also that there were no current plans for any future changes. We verified that the 401K plans in employee/retiree names at Fidelity are fully protected and not subject to attachment by any of the company's creditors. We were not advised of any changes in travel benefits.

Finally, we again asked how the retiree community could contribute to the viability of the company. We reaffirmed information provided to us some time ago that there are existing laws which prevent retirees from working alongside active employees in any operational area; however, there are many instances systemwide in which active employees & their costs may be assigned to community service functions instead of to operational activities. We agreed to initiate joint discussions with company representatives to determine how retirees could on behalf of UA replace active employees in such community service activities.

# **DEFINED-BENEFIT PLAN TERMINATION**

The following summarizes the benefits that should be available to United Airlines retirees upon the distressed termination on the defined benefit pension plans. (This includes the pilots A plan.)

Upon plan termination all the assets of the plan are transferred to the Pension Benefit Guarantee Corporation (PBGC). The PBGC will pay each retiree his/her pension benefit, or insurance benefit, limited by the maximum amount described below. The insurance benefit is funded from the \$19 per employee per year from all companies who have a defined benefit pension plan. The PBGC only considers qualified benefits, non-qualified benefits (i.e., the second check that some retirees receive) are not considered by the PBGC.)

The PBGC has six priority (PC). PC3 & PC4 apply to current retirees, also to those employees who could have retired three years prior to the plans termination.

The PC3 calculations are complicated. For PC3, the PBCG takes the assets in the plan and distributes them to all retirees & employees who could have retired three years prior to the plan termination. If these assets are sufficient to cover all these participants retirement pay, they will continue to receive that amount. If the funds are insufficient everyone's benefits will be reduced by the percentage of under funding (i.e., if the assets are 60% of the amount required to meet all the pension liabilities, then each participant will receive 60% of their pension benefits.) Pension benefit increases implemented within five years of the plans' termination will be prorated. If a retiree is receiving a pension benefit greater than the

guarantee listed below, and if the PC3 calculations using the plans assets still amount to more than the maximum guaranteed, the retiree would receive the greater amount.

PC4 is the insurance benefit. If under PC3 the participant's pension is reduced, due to lack of funds, PC4 will make up the individual's reduction - subject to the maximum guaranteed insurance limitation. In 1974 the Employee Retirement Income Security Act (ERISA) was enacted. The law specified a maximum insurance guaranteed amount. That amount has been adjusted each year, based on the cost of living increases. The same percentage is applied as is applied to Social Security benefits. For the year 2005 the maximum guaranteed amounts (rounded to the nearest dollar are:

The PC4 benefits apply to all vested members of a defined benefit plan. Active employees will receive the benefit when they retire. The amount of the initial benefit is then frozen for life. The maximum guaranteed insurance table is frozen on the date of plan termination. The maximum amount applies to one's age on the date the plan is terminated. Benefits are prorated for fractional years.

There are rumors about sharing the loss by asking United to buy annuities for all retirees equal to a percentage of their present benefits. This would not be in the best interest of older retirees and furthermore appears to be illegal. ERISA section 206 (d) (1) has an anti-alienation rule. IRS regulation 401 (a) (13) has the same anti-alienation rule and also has an anti-cutback rule in 411(d) (6). This means United has two options: Pay the benefits they agreed or terminate the plans. (These decisions require the approval of the bankruptcy court.)

Once the plan is terminated United will calculate the estimated benefits that will be paid to each retiree until the final calculations are made by

the PBGC. These final calculations are complex and may take a year or more to complete. Due to the many legal & technical issues that may arise, it is possible that only the adjusted age rated insurance figures listed previously will be used to calculate the estimated benefits. Failure to include the PC3 benefits in this calculation may result in reduced estimated benefits for some retirees. There should not be any break in payments to retirees. The first monthly check after termination should come from United and must conform to the post PBGC requirements. Subsequent checks should come from the PBGC. If necessary, adjustments will be made after the PBGC completes their final calculations. It may take up to a year to change the amounts set by the United plan administrator.

The PC4 guaranteed benefit is based upon a single life annuity. Retirees who have chosen other forms of benefits (i.e. contingent annuitant, 10-year certain, no remainder), will most likely receive the similar benefit subject to the maximum insurance limit discussed above. Under some retirement plans, the retiree had an option to take an initial cash withdrawal upon retiring and thus reduce their monthly pension payments. Retirees who elected to take an initial cash withdrawal will most likely see a reduction in their insurance benefit, (i.e., if a 60year-old retiree took an initial \$250,000 cash withdrawal, the \$250,000 would be converted into a single life annuity - about \$20,000 - this amount would be deducted from the retiree's PC4 insurance benefit. The PC3 benefit would not be affected since the retiree's current benefit already reflects the initial withdrawal.)

Older retirees should get most, if not all, of their current pension from their PC4 insurance benefit.

All of this assumes that the PBGC will continue in existence. They are currently about \$11 billion in the red and may need some kind of taxpayer bailout in the future. An important question for all retirees is what the administration in Washington, D.C. will do about pensions & the PBGC funding.

# COMPANION TRAVEL FOR RETIREES GOES ELECTRONIC IN JANUARY

Paper companion tickets will no longer be necessary for companion travel beginning Jan. 1, 2005. In lieu of the paper tickets, companion flight segments will be deducted from your annual allotment after they are flown.

Unused 2004 paper companion tickets will be converted to electronically stored flight segments on Jan. 1,2005 & will be valid through Feb. 28, 2005. In addition, the 2005 allotment of 24 flight segments will automatically be available to retirees for use on Jan. 1, 2005; you do not need to call to request them. The expiration date for the 2005 companion flight segments will be Dec. 31,2005.

The 2005 Companion Travel Guide has been mailed to retirees at their home address; see the guide for more details concerning the new procedures. The guide is also available on SkyNet,.

# ELECTRONIC COMPANION TRAVEL effective 1/1/05

Companion travel will be electronic or paperless beginning Jan. 1, 2005. The 2005 Companion Travel Guide is being distributed to everyone eligible for companion travel benefits to inform them of the changes to the program. Paper copies of the Guide are being distributed as follows:

- active employees (except PHLSW and LASSW flight attendants) via bulk co-mail
- all other companion travel eligible employees/retirees mailed to home address.

Important changes include:

The travel sponsor should use WebList, Apollo or 1-800-UAL-LIST to create the initial listing/PNR. Use of one of these systems by the travel sponsor to list a companion for travel will electronically authorize the companion to use one or more companion flight segments.

Companions can make limited itinerary changes after the PNR has been created; see the Guide for details.

# U.S. DOMESTIC ROUTE ADJUSTMENTS TAKE EFFECT IN JANUARY

Effective Jan. 6, 2005, United & United Express will reduce unprofitable flight frequencies from hub locations to several U.S.. domestic markets. United Express service will replace select mainline flying.

The company is adjusting its schedule & fleet size to best meet customer demand. United is expanding international flying, redeploying aircraft to more profitable routes & reducing the size of its mainline fleet. While U.S. domestic capacity will decrease, systemwide mainline available seat miles will decline by only 3% due to the increase in international capacity.

Flight reductions & reallocations, along with seasonal adjustments, result in a U.S. domestic capacity decrease of approximately 14% for 2005 compared to 2004.

Details on the Jan. 6 schedule changes at United's five hubs are as follows:

From Chicago, mainline frequencies will be reduced to Baltimore, Denver, Los Angeles, Manchester, Oakland, Philadelphia, Portland, Seattle, Sacramento & San Jose, CA United Express will replace select mainline frequencies with regional jet equipment to Atlanta, Buffalo, Cincinnati, Cleveland, Des Moines, Detroit, Indianapolis & Omaha. Additionally, United Express Embraer 170 regional jets will replace both mainline roundtrips in the Chicago-Albuquerque market. United Express will reduce departures from Chicago O'Hare to Albany, Colorado Springs, Harrisburg, Hartford, Norfolk, Raleigh/Durham, Rochester & Wichita. After the reductions, United, Ted & United Express will offer 614 daily departures from O'Hare.

From Denver, United will decrease frequencies to Baltimore, Boston, Columbus, Houston, Los Angeles, Minneapolis, Philadelphia, San Francisco, Seattle & Spokane. Ted temporarily will reduce one frequency to Orlando from Jan. 6 to Feb.14 due to a seasonal drop in demand. United Express will replace mainline aircraft on select departures between Denver & Atlanta, Boise, Charlotte, Colorado Springs, Moines. Des Detroit. Indianapolis, Oklahoma City, San Antonio & St. Louis. United Express will replace all mainline service between Denver & Cleveland. United Express will reduce frequency to Billings, El Paso, Memphis, Nashville & Rapid City, while increasing seasonal service to Palm Springs. United Express will discontinue service between Denver & Raleigh/Durham. After the reductions, United, Ted & United Express will offer 382 daily departures from Denver.

From San Francisco, United will shrink frequencies to Los Angeles, Newark, Philadelphia & Seattle. From Jan. 6 through Feb. 14, United temporarily will reduce frequencies between San Francisco & Honolulu, Kona & Maui due to a seasonal drop in demand. United Express will reduce frequencies from San Francisco to Eugene & Redding. In Jan. United, Ted & United Express will offer 229 daily departures from San Francisco.

From Los Angeles, United will reduce frequencies to Baltimore, Boston, Philadelphia, Portland & Seattle. Service to Maui will decrease during the Jan. schedule only. United, Ted & United Express will offer 236 daily departures from Los Angeles in Jan.

From Washington Dulles, mainline frequencies will reduce to San Francisco & Seattle, while United Express frequencies will decrease to Detroit, Hartford & Memphis. In Jan. United Ted & United Express will operate 307 daily departures from Washington Dulles.

# RUAEA Website Background

RUAEA decided to develop a website to enable members to access the current newsletter earlier than it's currently available by mail and to help reduce and control the escalating cost for RUAEA to print & mail the newsletter.

In addition, previous newsletters would be available on the website for members to view.

The RUAEA membership system hands off a file to the website of all RUAEA member names & addresses. When a member signs up for web access, their name & zip code are compared to this file, therefore, members need to utilize their surname as it appears on their Newsletter mailing label. The website in turn hands off a file to the Membership System that indicates that the member is receiving the Newsletter via the website. New computers were purchased to speed up the integration of this Membership function. Members

requesting the Newsletter via the website will no longer receive mailed copies of the newsletter enabling RUAEA to achieve cost savings from reduced postage costs.

RUAEA will be looking into possible future enhancements such as events calendar, membership directory, information advising members of volunteer activities to assist United as community service opportunities, well as temporary employment positions available to RUAEA may consider providing retirees. information regarding retiree tours, discount travel & hotels. Additional links to other United related sites will be considered as well as suggestions for additional enhancements from members.

As you can see by this list of possible future enhancements RUAEA has ambitious plans to put information at its members fingertips. RUAEA needs membership support to be successful. We need for you to sign up for the website access and help to make the site the informational tool that RUAEA envisions.

Login Page: (For Registered Users)

Initially the individual will be required to enter their User Name & their password that they will need to remember, as they will be prompted for these whenever they wish to view a Newsletter. Their password should be at least 6 characters in length.

Subsequent Logons will require the same userid and password.

# **Registration Page:** (For Unregistered Users)

When signing up for the website members must use their surname and zip code as it appears on their current newsletter mailing label.

The following information is required when registering.

E-mail address

### **Online Support:**

If the user has a question regarding the website or has a problem utilizing or registering for the website they may use this feature to convey their question or problem.

# **Newsletter in General:**

The current newsletter is available for viewing in two different formats. It is available on the website and has it sections indexed for ease of use. This is the easy way for users to view the newsletter, quickly move through the document and view or print specific sections. Each section is located under the Grey Menu shaded area on the left side of the screen.

The second option available is to download the file into a PDF file that can then be read using Adobe Acrobat Reader. This option allows the users to view, scroll, & print the Newsletter in the exact format that they would have if they had received the hard copy of the newsletter in the mail. It

includes graphics, logos, & pictures if any were present in the published newsletter for that month. If you don't already have Adobe Acrobat reader there is a link that with the URL address which you may click on to get it downloaded for free to your computer. To download and install this correctly you must know what operating system your computer has and identify it as such when prompted during the download and subsequent install.

The latest 13 versions of the Newsletter ultimately will be available in PDF format for members to view and print.





A deep breath should be taken before each cough; the cough must be deep & prolonged, as when producing sputum from deep inside the chest. A breath & a cough must be repeated about every 2 seconds without let-up until help arrives, or until the heart is felt to be beating normally again. Deep breaths get oxygen into the lungs, coughing movements squeeze the heart & keeps the blood circulating. The squeezing pressure on the heart also helps it regain normal rhythm. Once a Marine, always a Marine. I spent 8 years as a Marine Reservist (VMF-541-Corsairs) including a trip to Paris Island to learn how to be a Marine. 
