

## **UNITED AIRLINES HISTORICAL FOUNDATION**



### **THE NEW SWALLOW**

UAHF has chosen the New Swallow airplane as part of our logo.

In the Historic First Airmail Flight on April 6, 1926, a New Swallow was flown from Pasco, WA to Boise, ID & Elko, NV by Varney's Chief Pilot Leon Cuddeback.

Varney's fleet consisted of six 160-hp Curtiss C-6 engined New Swallows. These planes were found to be underpowered & were then updated with 200-hp Wright "Whirlwind" J-4 radial engines.

E. M. Laird Airplane Company founder Emil Matthew "Matty" Laird designed the Swallow in 1919/1920. The Swallow (it flew "like a Swallow") was the first made-for-production aircraft built in Wichita, KS. 43 Swallows were built between 1920 & 1923.

On Laird's staff were the engineer Lloyd Stearman & in charge of sales was Walter Beech, both of whom are now Legends in Aviation.

Following Laird's departure in 1924, the company's name was changed by prime financial backer Jacob M. Moellendick, to the Swallow Airplane Manufacturing Company. The Chief Engineer Lloyd Stearman was given the task of redesigning the Swallow.

This "New Swallow" was described as "the first new practical approach to commercial aircraft design. A complete breakaway from the old school of thought".

This past year UAHF videotaped an interview with Ward Stryker of Aurora, CO. As a young man, the 94-year-old worked as a Swallow wing builder in Wichita, KS. He had many interesting stories to tell.

We want to thank Marv Berryman for the research & writing this article about the "New Swallow."

- State tax will not be deducted because of the burden (for them) of recalculating your deductions if you should move to another state.
- They will send out a 1099 in Jan. for your taxes. If you are applying for a loan and need proof of your monthly income (pension), call 1-800-400-7242. They will send you a statement, but it will take two weeks.
- Last, but not least, we are 1 to 2 years away from knowing what our final monthly amount will be.

Our members report that they are extremely nice on the telephone. "--probably because that's all they do there, since there's no paperwork to handle".

The Nov. issue of the Newsletter had a very special piece written by Tom Goodyear from UAL's Historical Foundation. I especially enjoyed reading about the Retirement pin. The information about our service pins, that many of us call "seniority pins", was wonderful to read. To Tom's piece I would like to add more from research I did on the service pin for the Warhawk Air Museum where I volunteer as tour guide. My other job is adding UAL history memorabilia to our display at the museum. We started a collection of UAL service pins for that display. The executive director & I felt that a history of the pins should accompany them, so the research began. Bill Heath sent "feelers" out to get information; my husband contributed with his memory about his pins of 36 years, including his special Annual Award Winner pin. If you have pins you would like to donate to museum, please write to either Chic or Roni at above address.

To that history, similar to what Tom wrote, we added: The first through sixth pins presented to each employee, measured one centimeter round. From the seventh pin on, they were about ¼ centimeter larger. In the center is the red, white & blue shield (logo) of the airline. Below the shield are the words "United Air Lines". One propeller blade extends from the top of the shield & two from the sides. A pair of wings reach up from the upper corners of that shield. The wings are connected at the top by four stars. With the seventh pin, a large diamond replaced the propeller above the shield. The 4 stars represent the 4 airlines that merged (not at the same time) to form United Air Lines. They were Varney Airlines, Boeing Air Transport, National Air Transport & Pacific Air Transport ... BAT, NAT, & PAT.

Pin #1: One year pin – silver. Pin #2: Five-year pin – gold. Pin #3: Ten-year pin – gold with a diamond stud in the 1<sup>st</sup> star. Pin #4: Fifteen-year pin – gold with a diamond stud added to the 2<sup>nd</sup> star. Pin #5: Twenty-year pin – gold with a diamond stud added to the 3<sup>rd</sup> star. Pin #6: Twenty Five-year pin – gold with a diamond stud added to the 4<sup>th</sup> star. Pin #7: Thirty-year pin – gold with a large diamond above the shield. Every 5 years after 30, a diamond stud was added to each of the 4 stars.

(The following information was provided by Barbara Hanson, Coordinator – United Airlines Archives, Retired): *"The United Air Lines service emblem was introduced & given on Christmas Day 1937 to 1621 employees with 1, 5, & 10 years of service. 890 employees received silver pins denoting 1 year of service. 620 employees received gold pins denoting 5 years & 111 employees received gold pins, with a diamond stud in 1 star, denoting 10 years of service. Space was left for additional diamonds in the three remaining stars that would denote 15, 20, & 25 years of service. The service pin was designed by Zay Smith, a member of Patterson's staff, & was approved on Dec. 8, 1937."*
