

#### Access to Flying Together after not signing in for one year



Good information from **Connie Glattly**, Correspondent for the Northern Lites, that she received from **Kirk Moore**, Chairman, RAFA Travel Benefits Committee. <u>Additional advice</u>: *Retain this information if you don't access the Flying Together website very often so you will know how to get back into Flying Together*.

<u>Note</u>: When an UA retiree logs into Flying Together and receives one of these messages; "*Employee ID/Password Failed*" or "*Profile has been Deactivated*", it means they have not logged into the system for over a year and their profile was turned off. They are still eligible for pass travel privileges; however, they must

contact the Employee Service Center (ESC) to have their profile reinstated. If you get questions regarding this, please provide them the following instructions;

- 1. Send an email to the ESC at esc@united.com with the subject line "Retiree Resync"
- 2. The email should include:
  - ❖ The retiree's name, ID #, addresses on file, phone # and e-mail address
  - Or, they can call the ESC at 877-242-0075, option 4 and ask to have their profile reinstated.

#### United enhances seat assignment procedures for pass riders



Since United introduced its new pass travel privileges last spring, the company continues to make enhancements that help you get more out of the program. Your feedback was heard, and now United assigns pass riders to seats toward the front of its aircraft cabins before filling seats in the back.

With this SHARES enhancement, effective November 14, co-workers and retirees with higher seniority are more likely to receive seats in Economy Plus, if any of those seats are available.

"I like that I can more easily give a better seat to employees, especially those who have been around a long time," ORD Customer Service Representative Sue Brunner said. "These changes save us a lot of time in the boarding process because we no longer have to change seat assignments manually to make sure pass riders get seats in the front of Economy."

#### **Employee Mileage Plus Visa Card Annual Fee Rebate Form**



If you are a United employee or retiree and already the primary account holder (not an authorized user) of a Mileage Plus Visa Card, you may be eligible for a \$60 annual fee rebate.

Please follow these instructions to submit a rebate request:

- 1. One annual fee rebate per United employee is allowed per year.
- 2. Fill out this rebate request form within 60 days of your annual fee date.
- 3. Print the confirmation page for your records (Note: A confirmation email is not sent, so make sure to print a copy for your records).
- 4. Pay your bill when it comes, including the annual fee.
- 5. You will see a statement credit for \$60 and receive a confirmation letter from Chase within 90 days of the rebate form submission date.
- 6. Please be patient. This is a manual process and it takes time to get processed.
- 7. If you do not receive your credit within 90 days of submitting the form, please contact: mileageplusvisa@united.com

#### **Bus Service Discontinuation**




As United continues to relocate operations from the Elk Grove Village OPC to Willis Tower, the company needs to reallocate its resources where they will benefit the greatest number of co-workers. The number of people working at OPC has dropped so significantly it no longer makes financial sense to provide bus transportation between ORD and OPC. The Chicago Contact Center (CHIRR) was included in the original service due to its proximity to ORD and did not increase United's financial responsibly. However, with the changes at OPC, United will be discontinuing the bus service on Sunday, Jan. 27, 2013.

While United provided this bus for co-workers traveling on business, the company knows some of you also used it for personal trips. The business reasons no longer justify keeping the bus service, but United is pleased to continue to offer complimentary parking at OPC and CHIRR for those who can arrange another ride to and from the airport. At CHIRR, please park in the northwest corner of the lot.

United has negotiated a flat rate of \$11 with American Taxi for co-workers traveling between CHIRR and ORD. This is lower than the previous rate with American Taxi and 303 Taxi (which was \$14). Also note that PACE Commuter buses continue to run scheduled service from the CTA Blue Line Rosemont Stop. Route 606 stops at OPC and route 223 stops at CHIRR.

#### **Torgy's Travel Tips**

<u>Newsletter Manager's Note</u>: We are very happy to introduce a new columnist, **Kathie Torgison**. She is reviving the Travel Tips column with her own unique style. RUAEA members have many travel questions and we look forward to having Kathie as our resource. We welcome Kathie to our RUAEA newsletter and thank her for volunteering.



Thank you RUAEA for inviting me to write a column on Travel Tips for my fellow Retirees! I know I have some big shoes to fill, having worked with **Bob Brumfield** for many years in SEA. I retired in 2007 after 32 years with the company, most of them as an Apollo instructor for CS, RR and Intl Airport Ops Training. I took over as manager of the SEA Retiree Travel Desk from Bob and saw it through until the last tearful day, May 31<sup>st</sup>, 2012. So now, it is my pleasure to provide you with advisories, tips and suggestions as you use your hard-earned benefits to get out and **travel**!

**Enrolled Friends** - It is Open Enrollment time for 2013. Retirees are allowed to have 2 friends share our travel privileges. If you cannot decide whom you wish to name for 2013 you may designate "none" and then add names at a later date. If you already had a name or names from 2012, you can either re-enroll them, or change their slot to "none" so that you can decide later. Caution: You may never "swap"

names after the New Year begins, so be <u>certain</u> of your choice. Sometimes it makes sense to keep your selection at "none" until you are confident of your choice.

To access Enrolled Friends registration, go to **FlyingTogether>AllAboutMe>PassRiders.** You will see the top paragraph outlined in red with a column showing your 2012 selections and another column for 2013. Click on the word enroll on each line to either re-enroll the existing friend <u>or</u> designate a new friend <u>or</u> eliminate the existing friend and claim "none". <u>Caution</u>: Even though you may wish to carry over your current friend to 2013, you <u>must</u> click enroll and answer several screens of questions in order to validate this person for travel in 2013.

<u>ETKTS for ID90 Travel</u> - Electronic tickets are now mandatory for 24 interline carriers. This is welcome relief in most cases, as you no longer have to fill out forms or wait at the airport to have a ticket written. It comes with a cost of course, about \$2.20 per segment added to the total tkt price, but it is fast, efficient and a godsend when you are stuck without a backup. Here are the airlines:

Steps to access and purchase tickets go the Interline Fare Calculator website at:

- 1. <a href="https://ifc.id90.com">https://ifc.id90.com</a> OR FlyingTogether >Travel>Other Airline/Interline Travel>Visit ID90T website
- 2. Select United Airlines as <u>your</u> employing carrier
- 3. User ID: 6 digit file number (without U)
- 4. First time users will use their first initial and last name in lower case letters as password (example: jsmith) and will then be prompted to create their own password for future use.
- 5. On the home page, select the airline you wish to fly on, the origin/destination/date the appropriate travelers names.
- 6. Follow the prompts to select the appropriate flight and to view the tkt price.
- 7. Review the itinerary, select your form of payment and then select Purchase.
- 8. You will receive a confirmation and email.

If you end up with an unused ticket after your trip, simply access My Profile from the website home page. You can view all of your history and future travel here. Once you access the appropriate ticket, there will be an option to cancel/refund. Once completed, you will be refunded the ticket price, but not the booking fee.



The Dispatch room was where Mainliner crews went before each flight to create a Flight Plan for their trips. Skilled technicians furnished up-to-the-minute information about weather conditions along the flight route, reviewed completed flight plans and filed data with the local Air Route Traffic Control center.

In the adjoining "weather room", the latest weather information from hundreds of points on the continent were compiled and charted. Here the Captain discussed weather probabilities in detail with the Station Meteorologist and dispatcher.





The Captain and Dispatcher, met with the First Officer and a Meteorologist going over the many sources of information available. Sources included U.S. Weather Bureau reports assembled by Meteorologists stationed at dispatch centers on United's 15,000 mile system.

The reports included actual weather en-route (as reported on incoming pilot's logs) and charts showing wind velocity and direction at altitudes of 5, 10, 15 and



20 thousand feet. These charts were received four times daily over photo-facsimile machines.
