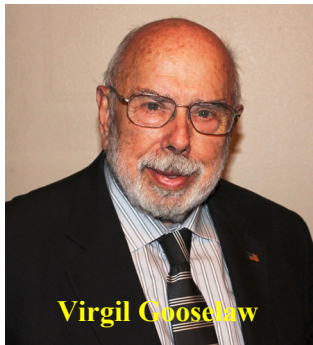

### Pass Travel Update From Kirk Moore

**1) Register your Enrolled Friends for 2017 now!**

**The enrollment period is December 1<sup>st</sup> until December 30<sup>th</sup> at 1900 CST.**

**To keep your 2016 EFs for 2017, no action is necessary; they automatically rollover.**

**To change your EFs for 2017, you must take action by 1900 CST on**

**December 30<sup>th</sup>.**

Access the Pass Travel Enrollment screen on **Flying-Together>Travel> "Update pass riders and buddies"** (It's the second blue tile under the photo on the Travel page).

**Note:** You will have to sign in again with your file number and password.

**Here's a step-by-step enrollment guide for retirees:**

**Important notes for RETIREES:**

Retirees do NOT have regular buddies or extended family buddies.

Retirees can NOT designate a "primary friend".

Retirees' eligible pass riders are: Spouse or Domestic Partner, up to two Enrolled Friends, Children until age 26 and up to two Parents.

**During the Pass Travel Enrollment period (December 1<sup>st</sup> - December 30<sup>th</sup> 1900 CST) retirees may:**

Choose new Enrolled Friend(s) to fly on 1/1/2017.

Remove EF(s) to open available slot(s) so you can add someone later in 2017. To remove EF(s), uncheck the box in the "Keep for 2017" column.



Note: To change your 2016 Enrolled Friend for a new EF in 2017: First remove the 2016 EF by unchecking their names inside the 2017 election tool, then click “confirm and continue”, then click “Add 2017 Pass Riders” and proceed to certify your new Enrolled Friend.

United will send you an email when you successfully complete enrollment.

Oops! Made a mistake? You can make changes until 1900 CST on December 30<sup>th</sup>.

**After 1900 CST on December 30<sup>th</sup>, NO CHANGES will be allowed** until the enrollment period in December 2017 for travel on 1/1/2018.

However, IF you left slot(s) open before 1900 CST on December 30<sup>th</sup>, you can fill the slot(s) with Enrolled Friend (s) anytime in 2017.

**IMPORTANT:** 2016 Enrolled Friend(s) who you change or remove for 2017 must complete all travel by 12/31/2016.

### 2) Get Google Trips; it’s free!

“Google Trips” is a new app to help you travel; especially to new places! Download the app to your IOS or Android mobile device; select a destination and it will show you lots of useful information including suggested sights, day plans, getting around, money, tipping, food, emergencies, etc. Add your own reservation info and friends’ recommendations then click “download” to have it all accessible on your phone or tablet *without using wifi!* Get the app and more information here: <https://get.google.com/trips/>

### 3) Reminder from the ETC: myUADiscount and space-available

“Retirees and their pass riders are reminded of these three important guidelines when booking myUADiscount travel:

1. Do not hold a confirmed reservation (myUADiscount, revenue, mileage) and space-available booking over the same routing for the same trip
2. You cannot travel standby on the same day that you have confirmed reservation for the same routing or same trip.
3. Once purchased, you may not cancel the confirmed reservation to revert back to a space-available listing on the same day, same trip”.

### Basic Economy offers customers more choices



Responding to strong consumer demand for more choices, United is introducing Basic Economy, a new fare option for United’s most price-sensitive customers. While the company will continue to offer products like United Polaris and standard economy, Basic Economy

allows United to compete effectively with ultra-low-cost and mainline carriers who also offer similar products.

While Basic Economy fares have some important, additional restrictions compared to United’s standard economy fares, customers will enjoy the same United Economy® cabin experience and services, including dining options, Wi-Fi and inflight entertainment. However, the following differences do apply:

- Automated seat assignments will be given at check-in, and passengers acknowledge at the point of a multi-seat purchase that seating together is not guaranteed.
- Carry-on bags are limited to one personal item, unless the customer is a MileagePlus® Premier® member, primary cardmember of a qualifying MileagePlus credit card or Star Alliance™ Gold member.
- There will be no voluntary ticket changes except as stated in the United 24-hour flexible booking policy.
- MileagePlus program members will earn redeemable award miles; however they will not earn Premier qualifying credit (miles, segments, or dollars), no lifetime miles, and no contribution to four segment minimum.
- Customers will not be eligible for Economy Plus or premium cabin upgrades.
- Customers will board in the last boarding group (currently Group 5) unless they’re a MileagePlus Premier member, primary cardmember of a qualifying MileagePlus credit card or Star Alliance Gold member.
- No combinability with regular economy fares or partner carriers. Interline travel is not permitted.

Delta launched its Basic Economy product in select markets in 2012 and expanded to most domestic markets in 2015, while American has announced a similar product to launch in the first half of 2017. United’s Basic Economy will be very similar to Delta’s Basic Economy, with the exception of earning Premier qualifying credits and carry-on bags, neither of which United’s product will allow. This operational benefit will simplify the boarding process and create more overhead space onboard, therefore helping to improve United’s on-time departure performance.

United does not anticipate Basic Economy will impact your ability to pass travel any more than existing fare products affect load factors. It’s important to note that Basic Economy isn’t discounting seats that have not sold; these price points exist today. Because customers who want to select seats or be eligible for upgrades are likely to choose a different fare product, United anticipates no impact on system load factors or on your ability to enjoy your pass travel privileges. The Basic Economy price point tickets will not be eligible for upgrade, which could enhance the employee travel experience. If you choose to purchase Basic Economy fares, you may use myUADiscount but the same conditions apply (no advance seat assignment, no carry-on, etc.).

So that customers make the right purchasing decision with no surprises, United is including very clear and prominent messaging throughout the booking path of United.com, customer contact centers, online travel agencies and corporate booking tools. They will see and acknowledge messages at booking, when they try to assign a seat or change their flight, and during check-in. Detailed information will be available on [United.com](http://United.com) as well.

Basic Economy will be available for sale in January, with travel starting in the second quarter of 2017. Before then, Customer Service and Contact Center employees will receive the training and resources they need to care for United's customers and answer their questions.

### **Fortune spotlights 'miracle comeback' at United**



Fortune highlighted what it called United's "miracle comeback" in a seven-page feature story in its December print issue. It also featured a 10-minute interview with Oscar on Fortune Live.

The article notes that the "comeback at United promises to substantially shift the balance of power in the \$700 billion global airlines industry."

More importantly, Oscar underscored the opportunity United has to build a great company that's good for investors but also good for customers and employees. *"It's a great, thriving business investment and great company, but it comes with heart and a friendly smile,"* Oscar said. *"People have gotten sour over time over who we are as corporations, but I think you can build a great company with heart."* Fortune praised United's improved on-time performance, newly negotiated labor contracts and improved stock price in naming Oscar number 20 on its Business Person of the Year annual ranking.

### **United reached settlement with the SEC**



On December 2, 2016 United resolved an investigation by the U.S. Securities and Exchange Commission into United's institution of a flight route in 2011 between EWR and CAE (Columbia, South Carolina). United agreed to pay a civil penalty of \$2.4 million and consented to certain reporting obligations. United is pleased to resolve this matter and to move forward, and to build the best airline in the world for our employees, customers and shareholders.

United will operate daily nonstop flights to the Cuban capital from EWR, and Saturday nonstop service from IAH.

Come January 20<sup>th</sup>, a new resident will call 1600 Pennsylvania Ave. home. Public housing has a different connotation when we remember that the White House, as well as so much of Washington, D.C. belongs "to the people". With that in mind, I made a visit just prior to the election to remind myself of all that this country honors and protects.

Beyond the visual grandeur of the recently refurbished Capitol building, sitting rather majestically atop The Hill, are the equally exquisite Library of Congress and the stately Supreme Court. Underground passageways link the buildings so inclement weather won't hamper your visit. The waiting lines for the guided tour of Congress are so superbly handled that you wonder why airport security can't run as smoothly! Each visitor group dons a headset and only your own tour guide can be heard despite there being 8 other groups with their tour guides close by. At the Supreme Court, you can line up in the exterior plaza for a first-come, first-served opportunity to hear an entire argument or a 3-minute observation, when Court is in session. When not in session, a lecture is given in the Courtroom every hour on the half-hour between 9:30am – 3:30pm. This is a not-to-be-missed opportunity. And the Library of Congress can captivate you for hours. The architecture and interior décor are stunning. Catch good views of the Capitol from the 2<sup>nd</sup> floor and find some of Washington's best bargains by attending a chamber music concert, literary program, lecture or cartoon art events that are presented frequently. Everything I've described so far is **free**. Moving towards the Washington Monument, The Mall's verdant squares of open space provide unobstructed views of the 555 ft tall monolith as well as of the Capitol behind you. This is a perfect spot for photographs at sunset. The monument's elevator was still not in operation, having been damaged in the earthquake of 2011, but the hardy can climb the 897 steps by picking up an entrance ticket at the booth on the east side of the monument, near 15<sup>th</sup> street. Anchoring both sides of The Mall between 3<sup>rd</sup> and 14<sup>th</sup> streets are 10 Smithsonian Museums and Galleries including the National Air and Space Museum, American History Museum, Natural History Museum, National Gallery of Art, and the American Indian Museum. The stunning new National Museum of African American History and Culture is located just steps away from the Washington Monument. Obtain tickets to this fantastic new museum **before** you come to DC or you will not get in. Go to [www.nmaahc.si.edu](http://www.nmaahc.si.edu) for ticket info. Once again, all of this is **free**. Sandwiched between the National Gallery of Art and the Natural History Museum on Constitution Ave is the National Archives, depository for the safekeeping of the Declaration of Independence, the Constitution, the Bill





of Rights as well as an original copy of the Magna Carta. Did I mention that it's **free**?

"The buck stops here" said President Harry Truman, but it actually starts here at the Bureau of Engraving and Printing at 14<sup>th</sup> and C streets, where you can watch millions of dollar bills being printed. The whole process unfolds before your watchful eyes on the FREE guided tour. There is a clear box containing a million dollars of real \$10 bills in the lobby and various unique gifts can be purchased at the end of the tour.

On a much more somber note, the US Holocaust Museum next door is an experience like no other, in my opinion. I have visited both Yad Vashem in Israel and NYC's Holocaust Museum but the profound impact of Washington's museum is without measure. Do not rush. Read the displays. Listen to the voices. Give yourself time to absorb the enormity of this tragedy. And if you're like me, you may even have to find a corner to let your emotions spill out. Note: If you are bringing grandchildren on your DC trip, all visitors to this museum must be over 11 years old. Admission is **free**.

The White House can be viewed through the wrought iron fences from The Ellipse on Pennsylvania Ave (near the National Christmas Tree) as well as from the other side on New York Ave. at Lafayette Park. Free public tours are given, subject to last-minute cancellation, however you must make a written request through your senator or representative **in advance**. Submission requests are accepted up to 6 months in advance and tickets are approved approximately 3 weeks before the requested date. Non US citizens must make their request through their closest US Embassy or Consulate.

Next are the war memorials honoring those who fought in World War II, Vietnam and Korea. You may encounter a volunteer on a ladder at the Vietnam Veterans Memorial reverently making a pencil etching of a soldier's name on the wall. The etching will be mailed to a family who cannot make the trip in person. The Vietnam Women's Memorial pays tribute to the 265,000 women who served there. And overlooking all of this is the Lincoln Memorial and Reflecting Pond. Standing here, I remembered the thousands of ordinary citizens who surrounded the pool in solidarity during the March on Washington in 1963. Martin Luther King's "I Have a Dream" speech rang out from this site and he is honored in a dramatic setting a few steps away on the Tidal Basin along with FDR and Thomas Jefferson.

I know this all sounds exhausting, but the good news is that The DC Circulator, a color-coded 6-route bus system will transport you nearly everywhere you want to go for 50¢ a ride (senior rate). Much cheaper than the ubiquitous hop on/off buses, these clean, efficient buses operate every 10 minutes in looping patterns. Most routes connect at Union Station, another not-to-be-missed architectural gem with lots of dining options. And don't forget the superb Metro subway system. Fly into/out of DCA and the green or yellow line will have you at The Mall in less than 15 minutes. Pick up a senior discount card at Metro Center.

I can't think of a more important place to visit as we enter 2017. Bring your grandchildren (the National Zoo is **free** and has pandas!) or take an educational trip on your own. Either way it will be memorable and easy on the budget.

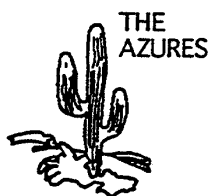
The group decided to make a \$300.00 contribution to the American Cancer Society Joe Lee Hope Lodge in Birmingham.

Brad would become United's first Inflight Service Supervisor. His sign-in number ... #1!

Brad says that this period as an I.S.S. was the best days of his career. But he had a feeling the job would not last. When the Courts said that the Airlines had to hire "female" Pilots and "male" Flight Attendants, Brad saw the end of the I.S.S. Program.

In February, 1977, he applied for and was accepted for Flight Attendant School. After finishing the training, he was assigned to CLESW.

Eventually he transferred back to LAX. In 1991, he was awarded the honor of "Flight Attendant of the System". Brad says, "*One of my biggest honors.*"

In July, 2003, Brad (along with 2600 others, accepted a buyout, and retired. Brad says, "*I wish I had not retired when I did, but do I regret one day in those 41 years? Only the last one! United totally changed my life, but more so, it opened the world to me ... and my parents. They (my parents) were as proud of me as if I had been President. So, thank you, United Air Lines. You made a small boy's dream come true.*"

Denver Municipal Airport was located on a large tract of rolling sand hills and grazing land. Among the “names” given the airport were “Rattlesnake Hollow” and “Stapleton’s Folly”.

In the Summer of 1928 construction began. The airport boundaries were Ulster Street on the West, East 26<sup>th</sup> Avenue on the South and East 38<sup>th</sup> to the North.

On October 18, 1929 Governor W. H. (Billy) Adams pressed a button and the “Eye of Denver”, a bright beacon on the tower began revolving. The Denver Municipal Airport was then officially open.

In 1930 Western Air Express changed its airmail route from Lowry Field (then East of Dahlia Street) and began carrying a few passengers. Two additional airlines that began serving Denver at time were United States Airways and Mid-Continent Airways.
