NEW TED FLIGHTS LAUNCH SEPT. 7

Beginning Sept. 7, 2005 & continuing through the fall, Ted service will be offered to popular destinations in the US, Mexico & the Caribbean, comprising part of its previously announced 20% fleet expansion.

Additional routes to be served by Ted's fleet expansion will be announced in the future.

The multi-route launch meets increasing customer demand for Ted service in these markets, represents a conversion of several United mainline routes to Ted, as well as one route that is brand new to United. As announced in March, 9 Airbus 320 aircraft are being converted from United to the Ted configuration to provide this service.

We've had such positive customer response to Ted in the last year, along with strong financial & operational results, prompting us to continue to launch Ted service in markets with significant low fare demand. The success of Ted continues to be driven by the effort & focus our employees have on ensuring we provide a high-quality customer experience.

Effective Sept. 7, 2005, Ted will offer roundtrip service between SFO & Ontario, CA, twice daily. This service is brand new to United, & does not represent a conversion of an existing mainline route to Ted.

Additionally, on the same date, Ted will start service between LAX & PHX with 2 daily flights complemented by continuing UAX service.

Also effective Sept. 7, 2005, the following roundtrip service will be available on Ted, unless otherwise specified:

DEN to MIA, twice daily

Washington Dulles to MIA, twice daily

Effective Oct. 2005, the following roundtrip service will be available on Ted:

CHI O'Hare to San Juan, once daily, effective Oct. 23

CHI O'Hare to MIA, twice daily, effective Oct. 31

Effective Nov. 15, 2005, the following roundtrip service will be available on Ted:

DEN to Cancun, once daily

Washington Dulles to Cancun, once daily Effective Dec. 18, 2005, the following roundtrip service will be available on Ted:

Washington Dulles to San Juan, once daily

TRAVEL EMBARGO SCHEDULED FOR MID-SUMMER FLIGHTS DEPARTING LONDON

Due to extremely high load factors, an embargo on United flights departing London will be in effect July 21 through Aug. 7 for unaccompanied companions of United employees & retirees; for United Express employees or retirees & their travel eligibles, including companions.

The embargo does not apply to United employees, retirees & their eligible travelers, including accompanied companions, or to travelers from other airlines who are traveling on company business.

United embargoes flights to prevent space-available travelers from being stranded during high travel seasons. For more information on embargoes, see Travel News within SkyNet.

RUAEA Regional Director Bob Cuff: The overview of where retirees are today is not a pretty sight. The bankruptcy has been going on too long. Many retirees won't see a change in their monthly payments. Current PBGC maximum payment is \$3801 per month (\$45,613 per year).

Retirees who have medical deductions taken from their pension checks will be billed separately.

The Sept. meeting is still without hosts.



TENNESSEE ROCKY TOPS

May 19 was a touring extravaganza for 22 of us who met at what was once called the "Gateway to the West". Situated where the western point of VA & the southeastern border of KY meet the northern edge of TN lies the Cumberland Gap of Dan'l Boone fame. It's fascinating, rugged country with historic & scenic locations to experience. We thank Herman & Bev Emmel for hosting the May luncheon at such a "you gotta see this" place, but which most of us never had.

The Ye Olde Tea and Coffee Shoppe was in Cumberland Gap's small downtown area in a historic building with a walk-in bank vault & a restored Model A on display. We're pleased that several guests were able to join us -- Dave Leonard's daughter, Patti; Dick McBride, a former

777 pilot, Pat Thompson, Jack Ferrell's flying buddy from their Navy days; & first-timer Jack Ball along with a friend, Dave Roach.

Jack Ball was a 41-year employee with UA & is a Knoxville native. After hiring on with Capital Airlines at MDW, he was soon able to transfer to TYS, except for a 6-month tour at CHA, spent most of his career in Int'l Air Freight & Customer Service at his home station. Jack retired from TYSCS in 1997, resides with his wife, Peggy, in the West Knoxville area.

After a short meeting, most of us drove through the Cumberland Gap tunnel (almost a mile long) to visit the Lost Squadron Museum in Middlesboro, KY. Many of you may have heard about the P-38 Tomcat Squadron which took off from Maine headed for WWII by way of Greenland in the early '40s. Weather caused the entire squadron to crashland on Greenland's ice cap. Eleven days later the crewmen were rescued, but it took another 50 years before the Glacier Girl, buried 268 feet under the ice, could be recovered piece by piece & restored to almost-mint condition. The F version P-38 is easily the star of the show at this small museum.

Several people stayed overnight at B&B's & motels to see more of the area the next day. Worthwhile was a tour of the Visitors' Center & a hike on the Wilderness Trail, a restored path that Boone and eventually 30 thousand others used to migrate through a narrow gap in one of the Cumberland ranges. I suspect that many of our ancestors made that dangerous trek from VA & NC through TN's Indian territory into wild, unexplored KY for homesteading. We thank them for it.

From there I took another comfortable European style coach almost a thousand miles up to Strathpeffer in northern Scotland for 9 days.
