General Membership Action: BYLAWS CHANGE In addition, at the Business Meeting, Saturday morning, May 23, 2009, the General Membership by unanimous vote elected to change our By Laws, in summary, as follows:

#### ARTICLE III MEMBERSHIP

Section I - Regular Members

All former employees of United Airlines who have reached retirement age are eligible to become members of RUAEA. (*Interpretation - any former employee of United who left prior to age 55 and at the time of application is now at least 55 may join*).

Spouses of retirees may become a regular member. All may do so by making application and paying the required dues. (Interpretation - Spouses of current members, non members, widows/widowers are eligible

for full regular membership complete with voting and holding national office).

Please note the new Membership Application form in this Newsletter. Cut it out and make copies, give to your spouse, take it to your local Chapter meeting for non RUAEA members, pass it on to Clipped Wings friends or your ex Covia buddies.

In other business, the results of our election were announced with **Mike Richards** as the new Director for the Arizona Region and **Chuck Cole**, the new Director for the Mountain Region. **Treatie Karwoski** for the Northeast, **Bruce Brodersen** for the Southeast and **Jack Hoober** for the Northwest were reelected to their respective Regions.

In the interest of supporting all United Retirees and former employees, we were pleased to have for the first time at a RUAEA Convention, the President of National Clipped Wings, Ms. **Pam Ziebarth**, and the Vice President Conventions/President Elect of RUPA (Retired United Pilots Assn), Mr. **Ron Jersey**. Each of our organizations is looking for ways to better benefit our respective members.

In closing, we announced next year's Convention site: **Orlando, FL!** Start making plans now for May 23, 2010 in Florida - See you there!

## RUAEA ANNUAL BUSINESS MEETING Saturday May 23, 2009 Hyatt Regency Hotel – Phoenix, AZ

The meeting was called to order at 0830 by President Ron Robertson

#### **President-Ron Robertson**

Ron welcomed all members to the annual business meeting. A motion was made and seconded to waive the reading of the 2008 business meeting minutes. The motion was carried. The current focus for the RUAEA Board is to revitalize our membership. There will be mass mailing to approximately 4300 retirees containing a letter from Ron, a brochure explaining RUAEA and an updated membership application. We have also invited Pam Ziebarth of Clipped Wings and Ron Jersey of RUPA, in an effort to extend our membership to those groups of retirees.

#### **Reports:**

#### Corporate Relations-Ed Tolle

Ed continues to meet with Mark Ugol, Senior Vice President of HR, a tradition started by Jim Fauber and Marlin Lade. He and Mort also meet monthly with Jill Chapman, Managing Director, Benefits Strategy to discuss retiree concerns. Dan Lynch of government Affairs may be contacting Ed for help with some upcoming political issues; upgrade of the ATC system and the Passenger Bill of Rights.

#### Past President - Mort Wax

There were a total of 1045 ballots cast in the May election, with almost 2/3<sup>rd</sup> voting online. This represents 14% of the total membership. The successful candidates for Regional Director are: Bruce Brodersen, Jack Hoober, Treatie Karwoski and Mike Richards. Charlie Cole has agreed to represent the Mountain Region and Ron has appointed him to the two year term. In 2010, all five Officer Positions are up for election, with three of the current officers ineligible for another term. There are also five Regional Director Positions to be filled, with one current Director ineligible for another term. Mort asks for everyone's help with recommendations for candidates for these positions.

#### Executive Vice President - Ron Bertacini

A change to the By laws has been proposed, that would allow all former employees of United Airlines, who have reached retirement age to become members of RUAEA. The change would also eliminate the Associate member category and add the Site Selection Committee Chair to the Board of Directors. A motion was made to accept these changes; it was seconded and voted in the affirmative.

#### <u>Membership Support/Newsletter – Virgil Gooselaw</u>

We currently have 8200 members with 7000 receiving the Newsletter in print and 1200 electronically. It was mentioned you can now get the Newsletter both ways (print and online) by paying an additional \$5.00. Virgil recognized the hard work of the secretaries, his wife Martha and John Chu of the Denver Office and all the Chapter correspondents. One secretary, Carol Sostarich, has resigned for personal reasons. Carol has done a great job and will be missed. We have a new secretary, Marilyn Hansen and welcome her into the Denver Office. There are three new columns in the Newsletter: Centenarian – A recognition of members who turn 100, The Writers Column - A column for members that have a story of interest and Easy Does It by Helen Cain - Recipes made easy. We continue to enjoy: Ask the Doctor, Ask the Pharmacist and Travel Tips by Bob. We commend the authors for their contribution.

#### Web Site - Jim Sommerfield/Ed Majewski

The idea of a website originated in 2002, with a goal of being tailored to retirees needs. To that end, all RUAEA members are encouraged to take advantage of this product by registering for either level two or three. Jim went through the steps of accomplishing this process.

Ed described some of the links that are available including; Financial, Travel, Chapters and Convention information. Ed will be working with Nationwide Hospitality in developing "RESX", a program tailored to

RUAEA member's travel needs. It will be available in June or July and details will be in the Newsletter.

#### Treasurer-Len Haubl

The annual audit on RUAEA's finances and the 2008 Convention was conducted and there were no adverse findings. Dues income declined 5%, but contributions were up 29%. Overall expenses are 3% higher than a year ago and 6% above budget.

#### Vice President Convention - Hank Gosselin

The 2010 Convention will be held in Orlando, FL from May 24<sup>th</sup> to May 30<sup>th</sup> at the Rosen Center Hotel. Jim Llewellyn from Orlando will be the Convention Chairperson. He thanked the local Phoenix committee for their help in putting on a first class convention. A cruise is being considered for a future convention site.

#### <u>Travel Desk – Jack Hoober</u>

The concept for a travel desk started in 1995 with one in Seattle. We now have three; Seattle, Portland and Chicago with a potential for a fourth in Portland. We operate them through the generosity of United, giving us Apollo access, office space and printers. They are manned exclusively by volunteers. The costs of the calls are underwritten by RUAEA and RUPA. They can check real time loads, list for travel and supply general information. They cannot check loads for other airlines, issue travel letters or reduced fare tickets.

#### Recognition of Outgoing Officers and Directors

Ron complimented Tony Sortino for his work as Regional Director – Mountain. He also presented a Certificate of Appreciation to Gordon Starr for all his past participation, the last being Regional Director – Arizona.

#### New Business

A question was raised about donations to the Flight 93 memorial in Shanksville, PA. RUAEA cannot take donations, but the Philadelphia Chapter has already collected thousands of dollars toward this remembrance. The contact for this chapter is on the RUAEA website or available through the Denver office. It was suggested we offer advertising space on our Website. This is a topic that is being pursued by the Board of Directors.

Motion was made to adjourn. It was seconded and approved. Meeting adjourned at 1030.

#### <u>United Issues RFP for</u> Next Generation Aircraft

United is kicking off a fleet modernization program with a request for proposal (RFP) that has the potential to result in a large order of next-generation widebody aircraft and narrowbody aircraft that would replace its oldest fleet type, the Boeing 757s.



"This presents a strategic opportunity for both United and the manufacturers as this program could well define our fleet strategy for the next twenty-five years," says

Glenn Tilton, chairman, president and CEO. "As we have consistently said, we will only invest in new aircraft when we can generate a return on our investment, and we believe we have a unique opportunity to do so now, leveraging a fleet replacement strategy as one of the building blocks to running a great airline."

The RFP is the start of a multi-month competitive process.

"The work we have completed to date through our Focus on 5 prepares us well to consider an investment in aircraft," says John Tague, EVP and chief operating officer. "We are building a best-in-class cost structure, and we are taking the right steps to enhance the quality of our service and our operational performance. New aircraft would provide us the opportunity to improve our cost structure, eliminating aircraft that are more costly to operate and delivering better service and an improved onboard environment for our employees and customers, while allowing us to consider markets not available to us today."

"We have consistently advocated a disciplined capacity strategy for the company, and we will only commit to new aircraft if it does not impede the progress we are making to build liquidity and improve our financial performance," says Kathryn Mikells, SVP and chief financial officer. "This is a competitive time for manufacturers, creating a unique opportunity for United. This process also represents a major strategic opportunity for Airbus and Boeing, as the winner will place its new generation widebody aircraft with one of the largest operators of twin-aisle aircraft in the world."

While United is doing the work necessary to determine if it is the right time to consider a future investment in aircraft, United remains committed to its current rollout of the International Premium Travel Experience (IPTE) aircraft. IPTE is a critical driver of customer satisfaction and is also allowing United to size its premium cabins appropriately.

If there is a compelling business case for ordering new aircraft, an order could be completed as early as the fall of 2009. Manufacturer financing involvement at some level is a typical part of the process.

#### Making NRSA Travel Easier

Traveling non-revenue, space available (NRSA) is an important benefit for retirees, our families and companions. Below are important tips and reminders for NRSA travelers that will help reduce the hassle of maneuvering through the airport and on board an aircraft this summer.

- Save time, check-in online Checking in online is definitely the best way to reduce the amount of time you spend standing in line at the airport.
  - Even if you have bags to check, you will reduce your hassle at United's hubs by using the Easy-Check-In Online Bag Drop location in the lobby. At smaller airports, check your bags with a skycap at the curb and skip the ticket counter all together.
  - To check in online, visit the Travel section on SkyNet or www.united.com/employeetravel.
  - In addition, if you go to <u>united.com</u>, Services and Information, Airport Information, Airport Check-In Info, you will find helpful information listing the peak wait times for the security checkpoint and ticket counter hours, as well as construction updates for all the airports that we serve.
- So Dress Properly As the weather gets warmer, it is important to remember that clothing for the beach or a picnic are not appropriate when traveling NRSA. Please see SkyNet's Travel section for the appropriate attire for traveling.
- Know the Nuances Friends and family traveling on companion passes are often not familiar with the nuances of NRSA travel. To help create a more pleasant travel experience for them, make sure that you complete their initial travel listing and verify that the name in the listing matches the name on their government-issued identification exactly.
  - It is also helpful if they have your employee identification number to check in online or to make itinerary changes en route, if needed, and that they are fully briefed on United's dress code. For everyone's convenience, there is a helpful travel brochure for companions available to print on Companion Travel found on SkyNet's Travel page.
- check the Latest Travel Embargoes If your travel plans include a trip overseas this summer, there are two international destinations that are planning travel embargoes: Rome (FCO) and Hong Kong (HKG). FCO's embargo will be in place from July 1 July 31 and HKG from July 15 August 15. The embargo restricts NRSA travel for unaccompanied companions as well as employees from other carriers including our United Express partners. But even United employees or retirees traveling to or from these destinations should consider purchasing a ZED ticket as an alternative as the flights will be full or subject to weight restrictions.

Seconomy Plus Availability - Economy Plus is an important source of revenue for the airline, so please be mindful that those seats are intended for our premium customers or for those willing to pay extra for additional legroom.

Employees, their travel eligible and companion travelers can be accommodated in Economy Plus when all other qualifying customers and up-sale opportunities have been completed.

#### **United Welcomes Back 107 Mechanics in Recall**

United announced the recall of approximately 107 Line Maintenance mechanics from furlough as an investment in its areas of focus related to the Clean, Workable Product and operational reliability initiatives.



These mechanics will focus on improving the workability of items in United's cabins, reducing the number of out-of-service aircraft and ensuring the reliability of its airplanes.

"The International Brotherhood of Teamsters (IBT) approached us to discuss opportunities to efficiently improve the workability of our aircraft, and we are pleased that collaboratively, we were able to work out a way to bring these mechanics back," says Jim Keenan, senior vice president-United Services. "It is essential that we make strategic investments in our product, to continue providing our customers with great service."

The 107 mechanics will be recalled at all of United's hubs. The recall process will begin immediately.

#### **United Partners With TSA in Secure Flight Program**

As the Transportation Security Administration (TSA) takes over pre-departure watch list matching from individual airlines, United is partnering with the agency to ensure it is in compliance with the new requirements.

United's reservations agents and customer service representatives at its ticket counters need to continue to collect the legal first and last names of all customers when they make



reservations, as do the travel agencies and online booking channels that serve as distribution channels for United's tickets.

As the government takes over the list matching, the

TSA will mandate that air carriers ask customers to provide additional information when making reservations, including:

- full name as it appears on the passenger's nonexpired, government-issued ID
- date of birth and gender

This additional information will be known as Secure Flight Passenger Data (SFPD). It is intended to standardize the watch list processing and enhance the security of domestic and international commercial air travel. SFPD will need to be collected from all customers who travel on United and United Express, including nonrevenue positive-space and space-available customers.

Once additional programming is complete, Reservations, Customer Service, the booking channels and travel agencies will need to collect all of the Secure Flight Passenger Data.

Programming to collect the full complement of this data will take several months; therefore, United is working closely with the U.S. government regarding its compliance schedule and will keep you posted as information becomes available. During the upgrades, United will remain in compliance as long as reservations are made with the customer's first and last name as it appears on his or her government-issued ID.

#### Passenger on Flight 881 Commends the Crew

A customer aboard United Flight 881 from Chicago to Narita on May 18, whose video clip of a fuel leak was recently covered in the news media, wrote to us explaining his version of events that day.

The flight crew on board was already aware of the situation and was taking appropriate action when the customer, who serves in a U.S. Air Force refueling squadron,



brought it to the attention of the inflight crew.

United's customer, Staff Sergeant Bartek B., explained he spotted the left wing fuel surge tank leaking on take off and documented it on video. When he arrived at Kadena Air Force Base in Japan, his story was published in an Air Force website, which news organizations later used for their reports.

In an e-mail, Staff Sergeant Bartek wrote:

"I wanted to e-mail you earlier to thank United and to commend your extremely professional flight crew for how they handled the situation and took care of myself and my senior master sergeant.

I want to especially thank Captain Ramon A. Navarro and (the) first officer for handling this situation with a cool, calm and collected attitude. They made dumping fuel and diverting seem like a routine proce-

dure and prevented passengers from panicking. At no time did any of the passengers feel nervous. Your crew handled this problem with a very professional attitude.

When I initially saw the leak on the runway at Chicago, I was hesitant to say a word, since the fuel system surge vent tank is designed to relieve excess pressure during ascend and descend. But once we leveled off and it became evident this leak would not subside, I did my best to get word to your crew ASAP. I also realize they would have noticed the leak in any case.

Once again, I would like to thank United for taking care of ALL of UA Flight 881 passengers and for safely delivering everyone to our final destinations. Thank you very much for your outstanding and professional flight and ground crews."

#### **New Column**



## Ask The Pharmacist Olympic Gold medalist and asthma sufferer Jackie Joyner-Kersee interviews a Medco specialist pharmacist about treatment

Approximately 20 million Americans have asthma, a condition that makes it difficult to breathe. Olympic Gold medalist Jackie Joyner-Kersee is a good example of someone who needed help to successfully control her asthma. In fact, it took several life-threatening attacks and multiple trips to the emergency room before Jackie started taking a proactive approach to asthma management. Now Jackie avoids attack triggers and takes medication to keep her asthma under control.



Jackie works with her doctor and a specialist pharmacist from Medco to help her manage living with asthma. Just like doctors, many Medco pharmacists are now specializing in the medications used to treat a single, ongoing health condition. Jackie relies on a

Medco Pulmonary (concerning your lungs) Pharmacist to help her stay informed about her asthma and to help her manage her medications. Jackie's Pulmonary Pharmacist has in-depth knowledge about pulmonary conditions, including asthma, and the medications used to treat them.

In the following conversation, Jackie Joyner-Kersee asks Medco Pulmonary Pharmacist Ron Erkens, R.Ph., some common questions about managing asthma.

Jackie: There seem to be a lot of medicines for asthma. What are some of the most common asthma medications?

**Ron:** People with asthma often use the following two different types of medications to help control their condition:

- + Long-term control medications (controllers) work to help reduce airway inflammation or relax muscles in the airways. They must be taken daily to prevent symptoms. They will not give quick relief if breathing suddenly worsens.
- + Quick-relief medications (relievers) relax airway muscles to provide rapid relief of symptoms. They can be taken as needed or when symptoms worsen, but will not control symptoms on a daily basis. Using more than one canister of reliever medication per month may indicate your breathing condition is not under control or you may not be using your inhaler correctly. Taking your medications correctly can lower your risk of doctor and emergency room visits, hospitalizations, and death.

Jackie: Many people have more than one chronic condition, so they are taking multiple medications. Are there any problems that can arise?

Ron: Yes, certain medications can have harmful interactions when taken together. This is why it's important to read labels on all medications, even over-the-counter medications. If you're still unsure, ask your doctor or pharmacist. Some medications used to treat asthma should be used with caution in patients with cardiovascular disease, high cholesterol, high blood pressure, diabetes, glaucoma, and certain food allergies. This is why it's important to tell your doctor your complete medical history, so the proper medication is prescribed without harmful side effects.

Jackie: What are the benefits of having a Pulmonary Pharmacist?

**Ron:** Pulmonary Pharmacists review National Asthma Education and Prevention Program Guideline recommendations for the treatment of asthma. We review patient medication profiles, check to see if the medications a patient is taking might adversely affect any medical condition that he or she has, look for duplication of medications and seek other opportunities that can help improve patient outcomes, as well as offer lower-cost options if they're available.

Jackie: Why do so many people with asthma end up in the emergency room?

**Ron:** Patients often stop or decrease their medications when they feel good. People need to take controller medications daily to prevent flare-ups later. Sometimes people overuse their rescue medications, which might be a sign of worsening or uncontrolled asthma. Knowing more about asthma and turning to health pro-

fessionals, like specialist pharmacists, to help you take medications correctly is key.

Jackie: What if someone can't afford asthma medication?

Ron: Talking to your doctor and pharmacist about generics may save you money. If you are taking a long-term medication, check with your pharmacy plan for any potential savings you can receive by filling your medications through Medco By Mail. Programs like My Rx Choices® at www.medco.com have cost-comparison tools that show Medco members how much they can save by choosing a generic drug or ordering their prescriptions through the mail.

Jackie: What advice do you have for people with asthma?

**Ron:** Although asthma is not curable, most patients who follow doctors' recommended treatment can live normal, active lives.

Asthma is one of the nation's most common and costly chronic conditions. The annual direct and indirect healthcare costs of asthma totals approximately \$19.7 billion.<sup>2</sup> By working closely with her doctor and Pulmonary Pharmacist, Jackie is controlling her asthma. You can, too!


#### **Travel Tips by Bob**

This issue of the Travel Tips is dedicated to a few timely reminders:

As of June 1, 2009, the rules have changed for reentry into the USA from Canada and Mexico. You must have a valid passport or a federally approved "enhanced" driver's license. Some states charge a fee to obtain the enhanced license, I know that for Washington

State, the fee is \$15.00. This will probably vary from state to state. The new rules apply to all modes of transportation. Children under 16 years of age can use a birth certificate. For additional details, go to <a href="https://www.getyouhome.gov">www.getyouhome.gov</a>.

A number of you travel on Southwest Airlines for various reasons. Be aware that they have recently enacted new unaccompanied minors fee of \$25 for ages 5-11. They have also started charging \$50.00 for a third bag or any bag weighing 51 pounds or more. You are still allowed to check two bags without a fee if 50 pounds or less.



This summer may be a good time to travel to Europe as it is predicted that 25% less travelers are planning tours because of the recession. I suggest if you go to Europe that you make London your first stop and return from another city. This is because of the high departure tax when returning to the USA. The tax, the last time I

checked, was \$155.00 for First Class, Business and Companion. Economy Class tax was \$93.00.

Another reason why this summer may be a good time to travel to Europe is because the value of the dollar has risen against the Euro and the Pound. I'm told that restaurants, hotels, tours and clothing stores are begging for customers. Also, if planning a tour to the Orient, the US Dollar is much the same as last year.

Most cruise lines, with the exception of Carnival, have moved out of the Mexican market for various reasons for the short term, with the expectation of returning in the fall. This summer may be a good time to look into a cruise.

At the end of the day, the word is that this summer may be an excellent time to travel as most Hotels are desperate for customers. It's always wise to call in advance and ask about the specials. FYI, I did reserve a room at the Sheraton in Denver in August for a Saturday & Sunday. The Sunday's cost is less than last year. Did you know that Wendy's offers seniors a 10% discount? They do, but you have to ask for it.

**Phyllis Bowman** also presented **Norm Strange** with his "crown" for organizing our chapter back in the early 1980s and for serving as our 1<sup>st</sup> president in 1982.

Bob Brumfield talked about the lack of security for carry-on items in the overhead bin, especially if they're out of your sight (e.g., behind you or way in front of you). This was also one of Helen Cain's points and she suggested keeping your valuables with you at your seat – not in the overhead bin. Bob talked about the 20% discount. If reservations won't waive the ticketing fee, go to Skynet and do it yourself. Under "Travel" and then "Employer Discount 20" there is an explanation of the benefit and a link to United's online reservation system that gives you the discount – without a ticketing fee. Bob also recommended using the "Search" feature in Skynet to find what you want, e.g., "Series 15" for the personnel regulations.

Marion Hafterson stated that it's important to carry your BlueCross BlueShield medical card when traveling – especially overseas, as it enables you to benefit from the discounted contract rates provided for in our plan. Without it, medical care can be very expensive.

After meetings and numerous dialogs with United we were able to restore/retain the BP-6 boarding priority. Another is the fact that there is no service charge for retiree travel in economy. This didn't happen by accident, RUAEA had input on this issue and we all will continue to benefit. There are also many life insurance, health and travel items that are specific to individuals. In these individual cases we have been very successful at working with United, to the retirees' satisfaction. This doesn't mean that all problems are immediately solved, but we do have a relationship wherein a resolution may be possible. I also want to clearly point out that in some of these major items the decision made in our favor was not solely due to RUAEA's action, but we got the word out to members early and we were influential in the company's decision. And then, on the other hand, we have been receptive to United's needs. We have assisted the company in various community and national efforts, e.g. the breast cancer run in Chicago Mother's Day, political efforts such as the Washington/Beijing route award and others yet to come this year.

I encourage you to join RUAEA to be part of a great organization that is dedicated to the betterment of retirees. Individually we are a voice in the wilderness, but numbers matter. I am puzzled why all retirees are not members of RUAEA. It may be because RUAEA is not known by all. This letter is an effort to reach out and let you know who RUAEA is. 
