## United Becomes First Airline to Join UN Global Compact and Commemorates World Environment Day

What does it mean to be a good corporate citizen in the world economy? As a company with operations around the world, United connects communities, enabling tourism and facilitating commerce and business opportunities. United believes it means engaging in initiatives that allow the company to use its assets and expertise to make a difference. That's why United has become the first airline to join the UN Global Compact, an initiative involving companies from around the world that are taking a leadership role in sustainability and responsible business practices.



One area of focus for the UN Global Compact is a commitment to promoting environmental responsibility. United commemorated its joining of the UN Global Compact by participating in World Environment Day, which is held every year on June 5 and is intended to stimulate awareness of the environment and enhance political attention and public action.

United will become the first airline to conduct two trans-Atlantic flights using state-of-the-art flight planning to reduce environmental impact and save fuel. The demonstration flights will be United Flight 945 from Frankfurt to Chicago and United Flight 944 from Chicago to Frankfurt.

*"We expect this effort will serve as a model for how cooperation and coordination can generate meaningful progress in our drive to protect the environment and improve our operational efficiency,"* said Joe Kolshak, SVP-Operations.

United estimates that the two flights will save nearly 6,400 pounds of fuel and reduce carbon dioxide emissions by almost 20,000 pounds.

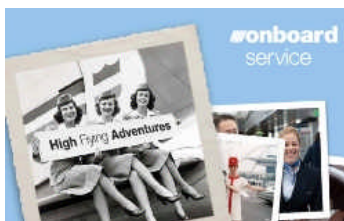
To mark World Environment Day, United is also giving out 10,000 specially designed Every Action Counts United luggage tags made from recycled plastic at all five of its hubs, and customers on all United domestic flights will see an in-flight video about United's commitment to the environment and the importance of all of us coming together to care for our one shared earth.

Some of the other initiatives include:

- ① Saving over 1 billion pounds of jet fuel since 2004 by changing how United plans its flights and fly its planes.
- ① Flying the first commercial engineering flight on a natural gas synthetic jet fuel to advance bio and synthetic fuels as environmentally beneficial alternatives to petroleum jet.
- ① Diverting 590 tons of waste - 25 million cans and 6 million plastic bottles - from landfill by recycling on board its planes across all our eligible U.S. routes.
- ① Planting close to 1,000 trees in the neighborhoods where United lives and works in partnership with the Alliance for Community Trees.

Protecting the environment is about the work United does every day and the actions that the company takes that have lasting impact. Continued progress is about each employee - within the company and the industry - taking action and doing the part to make a difference.

### **Join the Celebration: 80 Years of United Flight Attendant Service**



May 15, 1930, the world's first stewardess took to the sky and changed the air travel experience forever. She and seven other nurses were the industry's first professional flight attendants. They were hired to calm and comfort customers who were apprehensive about flying in those early days. Much like today, they were safety experts, emergency responders, service professionals, mediators and counselors.

"First Stewardess" Ellen Church began the journey from San Francisco to Chicago. Four stewardesses - one for each assigned segment - were staged along the

flight's route to complete the 13-stop, 20-hour trip on a Boeing 80A with 14 seats.

On May 15, 2010, Senior Vice President of On-board Service Alex Marren took that same journey to commemorate the event -- as a non-stop four hour flight, with 244 customers on a Boeing 767.

"We're kicking off a month-long celebration of the 80<sup>th</sup> anniversary of the flight attendant profession, including volunteers wearing vintage uniforms," says Alex. "So the next time you fly, take a moment to say "thank you," to our flight attendants, who have transformed the historic roles of their predecessors into today's safety and service professionals in the sky."

### **Glenn Tilton Joins Future of Aviation Advisory Committee Convened by DOT**

UAL Corp. Chairman, President and CEO Glenn Tilton has accepted an invitation to join the Future of Aviation Advisory Committee being convened by U.S. Department of Transportation (DOT) Secretary Ray LaHood.



The committee held its first meeting on May 25 in Washington and focused principally on five issue areas: 1. Ensuring aviation safety, 2. Ensuring a world-class aviation workforce, 3. Balancing the industry's competitiveness and viability, 4. Securing stable funding for aviation systems, and 5. Addressing environmental challenges and solutions.

*"I look forward to working with the Secretary and joining my colleagues on the Future of Aviation Advisory Committee to bring about meaningful policy initiatives that will strengthen our industry and our national economy,"* Glenn said. *"Our industry facilitates global commerce and strengthening it will enable us to provide a platform for sustained economic vitality."*

As United communicated to the Secretary in November at the Future of U.S. Aviation Forum, the company believes that three overarching imperatives should be addressed in order to secure the future of the industry and best prepare it for the global market realities of an intensely competitive industry. The 3 imperatives are:

- ➔ *Assist the U.S. Airline Industry to Return to Sustained Profitability* - The aviation sector and customers shoulder a federal tax burden that is typically higher than that paid by the alcohol and tobacco industries for so-called sin goods. Federal taxes represent as much as 20 percent of a domestic roundtrip airline ticket. This hampers United's ability to reinvest in areas that directly benefit its employees, customers and communities.



- *Ensure the Global Competitiveness of the U.S. Industry* - The airline industry contributes 3 trillion dollars a year to the global economy. It is a catalyst for commerce and tourism, creating jobs, connecting small communities and large cities to the world. Restoring U.S. competitiveness requires regulatory and structural reform that will enable airlines to operate like other global businesses. International investment, consolidation and cross-border ventures are among the business tools and options that should be made available to the industry.
- *Invest in Air Traffic Control Infrastructure* - While a satellite-based, modernized air traffic control system is a priority for DOT and the Federal Aviation Administration, much more needs to be done. The government must act now to fund this priority. There is broad agreement on this priority and its benefits. It will create jobs, improve customer service, improve safety and reduce emissions.

### Gauging the Right Amount of Fuel for Each Flight



A new process to more precisely determine the amount of fuel needed for each flight is helping United reduce its costs and impact on the environment. The Analyzed

Contingency Fuel (ACF) method brings more precision and less subjectivity to calculating the proper level of fuel for all its flights.

*"We developed our ACF standards in conjunction with the FAA," said Howard Attarian, VP-Flight Operations. "After two years of fuel burn data collection and analysis, ACF was officially implemented in late April."*

*"The idea is to develop a more consistent flight plan by giving dispatchers and pilots the tools to make the safest and most accurate decisions on fuel," says Captain Jim Barnes, of the ACF development team.*

ACF calculations not only compare the amount of fuel planned for each flight with the amount actually burned, they are also based on a series of conditions specific for each flight, including aircraft type, departure and arrival cities, weather conditions, season and even the time of day, all of which determine ground and air traffic. Fuel burn data from each flight is consistently updated in the system to maintain a high level of accuracy.

*"We wanted to go to the next level of fuel efficiency," says Mark Talaga, senior staff representative-Operations, who developed the modeling that led to the project's Six Sigma black belt and green belt certifica-*

*tions. "ACF considers all the values for a flight and asks several decision tree questions about weather, visibility and other variables to calculate the proper amount of contingency fuel."*

This new system improves United's previous fuel determination method but does not represent a minimum amount of fuel pilots can board; rather, it's a more accurate amount that allows for more fuel conservation in a safe and reliable operation.

*"Carrying too much fuel not only adds more weight to the aircraft, it increases the fuel burn rate - pumping more emissions into the atmosphere," Attarian added. "Given that fuel is our single largest fixed cost, conserving fuel is not just a key cost-saving contribution Flight Operations can deliver to the enterprise, it also helps us to maximize revenue by reducing the number of denied boardings due to weight restrictions."*

He concluded, *"We believe that industry adoption of these standards would reduce emissions across the board and create even wider fuel savings."*

### Inside Our Industry

Here's a look at some of the airline industry news announced recently. (Posted June 4, 2010)

- ATA President Jim May said passenger convenience will



remain a priority as the airline industry plans its response to a set of rules proposed by the Department of Transportation yesterday. The regulations, which are open to public comment for 60 days, include provisions designed to better compensate bumped passengers, improve delay notifications and expand just-implemented tarmac delay rules to more carriers and airports (Source: USA Today).

- The International Air Transport Association said on Tuesday air cargo volumes rebounded by an annualized 26 percent in the first quarter, and shippers and cargo executives expect a strong 2010 although growth could slow in the second half. The IATA said that improved cargo yields had boosted revenues by 30 to 40 percent in the first quarter (Source: Reuters).
- A strong recovery in premium travel is helping to allay fears that the recession may have created a permanent change in corporate travel spending. March saw a 10.8 percent increase in first- and business-class travel around the world, compared to an 8.8 percent rise in leisure travel, according to data by an international aviation group (Source: New York Times).

- ➔ As the summer season unleashes a pent-up demand for air travel, experts predict fuller planes and higher fares than in recent years. Corporate and leisure sales have grown anywhere from 15 percent to 39 percent in various reports, while the Air Transport Association predicts domestic capacity will increase only 0.2 percent from last year (Source: New York Times).
- ➔ The Air Force today is convening a meeting of experts in energy and aviation in an effort to spur development of commercially viable alternative jet fuels. The Air Force seeks to cut its consumption of fossil fuels in half by 2016 (Source: Boston Globe).

### **Merger Integration Planning Team Formed**



United announced the formation of the team that will begin integration planning in relation to its announced merger with Continental Airlines. Integration will begin after

United has gained approval for the merger and closed the transaction.

Glenn Tilton and Jeff Smisek will lead the Integration Steering Committee, which will include EVP and CFO Kathryn Mikells; EVP and Chief Administrative Officer Pete McDonald; Zane Rowe, Continental's EVP and CFO; and Jim Compton, Continental's EVP and Chief Marketing Officer.

Pete McDonald and Lori Gobillot, Continental's Staff VP and Assistant General Counsel, will report to the Steering Committee and will lead integration planning.

*"As this work gets under way, the most important contribution we can all make is to continue our momentum and focus on the good work that has put us in the position to effect this merger with Continental,"* Glenn noted in a message to all employees.

The Integration Management Office (IMO) led by Pete and Lori will be responsible for day-to-day integration planning and recommendations. The IMO will focus on identifying key strategic opportunities, including fleet plans, capital structure, product and service strategy and processes that will create a stronger airline, better positioned to succeed.

United expects to announce the full IMO organization structure and leadership soon, with planning work beginning in earnest in early June.

*"I look forward to working with our team and the leaders at Continental through the planning process as we define key strategic opportunities that will position us to succeed after the merger closes,"* says Pete.

### **Demolition Begins in Advance of Construction at Willis Tower**

United's move into the new operations center at Willis Tower in downtown Chicago took a major step forward on June 1<sup>st</sup>, as the company began demolition on four floors. The demolition work sets the stage for the first wave of approximately 1,000 employees to move in by the end of the year and the remainder in early 2011.



The next major milestone will be in early July when construction begins on these floors.

As noted in previous stories, the cost advantages provided by the city's incentive package represent a key opportunity to leave a sub-par facility, raise additional cash for the company and ultimately move into one of the highest-quality office facilities in Chicago. The move to Willis Tower will also provide more aligned and productive working relationships between and among its airline's operating functions.

### **Letter from United Benefits Service Center Direct Billing Process Change**

Dear Retiree,

As you may know, in early May, we launched an update to the United benefits website and implemented a new bill payment process for retiree benefits. Many of you reached out to the United Benefits Service Center with questions and experienced unusually long wait times. We apologize for any inconvenience and thank you for your patience as we addressed the situation. The volume of questions was significantly higher than projected, and we were unfortunately unable to provide you with the high level of service you are accustomed to receiving.

Despite these initial challenges, we are confident that the recent system upgrade will result in added flexibility and greater convenience for our retirees. The ability for you to manage your own account and view your payment history on-line will give you greater control and more timely information.

We are in the process of resolving billing and system issues that inadvertently resulted from these changes. During this period, we can assure you that your medical coverage will not be affected and that no one will lose their medical coverage as a result of the

recent system issues. The following steps have been taken to address the issues some retirees have experienced:

1. Additional resources were added to the Benefits Service Center to support the high call volume and wait times have dropped to no more than 1-2 minutes in most cases.
2. Passwords for the website were automatically reset to a default password. This allowed retirees to access the system and change their password without having to call and speak to a representative.
3. Payment or billing errors on accounts with automatic payment have been identified and the vast majority have been corrected. We are working actively to correct any remaining billing errors.
4. A number of retirees choose to pay in advance for their benefits, but in some cases, credits for these payments were not shown on the May bills. Credits and past due charges will begin showing on the billing statements in July. No action is needed for the May or June billing cycles. However, if you would like to pay for any past due charges, please contact a representative at the United Benefits Service Center.
5. In a few instances, retirees reported that they were charged banking fees as a result of a May billing cycle error. If you incurred any fee or penalty associated with your May payment, please call the United Benefits Service Center and we will work with your financial institution to restore your account appropriately.

Once again, we want to thank you for your patience and apologize for any inconvenience you experienced as a result of these recent changes.

#### **VP Total Rewards United Airlines – Doug Rose**

His goal is to maintain an ongoing dialogue with RUAEA and its members throughout the merger process. He was very glad to attend our Convention and hopes to do so every year.

#### **Managing Dir. Benefit Strategy – Rob Puryear**

Health care reform is one of their biggest concerns currently. It is a 2500 page document with more questions than answers. Areas that have potential impact for retirees and where they will need additional guidance are as follows;

- ➔ Requirement for no annual/lifetime benefits
- ➔ Coverage for dependent children up to age 26
- ➔ Change in amount of reimbursement in the Advantage Medicare Plan
- ➔ Medicare Part D – closing the “doughnut hole” in the prescription drug coverage
- ➔ Retiree re-insurance program

#### **United Airlines/ Travel – Patrick Reid**

Retiree travel in 2009 generated \$3,000,000 with more than 6000 segments taken to Hawaii. Some new

enhancements for employees and retirees are free Pet in Cabin, age limitation for children in international first class reduced to 12 years and fee for first and second bag waived on a 20% employee discount fare. They are trying to convert all ID90's to ZED fares. It is important you know your Companion travel pin number. This is protection against possible abuse of your companion coupons. You can change this on Skynet at Weblist. Go to Options and enter a new password if you can't remember assigning one.

#### **Alliant Credit Union – Dave Mooney**

This is the 75<sup>th</sup> anniversary of the Credit Union. Today assets exceed \$7 billion and over 250,000 members enjoy the Alliant Advantage. As a member – owned cooperative, Alliant provides members consistently superior financial value through high return on deposits and low rates on loans and helpful, knowledgeable and memorable service. In 2009, Alliant was in the top 1% of all credit unions, paid \$132 million in dividends and added 20 new sponsors while membership grew by 8%. Interest rates are likely to stay at historically low levels for an extended period of time. Alliant is offering members a Member certificate of Appreciation on a new or used vehicle or unsecured loan. See the website for complete information.

#### **ADP – Todd Hall**

There is a new website [www.ualbenefits.com](http://www.ualbenefits.com). Once signed in, you will be able to make personal changes, like address, marital status, etc. You will also be able to change the day of the month for your Medical payment. If you need to reset your password, just enter your employee number and the original password will be your birth month and last two digits of your birth year. You then can change the password to one of your own. He apologized for the confusion on the direct bill change-over and the long telephone wait time. This has all been corrected and you should be able to call now without any problems.

#### **PBGC Team Ldr. UA Plans – Thomas Hopkins**

The PBGC paid \$4 billion to over 600,000 retirees last year. There are sufficient reserves to continue these payments without using any tax funds. There are still United Airline retirees that have yet to receive their final determination letter. They send approximately 4000 a month and should be finished by the end of 2010.

#### **VSP – Oxana Lapchuk**

The Vision Service Plan is one of the largest vision plans in the US. They have the largest network of doctors for your vision needs. Enrollment dates are generally late October 28 to mid November. You can view the coverage and costs at [vsp.com/go/unitedretirees](http://vsp.com/go/unitedretirees) or call 800 400-4569.

#### **Blue Cross/ Blue Shield of IL – Celeste Medina**

There were over two trillion dollars spent on health care in the United States last year. Since fraud ac-

counted for over 10% of that number, they are very concerned that members report fraud. Be cautious of anyone offering "Free Screening" and then asking for an insurance card. Someone is paying for this service. It is important everyone review their EOB (Explanation Of Benefits) be it in paper form or on the Website. There is a number listed to report suspected fraud. #### **Medco – Pamela Morrison**

In 2009, Medco filled 118,000,000 prescriptions for over 67 million members. Between 2009 and 2015, a number of drugs are going off patent. Some of them are among the most widely prescribed in the world; Prevacid, Flomax, Ambien CR and Lipitor. Their mission is to make *medicine smarter, but more importantly adhere to your prescriptions* – "drugs don't work in patients that don't take them". Remember to use the new Medco Health Store for buying OTC medicines.

### **RUAEA ANNUAL BUSINESS MEETING**

**Saturday May 29, 2010**

**Rosen Centre Hotel – Orlando, Florida**

The meeting was called to order at 0830 by President Ron Robertson

President - Ron Robertson - Ron welcomed all members to the annual business meeting with a special thanks to first time attendees. "*Our main focus is to keep RUAEA meaningful and serve our 8000 members. We represent all 39,000 retirees and feel we make a difference*" He sent 5000 personal letters to recent retirees and received a 14% return in new members. In our attempt to remain proactive, Mickey Manfre from the Continental retiree group has been invited to our Convention. ### **Easy Does It**

So you don't/can't/won't have an outdoor **BBQ** to celebrate the Fourth of July? So what! You can do these "**Saucy Pork Spareribs**" easily (and less messy) in your *kitchen oven*. I've bent my rule about my recipes using only 4 or 5 ingredients ... this time, it's 8 if you count the water ... but so delicious. Accompanied by

"**Valerie Noel's Potato Dish**" in a separate bowl (recipe follows), just before you serve, you could add slightly warmed canned peach slices to your meat platter, adding pretty color and a nice blend of flavors.

### **"Saucy Pork Spareribs"**

Buy *especially meaty* ("farmers or country style") pork spareribs, *whatever amount* suits your needs. (\*The Sauce recipe makes a generous amount.) Cut ribs between bones into serving-size pieces. Place ribs in *one layer* in an appropriately sized **metal** baking pan. Do not use a glass baking dish. I had one break in my oven ... what a mess! Bake in a **preheated 500 F.** oven **15** minutes. Add another **5** minutes if you are making enough ribs to serve *over 6* persons. **Remove** from oven. **Drain**, discarding fat. **Reduce** oven temperature to **325 F.**

### **\*While ribs are baking, make Sauce:**

1/4 cup chopped onion (I cheat; I use frozen).

1/2 cup water

1/4 cup lemon juice (I use bottled "ReaLemon: 100% Lemon Juice)

2 Tablespoons brown sugar (Diabetics: Same amount of "Brown Sugar Twin" works fine)

2 Tablespoons Worcestershire Sauce

1 cup bottled Chili Sauce

1/4 teaspoon paprika

**Cook** sauce over low heat in pot, **uncovered**, **20** minutes. Watch carefully so it doesn't burn.

(1) **Pour** Sauce over ribs in pan; **cover** with heavyweight foil; **bake 2** hours.

(2) **Remove** foil ... bake additional **30** minutes.

(3) **Drain** ribs slightly on paper towels before placing on meat platter to serve.

### **"Valerie Noel's Potato Dish"**

Buy **10** medium size red ("new") potatoes, wash (do not peel) and thinly slice. If you have a food processor, Cuisinart etc., use the medium-slicing blade.

(1) **Generously brush** bottom and part way up sides of casserole dish with soft (room temp) butter.

(2) **Place** sliced red potatoes in casserole dish. Dot (cut tiny bits of butter) top of potatoes using approximately 1/3 cup butter (more or less).

(3) **Sprinkle** 1 oz. package dry onion soup mix (not "Cup-A-Soup") over potatoes.

(4) **Cover** with casserole lid or heavy foil.

(5) **Bake** in preheated 350 F. oven 45 minutes.

**Note:** *If you're doing the ribs and potatoes at the same time in the same oven, add the potato dish **55** minutes **before** the ribs are done.) And remember to put our American flag in your window or outside in a prominent location on July Fourth. God Bless America!*

**Dick Shryock** rattled off a series of short jokes!

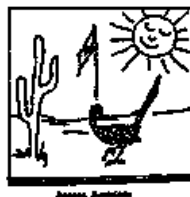
#### *2<sup>nd</sup> Report:*

This program offers **free** house calls regarding home weatherization, energy education, and information regarding free replacement of old appliances. Interested? You betcha! Telephone or go online: [www.pge.com/energypartners](http://www.pge.com/energypartners).

Did you know, depending on your income *and* if

you're local, that you can get monthly discounts from both PG&E and your local Water Department? For PG&E, call the telephone number on your monthly statement. Ask for the "CARE" *discount rate*. For the Water Department, telephone the number on your monthly statement and inquire about the "LIRA" discount. If you're not local, call your utility company and ask if they have this discount available to you.

From time to time, I receive inquiries as to how to receive the annual \$60 fee rebate from your UAL Visa Mileage Plus credit card account. So here we go again: You must already be a Mileage Plus Visa Signature (Chase) credit card holder. Go into Skynet (don't forget to add the small case letter "u" in front of your file number.) On the right side of your computer screen, go to the "Easy Links" column, and then scoot down to "Employee Discounts" on the left. Find the "Employee Mileage Plus Offers" and then, "Card Members Who Are Eligible For a \$60 Annual Fee Rebate". Now it's all up to you: Type in your name, file number or that of your spouse) and whatever else they ask for. If it doesn't go through the first time, repeat this procedure. Don't give up. You will eventually get a confirmation.

**Personally Speaking:** First of all, I want you to know that y'all will be celebrating my little Pembroke Welsh Corgi's 2<sup>nd</sup> birthday on July 4<sup>th</sup>. Easy on the fireworks, please! Second, don't be taken in by TV ad salesmen. I almost was ... and it took several months to get my \$1,000 deposit back. I had been sitting in a medical building, watching TV and killing time until my ride came to pick me up. Being unable to take a nice comforting bath for several years, the television advertisement for a walk-in therapeutic bathtub sounded heavenly. I called the telephone number on the TV screen and was visited the next day by a very slick salesman. With the medical disturbances I've had these past months, this tub sounded like a miracle to me. Before this con artist left my home, I had innocently signed a contract for both the bathtub and its installation. The starting price was \$18,000 but went down to \$13,500 before we concluded negotiations. The small print on the back of the contract was just that: small/tiny/mini/teensy! I couldn't and didn't read all of it, including the back page (legal size paper) that said I would be responsible for any local building permits, taxes and fees. That part was never orally mentioned to me along with some other major points. telephoning and finally reached a real live person (quite rude) and was told I would have to contact a lawyer. And this was a “diamond rated” company? (Want the company’s name? Email me.) For your eyes only, friends, this would have included the Board of Contractors, Better Business Bureau, and 2 local television stations who do consumer investigations. Just made another trip to NYC and Yonkers to see my oldest son's family. It was hard to believe that in May, I had to wear "Long Johns" for comfort ... but it didn't freeze or snow. I was last up there a few months ago, and for one lady I met, it wasn't a Merry Christmas. She was at a Christmas hen party and her husband (a prize winning writer), called to say he wasn't feeling well and could she come home? No big deal they all thought. She drove home and found husband dead on the floor.

I was invited to a party given by a lady from a European embassy and her Icelandic husband. Almost all the guests were Europeans from the U N and various embassies. Among the few exceptions were a Dutch doctor and me. We had WW2 in common to discuss, and we heard wacko stories at the party about diplomatic "screw-ups" around the planet.

At a dinner given by my daughter in law, I met a NY lady. We had a pleasant chat and I was later told that she was divorced, lives alone, is pretty smart and worth fifteen million bucks, yippee. She also lives next door to a bee farm I'd previously visited. I'd been taken to the apiary by her son who took photos of how bees spend their time in the off season, they're still busy. I met the lady that runs the apiary and I've never seen so many five gallon buckets of honey. It was in every room in her house (except the bath rooms). Some of the honey pails in the dining room leaked and she complained, "*All day long I'm licking my fingers.*" Unwisely I said, "*You need a change. Get your husband to lick your fingers.*" OOPS! She frowned and didn't reply. She, too, is divorced.

If you haven't been through IAD since January, you are in for a surprise. The quick 5 minute Ramp crossing from main terminals to Terminal A (UAXpress) by coach is no more. Now one MUST follow the signs down deep under the Ramp, take one of two trains, (like DEN), and some five minutes later and a lot of walking, take the elevator stairs up to say Terminal C or whatever one you want. The new multi million dollar excavation looks like an empty museum in my opinion. I noticed in a Yonkers store that all the help was semi-disabled in some way. The owner only hires former cops injured on the job. Right across one main road was a black and white banner seeking new cops at \$57,000 per year.

My youngest son, formerly a TV cameraman, after eighteen years of illness, entered the long, dark night and died at age 53 of Multiple Sclerosis.

Today is May 31<sup>st</sup>, Memorial Day and a good time to remember **Tom Baba** who worked in the Turbine Shop and before that on Dock 5, SFOOV. That's where we met in December 1956, and in my estimation Tom was an unknown WW2 hero from the Theater of Ops known as CBI-China-Burma-India. When I told him I too, had been in Burma he told me his story. Early in 1942, Tom enlisted in the U.S. Army from his home in Kauai. At home, the language spoken most often was Japanese and he could read and write English better than he spoke it.

Tom's name apparently came to the attention of a Col. Dulles and instead of being placed in Hawaii's own infantry regiment, he was placed in Detachment 101, Office of Strategic Services. Col. Dulles was the brother of John Foster Dulles, Pres. Roosevelt's Secretary of State in 1941 and throughout WW2. The Office

of Strategic Services (OSS) was Established by Dulles to fight “behind the lines” in France and likewise in Burma. After WW2. the OSS was renamed the CIA, (Central Intelligence Agency). Tom was sent to India as a Japanese interpreter where he was assigned to a small British trained group of Hill men in Assam (North East India) on the border with Burma. The Japanese Imperial Army had taken Burma and crossed into Assam, hoping to eventually take Calcutta (in the Province of Bengal). Tom’s unit was to get behind the Japanese, find and tap into their telegraph lines. Tom’s job was to translate what he heard and radio it back to Detach 101 in New Delhi, India. The C.O. of Tom’s group was a British Army Major who had managed Assamese Tea plantations and could speak the dialects of the Hill men. He took Tom aside and told him that should they be surrounded and near capture, Tom would be wise to take his own life immediately. The Japanese Imperial Army treated all Nisei and those of Japanese descent, as traitors to the Emperor. Nisei were executed slowly over a period of two or three days by strangulation with wire. Among the Hill men, Tom’s unit had to deal with were the Naga’s, a tribe of head hunters, whom the missionaries had spent years convincing them of their evil ways. With the arrival of the Japanese, the British Government told the Naga’s to forget the missionaries and bring in all the Japanese heads possible. They also rewarded them with heroin and strong Indian “pot” called “ganji”.

One of the Hill men threw away an American candy wrapper instead of burying it and it was found by a Japanese patrol. Tom’s unit barely avoided capture and for twenty one days, they fled back through Japanese lines and the Khasi hills towards India. They discarded everything including their radios. No more air drops of food, and motivated by hunger, fear and exhaustion, they ate leaves, bamboo shoots, and drank water from the bamboo. They were too sick to stop which meant capture. Tom said, “Unless we soon had food we couldn’t keep going and it was the Major that saved us”. He showed us how to catch bamboo rats, skin and eat them raw. We couldn’t light fires for the enemy was always near by. Tom said, “I vomited up the rat meat at first. I’m surprised we survived but we got back through the jungle to India.”

Tom Baba was returned Stateside in 1943. On his last day at SFOMB, I gave TOM a book by a Lieut. Charlton (I think) that named Tom on the Detachment 101 roster. Later, I tried to find him in Kauai but learned that he had likely moved to Oregon.

Tom Baba was a quiet hero who wasn’t given the glory in Hawaii accorded to One Puka Puka. Despite having to eat raw rats simply to stay alive, (Tom described it as worse than fearing the death that stared at him day and night in Assam), he lived a long life. He died in February, 2010.

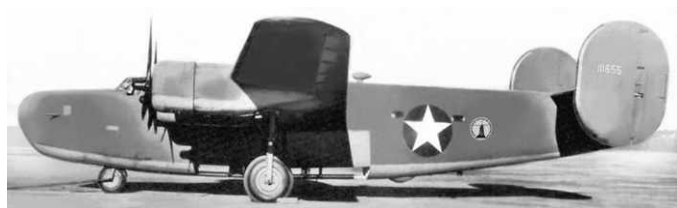

In July 1942, General H. H. George, head of the Air Transport Command, outlined plans for a "Pacific Oceanic Airline" from San Francisco to Amberly Field near Brisbane, Australia in the South Pacific.

The route was to be from San Francisco to Hickam Field, Honolulu - 2446 mi.; Hickam to Canton Island - 1908 mi.; Canton to Nandi, Fiji - 1250 mi.; Nandi to New Caledonia - 865 mi. - New Caledonia to Amberly Field, Brisbane, Australia - 1800 mi.

United's "Pat" Patterson accepted the challenge and agreed to start flying the 8269-mile overseas route within 40 days. United's ATC pilots were to operate the route, nearly as long as the entire United Mainline system, with equipment few of them had even seen.



The planes to be flown were fat-bellied, 4-engine,

included the use of "Mae Wests" (life jackets), Life Rafts and Emergency Radio Transmitters.

Most of the "newly-recruited Navigators" were former United Ticket Agents, Clerks & Accountants and students from the Boeing School.

The first C-87 was delivered Sept. 5, 1942 and all 25 crews were "checked-out" in it. Five more C-87s were delivered to the San Francisco Airport on Sept. 23, 1942. That same day Captain Jack O'Brien, a veteran of "Alaska Ops", and his crew took off for Australia. Three hours out of SFO the fuel gauges showed "no pressure". O'Brien returned to San Francisco where he was told "the C-87 fuel gauges sometimes worked and sometimes didn't work"!

O'Brien took off again and in 10 days, was back from Australia, having flown over 16,000 miles.
