#### **Attention! Attention! Tour Change!**







#### Receive An Unexpected ERRP Check From United?



Some retirees received a check from United due to the Early Retiree Reinsurance Program.

The Affordable Care Act (ACA) provided \$5 billion to establish the early retiree reinsurance program to encourage plan sponsors to continue providing health insurance to early retirees who are age 55 and older but are not yet eligible for Medicare (as well as the early retirees' spouse, surviving spouse

and dependents). The program was established June 1, 2010 and ends the earlier of January 1, 2014 or when appropriated funds are exhausted.

The program ceased accepting new program applications on May 6, 2011 and on December 9, 2011, CMS and HHS announced that the Early Retiree Reinsurance Program (ERRP) will not reimburse any claims incurred after December 31, 2011.

HHS has information for employers and unions interested in the Early Retiree Reinsurance Program - a website (<u>www.ERRP.gov</u>). The latest procedures and program requirements can be found on this site.

#### **Traveling this summer?**



Space-available standby lists: As more and more pass riders use their personal devices to access employeeRES/mobileRES and <u>united.com</u> to check standby lists during travel, domestic stations that do not have gate information display screens (GIDS) will discontinue printing standby lists and encourage pass travelers to check the mobile apps. International locations without GIDS will continue to print and post a current pass-rider standby list 60 minutes prior to the scheduled departure time to help ensure our employees' travel experience is the best it can be.

#### **Industry-first 'bug bounty' program now live**

Recently, United launched a <u>bug bounty</u> program that rewards customers who discover security issues with United's website. This started in the tech world, Microsoft, Google and Facebook have similar programs but United is the first airline to start one.

United takes security seriously, and the company welcomes input from experts who raise concerns in a constructive way. That's why United is inviting independent researchers to discover and report bugs that affect the confidentiality, integrity or availability of customer information. United will check out each report, and if the issue is valid, the first person to report it can receive 50,000, 250,000 or even 1 million MileagePlus miles.

The bug bounty program applies only to United's websites, apps and online portals. Tampering with inflight entertainment or other onboard systems is a federal crime, in addition to violating United policy. The FBI is investigating the individual who claimed he was able to manipulate aircraft systems while in flight. United's internal review with its aircraft manufacturer partners makes United confident that these claims are unfounded, and the company is cooperating with the FBI's investigation.

<u>Tripwire</u>, <u>TechCrunch</u> and <u>ZDNet</u> were among the media outlets who praised United's new bug bounty program, which was planned in January.

#### What's new with the United app?



United released an update to the iOS version of its United app on May 18, including several new features that mirror the changes United is making to the new <u>united.com</u> site. This United app update is another step in United's overall investment in digital channels to drive choice, control and convenience for its customers.

The new improvements include:

- Redesigned flight shopping and booking: Whether it's Wi-Fi availability, preferred connection cities, aircraft type, in-seat power or the inclusion of nearby cities, customers can sort, filter, include and exclude a variety of preferences to narrow or expand search results. United used the same infrastructure it built for <u>united.com</u> in the new app, creating a seamless experience for the customer.
- Features from <u>united.com</u>: United has brought to the app several popular features available on <u>united.com</u> such as FareLock<sup>SM</sup> to hold a customer's fare and complete the purchase of an itinerary at a later time and the ability to perform advanced flight searches by specific fare classes.
- ❖ Leading capabilities: United is the first airline to offer its loyalty program members <u>Touch ID</u>, which is the ability to sign into their account using their fingerprint. United also has one of the first apps to be part of the new <u>Apple Watch</u>, giving wearers their boarding gate, flight status and a summary of upcoming reservations. In addition, customers will be able to use the mobile boarding pass barcode in the Apple Watch to transit security.
- ❖ Additional Wi-Fi options: The app now supports all three of United's Wi-Fi vendors, Panasonic Wi-Fi, DIRECTV and Gogo's ATG Wi-Fi.

United will update the app for Android devices later this summer.

#### **Torgy's Travel Tips**



Last month I took you on a journey near Orlando where you could imagine a trip to outer space. This month I'm returning you to planet Earth, but still to another "out of this world" reality: "The Wizarding World of Harry Potter" at Universal Studios Florida. Now I am NOT a fan of these mega-amusement parks with astronomical ticket prices and interminably long waiting lines for neck-wrenching, ear shattering rides and overactive, over-tired kids dragging their exhausted parents to every gift shop in sight. That said, I still count the Harry Potter attractions as a must-see. In my opinion, no other portrayal of any fictional work comes close to matching reality as described in the books or manifested in the movies, as does this one about Harry Potter. The attention to detail is phenomenal and you cannot help believing it is all real!

Universal Studios Florida is located about a half-hour west of the Orlando Airport. The park has 2 halves: Islands of Adventure and the working Universal Studios. There is a Harry Potter world located in each side: Hogsmeade Village and Hogwarts Castle is found in Islands of Adventure and Diagon Alley is located in the Studios section. In order to see both, you must purchase a "Park-to-Park" ticket. It's worth it. The Hogwarts Express train, complete with Track 9 ¾ at Kings Cross station transports you between the 2 worlds. Tip: Start you visit at Diagon Alley early in the day and be sure to ride the train in both directions as the scenery and the experience is quite different and delightful.



You may have difficulty finding Diagon Alley once you enter the Studios side of the park, even if you're equipped with a park map. This is intentional and part of the magic! You'll easily find Kings Cross station and even the triple-decker Knight Bus complete with beds, chandelier, the conductor and the talkative shrunken head. But you'll have to search for the opening in the brick wall in order to wend your way out of the Muggle world and into the Wizarding world. Once there, be prepared for magic at every step. Ollivanders wand shop, Flourish and Blott's book store, the Leaky Cauldron and Weasley's Wizard Wheezes are just a few of the many places to step inside as you meander up and down the Alley's streets. Tip: Inquire about being "fitted" for a wand at Ollivanders. There is a marvelous experience awaiting you as small groups are ushered into the chamber behind the right side of the counter. I happened upon this by accident, as it is not published.

Then there is Gringott's Bank. The fire-breathing dragon perched atop the tall, wobbly-looking bank is worth more than a look, but the crowning

gem is the walk inside. Everything in Diagon Alley feels real, but walking into the bank is like walking into the movie itself. The line of ornate, high counters beneath arched windows along both walls is "staffed" by animatronic Goblins, formed from the same molds as used in the movies. This is not the old technology of Disneyland's Abraham Lincoln, this is 21st century near-to-lifelike technology, complete with moving hands guiding quills across their ledger books while eyebrows furrow and heads move and gestures made as they look over the line of you, the customers. They even talk to you as you near the entrance to the underground bank vaults where the roller-coaster type ride "Escape from Gringott's" awaits you in darkness. The ride is fast, loud and fun, but I would not have been disappointed at all, if there weren't even a ride. You have a second opportunity to interact with a very serious Gringott's Goblin down the street at the money exchange. Go ahead, ask him anything you want—he'll answer!

Of course, there is the opportunity to cast a spell and make magic happen, and Universal makes a ton of money by selling interactive magic wands. The wands work at any location where there is a medallion in the pavement. Swish the wand, correctly say enchanting words and presto a fountain shoots out water or a spoon stirs in a bowl by itself! The wands work in both parts of the park and they are extremely popular, as are the

Hogwarts school robes for purchase. Beware: the interactive wands are not cheap and neither are the robes. Still, I saw many families with more than one child, decked out with robes and wands.



Hogsmeade Village contains the Hogwarts Castle, a faithful reproduction of the School of Wizardry as well as the surrounding town. Exceptionally well done, again complete with a less rambunctious ride called the "Flight of the Hippogriff". For the very able-bodied thrill seeker there is the "Dragon Challenge" ride, a twist and loop, high-speed roller coaster which is marketed to riders who'll need the courage of a Triwizard Tournament champion. My neck hurt for 2 days after riding this one!

Amid the snow-topped roof houses in the village, you'll find the Three Broomsticks café and Honeyduke's Sweet Shop. Of course, no visit to either side would be complete without drinking some Butterbeer. It's available in liquid, frozen or slushy form and tastes a bit like a butterscotch/caramel soda. If it's hot when you visit, definitely order the slushy one with white marshmallow foam on top. Yum! A souvenir mug entitles you to discounted refills.

There are many, many more rides and attractions aside from the Wizarding World of Harry Potter and like all theme parks it can and does get extraordinarily crowded. Visiting in early November, when kids are still in school, was perfect as the lines were minimal, but there were still an appreciable number of families from the southern hemisphere since it was their summer vacation time.

When choosing a hotel near Universal Studios Florida, be aware that several hotels state they are located "across the street" from the main entrance. What they don't tell you is that the actual ticket gate is at least three quarters of a mile beyond the street entrance. Although the hotels often offer a shuttle service, it is a shared bus that stops at several hotels and requires advance reservations. The shuttle bus usually has only 4 departure times and if you board at the first hotel, it can take 45 minutes before you are at the ticket gate. Limited return times apply for the shuttle at the end of the day as well. Solution: Take the public bus, LYNX, number 21, 37 or 40 which serves the streets where most of the hotels/motels are located. Cost is only \$2 each way and the buses run frequently.

So get out there and use your flight benefits – a whole world awaits!





The Memorial Torch of Liberty, a tribute to the new light of freedom won by the sacrifice of the Heroes of Flight 93, is the gift of families of Flight 93. Symbolically, it is united with the torch held by the Statue of Liberty. The base and torch are made of stainless steel. It raises fourteen feet and weighs in excess of 1,400 pounds. Four ribbons form the Torch and represent each of the Four Flights of honor of September Eleventh.

The 200 million candlepower torch will project ten miles unto the sky and will be seen in all directions for ten miles from the Pennsylvania Turnpike.
