FROM THE DENVER OFFICE

It has been a long standing tradition of the Denver Chapter to prepare & mail the Newsletters, with the help of many volunteers. This has been done for over 30 years, usually on the last (4th) Saturday of each month. Normally there are 40-60 retirees that come to participate (some starting as early as 5:30 AM) to tab, label and bag the Newsletters. The week before the Saturday mailing, four families got together to "cut" the labels. This task prepared and sorted the labels for the Saturday mailing crew. There was always someone who volunteered to call everyone, to remind us of the mailing. We all looked forward to that call. This has been a wonderful social event, with goodies and drinks and always lots of conversation.

With a coming change in the postal regulations and apparent increased costs we will experience because of the way we prepare and mail the Newsletters; it became apparent that changes had to be made. Saturday, May 26th was the last mailing get-together for the Denver Chapter. The Newsletter will now be labeled and mailed by a vendor. The cost of doing this will probably be about the same as the "hands on method" we were using. But, there will be an increase in postage for "Periodical" mail (effective 7/15). This is our Newsletter's classification. The new postal service rates are variable, with numerous mailing schemes. Rates for periodicals mailed other than fully automated, will be very costly. The most reasonable rates are for those that use a fully automated process (postal worker hands off as much as possible). Our vendor can accomplish this for us and therefore we will obtain the most reasonable rates.

It goes without saying, that all of us in the Denver Chapter, have a hollow spot in our hearts. But, we do what we have to do to keep the Newsletter going.

The suggestion was made to have a Sat. morning "Mailing Team Breakfast" to keep the social activity going. We are looking into this to see if it is feasible. We do have the first Wed. of the month breakfast at DENTK. Until we learn more about the feasibility of the Sat. morning "Mailing Team Breakfast", we encourage all to attend the first Wed. of the month breakfast.

Three other items in this issue:

The first item is that the traditional "Red

Stamp" will go away since the Newsletter will now be done by a vendor. But "Red" will still be present on the Newsletter when it is time to renew. The vendor will have the renewal messages on the labels printed in red. The wording on the labels should be the same and are intended to advise of 2 different scenarios:

1. For *Current Membership Expiration Month* - The wording on the labels will be:

It's Time to renew your Membership.

Disregard this message if your dues are already paid.

2. For *Month Following Expiration* - The wording on the labels will be:

Your membership will expire unless your dues are received.

Please submit your dues payment at this time.

Disregard this notice if your dues are already paid.

The second item is the change in membership renewal date. A change in By-Laws was approved at the public business meeting in Sacramento, that allows the renewal date to be 12 months from the date dues are received in the Denver Office. In essence, this means the birth date will no longer be the renewal date. Again, the renewal date, effective immediately, will be 12 months after dues are received in the Denver Office.

The third item is a change in "Associate" member status. A change in By-Laws was approved at the public business meeting in Sacramento, that will make a deceased member's spouse automatically an Associate member until the deceased's membership expires. At the time the membership expires, the surviving spouse can elect to continue his/her membership by paying the current rate of dues. **Note:** The surviving spouse of a "Life Member" will not automatically become an Associate Member. If the surviving spouse of a Life Member desires to become an Associate Member, they may do so by paying the current rate of dues.

In our humble opinion, the two changes in By-Laws that affect our renewal date and surviving spouses automatically becoming Associate members is a good thing for our membership and will make our secretaries' job much easier.

RUAEA ANNUAL BUSINESS MEETING

Saturday June 2, 2007
Hyatt Sacramento, California

The meeting was called to order at 10:00 by President Mort Wax.

President - Mort Wax

Mort welcomed all members to the annual business meeting. A motion was made and seconded to waive the reading of the 2006 Business meeting minutes. The motion was carried. Mort announced that Jo Madden had left the position of Newsletter Editor and wished she were in attendance so we could show our appreciation to her as a group. The Executive Committee met yesterday and will carry a recommendation to the Board of Directors, that the Board, on behalf of all the membership make a presentation to Jo to demonstrate the affection and thanks of the membership for her years of service to RUAEA.

All current appointees will be presented to the Board for approval with the following exceptions:

- Nancy Hooper will be appointed to fill the opening on the Site Selection Committee.
- Dixie McCay has asked not to be reappointed to Membership Secretary.
- The Newsletter Editor position will remain open for the time being.

Reports:

Corporate Relations - Ed Tolle

In Ed's absence, Mort reported that HR is still in the process for transformation, and a new liaison for RUAEA will be named. United has initiated a new grassroots programs (UGNVA). This is an outgrowth of the efforts on behalf of the IAD-PEK route. Ed will fulfill the role as our representative, and will disseminate information that would concern and involve retirees.

Executive Vice President - Gordon Starr

Gordon commented on all the upgrades to the Newsletter and asked Virgil and Howard to speak about upcoming changes.

Membership Manager - Howard Tress

The membership database has been refined and during first quarter there are only two errors. Total membership for first quarter is 9153.

Newsletter Manager - Virgil Gooselaw

All chapter reports are greatly appreciated. The Newsletters will no longer be put together by the local chapter. Changes in USPS regulations make it advantageous to contract out the labeling and mailing of the Newsletters.

Web Site - Ed Majewski

Ed and Jim Sommerfield work to keep the website current and post information promptly. They also respond to password and website navigation issues. The website averages 480 daily hits and has had 1,002,000 hits since inception.

Treasurer - Len Haubl

Our 2006 audited income was \$194,000 with costs for the Newsletter at \$95,000 and \$56,000 for the convention. First quarter 2007 shows \$52,000 income and \$49,000 expenses at the moment. This will change when numbers are audited.

Vice President Convention - Hank Gosselin

Hank stated so far feedback has been extremely positive for this convention. The coverage in the Newsletter and on the website was great. The 2008 convention will be held in Pittsburgh, PA from May 19th to the 24th. Jeri Juth will be the Convention Chairperson. He thanked the local committee for all their help and asked for local chapters to think about hosting future conventions.

Past President - Marlin Lade

Marlin announced the results of the May election:

He reminds us all that next year all elected officers and five Regional Directors will be up for election. The nominating committee needs everyone's help to identify members to fill these leadership roles. The balloting next year will also take place online, via the RUAEA website.

Recognition of Outgoing Officers and Directors

Mort presented Certificates of Appreciation to outgoing Regional Directors Jeri Juth and Tom Good-year. He also presented one to Dixie McCay for her help in the Membership Office.

New business

Gordon reviewed the change in Article IV, page two, regarding dues payment. This change will make dues payable 12 months from the date, dues were last received. A motion was made to approve the change, it was seconded and carried. Gordon then presented the change to Article III, page two regarding associate members. A motion was made to approve the change. A question was called regarding life members and discussed. The motion on the floor was seconded and approved. Appropriate changes will be made to the Bylaws Manual, Policy and Procedures Manual and the Membership Enrollment Form.

Old Business

Mort & the Regional Directors met yesterday morning and discussed finding ways to encourage new members in RUAEA and also local chapter membership. There will be a new membership enrollment form posted on the Website reflecting the changes in the Bylaws. He also gave a large thanks to the Sacramento Chapter for their largesse during the convention, including the huge amount of door prizes won after the meeting.

A motion was made to adjourn. The motion carried and the meeting was adjourned at 11:30

BlueCrossBlueShield/Illinois - Veronica Gipson

- In the last four months they received 575,000 claims and released 572,000.
- Only 19% of members used the intranet. They would like to see more and go completely paperless.

UnitedVSP - Katrina Holzman

- Routine eye exams are necessary for early

detection of glaucoma, cataracts and diabetes. VSP pays for most exams with a \$10 copay.

- Benefit questions are answered through www.vsp.com or 800-877-7195.

Travel Desks - Bob Brumfield

- All retirees are encouraged to use Skynet for checking loads, listing and printing boarding passes.
- There are brochures available on companion travel. Make sure they read the literature before traveling.
- The travel desks at Seattle and Portland provide coverage five days a week and are supported by RUAEA and RUPA.
- The TSA has a special luggage lock that is widely available.

TRAVEL TIPS BY BOB

The annual RUAEA Convention 2007 is over; and a great one it was! I trust that everyone at the Saturday morning Benefit Session and the afternoon "break-out" received "helps" and answers to their questions.

The Session did focus on Retirees being more "Self-Service" conscious. Therefore, it helps to become familiar with the computer or find someone that is, and is willing to help you. "Self-Service" means not using paid employees unless required. Retirees are requested to use the kiosk computers for baggage check-in, home computers for listing, checking loads, and for Departure Management Boarding Passes.

If you need help preparing for travel or during your travel, the Retirees Travel Desks at PDX & SEA are there to assist you.

The new non-stop, Dulles to Rome is a huge success, with very heavy loads each day. If you plan on traveling to Rome anytime soon, because of the load factors, you may need a few additional days to get a seat.

From NewsReal - May 30-31

Summer Prep: Optimizing Customer Travel Convenience through Automation - In addition to adjusting our staffing levels to better handle the

busy summer season (see May 24 NewsReal), United also is putting our investment in automated technology to work for our customers.

- ✈ Use of our Easy Check-in units (ECUs) is growing steadily, with a 17 percent increase since 2004. Nearly 1,800 units are deployed worldwide. Recent upgrades, which allow customers to change flights, seats, add their names to standby lists, and check flight status, have been well-received. Our utilization data shows customers becoming more confident using self-service as a means to manage their travel.
- ✈ Our automation tools also allow us to track our customers through the system, and through Easy Rebook, we can accommodate them as best as possible. In many of our busier airports, new ECU kiosks enable customers to rebook a flight or join a standby list during irregular operations without having to leave the concourse. These concourse kiosks have been deployed at all hubs, and a total of 120 will have been added by the end of June.
- ✈ We have installed passport scanners in 18 international locations, all five U.S. hubs, and several United Express locations as well. With more than 700 scanners in place systemwide, we plan to retrofit another 388 on ECU kiosks before the end of the year.
- ✈ BagCheck, a service we launched last May that offers specially designated ECUs to customers with luggage to check, has enjoyed tremendous success. Currently available in nine U.S. airports, United estimates that more than 350,000 customers have used BagCheck since its launch. This tool is especially valuable during the busy season, as it helps reduce airport lobby congestion and check-in times.
- ✈ BagTrack, the automated online bag tracking tool launched in June 2006, received its millionth hit in March (see May 1 NewsReal). This customer-friendly and cost-effective technology gives customers an alternative way to track the status of a delayed luggage claim, once it is filed at the airport.

Thanks to the staff and volunteers that made Sacramento an enjoyable convention.

Verification letters for Southwest, Spirit and Jet-Blue:

- ➔ Verification letters may be requested through the Benefits Service Center at 888-825-0188. Please allow 4 – 6 weeks for receipt. Verification letters are valid for 90 days from the date of issuance for Spirit and JetBlue, and for one year from the date of issuance for Southwest.
- ➔ Please contact the Benefits Service Center at 888-825-0188 should a retiree encounter a situation in which information from the above carriers differs from the agreement stated in SkyNet. Please be sure to provide the name of the airlines and the location.
- ➔ Individual carrier agreements may be found in SkyNet by clicking on *Travel>Interline Travel Benefits>Individual Carrier Agreements* then click on the drop down box and select the airline on which you wish to travel.

TRANSCONTINENTAL AIR TRANSPORT

In early 1930, National Air Transport ceased flying passengers and focused on the more profitable mail flights. NAT passenger flights didn't resume until Oct. 1, 1930 following the Stout - NAT merger at Boeing Air Transport.

Transcontinental Air Transport (TAT), was the next passenger-carrying division of Clement Key's North American Aviation holding company.

The inaugural westbound Ford Tri-motor flight departed Columbus, Ohio on July 8, 1929.

Charles Lindbergh was given a substantial amount of stock and the position of "Technical Advisor" at TAT. The airline was then advertised and promoted as the "Lindbergh Line".

TAT was also known as "Take-A-Train". Day-time passenger travel was by Ford Tri-Motor and night-time travel was by Pullman rail-car.

The fare, New York to LA, was a hefty \$350 (\$3985 in 2006 dollars!) and the trip took 48 hours.

Although very luxurious, the flights averaged no more than 5 passengers in the 10 seat Trimotors. As a result, TAT lost \$2,750,000 (\$31,322,500) in the first 18 months of operation and shut down.

In 1930, U.S. Postmaster General Brown ruled that TAT would merge with "Pop" Hanshue's Western Air Express and become the "central route" of Brown's three new Transcontinental Air Routes.

The airline's name became "Transcontinental and Western Air" (TWA). Many years later the airline became "Trans World Airlines" (TWA). By Denver UAHF volunteer, Marvin Berryman
