### UNITED LAUNCHES ADDITIONAL WASHINGTON DULLES - SAO PAULO FLIGHT

Beginning Oct. 31, 2005, United is scheduled to offer customers additional daily nonstop service between our hub at Washington Dulles International Airport & Varig's hub, Sao Paulo Guarulhos International Airport in Brazil.

Our service expansion builds on the success of our existing daily flight to Sao Paulo from Dulles. Varig & the Star Alliance network enable us to meet a growing demand for our award-winning service among our

business, government & leisure customers traveling to & from Brazil.

Both Washington Dulles-Sao Paulo flights are timed to maximize convenience & connections at both Washington Dulles & Sao Paulo; will be operated with B767-300 aircraft, configured with 10 United First seats, 32 United Business seats, 71 seats in Economy Plus & 80 seats in United Economy.

Flight 825 leaves Washington Dulles 6:30 p.m. daily, arrives in Sao Paulo 7:05 a.m. the next day. Flight 824 departs Sao Paulo daily 12:25 a.m., arrives in Washington 7:20 a.m.

### **UNITED ANNOUNCES FLIGHT ATTENDANT RECALL**

United will recall an additional 500 flight attendants early from voluntary furlough, in response to a projected increase in load factors & to offset flight attendant attrition.

We're pleased to welcome back these returning flight attendants who will be joining their colleagues in continuing to provide outstanding service to our customers.

250 of this group will be recalled effective July 25, 2005, & 250 will return effective Aug. 8, 2005.

This group of 500 flight attendants is in addition to the 500 recalled last month & scheduled to return in June & July.

Presently, there are no United flight attendants on involuntary furlough.

### **UNITED TO EXPAND BUY ON BOARD PROGRAM**

Effective June 7, 2005, United will expand its buy on board program. Snack boxes, & restaurant-quality fresh sandwiches & salads will replace complimentary meals on United's transcontinental flights (other than the premium p.s. service), flights between the West Coast & HWI, all other domestic flights greater than 5 hours departing prior to 8:00 p.m., plus flights to & from the Caribbean & Mexico.

This change provides variety for our customers and is a smart business move for United. Customers aboard these flights will have more choices at an attractive & competitive price -- they can choose from a fresh sandwich or salad, plus

four different snack boxes containing 6 to 8 nonperishable, individually wrapped, brand-name products. Each offering will cost \$5. The snack box & fresh product offerings also reduce United's food costs.

On April 3, United replaced the buy on board salad & sandwich offerings with the snack box collection on mainline flights between 3½ & 5 hours. The popular snack boxes premiered on Ted in Oct. 2004 under the TedSelect name & are available on all Ted flights with travel times longer than 2½ hours.

### **ENHANCED CURBSIDE SERVICE IN TEST PROGRAM**

As part of its system wide examination of business practices to seek cost savings & improve customer service, United has been testing the idea of charging a two-dollar-per-bag fee for curbside check-in.

The fee is meant not as a revenue generator, but to save costs incurred by current curbside practices, as well as help shorten increasingly long lines in the lobby by providing more choices at the curb.

United receives only a fraction of the fee to maintain podiums & curbside equipment; the majority goes to the SkyCap vendor. By allowing the vendor to charge this fee, United eliminates its own multi-million dollar cost for SkyCap vendors. These companies have a greater incentive to increase service levels.

Though the small fee is intended in lieu of a gratuity for SkyCap service, customers are welcome to tip in addition to the fee.

The "Check and Go" program improves service for our customers overall; it enables those who use it to proceed directly from the curb to security, which can shorten the wait time.

### **ALLIANT CREDIT UNION OFFERS \$10,000 IN COLLEGE SCHOLARSHIPS**

Alliant Credit Union will award five, \$2,000 scholarships to members as part of its 3<sup>rd</sup> annual Members Scholarship Program. To apply, students must be Alliant members in good standing, also be enrolled for the fall 2005 semester in an accredited undergraduate program at a college, university or vocational/technical institution. The application deadline is June 30, 2005.

Providing scholarships for college-bound members is just one way the Chicago-based credit union is trying to help students (& their parents) meet the demands of increasing college tuition costs. A staunch advocate of youth financial literacy, Alliant this year implemented a “Banking on Our Future” program that sends teacher-volunteers into local schools on behalf of partner Operation HOPE, Inc.

Alliant offers one of the highest savings dividends in the country - as well as some of the lowest loan rates possible - so becoming a member is certainly beneficial to those working toward their education, explains David Mooney, Alliant President & CEO. As part of our “return-to-the-member” philosophy, this program allows students to apply for scholarship money to defer their tuition expenses.

To qualify for the Members Scholarship Program, the student must:

- **Join Alliant Credit Union** by completing a *Membership Enrollment Agreement* available online at [www.alliantcreditunion.org](http://www.alliantcreditunion.org), or by calling 800-328-1935 (*Mon. - Fri., 7:00 a.m. - 7:00 p.m. Central Time*).
- **Apply or enroll in an accredited undergraduate program** at a college, university, or vocational/technical institution (minimum 12 credit hours per semester) during the fall semester of 2005. (Graduate programs do not qualify.)
- **Complete required paperwork**, including a Members Scholarship Application, a 100-word statement of personal goals, & a 250-word essay on the topic, “What Does Belonging to Alliant Credit Union Mean to Me?” Also required is a list & description of the applicant’s community involvement/activities, accompanied by an official copy of high school or college transcript (whichever applicable).

Applications & paperwork must be postmarked to Alliant Credit Union by Thurs. June 30, 2005. A selection committee will begin the review process on July 1; will notify the winners by July 30. Alliant Credit Union employees, board of directors, scholarship committee members & their family members of the same household are not eligible. **NRSA TRAVEL POLICY REMINDERS**

As the busy summer travel season draws near, we offer these travel policy reminders for retired travelers:

- Listings must be made prior to arrival at the airport for all non-revenue space-available pleasure travel. Use Apollo, WebList, or 1-800-UAL-LSIT to make your listings at least 4 hours before domestic flights & 12 hours before international flights.
- After listing for NRSA travel, check in for your flight using EasyCheck-In Online, EasyCheck-In kiosks or curbside check-in.

Check-in for U.S. domestic trips can be done using EasyCheck-In Online up to 24 hours in advance of scheduled departure at [www.united.com/employeetravel](http://www.united.com/employeetravel) on a computer with an Internet connection & a printer. In order to use EasyCheck-In Online, the initial listing must have been created by the retiree.

Check-in for both U.S. domestic & international travel can be done using EasyCheck-

In kiosks, regardless of who created the initial listing, as long as the PNR is authorized for travel.

NRSA travelers with bags also can check in using EasyCheck-In Curbside SkyCap service at 82 U.S. domestic United and United Express locations.

Once again we headed for a busy May with the Loonies in Mackinaw City & the convention in Hollywood. Hope to see ya all there...

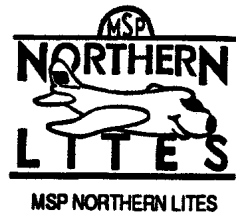

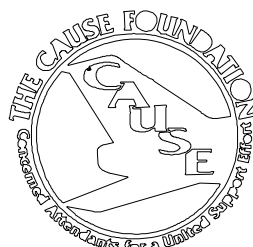
It was a good life for me & my family. I am so sorry to see the present state of our company; can only hope that we survive as a company that prospers once again.
