


#### RUAEA WEBSITE ACCESS IN 4 SIMPLE STEPS

For those RUAEA members who haven't as yet utilized the RUAEA website, it offers you many additional features, in addition to the RUAEA Newsletter that you are currently receiving. And if you desire, instead of receiving your RUAEA newsletter via US Mail, you may obtain it early online and have online access to previous versions of the newsletter.

The website offers Travel Desk information, along with 16 Different Travel Links. In addition, Special Interest Links have been set up for 12 different Retiree Categories with over 21 separate areas of interest. Come check them out! Of course, there are Online Convention Information and Online RUAEA Election Voting. All of the website features are available to you at no additional cost.

- → If you wish to continue receiving your Newsletter by US Mail and want to utilize the additional website features, choose <u>Level 2</u>.
- → If you wish to receive the Newsletter online and want to utilize the additional website features, choose Level 3.

To take advantage of the website and all of its features, merely type **www.ruaea.org** into your web browser. First time visitors to the RUAEA website will see the following on their screen:



From there, one can access limited portions of the website, and may sign up for access to the many website features.

- Step A. On the second paragraph, click on ".... Please click here ..."
- **Step B**. The user is then presented with a screen where they are given an introduction to the 2 Levels of access and their respective features. They then can choose to request either **Level 2**, or **Level 3** access.



**Step C.** Next, the user is presented with a screen that is used to verify that they are a RUAEA member in good standing. They must enter their **Last Name**, **Zip Code** and **E-Mail Address** in the appropriate boxes.



**Step D**. After the information is properly verified, the member is asked to provide a User Name and a Password to complete the signup process.

Finally a confirmation screen appears indicating that the sign up process was successful. Confirmation e-mail is then created when this screen appears and is mailed to the member with their user name and password. The member should retain that e-mail for future reference with regards to their username and password.

#### ASK THE DOCTOR - A VITAMIN A DAY KEEPS ...?

In the 25 years I was the Regional Flight Surgeon for United at Los Angeles, I encountered many employee/patients who consumed large amounts of various vitamins and supplements each day. Each of them had they own "cocktail" of pills, capsules, and extracts that presumably made them and kept them healthy. Yet, I often found that these same employees had poor sick leave records, several occupational medical problems, and often applied for FMLA for personal medical conditions. How could this happen if the large numbers of supplements were to keep them healthy? Here are some thoughts I have about the voluminous number of supplements that fill the shelves of Health Food Stores, Nutrition Centers, as well as discount warehouses and our neighborhood grocery stores.

First, let me stress that maintaining a balanced diet of carbohydrates, protein, and fat will satisfy the nutritional needs for most people. Low fat, unsaturated fat, elimination of trans fat, green vegetables, lean meats, fresh fish, and an adequate amount of water each day will eliminate the need for most of the supplements we see on store shelves. Of course, many of us have special needs because of medical conditions. Allergies, certain intolerances, and existing medical conditions will necessitate advice from your physician. Most of us, however, can follow the Center for Disease Control, American Hearth Association, American Diabetes Association, American Dietetic Association guidelines & lead a healthy life, without the added costs of supplements & vitamins. The problem is we don't comply with the guidelines on a 24/7 basis. All too often, patients tell me they are starting a certain diet for Lent, for a New Year's resolution, before summer, etc. In reality, we are on a "diet" each day of our lives. Whether it is the best diet for us is the key question. Assuming we follow a balanced diet each day, what supplements and/or vitamins are important?

Assuming you have no allergies or other contraindications, **ASPIRIN**, 81mg, per day is essential. This amazing all-purpose wonder drug has proven to lower the risk of stroke and heart attack. It lowers the risk of blood clots that can move through vessels in the legs to the lungs. Without a doubt, a valuable and vital daily supplement.

To protect and assist in joint health, **GLUCOSAMINE** and **CHRONDROITIN** at maximum strength have been associated with helping alleviate joint disorders. It does <u>NOT</u> cure arthritis or prevent it. It seems to be associated with overall joint health. For those of you with proven arthritis, they will probably give limited help. For the vast majority of us that have typical arthritis normally associated with aging, they may help.

For your eyes, the choice recommended is **LUTEIN**. There is some research to suggest that Lutein has a beneficial effect on the retina of the eye. The scourge of aging for the eye is macular degeneration (MD). There is no agreement about the cause of MD. There is no cure. The treatment is expensive, intimidating, and not guaranteed. Lutein may have some benefit in nourishing the retina and thus delaying or protecting against MD. This vitamin is available in several over-the-counter preparations. *Ocuvite* and *I-Caps* are two of the more popular brands.

For men, **SAW PALMETTO** may have some benefit for the prostate. With aging, the prostate gradually enlarges with varying effects. For some men, there is minimal interference with normal urinary and/or sexual func-

tion. For others, the enlarging prostate causes many difficulties that create embarrassment, urinary disorders, and frequent visits to the doctor. There is some indication that Saw Palmetto may have a favorable effect on the prostate by slowing its growth and delaying the complications, a rapid enlargement can cause.

For women, the fear of osteoporosis is very real. Most medical providers believe that the common incident of an elderly woman falling and breaking her hip is NOT what really happens. A lot of us believe, the hip breaks because of osteoporosis and then the woman falls. What can we do about osteoporosis? First, have a bone density study to determine if there is a problem. After that, follow the recommendation of your physician about the next step. If your doctor says everything is fine, you may want to consider taking something as simple as over-the-counter **TUMS**. Believe it or not, *Tums* has a high concentration of calcium and helps nourish our bones. Proper exercise will also be of benefit to the bones.

Finally, if you are over 50 years of age, a good **MULTI-VITAMIN** is a good choice. A multi-vitamin is the best way to make up for any dietary deficiencies we might have. The choice of a vitamin for seniors is wide open. Centrum Silver comes to mind, but there are several others that are equally as good for much less money.

There they are. Not many to choose. Very reasonable in price when choosing a generic equivalent. Just remember, these are SUPPLEMENTS, not replacements. The foundation of our daily life MUST be a balanced diet with regular exercise. I strongly advise AGAINST taking multiple types of the huge selection of OTC preparations available. If we eat properly, we can save money, maintain a healthier lifestyle, and truly enjoy our well-earned retirement.

#### **MEDCO COVERS SHINGLES SHOTS**

Medco covers the shingles vaccine **Zostavax** when obtained at a store pharmacy such as in a grocery store or drug store whose computer system is linked to Medco. It won't be covered for shots received in your doctor's office. There is a \$34.11 co-pay and you will probably also have to pay the administration fee of \$20-30. This is new and most pharmacies are unfamiliar with the Medco program, so show your BlueCross BlueShield/Medco insurance card and ask them to check in the computer for the coverage and find out how much out-of-pocket you will have to pay.

#### LET MEDCO HELP YOU SAVE ON INSULIN AND ANTIDEPRESSANTS

You may be aware that your prescription drug benefit, managed by Medco, already has a set limit on the number of times you can receive coverage for long-term medications (such as those used to treat high blood pressure or high cholesterol) when you purchase them at a participating retail pharmacy. As of May 1, 2008, this limit will also apply to antidepressants (such as *Cymbalta*<sup>®</sup>, *Paxil CR*<sup>®</sup>, and *Zoloft*<sup>®</sup>) and insulin (medications only, not supplies). Here is what you need to remember:

- The first three times you purchase an antidepressant or insulin at a participating retail pharmacy, you will pay your participating pharmacy coinsurance. After that, you will pay the entire cost of each long-term medication unless you choose to order through **Medco By Mail**.\*
  - (\*) If a retail pharmacy's cash price is lower than your retail coinsurance amount, your cost will not exceed the cash price regardless of the number of fills purchased at retail. In some circumstances, this price may be less than either your standard retail coinsurance amount or mail co-payment.

To save money on antidepressants, insulin, and other long-term medications, use Medco By Mail, your mail-order pharmacy, and pay just your mail-order copayment for typically up to a 90-day supply. Your medications will be delivered right to you, and standard shipping is free.

Please be assured that **Medco By Mail** has extensive experience in delivering temperature-sensitive medications (such as insulin) through the mail. Medications that are sensitive to extreme heat or cold are shipped in special packaging designed to keep the contents at the correct temperature throughout the delivery process. Additionally, Medco will expedite the shipment of temperature-sensitive medications to you at no additional cost.

There are two easy ways to start saving with Medco By Mail:

- 1. *By mail*: Ask your doctor for a new prescription for up to a 90-day supply, plus refills for up to 1 year (if appropriate).

  Mail the new prescription using the order form
  - Mail the new prescription using the order form available on www.medco.com.
- 2. *By phone*: Call Medco directly at 1-800-864-1425 and a representative will take care of the rest. With your approval, we'll contact your doctor to make arrangements to get your new 90-day prescription through mail order.

Your medication will usually arrive within 8 days after Medco receives your order. If we speak to your doctor and ask him or her to fax the prescription, you

will be billed later. Please make sure you have a 2-week supply of medication on hand while waiting for your new medication to arrive. If necessary, ask your doctor for a 14-day prescription that you can fill at a participating retail pharmacy. Once you get started, you can request refills easily online, by mail, or by phone.

You can also call Member Services toll-free at the number on your prescription drug ID card.

Headquartered in Japan, ANA is the country's second largest international carrier and the country's largest domestic airline with services throughout Asia, Oceania, North America and Europe.

ZED fares are an interline fare program used by many carriers worldwide for space-available travel, replacing industry discount (ID) 90/95 fares for interline travel on specific carriers. ZED pricing simplifies and significantly reduces the cost of non-revenue, space-available interline pleasure travel.

Beginning May 5, United added Star Alliance partner and founding member Scandinavian Airlines (SAS) to its portfolio of employee offline travel privileges. SAS is the multi-national airline for Denmark, Norway

and Sweden, operating services throughout Scandinavia, North America and Asia. In the case of SAS, United has signed an agreement that offers fares in both economy and business class.

United is constantly increasing the number of employee/retiree travel partnerships as well as making enhancements to existing agreements to ensure its Employee/Retiree Offline Travel Privilege Program remains competitive and brings value to employees/retirees for leisure travel.

#### <u>UNITED ANNOUNCES PLANS TO LAUNCH</u> NONSTOP SERVICE TO DUBAI & MOSCOW

We plan to tap into two thriving economies with new daily passenger and cargo service to Dubai (**DXB**) and Moscow (**DME**) from our Washington Dulles (**IAD**) hub. Pending government approvals, United plans to begin both of the services on October 26. The aircraft to fly the Dubai and Moscow services will be available as a result of our decision to delay our San Francisco-Guangzhou service, as well as our seasonal schedule changes.

Dubai, a key Middle East trade port, real estate haven and major world hub for IT and financial services, will become the second, fast-emerging Middle Eastern city United serves. In October 2006, we launched three weekly flights between Washington Dulles and Kuwait, and in December 2007 we increased this schedule to daily service.

Service to Moscow, Russia's prime financial, scientific and cultural center, will mark our fifth new capital-to-capital service in the last two years, bringing the total to 12.

With our first-ever flights to Dubai and Moscow, our Washington Dulles hub now will serve 24 international destinations, including five that began operating in the past two years: Beijing, Kuwait, Rio de Janeiro (seasonal service restarts in September), Rome and Tokyo. Washington Dulles also offers customers traveling from Dubai and Moscow onward connecting service to 88 destinations in the US, Canada and the Caribbean.

The proposed schedules are:

- → United Flight 976 (Boeing 777) departs IAD 10:02 PM and arrives at DXB 6:50 PM (\*) the following day. United Flight 977 (Boeing 777) departs DXB at 11:30 PM (\*) and arrives at IAD 6:44 AM.
- → United Flight 964 (Boeing 767) departs IAD

4:45 PM and arrives at DME 9:30 AM (\*) the following day. United Flight 965 (Boeing 767) departs DME at 11:20 AM (\*) and arrives at IAD 3:35 PM.

All routes and frequencies are subject to change. (\*) Scheduled departure times are for October 26 - November 1. US Daylight Saving Time ends on November 2, and flight times will adjust accordingly.

Both aircraft will undergo United's multi-million-dollar product enhancement that brings to United First and United Business true flat-bed seats, on-demand entertainment and other spruced-up amenities that create the optimal space to work, sleep or relax while traveling to Dubai for approximately 13 hours and Moscow for approximately 10 hours. United remains the only U.S. airline to offer customers a choice of four different seating sections - United First, United Business, Economy Plus and Economy.

The new route is expected to serve as an important cargo entryway for the Middle East region's high demand for petrochemical, construction and consumer goods and for Russia's growing demand for industrial and consumer commodities. Mail also is expected to represent a significant amount of cargo volume on these flights.

#### YOU CAN NOW RESET YOUR OWN SKYNET PASSWORD

Starting April 28, you are now able to reset or change your SkyNet password without having to call the Service Desk.

The new password management tool gives you more control over your password, while adding security to SkyNet's important applications and information. To use the password tool, follow these four steps:

- 1. Log into SkyNet. Go to the password management tool through the <u>Change Password</u> link under Quick Hits on the homepage.
- Click on the link for "Change Answers to Authentication Questions". This opens a list of 20 security questions choose four of them as your "challenge" questions.
- 3. Type in the answers to your four challenge questions and click on the "Save" button at the bottom of the screen. Once registered, you will be taken to a separate screen to validate your questions and click on "OK".
- 4. Next, you'll be asked to change your password. Type in your new password and confirm it by retyping the new password. Click on the "Change Password" button. This will now be your SkyNet password for the next 90 days.

If You Forget Your Password - Once you have com-

pleted these steps, you can choose to reset your password or change answers to your challenge questions at any time by using the Change Password link on SkyNet. If you forget your password:

- → Enter your user ID on the SkyNet log-in page and click on the "Forgot Your Password?" link.
- You will be asked to answer the four challenge questions that you selected in the password management tool. If you answer all four questions correctly, your password will be reset.

If you have forgotten your SkyNet password and have not yet answered your four challenge questions, you will need to call the Service Desk to reset your password.

You cannot use the password tool to reset a forgotten password until you answer at least four challenge questions.

When you log in with your new temporary password from the Service Desk, you will automatically be redirected to the password management tool to answer your challenge questions and reset your password.

#### UNITED & FEDEX DONATED RETIRED DC-10 AIRCRAFT TO ORBIS INTERNATIONAL

On April 7, United celebrated its 25-year partnership with ORBIS International and reaffirmed our commitment to ORBIS' future success. United, in partnership with FedEx, donated a DC-10 aircraft to enable ORBIS to continue its important mission well into the future.

ORBIS International, a nonprofit humanitarian organization, strives to eliminate avoidable blindness and restore sight in developing countries. According to the World Health Organization:

- → 37 million people worldwide are blind, and 90 percent of the blind live in developing countries
- → 1.4 million children under the age of 15 are blind
- → 75 percent of blindness is treatable and/or preventable

United donated the first plane to ORBIS, a DC-8 aircraft, which was subsequently converted to a fully-equipped teaching hospital. Since its first flight in 1982, ORBIS has treated more than 6.8 million people, trained 195,000 medical professionals, and flown over 900 programs in 86 countries.

United has been there every step of the way with sponsorship over the years through the United Airlines Foundation and with more than 300 employees or retirees who have volunteered in support of ORBIS programs. A United employee or retiree has supported practically every single ORBIS program.

The DC-10 aircraft, which United retired in 2001, will be converted into the next generation, state-of-the-art Flying Eye Hospital. The ORBIS founders - who originally approached United CEO Ed Carlson in the 1970s for their first plane donation - attended the celebration on April 7 at HDQ to mark this historic and continuing partnership.

"At United, we work to support the communities in which our employees live and work," says Pete McDonald, executive vice president and chief operating officer. "ORBIS represents the best that aviation, and people, can achieve for humankind. That is why we are so proud to partner with them."

#### **TRAVEL TIPS BY BOB**

This may have happened to you.

Upon arriving at your destination and obtaining your luggage, you notice something is wrong. The TSA approved locks are open or broken, the zippers are damaged beyond repair and there are all the signs present that your luggage is not intact. Upon closer scrutiny, you discover your suspicions are correct. Your luggage has been pilfered and some items that are near and dear to you may or may not be missing. You are very upset and wonder how this could happen! You report it to the Baggage Claim people, fill out the lost/damaged baggage forms and submit them. If you are fortunate, you get reimbursed for the damage and in some cases, for the missing items. The problem is that this incident seems to quietly get covered up and it continues to happen.

If this happens to you, you are being asked to help attack the problem and hopefully put an end to it. We should understand that we are not talking about accidental damage or a bag that just mistakenly gets misplaced. This is about what appears to be premeditated, unauthorized entry into luggage resulting in the damage to TSA approved locks, zippers being damaged beyond repair, your privacy being trampled and possibly items stolen. This problem is not peculiar to any one airline, it is happening on all of them. It is unknown if this problem is with TSA, Customs, FAA, airline personal or a combination. It could be happening in bag transfer areas by handling vendors. But, the point of my article is that we should understand that we have avenues of recourse that may help.

If this happens to you, your first stop should be to

the baggage claim department of the carrier that you traveled on. Fill out the required paperwork, submit it but don't stop there. This problem needs to be reported to a higher level than baggage claim. It needs to go up the chain to the top. I suggest you report/write to a number of agencies, including:

- The airline/s you were traveling on when the problem occurred. Your complaint should be in writing (with particulars) and addressed to the appropriate department i.e., VP of Baggage Services and etc.
- → Send copies to The Department of Transportation (FAA), US Customs Service, if applicable, TSA, Airport Authority/Management, where the problem occurred and don't forget your Senators and Representatives.

**Emails seem ineffective.** Signed letters are the most effective, because it lets the recipient know you are passionate enough about the complaint to take the time to personally address the problem. Always request a response. The response can be used to continue addressing the problem up the ladder. Also your complaint letter should have a reasonable solution/request to help prevent the problem. It could be something as simple as providing adequate security to assure the proper handling of your luggage.

I'm confident that if enough pressure is applied to the airlines, government agencies and politicians we'll see some changes. Just filing the initial complaint and not pursuing it up the ladder will not get the job done. This problem has to be raised to higher levels!

Norwood was included in "Black Wings", a permanent exhibit at the Smithsonian Institution, and his name is painted on a United Airlines aircraft displayed at Chicago's Museum of Science and Industry. Norwood has received numerous awards from his alma mater, SIUC, and was on the school's Board of Trustees for 27 years.

"The Statement of Purpose is to honor individuals whose contributions to the betterment of mankind have been accomplished in or on behalf of the State of Illinois, or, whose achievements have brought honor to the state because of their identity with it, whether by birth or residence, or by their dedication to those principles of democracy and humanity as exemplified by the great Illinoisan whose name we bear."

We heard President **Jim Zarek** got an early birth-day present from his wife, **Rita**. On May 17<sup>th</sup>, he went for a ride in a World War II B25 bomber aircraft, out at Falcon Field in Mesa. We'll look forward to hearing his story about that ride.

We sang a hearty congratulations to **Mattie** & **Marge Matschinegg** for 44 years of wedded bliss.



of-Lights", the prop display was "displaced" by a concession stand. It was then moved to a Chicago warehouse and left completely uncovered for several years.

Following **Jerry Baxley**'s "rescue" from the warehouse it was returned to SFOMC. **Eric Driggs** and **Gary Young** worked for weeks sanding and polishing the blades, removing the "etched-in bird-droppings". The tips were painted red, white & blue, "Hamilton Standard" decals applied and the stand was repainted.

**Peter Lopez**, **Eric Driggs** and **Gary Young** then set-up the display at the SFO Domestic Terminal, the SFO International Terminal, the SFO Maintenance Base and also at the Hiller Museum.

After the display had "run-its-course", **Jerry Baxley** and **Ron Utecht** decided to remove the stand and hang the prop in the main-entrance stairwell at SFOMC.

**9/11 happened!** ... The DC-6 propeller again went into storage. The blades and the hub were boxed-up and shipped to Chicago. **Barbara Hanson** wanted to mount the prop on a WHQ wall, but **Chapter 11 was filed** ... and the prop was placed in the WHQ basement.

In 2007, the efforts of **Barbara Hanson** and **Tom Goodyear** brought the propeller to Denver and now into the DENTK cafeteria.

#### <u>The DC-6 Propeller</u> <u>Display history</u>:

In the early 1970s, a new Supervisor-of-Stores at the SFO Maintenance noticed this propeller among a half-dozen unserviceable propellers in an engine test-cell room. He asked Plant Maintenance to construct a stand for it.

WHQ heard of the DC-6 propeller and requested it be sent to Chicago. Following a few years in the Chicago O'Hare "TunnelCheck your mailing label for Renewal Information
