Letter From The President

The internet and email are wonderful tools but can also be a detriment. It is an efficient way to communicate with others, but rumors and other misinformation can spread like wildfire. This has been quite evident with the newly announced Pass Travel Program. From the first inklings that a new “combined” program was in the works, opinions hit the cyber-airways. The infamous Travel

Survey only fueled the fire. Finally, the outline of the new program was released and now there is more frustration than anything else moving about cyberspace.

In the meantime, RUAEA along with the other major retiree organizations, RUPA, ARECA and the Golden Eagles have sent a response to the company looking for improvements to the program to become effective in January 2012. There are many issues but we, at this time, focused on additional vacation passes, an option for retirees to choose either the Enrolled Friends or Buddy Passes, Date of Hire (seniority) for boarding, combining employees and retirees in group B and continued pass benefits to surviving spouses. The Retired AFA and Retired IAM are also supporting these improvements and have submitted their response.

There is a group calling themselves United Retiree for Action, they are asking for signatures on a petition to the company for changes to the announced program. The retiree organizations have not endorsed this action since we have already submitted our response to the company which is essentially what they are covering in their petition. It is believed that they have over 4,500 signatures so far.

Then we have Jeff Smisek at a recent employee meeting in San Francisco who stated, when asked about the new Pass Travel Program, that he has not had as much mail about the program as he expected and that it seems that most are satisfied with the new program. We have no way of knowing how much mail or email he has received or for that matter, any other executive of the company. He did say that change is always possible.

During the first week of May, the company has started posting answers to inquiries to questions submitted via mypasstravel@united.com. You will find this information on SkyNet on the left side of the screen un-

der Travel Tools and then Questions and Answers. The company has seen fit to post a Disclaimer which reads as follows: *“United’s pass travel policy is a privilege and is not a right of employment. The terms of the policy are subject to modification or termination, in whole or in part, by the Company at any time and for any reason.”*

Many folks are looking for an immediate response and action from the company on these issues. From the tone of the Disclaimer that is not likely to happen. In spite of Jeff Smisek’s claim that he hasn’t seen much reaction to the new program, many of his subordinates have seen reaction from the organized retiree groups: RUAEA, RUPA, RAFA, ARECA and the Golden Eagles, as well numerous individuals. And the unstated message by the new United management is be quiet and accept what has been announced. I don’t think this is going to happen and there still are six to seven months before the program becomes effective.

B737-900ER with Boeing Sky Interior makes first revenue flight

United's first Next-Gen 737-900ER with the Boeing Sky Interior made its first revenue flight on May 3rd. Aircraft 445 departed Orlando (MCO) operating as Flight 687 at 3:04 p.m. and arrived in IAH at 4:30 p.m.

United is the first U.S. airline to operate both the B737-800 and B737-900ER aircraft featuring the new



interior. All future deliveries of Next-Gen Boeing 737s will feature the Boeing Sky Interior. The Boeing Sky Interior is inspired by the 787, and features a quieter cabin with improved ventilation, touch-screen flight attendant panels and controls, energy-efficient LED lighting, and larger overhead bins that retract into the ceiling. That allows UAL to accommodate more bags than before, while the bins take up less space in the cabin.

The B737-900ER is the sixth aircraft delivered to United following the merger close. United currently has 33 of this type – the second-largest -900ER fleet in the world.

This airplane is suited to transcontinental markets because it has one of the lowest fuel burns per mile in United's narrowbody fleet.

UA launches United Cruises



UA recently launched United Cruises, a service that enables its customers to book cruise travel online and earn Mileage Plus miles. Customers may book travel on 19

different cruise lines to destinations worldwide, including the Caribbean, Bahamas, Alaska, Europe, Mexico and Bermuda. CO offers customers a similar service, continental.com Cruises, in which travelers may earn and redeem miles for cruise travel.

Through united.com and continental.com, customers can now book cruises along with air, car and hotel needs. In addition to driving traffic to its website, United Cruises further expands the way United's customers can earn miles, an additional revenue source for the company.

DOT expands long tarmac delay ban, announces other changes



On April 20, Secretary Ray LaHood said the Department of Transportation (DOT) will expand the ban on lengthy tarmac delays to include non-U.S. airlines and that a four-hour tarmac delay limit will apply to all international flights from U.S. airports.

In addition, the DOT announced airlines will have to reimburse passengers for bag fees if the bags are lost

and to increase compensation to passengers involuntarily bumped from flights, doubling it in some cases. Airlines also will have to disclose via their websites all potential fees to customers - including fees for baggage, meals, canceling or changing reservations, advance seating, upgrades and any government taxes and fees.

The DOT also announced a number of changes to bookings. It will require airlines to allow customers to hold reservations at the quoted fare without payment, or cancel them without penalty, for at least 24 hours after a reservation is made, if the reservation is made at least one week prior to departure. The changes will go into effect this August.

Hedging and other strategies help United deal with high fuel prices



High fuel prices in the first quarter largely offset United's year-over-year revenue improvement. Excluding the impact of United's hedges, the consolidated fuel costs increased 34.5 percent, or \$725 million, year-over-year on a pro forma basis. Even when United includes the \$154 million benefit of its fuel hedges, the fuel costs in the quarter were still 28.4 percent higher than in the first quarter of 2010 on a pro forma basis.

Looking ahead, United has approximately 58 percent of its second-quarter fuel consumption hedged at an average jet fuel equivalent price of 114 dollars per barrel and approximately 36 percent of its fuel consumption in the second half of 2011 hedged at an average jet fuel equivalent price of 125 dollars per barrel.

United has a number of tools to use to combat high and volatile fuel prices. The new, combined network helps the company run its business successfully. It is global and globally diverse. United has broad presence in the Atlantic, Pacific and Latin markets, which allows the company to best fit the current and expected demand in each market. United also runs its business with the business traveler in mind, and its business travel mix provides more stable demand, even in times of rising fares. United also has some of the best partners in the business with its joint ventures across the Atlantic and Pacific and in the Star Alliance.

United is making changes in the operation, as well. When and where it can, it's using ground power rather than auxiliary power units (APU) to power the aircraft, and early results show the company can save about 200,000 gallons of jet fuel per month, or 7.5 million gallons per year when it fully implements its APU initiatives. United also continues to invest in fleet-related fuel savings initiatives, placing winglets on additional

aircraft, adding performance improvement packages on the UA Boeing 777s and taking delivery of new, more fuel-efficient aircraft. United expects to take delivery of its first 787 Dreamliner in the first half of next year, which will be substantially more fuel-efficient than the current-generation widebodies.

United Continental Holdings announces first-quarter results



United Continental Holdings, Inc. (UAL), the parent holding company of UA and CO, announced first-quarter 2011 financial results on April 21st. Prior to the merger on

Oct. 1, 2010, UAL results included only the financial results of UA. Pro forma results that consolidate the financial results for CO for first-quarter 2010 are included for meaningful year-over-year comparisons.

UAL reported a first-quarter net loss of \$136 million, excluding \$77 million of special charges consisting primarily of integration-related costs. This was an improvement of \$47 million compared to the pro forma results year-over-year. On a GAAP (generally accepted accounting principles) basis, UAL reported a first-quarter net loss of \$213 million.

UAL consolidated passenger revenue increased 11.5 percent in the first quarter of 2011 compared to the pro forma results for the same period in 2010. First-quarter 2011 consolidated passenger revenue per available seat mile increased 9.9 percent compared to the pro forma results year-over-year.

Rising fuel prices largely offset the improvement in revenue. UAL's first-quarter consolidated fuel expense, excluding the impact of hedges, increased 34.5 percent, or \$725 million, year-over-year on a pro forma basis.

Employees of the combined company earned cash incentive payments for operational performance totaling \$18 million during the first quarter of 2011.

United announces Pacific aircraft gauge optimization



United's global network provides opportunities to utilize its aircraft to support growth in its business. In the Micronesia market, United is adding new markets and putting

larger aircraft on routes between Guam (GUM) and the mainline United States.

As part of its fall schedule, United plans to operate a UA Boeing 777 on daily service between Honolulu

(HNL) and GUM, and between GUM and Tokyo Narita (NRT) in place of CO B767 service. This will provide additional capacity the market needs and more first class seats for its premium customers.

United also plans to begin new, four-times-a-week CO B737 service this fall between GUM and Okinawa (OKA), Japan, as well as daily CO B737 service between NRT and Hong Kong (HKG).

Below is a summary of the changes, pending government approval, which are effective on the dates shown:

- ➔ Effective September 28, GUM will add four-times-a-week roundtrip service in the GUM-OKA market operated with CO B737 equipment.
- ➔ Effective October 30, NRT will add daily roundtrip service in the NRT-HKG market operated with CO B737 equipment.
- ➔ Effective October 30, HKG will replace daily UA B747 service in the HKG-Ho Chi Minh City (SGN), Vietnam market with CO B737 equipment.
- ➔ Effective October 30, HKG will replace daily UA B747 service in the HKG-Singapore (SIN) market with CO B737 equipment

NMB ruling clears way for determination on stock clerk representation

The U.S. National Mediation Board (NMB) announced April 20th that United has created a single transportation system for the purposes of representation with stock clerks. This begins the process for the NMB to determine whether to conduct an election to resolve union representation.

Currently, the International Association of Machinists and Aerospace Workers (IAM) represents subsidiary UA storekeepers, and the subsidiary CO stock clerks are not represented by a union.

Technical Operations tells its story at MRO conference



UA Technical Operations debuted its new name and branding at the largest Maintenance, Repair and Overhaul (MRO) convention in North America in April, in Miami.

Supply Chain and Sales Managing Director Paul Lochab said, *"The strength of our network, the location of our maintenance facilities and the expertise of our technicians and engineers make a great package that we can offer to third-party customers seeking line maintenance, global emergency maintenance and select other MRO services."*

Technical Operations SVP Jim Keenan spoke to the audience of suppliers, vendors, original equipment manufacturers and regulators about the future of aviation maintenance and the importance of good relationships with airlines.

"Because of the merger, United Technical Operations has become one of the world's largest commercial airline customers of maintenance supplies and services. This gives United an opportunity to share its vision and shape the conversation about how good partner relationships with good business models, governance and customer service will benefit all stakeholders, including the airlines, the suppliers and the flying public."

UA wins accolades for China services

Travel Trade Gazette China (TTG China) recently named UA "Best American Airline." Now in their fourth year, TTG China Awards recognize China's best travel and tourism organizations as determined by votes cast by 32,000 industry professionals.

In addition, Travel Trade Gazette Asia (TTG Asia) has named UA "Best North American Airline" in each of the past 11 years (2000-2010).

"We are honored to have been recognized again for our efforts to ensure an outstanding travel experience for our customers," said China and Korea Managing Director Wally Dias.

United has served China for 25 years and offers more non-stop flights to the U.S. than any other airline. United is adding daily non-stop service between LAX and Shanghai (PVG) starting May 20.

CO and UA Flight Operations co-locate at LAX



Starting May 3rd, Flight Operations combined the subsidiary UA and CO operations at LAX, as more than a dozen CO pilots begin flying from a newly established, co-

located base at the airport. The move was facilitated by the Transition Agreement between the company and the Air Line Pilots Association.

CO previously announced the establishment of a Boeing 737 pilot base at LAX, and collaborative work between the two Flight Operations departments began immediately.

"We are excited for both groups and look forward to working with all LAX-based pilots and their respective flight management teams," CO System Chief Pilot Steve Arnold noted. Initially, CO pilots will operate two daily

flights, including Flight 3 to Honolulu (HNL) and Flight 40 to EWR. UA System Chief Pilot Curt Hughes and Steve were in LAX Tuesday for the start-up.

The current LAX UA Flight Management team will continue to provide support to UA pilots, and CO Flight Management staff are in place to support the newly assigned CO pilots. The LAX base will increase its CO pilot staffing to more than 60 by summer. Approximately 680 UA pilots are based at LAX.

Mileage Plus wins Best Elite-level Program

At the second annual Frequent Traveler Awards in New York in April, UA's Mileage Plus program took home top honors for best elite-level program in the Americas for the second year in a row. The Frequent Traveler Awards replaced the Freddie Awards last year as the leading industry award for airline and frequent flier programs.

Led by a group of volunteers from the FlyerTalk community, the Frequent Traveler Awards revived the Freddie's tradition of identifying the best frequent flyer and loyalty programs. This year, frequent flyers from around the world cast more than one million votes for their favorites.

United highlights new PVG-LAX service with media in Shanghai



United hosted a media roundtable in Shanghai, inviting 18 key Chinese journalists to a discussion about United's strong commitment to the China market, as exemplified by its new daily Shanghai (PVG)-LAX service. Currently, United operates three daily flights from PVG to SFO, ORD and EWR. This new LAX service will further strengthen its strong network from PVG to the US.

With a population of more than 22 million, Shanghai is China's most populous city and a major financial and commercial center. Earlier this month, the Civil Aviation Administration of China announced that China will build 56 airports in the next five years to expand the country's capacity, investing \$230 billion to handle an estimated 450 million total passengers a year.

Retro Airbus continues system tour

With a stop in CLE on April 12th, United's "Friend Ship" retro Airbus 320 has now visited all eight U.S. hubs and 10 North American mainline stations, from



Calgary, Alberta (YYC), Canada, to Orlando (MCO), Fla., since making its debut at ORD.

Co-workers, customers and aviation enthusiasts alike have been on hand at every stop to greet the 1970s paint job, which UA co-workers chose to mark the airline's 85th anniversary. United painted an A320 with the livery because it routes that fleet type to many different stations - and this plane is no exception.

At EWR April 11th, United handed out commemorative 85th anniversary posters and postcards to co-workers and customers who came to see the plane. An anniversary banner and balloons decorated the gate, and dozens of co-workers posed with the plane on the ramp.

"It was nice to recall our past and even better to be reminded of how we're going forward as one United," said Customer Service Managing Director Cathy Innocenti.

CLE hosted the Friend Ship at Gate C23 for about an hour, long enough for leaders to recognize co-workers celebrating milestone service anniversaries during gate-side festivities. United held similar events at other stops along the tour.

Ask The Doctor - The Most Dangerous Drug of Abuse In the World Today (Part III)

Now that we know who can be an alcoholic, the huge question for consideration now is what to do to help him/her. What should we do to identify and more importantly, treat them so that they may return to a truly functional individual in society?

First of all, there will be **total** failure if we approach the alcoholic one on one. I have first hand experience in this approach. While at LAXMD, I was fortunate enough to assist in the identification, evaluation, treatment, and rehabilitation of over 80 alcoholics. At one point during my 25 years, we intervened in as many as eight in one year. While talking to a psychiatrist friend of mine, he shared that he identified **three** alcoholics in the previous five years. I am **not** a psychiatrist, yet I was more successful than a well qualified mental health expert! How did that happen?

It is vital to remember that a practicing alcoholic is an expert manipulator, and is incredibly adept at denial. He/she is superior at divide and conquer, he/she is a

master planner of concealment, and he/she gets “on and off the wagon” on a whim. Given these traits, there will be no success in merely talking with them, reasoning with them, threatening them, pleading with them, etc. etc. So, what works?

The word for it is **intervention**. The process is effective but complicated, simple but intricate. It is the best way to confront the alcoholic (or any drug addict). It is the title of a popular television show on the A&E network. I strongly recommend viewing the show to see how effective the intervention process can be. Simply put, a skilled counselor assists the significant others of the alcoholic/addict in a confrontation that takes place as a total surprise to the alcoholic/addict. The significant others **may** include a spouse, children, siblings, parents, grandparents, religious contact, best friend(s), supervisor, physician, union representative, and/or EAP counselor. The only ones involved are those who have first hand information about the individual. The key words are **first hand** because second hand information is **not** useful in any way. The significant others present their first hand accounts in the form of a personally written letter. The information presented during the intervention is so powerful and emotional that an account presented from memory will fail and fail miserably. **All** the significant others have painful accounts of their own personal hell that the alcoholic/addict did which caused them emotional and sometimes physical pain.

The counselor meets with the significant others to discuss the behavior that requires the intervention in the first place. The counselor receives all the information and determines the most appropriate information to present, who will present it and in what order, and helps develop the plan for the surprise meeting. The counselor pre-arranges the treatment facility that will be used and the transportation to the facility. The counselor may also have to arrange for the safe accommodations for some of the significant others. The selection of the counselor is crucial to the success of the intervention.

The information presented at interventions must be given in a non-threatening loving manner that is factual, caring, but uncompromising in content. We call it tough love because the information comes from a loved one whom the alcoholic/addict has “injured” emotionally and/or physically. It is a very difficult situation for all concerned. None of the intervention group knows exactly how the alcoholic/addict will react. The information tells of gut-wrenching events that the addict did to the person presenting it. The story causes a huge outpouring of emotion in the presenter and the alcoholic/addict. Usually, the last presenter has the most devastating information and most always breaks the resistance of the addict. Specifically, the alcoholic/addict gets the message that their alcohol (drug) use has caused havoc in the lives of his/her loved ones in a way he/she had not

realized. It is a hard truth, but the alcoholic/addict is the last to know how their behavior damaged their loved ones. Remember, I said denial and manipulation are the modus operandi of the alcoholic/addict. At the intervention, all of that behavior gets destroyed; and the real consequences of that behavior emerge.

The selection of a counselor to facilitate the intervention is critical. In the community, there are addiction treatment facilities in almost every metropolitan area that have such counselors. A few of the more famous ones include The Hazelton Center, the Kaiser Medical Programs, and the Betty Ford Center. Further, there are Alcoholics Anonymous chapters in numerous locations that can direct any one to such counselors. At United Airlines, there was a committee of a medical doctor, EAP representative, flight manager, and ALPA representative that collectively conducted the intervention on our pilots. In my experience at LAXMD, we successfully intervened with over 80 airline pilots and helped them on the way to a clean and sober life.

That is the way to identify the alcoholic/addict and get them on his/her way to recovery.

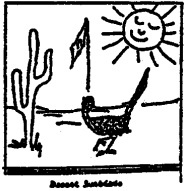

We had a great raffle, with many bottles of wine, boxes of chocolates and a lot of little Easter Bunnies.

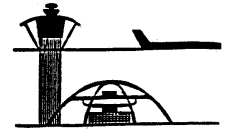

Greetings from the Nations Capital!

The cherry blossoms are gone but the dogwoods and azaleas are in full bloom, a beautiful time to visit Washington DC. This correspondent was visiting North

Carolina and missed the April meeting, however, here is her report covering a visit to the “Wright Brothers” in Kitty Hawk, North Carolina.

I travelled with 30 other Wright Brothers enthusiasts on a 4 day bus tour to see the location of the first flight that took place on December 17, 1903. It was quite a thrill to see where it all started so long ago!

Orville and Wilbur Wright, a pair of bicycle mechanics from Dayton Ohio, launched a heavier than air machine 120ft across a windy stretch of sand and stayed aloft for 12 seconds. Both brothers completed a short flight as well as 3 men from the ocean rescue station located at Kitty Hawk.

A National Park Service representative gave us a 45 minute lecture in the Wright Brother Museum with a replica of the aircraft as the backdrop. (The original aircraft is in the Smithsonian Air and Space Museum in Washington DC).

The barrier islands of North Carolina are windy, have few trees but many beautiful beaches. There were many interesting lighthouses to visit and another museum called “The Graveyard of the Atlantic” that is devoted to the more than 1000 ships that ran aground in the 16th, 17th and 18th centuries.

This definitely a “must see” trip for aircraft enthusiasts! Travel time by road from Northern Virginia (Vienna) was exactly 6 hours with a one hour break for lunch.

Part 2: Nepal ~ More details of **Sharon Burbank’s** (IADCS) trip to Nepal, February 2011: This was a “once in a lifetime” trip and Sharon has more interesting information to share.

The group took a side trip to Pokhara, which is a busy city that caters to tourists who are interested in trekking along the Annapura Range. The city sits along the beautiful Lake Phewa and offers boating and fishing. While the group was in Pokhara, we were able to shop and bargain for pashmina shawls, jewelry and souvenirs. Our plan was to bicycle around the lake and take in the sights along the way. We visited Devils Falls, which featured a cave that had a temple inside! The group rode their bicycles through the traffic of motorcycles, scooters and cars and then we started around the lake. It was beautiful and our guide had told us it was easy riding!

The ride was hilly, then rocky and then smooth pavement at last! We saw water buffalo lying in a muddy field and the sky was full of hang gliders of every color, what a sight!

The Nepalese farm small patches of land on the mountainsides and make good use of water buffalo for plowing and working the fields. The population is hard working and they seem to be content with their lives and enjoy the beauty that surrounds them.

The next morning the group left Pokhara and started

the 6 hour drive to Kathmandu to begin their journey home and back to the “real world”.
