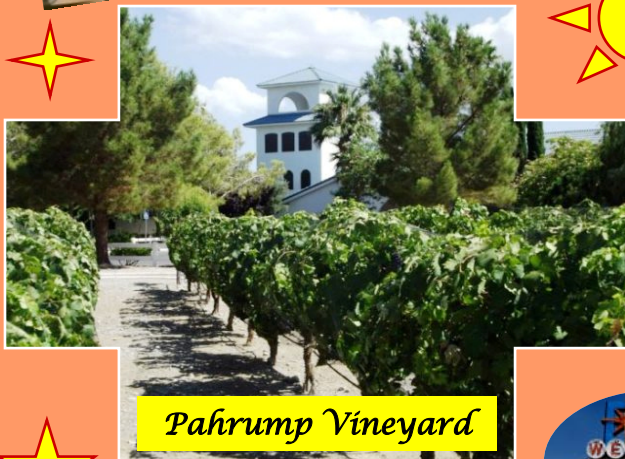

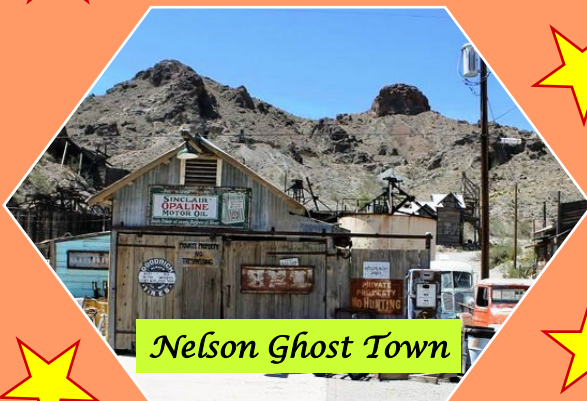

Letter From The President



Happy Spring time! I hope you all are finalizing plans for the summer. We are not going to get any younger and we might as well enjoy ourselves spending time with friends and family or maybe just some quiet time in a place that you want to disappear.

The activity scale has been high all year for RUAEA. In March we held the mid year Board Meeting in Las Vegas. We have been working with the Convention Committee and the Las Vegas Silverliners planning for the 2017 Convention. The Silverliners are doing a great job and are keeping **John Zoboli**, our VP of Conventions busy. It is a lot of work putting things together for a convention and it always requires someone to step-up and take the lead. **Don Rutkowski** of the Silverliners is the man and he wears many hats right now. He is a super fellow and supplies the motivation to get the job done. Be sure and make plans to attend September 25 - 28. This issue is our Convention Issue and has information concerning the Convention.

On April 12, as planned we had our second meeting at World Headquarters in Chicago. We were scheduled to meet with Oscar, but he was tied up with the fallout of the incident regarding the United Express flight and was not able to meet. United President Scott Kirby took his place and chaired the meeting. Those present from the company were: VP Total Rewards, Anthony Scatone, HR Retiree Services, Janet Tyse, Corporate Communications, Julia Wislocha and Mandeep Grewal, MD Chief of Staff. This is the first time that most of us met Scott and we appreciate that he was able to take time to be with us.

We had been requested to have the three top items that our retirees were concerned with so that they could be presented at this meeting. All three had to do with pass travel and the first one discussed was "Boarding Priority". It is felt by most retirees that the "playing field" needs to be leveled so that the retiree has an equal chance of being boarded when using trip passes (those below the vacation pass) as does the active employee. This item took most of the meeting. We presented what we felt would work for the retirees and Scott supplied

the "cons" to our proposal. We discussed "Enrolled Friends" and how we would like to see it expanded, "Vacation Passes" were discussed and proposals for enhancement of the vacation pass was promoted by the retirees and pass privileges for the "Surviving Spouse" of the retiree was also put in play. But, as stated, most of the time was spent on boarding priority. And no decisions were made in this meeting, as was expected.

With a few minutes of our time left, Oscar came in. He was given a warm welcome expressed by a "standing ovation". To me, it was a very moving moment. He had just been on Good Morning America and had been fielding, for the past few days, every type of critical question imaginable while trying to hold down the damage that had been done to our company. All of which was probably not United's fault, but being the man he is, he accepted the responsibility because it was a "United" flight. I am pleased to know that the Board of Directors supports Oscar and the efforts he is putting forth to rectify the incident. And it goes without further comment that the retirees also support Oscar and the Company for handling the matter in a dignified manner. In other words we are behind them!

Before the meeting broke up we agreed to meet again in a few months, probably in June. We hope to get some resolution of the items we discussed. We have been told that these meetings will continue and that the dialog between the retirees and the company is desirable and we want to continue to promote this relationship. We must also understand that we (the Retirees) have no bargaining power; we are not legal representatives or a union. What changes come, if any, will be a result of management's willingness to listen and make concessions or not, based on a sense of fairness. The Leaders of the Retiree Groups need everyone's support and understanding.

On to another subject: The Denver Office is in a state of transition. The entire Training Center is being renovated in preparation to house all of United's flight training and segments of other types of training. The verbal communication in and out of the office is not good, and internet access reliability and speed is marginal. **Cas Spokas** our Membership Manager has done wonders with the systems, but we are limited. There is a new phone system being installed, but it isn't totally up and running yet and some of the old is still there. The bottom line is we don't have a voice mail box and probably won't until the system is fully functional which may be 6-10 months away. Such things as address changes have been affected and just any message that needs to go to a voice mail box, doesn't happen at this time. Another situation that has affected us is that we normally have three secretaries that work the office, but due to surgery, **Juliana Alfonso** has been out and the other two, **Marilyn Hansen** and **Carol Bare** have

been handling the office load. Juliana is doing well and returned to work the first week of May. We appreciate the added work they have been able to do. Our Exec VP **Jim Simon** in concordance with Membership Manager **Cas Spokas** have been working on the means that you, the membership, have to get your needs taken care of. See Jim's article in this Newsletter.

Convention Information **From Convention VP, John Zoboli**



The first thing to do upon checking in to the Hotel is to proceed to the Rewards Desk and sign up for the Rewards Card. The Rewards Card is used in all of the Restaurants, Gaming Machines and for some items in the Guest Shop. The card when used will accumu-

late points or, in the case of the Buffet, reduces the price. If you are a Veteran and provide proof, the card has additional benefits especially on Mondays. As with most casino reward cards, once a certain reward level is reached, it may be used for comp meals.

The weather in Las Vegas at the end of September / early October should be warm. The average for the last few years has been 76/82°F. Humidity average has been 25/30%. Comfortable for the end of September. As always, sun screen and head cover is recommended, it is the desert.

To locate the convention area, proceed thru the gaming area, turning left each time the lay of the building changes. You will come to the sport book area, take the escalator up. The convention area is to the right thru large glass doors. Watch for signs.

If you have been saving your change for the Casino, stop. Convert the change to paper bills. I have not seen any machines in the casino that accepts coin. The machines only accept paper bills and the script you receive as winnings at the machine. The script can be converted to cash or re used in another machine as credit. The table games prefer house chips which are purchased at the cage. Chips and script can not be used at the restaurants, bars or gift shop.

Pass Travel UPDATE by Kirk Moore

1) **Pass Travel Attire** ~ Due to the recent “leggings event” in the news, it’s important for you and your pass riders to review the Pass Travel Attire policy before arriving at the airport. You are ultimately responsible for your pass riders’ behavior and appearance when they are traveling under your pass travel privileges. Remember, when in doubt, don’t wear it.

Traveling on “Other Airlines”? Dress appropriately or you may be denied boarding. Check the interline agreement on FlyingTogether > Travel > OtherAirline InterlineTravel for travel attire guidelines. 2) **Pass Travel on Qatar Airways ends May 5th** ~ From the Employee Travel Center:

Qatar Airways agreement canceled effective May 5th. Our commercial interline ticketing and baggage agreement (ITB) with Qatar Airways (QR) will cease on May 5, 2017. QR’s internal policy does not support a pass travel agreement without an active commercial ITB. Therefore, United’s leisure pass travel agreement with QR will be canceled and all travel must be completed by May 5th. If you have future travel plans on QR, you can request a refund for any unused tickets via the ID90Travel website or by calling them at 1-877-298-5233.

Helpful information:

- ❖ View the quick reference guide (PDF document) on how to request a refund using the ID90Travel website.
- ❖ When logging in to the ID90Travel website, use your six-digit uID without the U.
- ❖ For ID90Travel website password assistance, call 1-877-298-5233 (Toll free 24-hours).

3) **Other Airline travel on Star Alliance; BC or YC?** If you buy a Business Class ZED ticket on Star Alliance partners, you will receive a refund if you have to sit in Economy Class (allow at least 4 weeks for refund processing). On non-Star Alliance carriers there

are no fare-difference refunds; so buy both BC and YC ZEDs and use the one for cabin that has available seats. Note: If you purchase a YC ZED ticket and Economy is full, you will NOT be seated in BC. Read this message from the ETC:

We have agreed with our Star Alliance partners to refund the difference when a C class seat is purchased but we are seated in Y. This agreement is only with our Star Alliance partners.

Other partners that we have a C class agreement with are not entitled to issue a refund on the difference. It is recommended that a C and Y class ticket is purchased and that the employee/retiree can get a refund on the ticket that is not used.

4) **TSA will not accept Driver Licenses from 6 states in 2018** ~ Important information from the TSA: This may apply to residents of Kentucky, Maine, Minnesota, Missouri, Montana, Oklahoma, Pennsylvania, South Carolina, and Washington. Other states may be affected in the near future.

Hiring Flight Attendants became particularly challenging. Only about one of one hundred applicants was selected. So, as Robb says, "*I kind of hired myself to be a Flight Attendant.*" This was in 1977.

Robb stayed a Flight Attendant until his retirement in 2003. He had flown out of CLESW, LAXSW, SFOSW, and SEASW. Robb says, "*I was so lucky to have worked at a job I loved; and honored to have represented United*

Air Lines. But, despite all the great memories, I was so happy to retire after 38 years with United."

Robb is now what we call a "snowbird", splitting his time between Palm Springs and Edmonds, Washington, a Seattle suburb.
