FROM THE PRESIDENT

By the time you read this the annual convention, 2004 hosted by the Seattle Emerald City Slickers will be fond memories. Pictures in next month's Newsletter will highlight some of the attendees & activities. In last month's Newsletter, Jim Fauber reflected on key happenings during his term as Pres. I wonder if people like Tom Plunkett, Charley Field, Charlie Urback & others had any idea what they started, almost 30 years ago, when they founded RUAEA.

Our world as a United Airlines retiree has certainly changed over this time - especially in the last 2 years. Our membership, especially the more recent retirees, have put our feet to the fire & demanded that we - RUAEA - play a stronger role in representing retirees' interests & concerns. Your Board of Directors & Officers have addressed this and responded over the last year and a half. In the most recent Board of Directors & Officers meeting they unanimously approved formally changing the role of RUAEA to include being "an advocate for retiree causes & concerns". This change is profound. It dictates that RUAEA truly represent retirees in matters that affect them. It suggests a stronger RUAEA presence & representation in WHQ. It suggests more effective communication, especially through RUAEA's website.

This change was an item of business in the annual business meeting in Seattle. The membership voted on it. (I don't know the outcome of that vote, as I am writing this before the convention.) If the membership approved this change the new Officers & Directors have new marching orders. To carry this out effectively and efficiently will require the support of everyone in RUAEA. The major challenge of your new Officers & Directors is to continue and maintain the benefits, features & strengths of RUAEA that we have experienced and enjoyed over the years; and to develop & incorporate the additional role defined for RUAEA. We will keep you informed on these developments and will be asking for your support and help.

As I mentioned earlier, I wonder if the people who founded RUAEA envisioned the vital and vibrant organization they founded. What is your vision of RUAEA in two years? Five Years? Together we need to share our vision. Together we can make it happen.

UPDATE - MEDICAL INSURANCE NEGOTIATIONS - April 24, 2004

As we have mentioned, we are kept up to date on the process of the negotiations but not the content or details. (We have received many e-mails from retirees with suggestions, comments & concerns. We have passed these on to our team.) Mort Wax, our representative on the Salaried & Management Committee, gave us the following update on the process: Benefits consultants for all of the committees met together to develop a consensus approach to subsequent negotiations with the company. On April 30 the Salaried & Management Committee participated with our legal counsel, financial advisors & benefits consultants to review this.

The Salaried and Management consultants will refine our approach. We assume the other committees will do the same.

On May 5 there will be a joint meeting of all committees in Chicago to review & hopefully approve the consensus approach for negotiation.

On May 6, legal counsel will meet with United's legal counsel to establish the timetable and framework for negotiation.

In Bankruptcy Court, the Judge approved United's request for a delay in its submittal of its Business Plan to June 30, 2004. By then there should be a decision by the ATSB on the application for the loan guarantee. This provides more time for our negotiation and resets the timetable; i.e. delay in the Business Plan filing from May 21 to June 30 will delay the Judge's decision date from June 18 to the last week in July.

Specifically related to post-medicare medical insurance plans, many of you have seen the EEOC decision that companies have a unilateral right to terminate them without age discrimination issues. This has not yet been addressed by our committee. Potentially it could have an impact on the negotiation.

(Mort will give everyone a comprehensive review & update at the annual convention in SEA on May 29. That is too late to include in the June Newsletter.)

UNITED ANNOUNCES SIGNIFICANT EXPANSION TO MEXICO, THE CARIBBEAN & CENTRAL AMERICA

United announced that it is again bolstering its international portfolio with service to new destinations in Mexico, the Caribbean & Central America, in time for winter holiday travel. Service is scheduled to begin in Dec, subject to approval of government operating authority.

United plans to offer new Mexico service to Cozumel, Cancun, San Jose del Cabo, Puerto Vallarta & Ixtapa.

Caribbean service will include Montego Bay, Jamaica; Punta Cana, Dominican Republic; and St. Maarten, Netherlands Antilles; and additional service to Grand Cayman, Cayman Islands.

United will also launch Central American service from Chicago O'Hare to San Jose, Costa Rica. United currently serves San Jose, Costa Rica; Cancun, Mexico; San Juan Puerto Rico, Grand Cayman (seasonal service); St. Thomas, Aruba and Bermuda.

Flight times, frequencies & other additional information will be made available upon receipt of government operating authority.

WORLD AIRLINE FUEL COSTS TO RISE BY 8 BILLION DOLLARS

Airlines that fly internationally are expected to pay 8 billion dollars more for fuel this year than in 2003, the International Air Transport Association reported. The international airline industry is

projected to post 3.2 billion dollars in profits in 2004, but fuel prices are driving up costs just as business is starting to return.

**TED GOES INTERNATIONAL,
APPLIES TO SERVE PUERTO VALLARTA;
UNITED APPLIES TO SERVE COZUMEL**

Ted is preparing to fly south of the border. United, on behalf of Ted, has petitioned the U.S. Department of Transportation for authorization to fly seasonal service between Denver, CO & Puerto Vallarta, Jalisco, Mexico.

If approved by DOT (Dept. of Transportation), Ted will serve this market daily between Dec. & April with its distinctive A320 aircraft. Ted planes have 156 seats with an expanded Economy Plus section of 66 seats & 90 seats in United Economy.

United also has applied for authority to serve the market between Chicago, IL & Cozumel, Quintana Roo, Mexico, with thrice-weekly seasonal service between Dec. & Apr. If the application is approved, we will use a mainline A320, with 12 United First seats and 126 United Economy seats, on this route.

**ANNOUNCED NEW INTERNATIONAL
ROUTES**

United will begin Beijing-San Francisco & Chicago-Osaka service in June. United also announced this week that it will be the first U.S. Commercial carrier to provide service to Vietnam, implementing daily San Francisco-Ho Chi Minh City service via Hong Kong as soon as the necessary regulatory procedures have been completed by the relevant Vietnamese and U.S. government agencies.

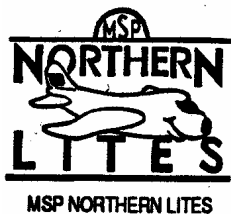
May 19 many Escapees went to Door County to join the Loonies on their 3-day semi-annual affair. This is a guaranteed fun time with a very friendly loving group.

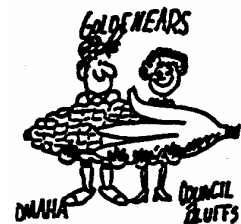

Randy was kind enough to update us, as of Apr. 12, on the status of United's proposal to increase the cost of medical benefits for retirees. He advised much of the information has been made available on the District 141 website & hotline 1-

800-411-6069. Randy advised the next step in the process is to try & reach a consensual agreement with the company.

Randy went on to say that not all retirees are represented by the unions; for example, ALPA has a separate group representing their retirees. The IAM, with the largest group of retirees, & the AFA are represented by their unions. The bankruptcy judge appointed a Salaried & Management Team to represent their retirees. It was encouraging to hear that a coalition within United of its labor unions plus salaried & management as well as other industries & corporations, lobbied for pension legislation which was passed & recently signed by President Bush.

Randy advised in 1997, United pensions were funded to 110%. They decreased 40% by 2003. The Senate recently voted to secure our pensions & give a 2-year recovery period where companies with under-funded plans would not be required to make 100% of the additional contributions required by law. This measure protects employees' pensions in the worst travel recession in our history. Randy commended the Senate & Congress for taking this step.
