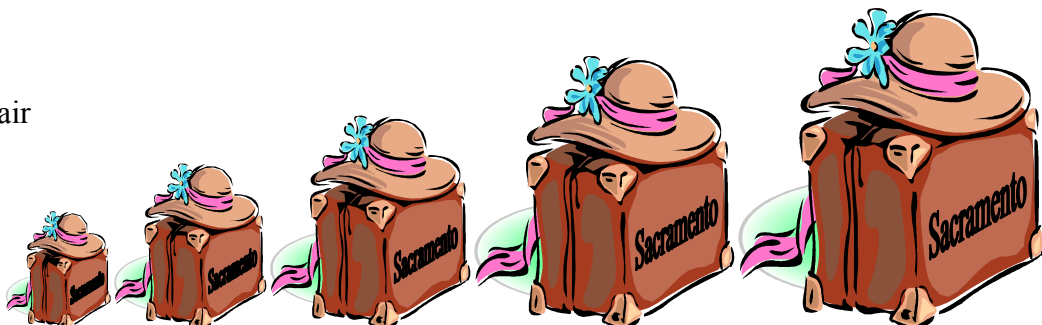

## FROM THE PRESIDENT - MAY 2007

In a February letter, I reported to you that we, RUAEA, were engaged in efforts with the company through meetings and independent conversations on your behalf to provide that existing privileges and benefits be not only retained, but enhanced. Our efforts to advocate for our membership have and are continuing. Ed Tolle, our Corporate Relations Representative, and I have been meeting and talking to our company contacts on a regular basis. We will continue to do so to insure that the goal stated above will be reached.

I cannot tell you at this time that everything Ed and I would like to see happen is going to occur immediately. What I can tell you is some of what we have been able to achieve during the past several months:

1. We have reached an understanding with the company that all retiree programs, including discount programs, can be subject to discussion, understanding and modification, if justifiable.
2. The company has agreed with us that costs and options within programs will be transparent.
3. Upon our continuing request, the company has improved its management of medical plan appeal cases and its approach for the handling of missed contributions.
4. Discussions on the subject of retiree travel privileges have been held & are continuing.

I can assure you that RUAEA's reception at WHQ represents their understanding that the retiree community is an integral constituent for the company. Ed & I will continue to work for all of us & will continue to report to you on an ongoing basis.

**at 800-233-1234, call the hotel direct (916) 443-1234 or go to the RUAEA website at www.ruaea.org and there is a link to a Hyatt reservation page with the correct price of \$99 per night double occupancy plus taxes. Be sure to identify yourself as a member of RUAEA.**

As was the case at the Washington convention, we will be having a special Hospitality time in the Hospitality Room on Tues., Wed. and Thurs. evenings.

### **Hot News ...**

**When checking in at the Hyatt, be sure to ask for your free *Sacramento Gold Card*. This card will get you discounts at some of the nearby restaurants as well as discounts at some attractions in the area for the do-it-on-your-own folks. We have also been able to negotiate some discounts with other establishments near the hotel, checkout the information in the Hospitality Room.**

Don't forget to look into the travel options on getting to Sacramento. United offers employees/retirees a discount of 20% on most fares. When booking the flights, be sure to tell the agent you are a retiree; the special code is **S\*PMO/EMP20**. Another option is to use a senior fare on Southwest. These fares are at least 50% of the standard fare and are changeable and cancelable with no penalty. You can check them out at southwest.com. You do have to be 65 or older. And then there is Amtrak, we have heard from several that they are planning to arrive by train. The Amtrak station is about a dozen blocks from the hotel. Finally here is a recap of the space available options. United has a good schedule with 27 daily flights. Also there are many other carriers that offer us a 90% or 95% discount - Alaska/Horizon, Aloha, American, Continental, Delta, Frontier, Hawaiian, Mexicana, Northwest and US Airways/America West. American offers ZED (Zonal Employee Discount) fares that are based on mileage. An example is DFW to SMF is \$31 each way. To obtain ID90, ID95 or ZED fare tickets, contact the Interline Ticketing Desk at 1-888-874-1581. Their hours are 0700-2100 CT

Mon. – Fri. and 0700-1900 CT Sat. & Sun. And last but not least, Jet-Blue and Southwest offer retirees standby fares at \$25.00 OW and \$50.00 RT plus taxes. For both of these carriers you will need a letter of introduction that may be obtained by calling United's Benefit Dept. at 1-888-825-0188.

**News flash ... Express Jet is scheduled to begin service in and out of Sacramento in April with non-stop flights between Sacramento and the following cities; San Antonio, Spokane, Tucson, Colorado Springs, Oklahoma City, Tulsa and Albuquerque. Express Jet has operated as a feeder for Continental Airlines.**

### **#1 FLIGHT ATTENDANT RETIRES FROM FRIENDLY SKIES AFTER 60 YEARS**

CHICAGO - United Airlines Flight Attendants, represented by the Association of Flight Attendants -CWA, AFL-CIO (AFA-CWA), applaud the number one Flight Attendant in the industry, **Iris Peterson**, as she retires from the job that started as "sky girl" or "stewardess"

and evolved to "certified safety professional" and a career for "Flight Attendants."

"There's no way to celebrate the career of this phenomenal woman without recognizing the extraordinary achievements she was a part of fighting for throughout her career. Iris led the way in shaping the career we are each so proud to call our own," stated Greg Davidowitch, President of AFA-CWA at United Airlines.

When Ms. Peterson began her career in 1946, jet engines were nowhere in sight and job restrictions included age, gender, ethnicity & weight. But the vision of Ms. Peterson & her peers helped to destroy these discriminatory practices. Today, the Flight Attendant profession is often recognized as a leader in advancing the rights of women & uprooting gender discrimination.

Active in her union throughout her career, Iris

held various leadership positions & often represented her colleagues in grievances & safety issues on Capitol Hill. AFA-CWA historian & retired flight attendant Georgia Nielsen tells us that Ms. Peterson was often an integral part of advancing her profession through activity in her union. In 1953, she was the first official lobbyist for the Air Line Stewards & Stewardesses Association. In 1968, the same year that stewardesses won the right to hold the job if they were married, Ms. Peterson participated in safety plans for the first jumbo aircraft. She worked with aircraft engineers & was instrumental in gaining acceptance for 17 safety items, including the evacuation alarm, which is now a standard on equipment worldwide.

"Iris has been a mentor to all of us who've followed in her steps," Davidowitch continued. "She has spent a lifetime committed to her airline & to improving the profession she has loved for six decades. As her fellow crewmembers, we have been lucky to receive her guidance for 60 years. Iris is an intensely private person, but Flight Attendants everywhere are the beneficiaries of her dedication & commitment to our profession. She is truly one in a million."

### **FROM THE DENVER OFFICE**

Two items in this issue: The first one is a reminder concerning the "Red Stamp" and how the wording on the labels advises us of renewal time. The second one advises all of the new e-mail address for the Denver Office.

In an effort to reduce some of the confusion



concerning the infamous “Red Stamp”, we have changed the wording on the affected address labels.

The red stamp & the wording on the labels are intended to advise of 2 different scenarios:

1. *Current Membership Expiration Month*
2. *Month Following Expiration.* This is the month past normal renewal month & the Newsletter will stop if Membership is not renewed. Also, please disregard the message if dues were sent in.

The new wording on the address label for these 2 scenarios will change to:

1. For *Current Membership Expiration Month* - The wording on the labels will be:  
**It’s Time to renew your Membership.**  
**Disregard this message if your dues are already paid.**
2. For *Month Following Expiration* - The wording on the labels will be:  
**Your membership will expire unless your dues are received.**  
**Please submit your dues payment at this time.**  
**Disregard this notice if your dues are already paid.**

Hopefully, this change will clear up any confusion regarding the “Red Stamp”.

### **DRESS CODE REMINDER FOR PLEASURE AND BUSINESS TRAVEL**

Because employees, their travel eligibles and companions have been turned away at the gate, or not been seated in their preferred class, for being inappropriately dressed for non-revenue, space-available (NRSA) or non-revenue positive-space (NRPS) travel, it’s important to remember and abide by the dress code for traveling on United, United Express and Ted flights.

Being inappropriately dressed for NRSA or NRPS travel also puts the customer service representatives (CSRs) working these flights in the awkward, time-consuming position of serving as dress-code referees. Be respectful to your local CSR -

follow the code.

The purpose of the dress code - which applies to travelers age 12 and above - is to ensure that the appearance of employees and their eligible travelers reflects favorably upon United with customers.

Not allowed in any class of service are flip-flops or thong sandals, T-shirts, tank tops, mini skirts, bare midriffs, workout attire or jogging suits. Jeans are prohibited for NRSA travelers listed for the first-class cabin.

For full dress code details, go to the “Travel” section of SkyNet, and click “Pleasure” under “Travel Policy (Series 10)”. United’s travel dress code may also be found in Apollo under HOW DRESS, and on the EasyCheck-in units.

When traveling on a space-available basis on other carriers, keep in mind that they may have stricter dress codes that must be observed. Be sure to check the airline’s regulations before traveling.

### **TRAVEL TIPS BY BOB**

#### ***Some Changes, Reminders and Helps***

*Remember the **3-1-1** Air Travel rule:*

- ➔ **3** ounce or less size containers of liquid or gel
- ➔ **1** quart sized, clear plastic zip top bag holding 3 ounce or smaller containers
- ➔ **1** bag per traveler placed in the security screening bin

By understanding & practicing the **3-1-1** on Travel Rule, your trip through security will be easier.

The exception to the above **3-1-1** rule is you can declare some larger quantities of liquids, such as: Prescription Medications, Baby Formula & Milk. These items are allowed in quantities exceeding three ounces & are not required to be in the zip-top bag. It’s wise to declare these items for inspection at the checkpoint; it prevents a lot of problems.

*Getting ready for International Travel?* - Check your Passport for expiration date & check to see if a VISA is required. It takes time to obtain these documents so, plan ahead. Without the required documents you won’t be going anywhere, internationally.

Be aware that departure fees in Europe are high. In some airports the fees run \$150.00 USD or more depending on the exchange rate at the time. See

TSA is able to open these special locks to inspect your luggage, but no one else in baggage handling can. Be sure the package state the lock is TSA approved before purchasing it. Bob mention that employee travel is more self-service, from listing to check-in. He recommends checking in for flights at home on your computer & printing out your own boarding passes. This is especially important for United Express flights because boarding priority is based on check-in time. You can check-in 24 hours before departure time. Also, Bob has found that at SEATAC at 9 PM nightly all TSA Security Check Points are closed except for the one in the Market Place area behind the NorthWest counters. This means lines will be longer. Consequently, United has a 45 minute cut-off (prior to departures) at the check-in to make sure passengers will clear security. Also, the aircraft doors are usually closed 10 minutes before departure to ensure an on time departure. This add up to getting there early! Regarding Companion passes, have you Companion stand by starting with the first flight of the day to improve their chances of getting out & consider having them buy a ticket if they must be at their destination on time.

I have gotten busier since Sept. 05 when I joined the Prison Fellowship Ministry. I teach a Bible study every Wed. evening to a group of 12 inmates at the Santa Rita Prison. On the weekends I join a group of 4 other volunteers to teach a two day seminar at various other State Prisons in Southern Arizona, 0800 to 1530 each day to groups as large as 50. We break up into 5 smaller groups frequently during the 2 days in order to have a "one on one" discussion on the practicality of each phase of the teaching. Seminars are focused on the necessary steps to successfully transitions to a productive life in the outside "more dangerous world".

Incongruous but true, when you consider after 10 to 25 years of prison life they suddenly must provide for their own shelter, food & clothing. And, without the proper training that many never had especially the Biblical training of what God expects of each of us, they usually end up back in prison (approximately 70% of the time). This factor alone, when I first learned of it, is what led me to become involved with P.F.M. The need for volunteers in P.F.M. is enormous, and not all volunteers need to come in physical contact with the prison inmates. It depends on what your talents are. One of the most recent and most troubling statistics is "one out of every 30 adults in America is either in prison, on parole or on probation".
