

2014 San Diego RUAEA Convention Survey

At the San Diego Convention, attendees were asked to complete a survey about our yearly conventions. We would like to share the results with the membership. With about 330 attendees, we had 129 respond or 39.1

percent. Remember that most of the attendees were couples. The comments offered, in addition to the major issues surveyed, were welcomed and will be reviewed for feasibility in the planning process of future conventions. It is apparent from the survey results that our members realize the challenges of continuing to provide annual conventions, increasingly impacted as they are by the realities of declining participation of local chapters and the ever escalating costs of doing business in America today. The results are as follows:

- Would consider hosting a future convention 20% yes, 26% no and 54% no comment
- Maximum rate \$100-\$125 57%, \$125-\$150 34%
- Room rate to include breakfast 42% important, 47% nice and 12% not important
- East Coast/West Coast Rotation 24% prefer, 36% desirable and 39% no preference
- Hospitality Nights Preferences 47% one night, 46% two nights
- Will volunteer to assist at a convention 66% yes, 26% no and 9% no comment
- Will volunteer to assist a local committee at convention 50% yes, 34% no and 17% no comment
- Use of credit card vs. personal check 33% yes, 6% no, 53% would be nice and 9% no comment

Jeff and DL and AA CEOs press Washington to invoke consultation with Middle Eastern governments over abuse of Open Skies treaties



Jeff and the CEOs of American Airlines (AA) and Delta Airlines (DL) last week met in Washington, D.C., with representatives from the White House, the DOT, the State Department and other government agencies to ask U.S. government officials to invoke the consultation provisions under the Open Skies agreements in place with Qatar and the United Arab Emirates, in light of the abuse of those treaties by state-owned carriers Qatar Airways (QR), Etihad Airways (EY) and Emirates Airline (EK).

The CEOs cited compelling, documented evidence that Qatar and the UAE had granted more than \$40 billion in subsidies and other unfair benefits to QR, EY and EK over the past 10 years. Those subsidies, Jeff and the other CEOs said, have enabled a massive deployment of subsidized capacity by the Middle East carriers at rates almost four times the rate of global gross domestic product growth, unfairly taking substantial current and potential future market share from other airlines, including U.S. carriers.

The CEOs pointed out that, because Gulf carriers do not meaningfully stimulate passenger demand, the only way those carriers can grow at their projected rate - 10 times more available seat miles (capacity) in 2020 compared with 2007 - is to use their subsidies to take substantial share from other airlines, including U.S. carriers. Because more than half of U.S. carriers' long-haul international flights connect to and from domestic flights at U.S. hubs, long-haul flying that is adversely affected by the Gulf carriers' subsidized capacity has a negative impact on U.S. domestic service and smaller communities.

"U.S. carriers can compete successfully against any airline in the world when the playing field is level, free of multi-billion dollar subsidies and the market distortions that those subsidies cause," Jeff said. "We need revised Open Skies agreements with Qatar and the UAE to address the abuse of the treaties by Qatar Airways, Etihad and Emirates. Having used their massive subsidies to expand dramatically into Europe, Asia and Australia, the Gulf carriers are targeting the U.S. and our employees next."

Travel page on Flying Together gets a makeover ~ The Travel page has been refreshed and is now more user-friendly!

Sign into <https://flyingtogether.ual.com> and click on the Travel tab. You will see handy new links to "Book a Flight" (employeeRES), "Update Pass Riders" (My Info>PassRiders), "Pass Travel Report"**, "Route Maps" and "Employee Discounts" right across the page. On the right side is a search box, different ways to travel (on UA, myUAdiscount, Other Airline travel, etc), Q&A's, and helpful contact information.



Important Advisories are in the middle of the page and the familiar links are in the left column.

The new layout is easier to navigate....check it out today!

Get some departure taxes refunded if transiting ~ Pass riders may get a refund on some pre-paid departure taxes when transiting from another airline to United in certain international cities. When listing in employeeRES, pay attention to a pop-up notice in step #4 of the booking process. For example; when transiting London from another carrier, then pass riding on United Airlines to the USA in less than 24 hours:

Notice - All space-available pass riders departing on UA flights from the United Kingdom will have the UB and GB departure tax pre-paid or payroll deducted. If connecting in a United Kingdom city less than 24 hours from another airline carrier, a copy of the boarding pass from that carrier must be submitted to the Employee Pass Charge Team (EPC@united.com) in order to be exempt from the GB departure tax. Transit pass riders are still responsible for the UB departure tax.

So, what is the "GB" departure tax? It's the "U.K. Air Passenger Duty", which amounts to over \$100.00 per person! Visit the Pass Travel Calculator to see for yourself (employeeRES>Quick Links> Pass Calculator). If you transit London (in < 24 hours) to the USA, be sure to keep the other airline inbound boarding pass to send to the Employee Pass Charge Team (epc@united.com) for the refund!

We thank **Carol Schmus** (HNL RAFA) who passed this info to us. She discovered 50% of the Japanese tax can be refunded when transiting thru Narita on the same calendar day. Like the UK departure tax, save your inbound other airline boarding pass so that you can send it to epc@united.com for assistance with your refund.

Regardless of what city you are leaving from (LHR or NRT), the departure airline must be United. The EPC Team cannot adjust any departure taxes you paid on another airline.

Please Note: If the city you are transiting offers a refund or exemption it will be noted in step 4 of the listing process in employeeRES. If there is no notice, there is no refund/exemption.

Imputed income taxes and 1099s from United

If your "taxable pass riders" accrue more than \$600 in imputed income in a fiscal year (flights flown between November 1st and October 31st of the following year) then you'll receive a 1099-MISC from United via US Mail. If your pass riders accrue less than \$600 then you do not get a 1099-MISC form and you do not have to declare any imputed income on your tax forms.

"Imputed taxes" on airline pass travel are complex, as are most things in the IRS code. Retirees should **consult** their CPA to verify all these points. For a more detailed explanation, go to the Travel Benefits tab at www.rafa-cwa.org.

The following message is from United: *"United uses box 7 ("Nonemployee compensation") of Form 1099-MISC instead of box 3 ("Other income") to report the taxable income resulting from taxable pass travel because United believes that the income is most appropriately reported there. Since your travel privileges are available to you as a result of your prior services for the Company, and you are not currently an active employee, United believes that your travel-related income is a form of nonemployee compensation that is properly reportable in box 7. While reporting the income in box 3 may also be possible, the Company does not believe that it is the most appropriate means of doing so."*

Tech Ops attracting more lucrative third-party work



Tech Ops is more than the maintenance division of United, it's also a business within the business that generates revenue. In 2014, Tech Ops supported the "improve our financial performance" cornerstone of the Route Map by delivering \$127 million in revenue, a 41 percent year-over-year increase from 2013.

The Tech Ops revenue goal for 2015 is \$135 million, and the division will once again rely on employees who have a proven track record of execution, of suggesting and implementing process improvements, and in helping identify

areas in which we can excel.

"We are in the maintenance, repair and overhaul (MRO) business and are building our portfolio of customers to make sure that it's a good match with our strengths and our capabilities," said MRO Engineering and Business Development Managing Director Stephen Rooney.

"We are actively pursuing new engine, component and line maintenance opportunities with domestic and international carriers, the U.S. government, aircraft industry original equipment manufacturers and others,"

Stephen said. *“At the same time, we are working to retain and grow business from customers who have already been impressed with our work and helped us grow in 2014. Throughout, we will focus on the primary task, maintaining and improving United’s fleet.”*

“We should all take pride in how we increased sales by 41 percent and delivered as promised on those commitments,” said Engine and Component MRO Managing Director Mark Eldred. *“Kudos to everyone who contributed, in departments that include Maintenance, Inspection, Purchasing, Supply Chain, Vendor Management, Engineering, Finance and Sales.”*

Among highlights from last year that give United momentum starting off 2015:

- ❖ United added Lufthansa (LH) composites and avionics repair and overhaul to its component maintenance portfolio at the San Francisco Maintenance Center.
- ❖ United brought in new customer engines from Pratt & Whitney Engine Leasing and Omni and increased its U.S. Air Force engine production by 35 percent. United also provided engine-testing services to Pratt & Whitney Engine Leasing, Korean Air (KE) and the A.J. Walters leasing firm.
- ❖ In Line Maintenance, United regularly went above and beyond to support customer aircraft and received numerous compliment and recognition letters. United added Aeromexico (AM) and Air Canada (AC) and expanded services to Air China (CA), Japan Airlines (JL) and KE. The company provided Global Emergency Maintenance repairs with teams from DEN, ORD and SFO serving clients such as JetBlue (B6) and GDC Technics Inc.
- ❖ And in Ground Service Equipment (GSE), United signed agreements with Aeromag and JetStream Ground Services for preventative and routine maintenance, executed leases with other operators for unused equipment, and developed a process to work on ground service equipment on an ad hoc basis at stations where United is approached by would-be customers but do not have a contract in place.

New united.com on its way



United is combining the award-winning design features of the United mobile app with all-new functionality to create a redesigned united.com. This phased redesign of the entire website is another step in United’s overall investment in its digital channels. The redesign is part of the 2015 Route Map business plan.

United has started with the site’s home page and booking path, which will feature an all-new look, a personalized home page, filter and sorting tools, flexible date price calendar and other user-friendly booking features. As United completes its final testing phase of the site, it will soon begin introducing the home page and booking path to select customers and employees in a phased beta release. The audience for the beta test will be initially a closed, invitation-only group, followed by a second beta phase open publicly. A phased approach gives United’s customers time to become familiar with the new look before the company officially cuts over to the new site.

United implements MileagePlus login change for added security



Unknown and unauthorized parties attempted to use user names and passwords obtained from sources completely unrelated to United to access MileagePlus accounts, hoping the login information would be the same because users tend to use the same user name and password across multiple sites. To help protect members’ information, among other actions, United is requiring members to log in to their MileagePlus accounts using their MileagePlus number and password rather than their user name and password.

Torgy's Travel Tips



Offline standby travel can be both a blessing and a curse! When UA doesn't fly where you want to go, it's great to have nearly 100 other carriers as alternatives. And it has opened up many opportunities for those of us who reside in cities where UA has either withdrawn service or has cut back routes and/or capacity.

But offline travel involves a lot more effort to use because of the process of obtaining your ticket and listing. Recently, there have been quite a few changes to these processes. I will take this month's column and attempt to clarify the changes, explain the new procedures and offer some helpful resources. If you're up for it, read on!

A short time ago, the vendor who issues the majority of our interline Etkts changed the name of their company and website address. ID90T.com became ID90Travel.com. Although the profiles in FlyingTogether still show the old website, our system automatically redirects you to their **new** website. (Take a look at your URL line and you will see this new address). When it works, all is good and off you go as usual. **But**, because of this "behind-the-scenes detour", some browsers (like Internet Explorer and Safari) often do not recognize the new website and simply redisplay the same page you were reading. Don't despair! There is a solution: Access *Compatibility View Settings* in your browser's Internet Options. Type ID90Travel.com in the box and click Add. Close the box and you're done. The next time you click on the ID90 link in our system, it will take you to their new website.

Next, ID90Travel.com has reformatted their entire website. Your authorization credentials from UA are supposed to transfer over to the new website automatically when you click on the link in FlyingTogether. When it works correctly, you will see a "Welcome Back" box display with room for you to type your ID90Travel password. When successful, you will then come to their new Home Page and your name will show in the upper right corner. Sometimes however, UA does not send across your credentials and you will see "Welcome UA Research" instead of your name. **Stop** right there and do the following:

1. Click on the down arrow underneath Welcome UA Research
2. Click "Sign out"
3. Wait for a large pop-up box that says "Welcome Back – Please Sign In"
4. **Do not sign in**
5. Click the tiny blue link at the lower left corner of the box: *Sign on as a different user*
6. Follow the prompts and you will then be OK

ID90Travel has tutorials you may access on You Tube to assist you with all of this. Go to: <http://youtu.be/o-lw9zqbXhw> and <http://youtu.be/jKVGefmG6Xa> or you can speak to a real human at ID90Travel by calling 877 298-5233. The UA Computer Support Desk can also assist with the Compatibility View issues. They can be reached at 800 255-5801.

Listing on offline carriers has also undergone changes recently. In an effort to keep reservation phone lines open for paying customers, many carriers are now requiring standby travelers to list over the internet. Most of these listings are done on the website MyIDTravel.com which you can access through FlyingTogether. This site handles the listings for 28 major carriers, including American, US Air, KLM, Thai, Swiss, Qantas and Cathay Pacific. If you are flying Jet Blue, Delta, Lufthansa, Southwest or TAP, you are automatically listed when you purchase your standby ticket on the new MyIDPurchase.com website referenced in FlyingTogether. And the same automatic listing occurs when you buy your ticket on the ID90Travel.com website for Alaska, Hawaiian, Frontier and Spirit Airlines. You don't have to commit this all to memory you just need to follow the directions spelled out in FlyingTogether for the airline you want.

Lastly, what about baggage allowance when flying standby offline? Well, it just got easier to find out! Check the website www.FlyZed.info for the answer! This is a great resource for all kinds of questions when flying offline. You can find the answers to dress code, check-in procedures, embargoes, listing options and baggage questions all in one place.

So, get out there and give it a try. You never know where your travels will take you!



The member we would like to feature this month is **Leon Manou** ~ Leon was the middle of 10 children, born on a farm in Puget Sur Argens Var, France. This is a medieval village with narrow streets, old homes, and squares surrounded by pine groves and streams in the midst of wild flowers. It is located 3 miles from the coast of the French Riviera, west of Cannes.

Leon was in the French Army where he pared, rasped, scraped, smoothed, blackened, and burnished as he practiced the handicraft of shoemaking. He made and repaired boots for officers.

Leon arrived in California in June, 1961, and did not know a word of English. Leon worked on a farm in Fresno, and upon moving to San Jose, he worked in a shoe shop during the day, and for the Santa Clara Packing Company at night. In 1963, Leon went to San Jose City College where he got his Associate Arts Degree as an Aircraft Mechanic. By February, 1966 Leon said he was discouraged about not being able to find a permanent job, and was ready to return to France. However, he saw an ad in the paper where United Air Lines (UAL) was hiring mechanics. He put in an application and was hired 2 weeks later. Leon states, "*I became a happy man.*"

Leon began at SFOPD Accessory Shop, overhauling EXCITER Boxes. For the next 10 years he worked on oil pumps, fuel pumps, fuel controls, gear boxes, and bleed valve governors were added to the list. Leon also worked on APUs and GPU Fuel Controls, then APU and GPU Engines. He also worked with/for **Tony Urso** in Sheet Metal. In 1980, Leon got his Air Frame License and worked on DC10-6 and DC10-50, and JT8 Engines. In 1989, Leon took the test for Inspector, but did not like the job so he returned to CF6. He became Lead Man in Big Engine Subassembly. A special job that he did for UAL was working on KC10 Air Force Tankers, which refuel airplanes in flight. Four of these planes were based overseas, but Leon only traveled in the United States repairing KC10s. Leon retired from SFOPD September, 2002.

Leon's wife, **Katrina Millar**, was a teacher and she came from Scotland to Canada to the United States. She was visiting her sister, Helen, who was a supervisor for UAL in Reno. Leon & Katrina met in 1969 and were married in 1970. Katrina worked in Reservations for UAL in San Francisco from 1969 to 1972. After the birth of their two children, Katrina went back to teaching - first as a teacher aide, and then as a Reading Teacher until she retired in 2007.

Leon's hobby is painting, and I have it on good authority (**Tony Urso**) that Leon is a very accomplished artist.

Leon & Katrina have a daughter, Jacqueline, also a Reading Specialist. Jacqueline's husband, Christopher, works for Computer Graphics. They have two boys, Millar and Iain, and live in Lake Oswego, Oregon. (Thus all those trips Leon & Katrina take to Portland!)

Leon & Katrina's son, Daniel, works as a bus driver for Oracle and is a student at San Francisco Academy of Fine Arts, studying Computer Graphics and Texturizing. Leon states, "*I still have wonderful memories of the 37 years I spent with UAL.*"

Bob Brooks passed around the sign-up sheet for hosting lunches in 2015. It was awesome to see the sheet all filled out. Thanks to everyone who signed up.




