I know you will enjoy viewing this beautiful airplane. We thank Clay for sharing this part of United's history with us.

GENERAL NEWS

FROM THE PRESIDENT

Dear Members:

United seeks modification in medical benefits for retirees.

It is an understatement that all retirees have read, heard & discussed the health insurance issue that was announced by United.

It is true that under the bankruptcy umbrella, with the consent of the bankruptcy court, United can legally cancel their contracts and financial commitments. The company's position is that to come out of bankruptcy they must reduce their insurance costs. Their position is that they want to negotiate what and how to do this.

As provided for in the U.S. bankruptcy code, unions are the presumed representatives of retirees who have been members of that union. United said that unions who accept will serve on the committee along with representatives they approve to represent the non-union, management & salaried retirees.

RUAEA is the largest of all the retiree organizations; our membership is open to union & non-union retirees. RUAEA must be a part of these hearings. We want to represent, not just RUAEA non-union, management & salaried retirees, but all of the retirees that fall into that category. I have discussed this with the key United principals about our involvement in these hearings.

We presented United with three names that we would like to represent us before the bankruptcy

court. They are Mort Wax, Jim Houser & Ed Tolle. All three have been accepted into the pool. The bankruptcy court must approve committee membership. If they are accepted by the court, United has offered both legal and financial assistance in presenting our case before the court.

I believe we are not, and cannot be, immune from the real world. United in its weakened status of bankruptcy and creditors makes United, the current employees, and retirees very vulnerable. I pray that the bankruptcy court, United, and the representatives chosen by the court to negotiate the health insurance issue will approach the problem with understanding, realism and with the best interest of United and its retirees in exiting from bankruptcy. We must get this job done.

Retirees can express their displeasure by calling 1-866-825-4104 or by e-mail <u>BB-Retiree-Medical@united.com</u> - do not write or e-mail Judge Eugene Wedoff as he will not read your letters or e-mail. His job is to remain unbiased in this case.

I want to tell you that the RUAEA Board of Directors meeting was held in SEA on the 28th of Jan.; a lengthy discussion took place about the role RUAEA should play in issues concerning retiree benefits in the future. It was decided that RUAEA must change the way we do business. We must become more "pro-active", not just a social organization. This process started right after the bankruptcy was announced on Dec. 9 and has the approval of the board.

Now, for some good news. Rich Bouska, the national president of RUPA, sent this message to me: "As you have heard by now, the senate has passed the Pension Reform Bill that will allow all airlines relief by giving another two years in order to fund pensions. This is great news! But we need to pick up the phone and and call (202) 456-1111.

"This is the White House Comment Line. You will speak to a real live volunteer that will take your comments regarding issues. Say you are calling to ask President Bush to sign HR3108 Pension Reform. Bush says he is going to veto the bill. Tell them you are a UAL pensioner. Ask your friends & family to call as well.

"The oval office sends runners down two or three times a day to pick up tallies on issues. This could make a difference. Call today."

For this to happen we need to provide the support required. We are looking for someone who is interested, has the skills to design, write & maintain our website. We want to share the direction we are going to make our website more interesting and valuable to retirees. If you know of someone who could and would help us with this, please let me know.

New things happen every day

We want to start off slowly, so we are asking for your help. Below are the subjects we will accept at this time.

There are only 3 items we are accepting at this time: the first would be for address changes, name changes, or personal status changes. These items would be titled "Membership" in the subject bar of your e-mail. When you send this information we must have your name as it appears on your mailing label & your file number. Also include the changes you are requesting.

The second item would be for correspondence to someone particular in the office staff, such as Jo Madden, Mel Conine, Howard Tress, or the secretaries, Harriet Ahr, Beverly Strand, or Adele Fishler. For those of you who don't know Howard, he is the co-office manager of the DEN RUAEA office who handles the technical side of the office equipment & also is the liaison to the website. For correspondence in the subject bar just enter their "first name" i.e. Jo, Mel, Tom or Howard.

Last, but not least, if you need to send an e-mail for the newsletter, address it in the subject bar "Newsletter". This is limited to chapter correspondence & Executive Boards Members at the present time.

Another improvement is the ability for a retiree who has not joined RUAEA to down load an application from the website. Then they can mail it to the office via the U.S. Postal Service, naturally with their check. It has been requested that you need to **include your file number on your checks** also. This is just a more expedient way for a new member to join our organization without the need to send a letter to our office, we send them their request, they mail the whole thing back again & get the same result. So if you know of any retirees who aren't members, let them read this, also encourage them to join RUAEA.

Our secretaries have been instructed, that if they receive anything other than the abovementioned subject(s), they are to consider them SPAM & delete them immediately. We are going to start off slowly with accepting e-mails. After a few months we will re-evaluate our process and adjust it accordingly.

Spotlight on IRAs

Update IRA Beneficiaries -- Ensure funds go where you intend.

If you've updated beneficiaries for your Alliant Credit Union savings or checking account, that doesn't necessarily mean your IRA (individual retirement account) beneficiaries are up-to-date. Specific beneficiary forms are required for changes to your Roth & Traditional IRAs. You can access & print these forms from the Alliant website at www.alliantcreditunion.org under the Applications & Forms, IRA Forms section. Or, you can call our TeleCenter at 800-328-1935 to have a form sent to you by mail. If you have not reviewed your IRA beneficiaries for some time, you may want to verify that these designations are current.

Open a Coverdell Education Savings Account for Grandchildren

It may be hard to imagine your young grandchild going off to college someday, but with a little foresight, you can help ensure a bright future for your pride and joy. Opening a Coverdell Education Savings Account may be the most important thing you can do for any youngster. Many financial planners agree that a Coverdell account is the single best way to save for school.

The Coverdell account is tax-privileged savings that replaces and improves upon the old Education IRA. The savings set aside in Coverdell accounts, plus the earnings they make, are fully available for qualified school bills & offer tax-free withdrawals to cover education costs such as books, tuition, room & board. They're not just for college kids. The Coverdell could be used at any school, public

or private, for grammar school & high school.

Contributions are limited to \$2,000 a year per beneficiary, which amounts to about \$166 a month. Even if you can't contribute the full yearly allowable, consider that an annual contribution earning 2.25% (the credit union's current savings and IRA dividend rate) will grow to \$4,434 in 10 years. In addition, anyone can make contributions to the Coverdell account you open for the child, including the child's parents, aunts & uncles, or family friends. Contributions make great birthday or holiday gifts that last a lifetime.

SIMPLER WAY TO OBTAIN INTERLINE REDUCED-FARE TICKETS

As a result of the previously announced closure of U.S. City & employee ticket offices, United has an easy way for U.S.-based retirees to purchase their reduced-rate interline tickets. International employees can continue to purchase reduced-fare tickets through their normal channels.

Retirees can call the Interline Pleasure Travel Desk in Reservations, #1-888-874-1581. the line will be open Mon. through Fri from 0700 to 2100 Central time. A reservations sales & service representative will assist with the purchase of reduced-rate interline tickets. This service will

provide pricing information & will send the tickets to the retiree.

This service will simplify the reduced-fare ticketing process and will allow customer service representatives to focus on serving revenue customers. Instead of making multiple trips to the airport for tickets, U.S-based retirees won't even have to leave home.

Reduced-rate interline tickets can be purchased by credit card or check and can be sent free of charge via U.S. mail, or for a \$15 fee via FedEx. Those requesting tickets should allow 5 to 7 business days for ticket receipt if paying by credit card & 10 business days if paying by check. As always, retirees should review the SkyNet Travel section to determine which carriers offer reduced-rate travel to United retirees & their eligibles before calling to request a ticket. Retirees also should have their itinerary, names of persons traveling, dates of travel & their file numbers ready before they call.

Retirees also can e-mail their interline reducedfare requests to <u>interlinepleasuretvl@united.com</u> with this same information.

In the event of last-minute travel plans, reduced-fare interline tickets can be requested by phone & picked up at the airport. Retirees should call the Interline Pleasure Travel Desk to create a passenger name record (PNR) & obtain their record locator number. Upon arrival at the airport, travelers should proceed to the check-in counter, provide the CSR with their record locator numbers to have their tickets printed. A form of payment will be required at that time.

The new ticketing service is available only for the purchase of reduced-fare tickets on other airlines. For space-available travel, retirees should continue to use Weblist for the VRU system at 1-800-UAL-LIST to make United or United Express pass travel listings for themselves or to list companions on United.

Unused reduced-fare tickets can be refunded by United's Refund Department at United Airlines, Passnger Refunds-WHQAK, P.O. Box 66282, Chicago, IL 60666.

More information on this service for obtaining reduced-fare interline tickets is available on SkyNet. From the home page main menu, select "Travel", then click on "Interline Travel Benefits".

UNITED LAUNCHES NEW INTERNATIONAL ROUTES

United will launch 3 major new international routes. New flights include daily nonstop service between Chicago O'Hare International Airport (ORD) & Osaka, Japan (KIX), also between Washington Dulles International Airport (IAD) & Zurich, Switzerland, (ZRH), effective June 10, 2004. By the end of Oct. United will also add daily nonstop service from Chicago (ORD) to Buenos Aires (EZE).

Flights between Chicago & Osaka will be with Boeing 777 aircraft. Flights between Chicago & Buenos Aires and between Dulles & Zurich will be with Boeing 767 aircraft.

COMPANION FARES DECREASE FOR 90 FLIGHT SEGMENTS & \$25 MINIMUM RETURNS

Effective 2/1/04 United changed the companion ticket program in two ways. Companion ticket fares will decrease for 90 flight segments. The \$25 minimum fee was reinstated. The fare reduction is due to changes in pricing that allow Revenue Management to use a broader range of fares. In addition, international companion fares now will be based on the lowest unrestricted round-trip FBC instead on the lowest unrestricted one-way FBC.

On average, 74 U.S. flight segments will decrease their companion fee by \$25 & 16 international-segment fares will drop \$58. Examples of one-way fare changes include SFO-NY from \$113 to \$56, CHI-PHX from \$85 to \$60, and DCA-Amsterdam from \$199 to \$123. Taxes & fees will continue to be charged in addition to the base companion fare.






