## HOORAY FOR HOLLYWOOD!



The famous Hollywood sign originally read "Hollywoodland." It was erected in 1923 to advertise a new housing development in the hills above Hollywood. For several years the sign was left to deteriorate. In 1949, the Hollywood Chamber of Commerce stepped in, offered to remove the last four letters and repair the rest. The sign, located at the top of Mount Lee, is now a registered trademark of the Chamber of Commerce, who also manages the venerable Walk of Fame. The sign can be easily seen from the levels of the area at the rear of Hollywood & Highland, also on two levels are viewing telescopes for a close up look.

Another interesting landmark in the area is the famous Capitol Records building, on Vine Street just north of Hollywood Blvd. It is a recording studio not open to the public, but its unique circular design looks like a stack of old 45 RPM records. Yet another location to record with your camera. Bring lots of film (or a digital camera).

# GENERAL NEWS

## FROM THE PRESIDENT

I assume you have been following the events in United's bankruptcy.

The Flight Attendants, Pilots, Meteorologists & Dispatchers have all reached agreements, the membership ratified the agreements & the bankruptcy judge approved the agreements. AMFA members rejected their tentative agreement; the IAM & United did not reach an agreement. Upon petition by United, the bankruptcy judge ordered an immediate pay reduction of 11.5% for the IAM & a 10% reduction for AMFA. The IAM & AMFA are in negotiations with United; are targeting to reach an agreement by April. All Salaried & Management employees' salaries were reduced from 4% to 14% on Jan. 1. In addition all Salaried & Management employees are paying part of their medical insurance, the number of Holidays has been reduced also vacations have been reduced.

Currently all the unions & United are in negotiations regarding the pension plans. The target date for resolving this issue is April.

The biggest impact on income & benefits is and will be on active employees.

A number of RUAEA members have suggested that RUAEA become more aggressive with the company, hire legal council, file suit in the bankruptcy court and become a principal in the bankruptcy proceedings. The key issues affecting retirees are travel, medical insurance & pension. Your RUAEA Officers have discussed this, assessed the cost/benefit we would realize in pursuing this direction. Frankly, our assessment is that we would have little if anything to gain. Since our membership voted for RUAEA to pursue a proactive stance with the company regarding retiree interests, issues & concerns we have established a formal presence in WHQ. Under the leadership of Ed Tolle, assisted by other retirees, he meets frequently & regularly with the principals responsible for retiree benefits & policies. In addition, Ed, Mort Wax & I meet regularly with Glenn Tilton & Sara Fields regarding these matters. Currently the status is:

Travel: The policy regarding travel, in which we pay a service charge, was implemented 2 years

ago. There is no change; no change is planned. (The exception is the interline travel in which service charges are based on the ZED program rather than the ID 75, ID 90 & ID 95. These details are published in the newsletter, the RUAEA website & on Skynet.)

Medical insurance: Last summer all the insurance plans for retirees were negotiated with the company & approved by the bankruptcy judge. There is no change to this as long as United is a viable company. (Many members have asked what alternative plans are available in the marketplace in lieu of United's plans; secondly, what would be available to retirees in the event United does not survive. Refer to Mort's article in this newsletter regarding this issue.)

Pensions: As mentioned above, United is negotiating with all the unions regarding the pension plans. The ERISA Act of 1979 & the guidelines of the PBGC are very clear in the event of termination of the defined benefit plans. I wrote articles in the Nov. 2004 & in the Jan. 2005 Newsletters detailing what we retirees can expect upon termination of the plans.

I mentioned that we are working very closely with the top management & principals of United Airlines. We are being kept informed of the status and progress in bankruptcy; the impact on retiree benefits & policies. We have the opportunity to provide input regarding these matters. We have assessed that hiring legal representation and/or becoming an active player in the bankruptcy court proceedings would not change the status of our benefits, therefore we will continue to work in a positive, collaborative, problem-solving approach directly with the principals of United. We will continue to maintain open communications re these issues. We will continue to support United in its survival struggle also assist in whatever ways we can to reach that goal.

We will continue to try our best to keep you informed.

## FROM THE EXECUTIVE VICE PRESIDENT

Especially over the past two months many retirees have been asking questions about our

medical insurance. Members of RUAEA & RUPA are questioning:

- Is there a better alternative to United's existing health insurance group plan?
- What alternatives would be available in the event there is no United medical/prescription coverage plans?

Recently we jointly pursued answers to these 2 questions.

There are 2 organizations who have been providing assistance to furloughed United employees with needs involving health plans. We met with them on Jan. 20. Pres. Marlin Lade, RUAEA member Chick McErlean & I, together with Pres. Rich Bouska of RUPA & Dick Schultz of RUPA met with representatives of IMA of CO & AXA Advisors (some of them furloughed pilots) to receive information on what is available & what are our options.

First, what are better alternatives to United's existing health insurance group plan? By law an employer/employee relationship must exist for a group plan to be possible. For a different group plan, United would have to contribute as it does to the current retiree plan. There is no option for a group plan if United does not contribute. Neither RUAEA nor RUPA could be a sponsor because neither organization provides an "employer/employee relationship". (For example, AARP. AARP has worked with an insurance underwriter to provide insurance for its members, however, members join an insurance plan as an individual, not a group plan.)

IMA of CO researched health insurance plans offered by Aetna, Blue Cross/Blue Shield, CIGNA, UHC & Great West. Their analysis was that none offered benefits & costs that could compete with what United is currently offering. They supplied us with documentation of their findings. Their recommendation is "...stay with current United program."

Each of us has the prerogative to individually contract with any health insurance provider instead of United's group plan.

Second, what are the alternatives in the event there is no United medical/prescription coverage plan? For pre-65 retirees, the only options are individual programs that are individually underwritten, that vary based upon need and that vary in premium levels. Because these programs

are individually underwritten, specific medical conditions & related complications can be excluded or can be entirely declined for coverage. In case the insurance coverage is declined, the only available option would be a State uninsured pool. For post-65 retirees, who are covered by Medicare A & B, there are 10 supplemental (Medigap) Standard plus Medicare Advantage plans available. Again, please note that in the event of United medical plan termination preexisting conditions covered under the canceled group plan will be covered only within 63 days of group plan termination when applying for a replacement supplemental plan.

If you are interested in reviewing options & costs available to you, we recommend that you access either or both the Defined Contribution Benefit Solutions & Medicare websites at [www.chooseyourbenefits.com](http://www.chooseyourbenefits.com) or [www.medicare.gov](http://www.medicare.gov). You can compare your options & costs; advantages & limitations. Our advice is:

1. Be careful! There may be no guaranteed coverage upon selection of an individual contract carrier. Applicants may be required to go through the carrier's health screening process.
2. Be careful. Once you voluntarily suspend United's group plan you will not be able to re-enroll, unless you can provide proof that you had continuous coverage in an eligible plan while your United plan coverage was dropped. Eligible plans include another employer-sponsored health plan, a Medicare HMO or Medigap-"Plan J" & coverage through TriCare for active & retired military personnel plus their dependents. (See Section 2 of your United Summary Plan Description.)

## **RUAEA BOARD OF DIRECTORS MEETING**

January 31, 2005

Pres. Marlin Lade opened the meeting and commented on areas of retirees concerns, namely: pensions, health insurance & travel benefits. The Policy & Procedure Manual has been amended.

The By-Laws will also be amended pending the approval of the RUAEA members at the 2005 Annual Business meeting in Hollywood. The proposed By-Law changes will be published in the April 2005 edition of the Newsletter. This is necessary, to reflect the new RUAEA policy, changes in the Denver Office & incorporating the newly created appointed positions as Board members.

Executive VP Mort Wax reported that Newsletter typist Shirley Smith has retired & the position has been filled by John Chu. The number of Newsletter Membership Secretary personnel will be increased from 3 to 5, one for each day, due to the large volume of new membership. A Denver Procedures Manual is needed for the proposed new Denver Audit. The Reinstatement file will be changed. After one year in arrears, member will be dropped off the membership file. Upon reinstatement, old arrears member will be treated as a new member. An Associate member will retain the birth-date of the deceased RUAEA member. When the birthday falls within the first five months of the date from when an Associate membership application is processed in the DEN office, renewal of membership is not due until the next birthday.

Membership /Support Manager Howard Tress distributed a new member & membership renewal procedures to the Board. One for the RUAEA website is in development. Once your ID & password are established, there will be no need to use each sign when logging on to [www.ruaea.com](http://www.ruaea.com) as security is assured.

Newsletter Manager Virgil Gooselaw reported an increase of new membership at 33% & an increase of costs for printing the Newsletter has risen 10% with projection to 20% for this year. Will limit the Newsletter to 52 pages. Expense would significantly decrease with sign-up for electronic copy ([www.ruaea.com](http://www.ruaea.com)).

Website Manager Jim Sommerfield reported on possible new enhancements for the RUAEA website & requested additions to the proposed Website Managers Duties for the Policy and Procedures Manual.

Membership Secy. Harriet Ahr reported membership at 11,932 as of Jan. 29, 2005. Secretaries are still processing "beige" application forms.

Newsletter Editor – Jo Madden requested the

deadline date for news items to be published in the Newsletter be moved back to the sixth (6<sup>th</sup>) of the month from the current thirteenth (13<sup>th</sup>) date. Motion made, seconded & carried. Effective with the April issue. The list of new members ended with the letter M; will be continued in the next issue due to Newsletter size constraints. Invitations will be sent to the Chapter correspondents for the Correspondents Breakfast at the Convention.

The Financial Statements for the 4th quarter & year-end 2004 were distributed & reported to the Board by Treasurer Charlie Lewis. The 2004 Annual Audit was completed. RUAEA is financially sound. Motion made, seconded & carried to accept the 2005 Budget as amended to increase the proposed cost of printing the Newsletter due to large number of new members.

Convention Chairman Hal Klobe made a progress report for the 2005 Hollywood Convention. All convention activities are on schedule. VP of Conventions Bud Hubbard reported that the 2006 Convention city will be announced at the 2005 Hollywood Convention. The Site Selection Committee has begun the search for the 2007 Convention city.

The nominating committee is selecting the slate of candidates for the office of Regional Directors for the Northwest Region & Arizona Region. These Directors have served two, 2 year terms, also candidates for the Mountain Region & Northeast Region Directors who are up for reelection. Please contact the Nominating Committee Chairman Jim Fauber, committee members Helen Cauwels or Gordon Starr or a Regional Director if you are interested ASAP. Phone numbers are available on the back of the Newsletter. **UNITED MAKES INTERLINE TRAVEL  
MORE AFFORDABLE**

United announces the initial rollout of even more affordable interline rates through the Zonal Employee Discount (ZED) program -- an interline fare program widely used by other carriers. United employees & retirees are eligible to purchase ZED reduced-rate interline tickets initially only on Lufthansa, with other carriers to be added as agreements & automation are completed.

ZED fares replace industry discount ID90/95 fares for interline travel, simplify & significantly reduce pricing for non-revenue space-available interline pleasure travel. For example, the ZED fare for travel from Munich to Chicago is \$96.69 compared to the current ID95 fare of \$280.69 -- a 66% savings. For details on how to find out what ZED fares will cost, visit the Apollo profile S\*UPE/INTERLINE-ZED.

ZED pricing is based on mileage between the origin & destination per segment rather than a percentage of the market fare. ZED fares also offer a larger discount in part because surcharges on interline pleasure travel are eliminated, except for government-mandated fees. To start, adult ZED fares will apply to all eligible interline travels, including children & infants; however, future enhancements to the program will include child & infant discount fares.

Offering fares using the ZED formula is a positive benefit for all employees & retirees also adds no incremental cost to the company.

Eligible employees & retirees purchase ZED tickets & request refunds the same way they currently do for ID90/95s. Current interline policies remain the same. Initially, ZED fares are available to United employees/retirees traveling on Lufthansa interline tickets. The ZED team -- comprised of Onboard Service, Flight Operations, Worldwide Sales Performance & International Support, Information Services Division, Revenue Management, Reservations Planning, Customer Service Planning & Human Resources -- is working

to add other carriers in the near future.

United is pursuing ZED agreement with numerous other carriers worldwide that use the ZED systems; will add airlines to its ZED program as quickly as possible, focusing on carriers that employees use most frequently for interline travel. United initially implemented ZED on Lufthansa, because it's the most used carrier among employees & retirees for interline travel.

**STANDBY TRAVEL BETWEEN BRAZIL &  
U.S. WILL BE DIFFICULT THROUGH  
MARCH**

Standby travelers will find it challenging to fly between the US & Rio de Janeiro & Sao Paulo from now until the Easter holiday, due to the Carnival festivities in Brazil. Although flights may appear to have seats open, weight & balance restrictions are also affecting the number of passengers who can board.

Employees & Retirees who have eligible dependents or unaccompanied companions planning to travel on these routes should advise them that space-available travel may be difficult during this high-volume period.

**CUSTOMERS EARN MILES IN UNITED PET  
CLASS**

Pets are eligible for top-notch travel perks, just like their owners. With the introduction of United Pet Class, Mileage Plus members can earn miles for flying with companions who bark, meow & chirp.

United transports approximately 150,000 animals per year for a fee. Pet carrying fees range from \$80 each way for in-cabin carrying to \$200 each way for large kennels transported in the cargo hold. Along with the fees, all United policies on pet travel remain the same, including in-cabin capacity limits.

United's Pet Class program kicks off with a special offer for Mileage Plus members to earn 1,200 bonus miles when their pets fly with them. This offer is good through May 27, 2005.

Whether shipping pets as checked baggage or riding with them in the cabin, Pet Class customers

who register for the offer will earn the bonus miles when they purchase & complete one paid, qualifying roundtrip flight to any United destination worldwide, so long as the pets accompany them on at least one segment of the same itinerary.

United also is the Official Airline of the American Kennel Club (AKC), which recently held a nationally sponsored dog show championship in Tampa, FL., where United promoted its new program to a full house of media representatives & potential customers. ### **UNITED ADDS 3 MORE NONSTOP CHI/ HONG KONG FLIGHTS TO WEEKLY SCHEDULE**

United is adding 3 more flights to our existing daily CHI/Hong Kong schedule. In early June, the CHI/Hong Kong route will have 10 daily nonstop flights per week.

Beginning Jun. 7, United Flight 829 will depart CHI on Tues., Fri. & Sun. at 3:10 p.m., arrive in Hong Kong 7:45 p.m. the next day. Starting Jun. 10, United Flight 828 will depart Hong Kong Tues., Fri. & Sun., 10:10 a.m., arrive in CHI 11:40 a.m. the same day.

### **TED TO ENTER LOW-COST MARKET AT CHICAGO MIDWAY AIRPORT**

Ted will launch 3 daily flights to DEN & 2 daily flights to Washington Dulles from CHI Midway Airport, the heart of Chicago's low-cost carrier market. Beginning Apr. 3, United is expanding its Ted service to Midway Airport, located on the city's southwest side.

United will operate the new Ted service using 156-seat Airbus A320 aircraft.

### **UNITED TO RECALL 150 PILOTS**

150 pilots previously laid off will be called back to work this year to offset pilot retirements.

United expects to recall 75 pilots in the spring & 75 later in the year.

The Company has about 6,400 active pilots; 2133 pilots on furlough, according to the Air Line

Pilot Association.
