



# The Writers Column: A Perspective on US Airways 1549 Ditching in the Hudson River by Tim Joslin Sr. (Retired UAL pilot)

"US Air 1549, LaGuardia tower, taxi into position and hold on Runway 4." "Roger, US Air 1549 into position on Runway 4." In the cockpit, Captain Sullenberger calls for final items on pre-takeoff checklist. "US Air 1549, LaGuardia Tower, cleared for takeoff!" "Roger, US Air 1549 cleared for takeoff?" Captain speaks to the co-pilot, "you have the aircraft." Co-pilot assumes control and takeoff roll begins. Captain (pilot not flying) calls out airspeeds as aircraft accelerates down the runway. "V1, VR (rotation), V2 (aircraft airborne)." Copilot says "positive climb, gear up" and Captain raises the landing gear. LaGuardia tower transmits "US Air 1549 contact New York Departure Control". Captain acknowledges La Guardia Tower and switches to departure control frequency. Co-pilot continues to fly and requests flap retraction on schedule set by gross weight and airspeed. Captain contacts departure control, retracts flaps on command and does the after takeoff checklist.

At an altitude of approximately 3200 ft, a few miles NW of LaGuardia Airport, the co-pilot exclaims "a formation of geese!" The Captain only has time to look up and then, instinctively, lower his head to avoid the impending collision. The next sounds heard are the booming backfires (compressor stalls) from both engines as they try to swallow the twenty pound Canadian Geese. Jet engines are certified to ingest a 4 lb. bird but not a 20 lb. carcass! The engines immediately begin to wind down, losing power. US Airways 1549 has become a glider and starts descending.

Captain Sullenberger says, "I have the aircraft!" and takes control from the co-pilot. In the passenger cabin, there is the smell of burning feathers and smoke along with the realization, by the flight attendants and the more experienced travelers, that something has gone very wrong. Captain Sullenberger declares an emergency on their radio frequency, informing New York Departure Control that they have lost both engines and

orders the co-pilot to execute the Engine Relight Procedure (three pages long). LaGuardia Tower is informed of the emergency and immediately shuts down all take-offs and landings, clearing the way for a US Airways return to the airport.

Captain Sullenberger makes a quick decision, after initially turning back towards LaGuardia Airport, that the aircraft does not have the altitude or airspeed to make that airport. Air traffic controllers then suggest Teterboro Airport, just west of the Hudson on the New Jersey side. The Captain has never landed there, is not familiar with surrounding obstacles and quickly calculates that it is too far. The co-pilot frantically continues to try restarting both engines with no success! As the disabled aircraft descends over the George Washington Bridge, the Captain makes his decision: "We will be in the Hudson", he declares over the radio.

Normal ditching of a powered aircraft calls for full landing flaps, gear up, and splashing down with full power on the engines, to land as slow as possible without stalling the aircraft. If done right, a ditching is survivable. Captain Sullenberger's strategy is quickly formed based on his Glider Pilot Rating. He commands the co-pilot to extend the slats (leading edge flaps). A far cry from the normal full flaps called for, but a compromise that might work in this situation. The aircraft is now at 300 ft over the Hudson River with airspeed of 153 knots. The Captain keys the passenger address system and yells, "THIS IS THE CAPTAIN, BRACE FOR LANDING!" The flight attendants, knowing impact is imminent, began yelling from throughout the cabin, "BRACE, BRACE, BRACE,"

The Captain has visually selected an area on the river which is close to some ferry docks. He commands the co-pilot, "call out my airspeed". If the aircraft gets too slow before splashdown, it could stall, resulting in loss of flight controls and a disastrous result. Captain Sullenberger's physical manipulations of the flight controls, in the last seconds before splashdown, result in the wings level, nose slightly high and airspeed deteriorating toward a stall. Splashdown is characterized by one deadheading crew as akin to moderate turbulence. One of the passengers compares it to a rear-end collision with a car. Overall, an excellent result! Shouts of "EVACUATE, EVACUATE" ring throughout the aircraft "RELEASE YOUR SEATBELTS AND GET OUT!", "COME THIS WAY" directing passengers to the nearest working emergency exit.

One passenger in the aft cabin partially opens a submerged emergency door but is stopped by others. Water begins to leak into aft cabin and passengers become alarmed as water laps at their knees and passengers farther forward don't appear to be moving. Finally, there is movement and passengers escape either through over wing exits or into two inflated forward door slides which serve as rafts. After all passengers appear to be out of the aircraft, Captain Sullenberger makes two complete trips up and down the length of the cabin to verify no one is left behind. The aircraft continues to float, even after all passengers and crew are picked up by rescue personnel. It drifts about 4 miles down the river before it is grounded by a tugboat.


The Miracle on the Hudson has happened!

As a postscript, Model A-321, from the aircraft manufacturer, was designed and certified with no over wing exits!



#### **Know our Volunteers**

#### <u>United and Aer Lingus Announced</u> <u>Transatlantic Partnership</u>

United is expanding its relationship with code share partner Aer Lingus. This relationship enables United to introduce service between Washington Dulles and Madrid, this is an opportunity to leverage the new EU-US Open Skies Agreement with a new transatlantic, nonstop route that would not be economically viable on its own and brings more traffic and revenue to its network.

The new route opens for sale this April, with daily

service starting in March 2010.

Under the agreement, which covers select long-haul service between North America and Europe, United will manage revenue generation and Aer Lingus will be responsible for operational aspects. The new route structure will be operated and sold under both Aer Lingus and United codes, leveraging both carriers' networks.

"Our expanded agreement takes advantage of new opportunities under the US-EU Open Skies Agreement, benefiting our customers with additional competition and capacity in these markets," says Glenn Tilton, United chairman, president and CEO. "This partnership provides for a deeper commercial relationship with Aer Lingus, and capitalizes on the unique strengths of both our companies."

On a related note, Ryanair was making a takeover bid for Aer Lingus and made a friendly poke at United partnership agreement. United responded, in kind, by saying it appreciates Ryanair's congratulations on a good addition to its network, and look forward to taking Aer Lingus customers to four continents and hundreds of destinations that Ryanair doesn't serve.

## ATC Modernization Essential for Revitalizing Economy

As President Obama and a new Congress continue to deliberate on how to best revitalize the economy, United's industry leadership is essential to ensure investment in a Next Generation Air Traffic Control (ATC) system.

This week, Glenn Tilton, representing United and the Air Transport Association (ATA), conducted a number of visits with administration and Congressional leaders to advocate for modernizing the ATC and investing specifically in aircraft equipage and avionics. A modern ATC system is an essential underpinning for sustained future economic growth that will benefit the airline industry, its employees and customers.

Both Glenn and James May, ATA president and CEO, commended President Obama for his focus on confronting the economic challenges and urged the use of federal stimulus investments to include the Next Generation ATC system.

Investing in modernizing aircraft equipage can generate 77,000 jobs in a variety of industries, reduce greenhouse gas emissions by up to 12 percent (equivalent to taking 2.2 million cars off the road), reduce passenger delays across the system and help transform the broader economy.

Other aviation partners supporting this request include the Air Line Pilots Association, International Brotherhood of Teamsters, National Business Aircraft Association, Regional Airlines Association and Aerospace Industries Association.

Aviation is critical to helping speed our nation's return to economic growth and prosperity, notes Glenn and Jim in a letter from the ATA to President Obama. "Any sustained national recovery will depend on affordable and efficient transportation networks connecting more people in more places. Decisions made in Washington in 2009 will determine whether our aviation infrastructure is up to the challenge."

## Bees in the Bellies Contribute To a Better Bottom Line

Passengers on the starboard side of Flight 870 from Sydney must have wondered about the film crew waiting on the ramp as the B747 pulled up to the gate in San Francisco one recent January morning. Were they on hand to greet a VIP passenger after the 13-hour flight? Actually, they were there to document the arrival of two United Cargo pallets loaded with tens of thousands of VIPs – "Very Important Pollinators."

Flight 870 carried a shipment of bees, imported from Australia to help California growers deal with the sudden decline in the bee population in the United States. A non-profit organization making a movie called "Return of the Honeybee" was at SFO to track the bees from the cargo hold of the B747 over to the Cargo facility. There, the bees were claimed by a California-based pollination service that imports Australian bees to reinforce the domestic colonies that pollinate almond orchards and other agricultural interests in California.

The customer, one of many frequent shippers with United Cargo, says he's pleased with our cargo shipping service that he's received the past few years: "I bring in about 10,000 boxes of bees each winter from Australia, where it's summer this time of year, and have been since 2004. Without these bees, our agricultural industry would be in serious trouble." Bees? All in a days work.

While the film crew watched with excitement, the ramp personal who unloaded the bees did so with their usual care. The SFO ramp crews "have seen just about everything you can imagine emerge from the bellies of our planes over the years," says Scott Ramos, ramp supervisor. "I don't think there's an animal or food we haven't unloaded at some point."

Cargo's revenue has grown over the years to 854 million dollars in 2008, an 11% increase over 2007.

Maximizing cargo revenue opportunities on every flight, especially internationally, is at the forefront of the Cargo operation for 2009, says Managing Director Kyle Betterton.

"Once passengers, their luggage and mail are loaded on an airplane, that leaves a certain amount of space for us to fill," Kyle said. "Our goal is to fill all of that space, up to the weight limits, on each of those airplanes."

### With United's Support, Chicago Students Witness History

On television and the Internet, millions of people around the world watched the inauguration of President Barack Obama. With United's help, a group of 15 students from the South Shore School of the Arts, United's partner high school in Chicago, joined the throngs of people who were fortunate to witness this historic event in person.

Their once-in-a-lifetime trip to the nation's capital many of the students had never visited Washington before, and most had never flown - began early Monday morning with a surprise greeting by news reporters from Chicago's network television affiliates, who filmed the students stepping off their school bus and checking in at United counter at O'Hare. The students were given United backpacks and pens, as well as cameras and journals to document their trip and, after a send-off by ORD Customer Service Manager Lisa Cole, boarded Flight 580 to Baltimore (BWI).

"Everything was good and smooth" on board and upon arrival at BWI, says student Phillip Dickerson, who filmed the entire flight while on board.

The group hit the ground running, checking into their hotel and embarking on a volunteer project as part of their community service work on Martin Luther King, Jr. Day. On Inauguration Day, a busy itinerary was highlighted by the chance to witness the swearing-in up close. "It was fun, it was nice, it was great." said student Michelle Hawkins. "It was cold, but it didn't matter. I was so elated to be there."

A special Inaugural Ball was arranged in the evening for the students who dressed in ball gowns and tuxedos.

The next day's agenda included visits to historic attractions, including the Corcoran College of Art and Design and the Capitol.

#### Fourth Quarter 2008 Financial Results

**UAL Corp:** 

- → Reported a fourth quarter pre-tax loss of 547 million dollars excluding non-cash, net mark-to-market hedge losses and certain accounting charges. Including these items, United reported a pre-tax loss of 1.3 billion dollars.
- Reported basic and diluted loss per share for the fourth quarter of 4 dollars, 22 cents, excluding non-cash, net mark-to-market hedge losses and certain accounting charges. Including these items, United's

- loss per share was 9 dollars, 91 cents.
- → Reported solid revenue performance with a 4.7 percent increase year-over-year in fourth-quarter consolidated passenger unit revenue per available seat mile (PRASM), excluding Mileage Plus accounting impacts. Including these impacts, consolidated PRASM increased 2.1 percent year-over-year.
- → United reduced the total operating expenses (\*\*) 7.4 percent for the quarter, compared to the prior-year period. Capacity reductions typically result in significant increases in unit costs since fixed costs take longer to address and, in the short term, are spread over a smaller number of seat miles. In the fourth quarter, United managed to hold its non-fuel unit costs per available seat mile (CASM) for the quarter, excluding certain accounting charges, to a modest 1.6 percent increase, despite the 11.7 percent total capacity reduction that was achieved for the fourth quarter.
- Raised nearly 390 million dollars in cash in the fourth quarter through various activities, including aircraft financings, asset sales and equity issuances.
- Recorded its best fourth-quarter on-time performance since 2004.

United is taking additional steps in 2009 to reduce overhead costs (Please see the following story on salaried and management reductions).

United reported a pre-tax loss, excluding non-cash, net mark-to-market losses and certain accounting charges, of 547 million dollars for the quarter. This compared to an adjusted pre-tax loss of 105 million dollars in the fourth quarter of 2007, as the recent fall in fuel prices drove losses on fuel hedges put in place earlier in the year when prices were rising to unprecedented levels. Including these items, United's fourth-quarter pre-tax loss was 1.3 billion dollars in 2008 compared to a pre-tax loss of 98 million dollars in 2007.

Total passenger revenue for the quarter decreased 8.7 percent year-over-year as consolidated capacity declined 10.6 percent, consolidated yield increased 2.4 percent and load factor decreased 0.3 points. Cargo revenue for the quarter decreased 19.3 percent year-over-year as a result of lower international capacity and weakening demand.

Continued Focus on Cost Performance: Mainline CASM, excluding fuel and certain accounting charges, was up only 1.6 percent in the fourth quarter, despite an 11.7 percent decline in mainline capacity as United took aggressive action to remove fixed as well as variable costs from the system while reducing capacity. For the full year 2008, mainline CASM excluding fuel and certain accounting charges was up only 1.5 percent, despite a 4.2 percent decline in capacity.

<u>Lower Fuel Prices Resulted in Hedging Losses:</u> United recorded 370 million dollars in cash losses on fuel hedges that settled in the quarter, as the recent fall in fuel prices drove losses on hedges put in place earlier in the year to mitigate the steep increase in prices that had occurred in the second and third quarters of 2008. In addition, United also recorded non-cash net, mark-to-market losses on its fuel hedges of 566 million dollars.

Actions Taken to Enhance Our Cash Position: United completed several transactions during the fourth quarter that helped strengthen its liquidity. It raised 215 million dollars from aircraft financing transactions that closed during the quarter along with 66 million dollars in proceeds from asset sales. United also received net proceeds of 107 million dollars through equity issuances during the quarter.

During the fourth quarter, United generated negative 989 million dollars of operating cash flow and negative 1.1 billion dollars of free cash flow, defined as operating cash flow less capital expenditures. Both the operating cash flow and free cash flow include 587 million dollars in additional net fuel hedge deposits that were paid during the quarter.

The company ended the quarter with an unrestricted cash balance of 2.0 billion dollars, a restricted cash balance of 272 million dollars and 965 million dollars in cash deposits held by our fuel hedge counterparties.

Early in 2009: Early in the first quarter of 2009, United closed an additional aircraft financing transaction, which raised 95 million dollars and expect to raise approximately 160 million dollars from a cargo facility relocation agreement with ORD. In January, United received net proceeds of 62 million dollars from equity issuances and anticipate receiving an additional 27 million dollars of net proceeds in the first quarter by completing the equity issuances that were announced in December. Altogether, United expects to raise about 350 million dollars from these transactions by the end of the first quarter.

Significant Improvement in Operating Results: United has seen significant improvement in its operational performance during the fourth quarter as a result of its increased focus on operational execution, improvements in the schedule structure and the industry-wide reduction in capacity. United is also benefiting from the November opening of the new runway at ORD.

<u>United's on-time arrival</u>: Performance for the fourth quarter was 79.2 percent, United's best fourth-quarter performance since 2004. The cancellation rate was 1.4 percent, its lowest fourth-quarter rate since 2005. As a result of these improvements, United ranked second in on-time performance for the fourth quarter among the five major U.S. network carriers, including Continental Airlines, American Airlines, US Airways and the combined Delta/Northwest Airlines.

United is on track to complete the previously announced removal of 100 aircraft from its fleet by the end

of 2009.

## ASK THE PHARMACIST What you should know about cholesterol!

Cholesterol is a waxy, fat-like substance that's found in all cells of the body. It has both good and bad effects on your overall health. Your body uses cholesterol to make hormones, vitamin D, and substances that help you digest foods.

Too much cholesterol in the blood, or high blood cholesterol, can be serious. People with high blood cholesterol have a greater chance of getting heart disease. High blood cholesterol on its own does not cause symptoms; so many people are unaware that their cholesterol level is too high.

When your body has too much cholesterol, deposits of fat, called plaque, form inside blood vessel walls. The blood vessel walls thicken and become narrower (a condition called atherosclerosis). This change reduces blood flow through the blood vessels. Fatty plaques caused by high cholesterol can rupture, possibly leading to heart attacks or strokes.

#### What are your cholesterol numbers?

It's important to find out what your cholesterol levels are, because lowering cholesterol levels that are too high, lessens your risk of developing heart disease. When you get your cholesterol checked, your healthcare provider will give you a number for your total cholesterol level.

- A total cholesterol level of less than 200 is considered desirable.
- A total cholesterol level of 200 to 239 is considered borderline high.
- A total cholesterol level of 240 or above is considered high.

When your cholesterol is found to be high, your healthcare provider may also check the amount of LDL (low-density lipoprotein) and HDL (high-density lipoprotein) in your blood. LDL cholesterol is called bad cholesterol. HDL cholesterol is called good cholesterol. It's good to have low levels of LDL and high levels of HDL.

#### Lowering your bad cholesterol

Eating right, exercising, and not smoking can often control cholesterol levels. If you have a high risk for heart disease, your healthcare provider may prescribe cholesterol-lowering medication and recommend changes in lifestyle. Many cholesterol-lowering medications are available as generics. If your doctor recommends a cholesterol-lowering medication, ask about an available generic medication that may save you money. Here are some tips for lowering high cholesterol levels:

- Increase your dietary fiber by eating more fruits, vegetables, and whole grains.
- Lose weight.
- Increase physical activity.

# RUAEA Membership Dues Increase (Please Note that this policy is not effective until JUNE 1, 2009)

RUAEA, like any other organization that provides a service to its membership has to weigh the expense of providing the service relative to its income. Our source of income is primarily from membership dues and a nominal amount of income from savings accounts. Another source is from contributions, of which we are grateful. In view of the fact that our costs have gradually increased over the last ten years (since our last dues increase) we feel it necessary to make an adjustment. At our last Board of Directors meeting, an increase in dues was recommended. The recommendation was weighed and after due consideration the board approved a nominal increase. In addition to the increase, a multiyears' choice (at a discount) was also approved, for a limited period of time, and an option to receive both the web/internet and paper versions. The new dues structure (effective June 1, 2009) is as follows:

#### Domestic Members:

- \* One year \$25.00
- \* Two years \$45.00
- \* Three years \$60.00

Domestic and Foreign Regular members can receive the monthly RUAEA newsletter either via the U.S. mail or the Internet (usually available 3 weeks ahead of the mailed edition). If you would like to have both Internet and US mail, you can get it for an additional \$5.00 per year. NOTE: The option of both paper and Internet is not available for Life Members. You can have one but not both.

#### Canadian Members:

- One year \$45.00
- **Solution** Two years \$85.00
- **∞** Three years \$105.00

#### Foreign Members:

- ★ One year \$50.00
- ★ Two years \$95.00
- **★** Three years \$120.00

Regular Members from Canada or Foreign locations may receive their Newsletter by the internet <u>only</u> at the Domestic yearly rates. <u>NOTE</u>: Once this option is selected, you cannot revert back to the paper Newsletter until the membership expiration date.

**NOTE:** The two and three year options listed above will be available for <u>one time only</u> beginning **June 1**, **2009** and ending **June 1**, **2010**. After that, the dues structure will revert to one year increments.

#### **Travel Tips By Bob**

I have recently been receiving queries concerning Boarding Priorities, so I thought I would dedicate this month's Travel Tips to boarding priority. Most of the following is taken from the Travel Section in SkyNet and then some words of wisdom at the end.

Employee/eligibles and companion travelers are accommodated on a space-available basis by boarding priority and, within each boarding priority, by seniority.

Boarding Priority refers to the type of travel (e.g., emergency, business, pleasure) and the status of the individual traveler (e.g., crew member, retiree/dependent, employee/dependent/enrolled friend, and companion). Passes are coded with a "BP" and a number showing boarding priority. The lower the "BP" number, the higher the priority. Stand-by travel eligibles and companions traveling with an employee/retiree flying on a NRPS business pass/emergency travel or with an emplovee working as a crew member (including deadheading) are considered unaccompanied and the lower space available boarding priority applies, thus a higher number. Pleasure travel for employees, their travel eligibles, and companions are ordinarily coded BP8A, 8B or 8C. Pleasure travel for high-seniority retirees and their dependents is likely to be coded BP6B.

Seniority is based on Date of Employment, with more senior employees and retirees boarded ahead of less senior employees and retirees. Dependents, travel eligibles and companions are boarded according to the seniority of the employee\* or retiree\* from whom they derive their travel privilege. Retirees with less than 25 years of service and surviving spouse\*\*/surviving domestic partners\*\*/Dependents\*\* and parents\*\* of active employees are boarded based on the years and months of company service.

\*\* Boarded by company seniority if the employee died while performing work-related duties or when traveling on business or pleasure travel where the death was caused by a UA/UAX aircraft accident or by the intentional conduct of a third party while on board a United/United Express aircraft. Employee death caused by a car accident or while on a layover or personal time is excluded.

Surviving dependents of employees killed on duty or when traveling on a UA/UAX aircraft: Surviving spouses, domestic partners and eligible dependents including parents of employees who are killed on duty or when traveling on a UA/UAX aircraft are entitled to unlimited space available travel subject to service

charges and applicable taxes and fees\*. Surviving dependents will board based on the employee's company seniority date instead of his/her years and months of active service. To qualify, the employee must have died in an industrial accident while performing work; where the death was caused by an aircraft accident or by the intentional conduct of a third party; or while traveling positive space for business or space-available for pleasure onboard a UA/UAX aircraft. The higher BP-6B boarding priority for travel flown domestically will be reached upon the 25<sup>th</sup> anniversary of the deceased employee's company seniority date or upon the date the deceased employee would have reached the early retirement age, whichever occurs later. This policy is not applicable if the accident or incident occurs while on personal time during a trip layover, if in an automobile or airport/business transport accident or when job duties are not being performed except when traveling on a UA/ UAX aircraft for business or for pleasure.

Surviving parents/step parents of a deceased employee: Two surviving parents or step parents of a deceased employee are entitled to unlimited space available ID90 travel for three years from the date of the employee's death on United and United Express at a BP-8B boarding priority. Parents/Step parents must be eligible for Travel Privileges prior to the death of the employee. Parent names will be retained in employee \*FNZ profile. \* Surviving parent travel is subject to imputed income.

Boarding Priority is determined by the Computer and will be auto printed on your Boarding Pass. The Gate Agents are responsible for orderly boarding and may elect not to board in the Boarding Priority order. Normally when this happens the agent sees that all the top BP's will not be able to be in First Class, thus they will go ahead and board the rest in the Economy Cabin. And, if the Economy section is full then the top BP may be called later for boarding in the Economy +5 section, which is a seat with more leg room.

The Large HUB Cities ORD, IAD, & SFO (soon to be DEN & LAX) and eventually other major airports will have Lighted Signs of Boarding showing the names (first three letters plus initial) of standbys and the order they are being called up. Please **DO NOT** approach the Podium to question the Boarding Agent/s concerning the sequence of boarding as there may be revenue standby's included in the list and they always go before NRSA. To view the Boarding Priority from BP-6B down to BP-10 please go to SkyNet and on the Home Page in the upper right side click on the "Travel" icon and then look on the right side of the page for the Travel Policy box. In the box, see "NRSA Boarding Priority" and click on it. The "Boarding Priority" page will appear and then scroll down to the boarding priority chart. You can call any of the Retiree Travel Desks (PDX/ SEA/ORD) for questions in reading these BP Tables and assistance getting into SkyNet.

And a reminder: Get your off-line discount tickets from the Interline Ticketing Desk at 1-888-874-1581 ten (10) business days in advance. **Do not** expect to pick-up tickets at the Airport the day of travel. Inclement weather, delays or flight cancelations will occupy the Ticket Counters and you **will** be refused. The Customer comes first at United.



do was determine the direction to Medford.

He "pan-caked" the 40B into a mountainside and slid through the snow into a tree. He was uninjured and the plane was not too seriously damaged. After he was down, he continued to sit in the cockpit listening to the signals and determined the direction of Medford.

Boeing installed thirty radio transmitters along its routes between Seattle and Los Angeles and between Oakland and Chicago to communicate with its pilots.

Pilots still held their course by watching for the flashing beacons placed at 25 mile intervals, however, in bad weather pilots had to fly below the clouds to be able to see the beacons.

Pacific Air Transport pilot J. R. "Russ" Cunningham argued that if pilots could follow the radio beams from the transmitters, they could fly above the clouds and avoid dangerous terrain.




One New Year's Eve while Cunningham was flying a passenger-less Boeing 40-B from Seattle to Medford, a storm developed over Oregon. He climbed above the clouds, flying by compass but checking his direction by the strength of the radio signals from below.

At 12,000 feet he picked up a load of ice and rapidly lost altitude. At 6,000 feet, he was nearing Medford and he knew that he would not make it over the mountains.

On the way down he continued talking to the station in Medford telling the operator, "Keep on talking to me, keep talking to me". What Cunningham was trying to car" from a shed and drove to Medford Airport.

Word got around and before long, "riding-thebeam" was a regular practice for air transport pilots.





After the radio-transmitters were re-equipped with directional beams, following the "dot-dashes" or the "dash-dots" became the standard practice.

Ninety-five percent of the time this system worked.

During the other five percent, static crackled in the pilot's earphones disrupting voices and radio range signals from below, often drowning them out completely.

After the "Electronic Flying Era" began in 1929, nearly all crashes came in this five-percent "nightmare" time. By Marvin Berryman, DENTK (Ret.)
