



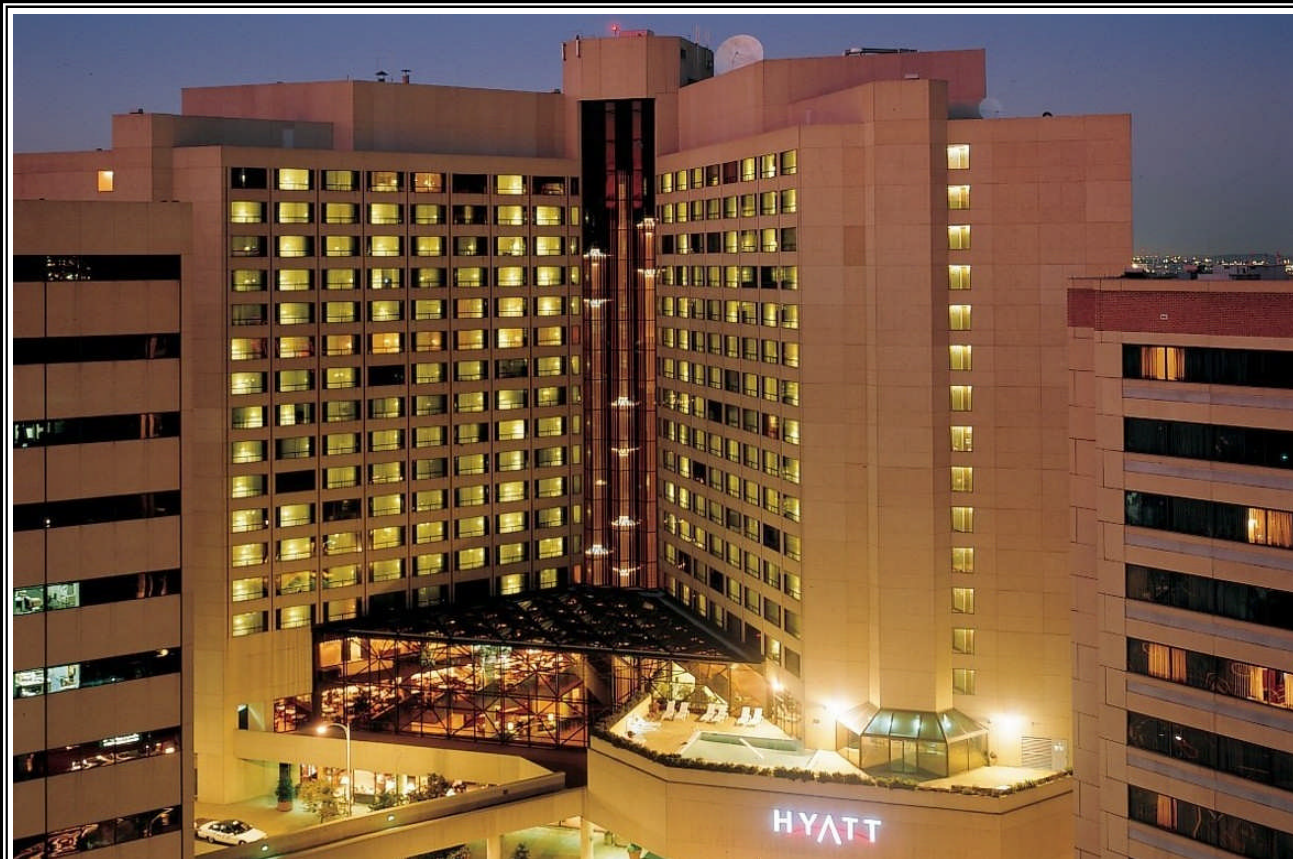

Letter From The President

The new pass policy is scheduled to go into effect March 3, 2012. Employees and retirees will find information about the new policy on the company website *Flying Together* and then click on *Travel* on the header line. Once in the *Travel* section there are several subjects to check. Unfortunately,

the company does not plan to mail this information to anyone; they are depending on internet access as the only way to communicate information about the new pass policy. This is disturbing as with the pass travel survey, many will be left in the dark.

Over the last several years RUAEA along with RUPA has supported three Travel Desks ~ Seattle, Portland and Chicago. These three Travel Desks were staffed with retired volunteers to assist pass travelers who either didn't have computer access or were en route without computer access. With the change from Apollo to Shares, the company has decided that it will not provide the equipment and training to keep these desks in operation. RUAEA and RUPA have decided to continue to support these desks through March 31. In this way, they can offer some assistance on how to go about making travel plans. On behalf of RUAEA, we want to thank those who volunteered their time and expertise over the years.

Two other issues remain unresolved at this time. What is and will be the status for pass travel for surviving spouses. We were told at one time in the past that there would be no change but since then the company has avoided the question entirely. It has been asked numerous times with either no response or we are working on it. In either case not a satisfactory answer. The other issue is when the new pass policy takes effect on March 3, 2012 will the 1-800-UAL-LIST automated phone contact still be active? Again, we have no response from the company. If that number is no longer active, what does one do if they are not connected to the internet? Will there be a fee for talking with a reservations agent as has been suggested? These do not appear to be tough questions.

I personally am not a subscriber to any of the Social Networks available like Facebook, My Space, Twitter,

etc. Many retirees are and that is fine. On these sites, subscribers can and do post items of interest to them and have ways of keeping in touch with friends and reacquaint with old friends. Information on Facebook, etc. is from individuals and the information may be just that person's opinion. While we have a link on our website to Facebook, we as an organization do not post information on this or other sites. **RUAEA's official website is www.ruaea.org**. This is the place for verified news.

Certify your dependents for continued healthcare coverage



United is asking all US-based co-workers and retirees to confirm that their spouses, domestic partners, children or stepchildren enrolled in healthcare coverage meet eligibility requirements as defined by the company's healthcare plans.

To certify your dependents, go to

All About Me and click on the "Dependents – Healthcare" link to start the certification process. **If you do not confirm dependents by March 9, they will lose medical, dental and vision coverage through the company for 2012.**

United is undertaking this process to ensure that co-workers and retirees cover only eligible dependents as family situations often change from year to year. Coverage for ineligible individuals creates compliance risk with federal law and places additional costs on companies and their employees, so it's important for co-workers to certify dependents.

While most dependent information has been loaded into All About Me, a small number of dependents are not yet visible in the system. This does not affect whether those dependents have healthcare coverage. If all of your dependents are not visible in All About Me, please check back as we are uploading the remaining dependent files and expect to have all files available soon.

CO subsidiary co-workers and retirees have participated in this annual process since 2008, but this is a new activity for those with the UA subsidiary.

UAL is on track to launch common PSS March 3



United plans to convert to the consolidated SHARES passenger service system (PSS) platform in the overnight hours preceding the morning operations start-up on March 3. At that time, the company

will begin managing all passenger travel data through the SHARES system, allowing seamless customer service across both airlines.

"Our UA customer service and reservations agents have been working very hard to get ready for the conversion to SHARES," said Airport Operations PSS Planning VP Joanne Calabrese. "Their co-workers and coaches — the experienced CO agents — have helped every step of the way, proving yet again that the path to success is to work together."

Later in 2012, United will introduce a point-and-click user interface for SHARES, which will be more intuitive and easier to use. It will enable the company to deliver even higher levels of customer service than the native SHARES system.

The launch of a single PSS affects several other business areas as well, including MileagePlus, United's combined loyalty program. Soon, United will inform MileagePlus members that their 2012 status levels and benefits will begin on March 3. Starting January 18, MileagePlus and OnePass members may go online and log in to a personalized preview of the 2012 MileagePlus program, including details on their 2012 status (if applicable), recalculated lifetime miles balances for many and additional information on account numbers in the new program.

The 2012 Pass Travel program also becomes effective March 3.

United announces 2011 and Q4 2011 profit



On January 26th, UAL reported full-year 2011 net income of \$1.3 billion or \$3.49 per diluted share, excluding \$483 million of special items consisting primarily of integration-related costs. Including special items, United reported full-year 2011 net income of \$840 million or \$2.26 per diluted share. Therefore, eligible co-workers earned \$265 million in profit sharing for full-year 2011, which United will distribute on February 14 in payments equal to approximately 5 percent of their eligible 2011 annual wages.

UAL reported fourth-quarter net income of \$109 million or \$0.30 per diluted share, excluding \$247 million of special items. Including special items, United reported a fourth-quarter 2011 net loss of \$138 million or \$0.42 loss per share.

United's 2011 consolidated passenger revenue increased 9.0 percent and passenger revenue per available seat mile (PRASM) increased 9.2 percent in 2011 compared to the pro forma results for 2010. In the fourth quarter, consolidated passenger revenue increased 5.6 percent and PRASM increased 8.2 percent from the same period in the prior year.

Consolidated fuel expense for 2011, excluding the impact of hedges, increased 36.5 percent, or \$3.4 billion, year-over-year on a pro forma basis.

United's combined network operated more than two million flights and had 142 million passengers in 2011, carrying the most traffic of any airline in the world.

United reaches tentative agreement with AFA for UA flight attendants



The United Master Executive Council (MEC) of the Association of Flight Attendants (AFA) has approved a tentative agreement reached January 7 between AFA and United for a flight attendants' contract and is recommending the tentative agreement to UA flight attendants for their consideration and ratification. The agreement is the result of an expedited mediation process that began last September, modeled on the National Mediation Board's Expedited Mediation Program. Subsidiary CO flight attendants currently represented by the AFA ratified their collective bargaining agreement in February 2011.

NMB investigation doesn't impact tentative agreement with UA flight attendants



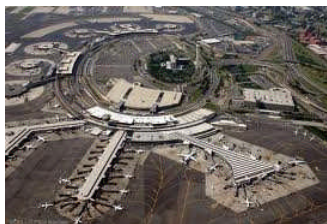
The National Mediation Board (NMB) legal department recently notified the Association of Flight Attendants (AFA), the International Association of Machinists (IAM) and the company that it will conduct an investigation into allegations of interference during the election for representation of our flight attendants between the AFA and IAM. The allegations primarily concern assertion of improper conduct between the two unions.

United anticipated this step, as it is typical in a high-profile election. In fact, this happened recently in the Delta-AFA investigation, where eventually the NMB found no interference to exist. It is important to understand that this is not a determination on the merits of the allegations, nor does it impact current representation.

It also has no effect on the tentative agreement reached with the AFA for s-UA flight attendants.

New hangar underscores United's commitment to EWR

United's maintenance co-workers at EWR will keep its Boeing 787s and other widebody airplanes in top shape from a new \$25 million hangar on three acres of airport land, Technical Operations SVP Jim Keenan announced.



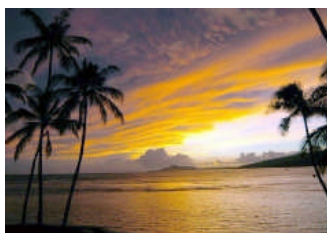
Airport officials hosted a news conference to announce that and other private sector investments to EWR in advance of the 2014 Super Bowl at MetLife Stadium in East Rutherford, N.J. Jim said United worked out a new 25-year lease on land for the new hangar. He said the project will result in 210 jobs, \$12 million in wages and \$52 million in economic activity over the life of the project. United expects to open the 85,000-square-foot hangar in September 2013.

"Construction of this widebody hangar underscores our commitment to Newark, the state of New Jersey and the region," Jim said. "As one of New Jersey's largest employers and the New York area's largest airline, we are committed to being an active, engaged partner as we connect this region to the world."

United flies to a daily average of 153 destinations including 75 international destinations, more than any other airline, from the New York market, which also includes New York-LaGuardia and New York-Kennedy. In 2012, United will offer 25 percent of the total airline seats in the market, also leading the industry.

In addition to United's EWR hangar, the company has preliminary plans and a site identified for a maintenance hangar for IAD operations. The Metropolitan Washington Airports Authority board has approved our proposal, and United is working now to complete the plans and design so it can finalize the capital needed for construction.

IAD-HNL daily, other nonstops start this summer



United will begin the only nonstop service between IAD and HNL (Honolulu) June 7, flying daily using Boeing 767-400 aircraft. United, the largest carrier between the mainland U.S.

and Hawaii, connects Aloha State airports with eight mainland cities, as well as GUM, MAJ (Majuro, Marshall Islands) and NRT (Tokyo), offering nonstop service in 23 city pairs.

United also announced a number of new seasonal routes starting this summer. Those include DEN-FAI (Fairbanks, Alaska), IAH-RAP (Rapid City, S.D.), IAH-JAC (Jackson Hole, Wyo.) and SFO-JAC.

With these additions, United will remain within the previously announced capacity guidance.

Passenger service employee representation election began January 17



Co-workers voting in the upcoming passenger service employee representation election, including customer service representatives and reservations agents, received voting in-

structions from the National Mediation Board (NMB) beginning January 17. The NMB mailed the confidential voting instructions to co-workers' homes and will conduct the vote by secret ballot. Voting can be done by phone or online, and the instructions will include unique voter identification and personal identification numbers for each eligible voter. Co-workers may vote for representation or for no representative. The NMB counts only the votes that co-workers cast.

The election closes at 2 p.m. EST on Feb. 21, and the NMB will announce the results at that time. More information is available at ATWfacts.com.

“EASY DOES IT” Recipe Column - Baked “Country Style” (or Regular) Pork Shoulder Ribs



Due to a still-busy season and some other challenges, I've turned to my daughters for help this month. They're wonderful cooks and Valerie Noel has provided me with the easiest **Pork Rib** recipe you ever saw ... or ate! Right now, I need “simple” and the following certainly fits the bill. And there's more than

enough meat left over to surprise your friend(s) with a great dinner and for sandwiches the next day. **Note:** This will take 4 hours in a pre-heated 325 oven.

Purchase a 3 to 3 ½ lb. package of pork ribs. Cut apart to the size of your liking. Place in large pan or baking dish. (Pyrex is easier to clean afterwards.)

Sprinkle meat with salt, pepper and 1 large yellow onion, generously sliced and chopped.

Purchase two 18 oz. bottles (or one 32 oz. bottle if you can find it) of barbeque sauce. (I like a slightly sweeter end product so I bought “Sweet Baby Ray's

Hickory & Brown Sugar BBQ sauce”. You can use whatever pleases you.)

Cover meat completely with all of the BBQ sauce. Cover pan/baking dish with foil. Place in oven and do not open the oven door during baking (4 hours). The meat will be very tender and just “fall off the bone” ... yummy! My girls pointed me towards the grocery store's deli section. There, sitting in the cold, was a 24oz. tub in a box which surely had my name on it: “Simply Potatoes”, traditional mashed potatoes by Crystal Farms, although I'm sure other companies make it as well. But I had never heard of it. It microwaves in under 6 minutes and is delicious ... as well as sparing me the peeling, cooking and beating up of a poor little defenseless potato. P.S. Before serving, I added garlic powder and butter to the potatoes. Double yummy!

You can add a nice green salad. I cheated: I bought one of those prepackaged salads in the vegetable department and just chopped and added some romaine lettuce.

Now, enjoy the easiest meal ever you didn't have to slave over.

The Convention managers are **Marilyn Marcy** and **Linda Scriven**, they are both long time residents of the Washington area so they have lots of great ideas for your free time.

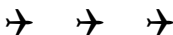

For an example they chose UA's \$25 bag fee and compared it to CO and UAL Jeff Smisek's \$4.4 million salary.
