Thank you to **John Haferbecker** for keeping us informed of the following two changes:

1. **United MileagePlus Explorer Card** (this is good news) ~ If you are a United retiree who is the primary Cardmember of the United MileagePlus Explorer Card and participated in the previous MileagePlus Visa rebate program in 2012, you are eligible to receive an annual \$80

statement credit from Chase. There are no forms to submit to receive this credit. The credit will be applied by Chase automatically to your April credit card statement each year this offer is in effect; please allow an additional month for the credit to be reflected on your paper statement.

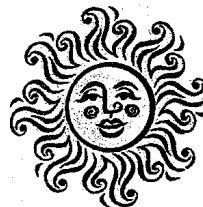
To be eligible for the \$80 statement credit in 2013, you must be a United retiree who participated in the 2012 MileagePlus Visa rebate program and a primary Cardmember of the MileagePlus Explorer Card effective March 1, 2013. If you currently have another MileagePlus credit card from Chase, and would like to take advantage of this offer, please contact Chase at the number on the back of your credit card to see if you are eligible to get the Explorer Card.

All former rebate offers provided to United employees and retirees were discontinued December 31, 2012.

United enhances boarding procedures

As many of you are aware, UAL has been working on getting its boarding processes right and have made a number of changes as it has worked toward that goal. With input from you and United's customers, the company is going to be making a series of changes during 2013 that it believes will improve customer satisfaction and increase the number of on-time departures.

Simplified boarding groups ~ In the first change, United is reducing the number of groups that customers

are divided into for boarding, from 7 to 5. Instead of 4 groups for Premiers and premium customers and 3 groups for general customers, it will use 2 groups for Premiers and premium customers, including select MileagePlus credit card members, and three groups for the remaining passengers. United also is updating the clear and simple announcements that agents use to guide the boarding at our gates. The company expects these changes to be fully implemented in January.

Revised gate layouts with dedicated boarding lanes ~ In the second change, which United expects to begin to roll out in March and April, the company is planning to improve the layout of its gates by setting up designated lanes and clear signage for each of the five boarding groups. With the new layout, United will place greater emphasis on and create better access for Premiers and premium customers by designating specific areas for passengers to line up in advance of boarding. In addition to reducing crowding, these dedicated lanes will enable the existing Premier Access lane to function in its intended manner, allowing Premiers to board at their leisure throughout the boarding process. While United will deploy the layout at as many gates as possible, it is developing alternatives for airports where gate areas are too small for five boarding lanes.

Introducing the “WilMA” (window-middle seat-aisle) approach for general boarding ~ In the third change, United will modify the method it uses to determine how customers are assigned to the three general boarding groups. The new method will speed the movement of customers onboard the aircraft as they stow their carry-ons and get seated. This last change, which requires more IT work, will come after the first two changes.

Called “WilMA,” the revised method will apply to the general boarding groups 3, 4 and 5. The first group to board will be customers sitting in window seats, followed by those in middle seats and finally those in aisle seats. Coinciding with WilMA, United will board customers on most United Express flights in four groups, but it will use five boarding groups for mainline flights.

This approach – used by our United subsidiary before the merger – replaces its current system of assigning general group customers to groups based on their row number, starting with those in the back of the aircraft.

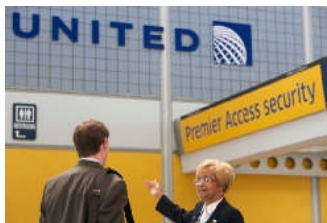

TSA reinforces Secure Flight requirements



Under the Secure Flight program, a customer making a reservation is required to provide his or her full name, date of birth and gender, as it appears on the government-issued identification card he or she plans to use when traveling. This information is called Secure Flight Passenger Data, and it's used for security screening. To ensure compliance with the mandate, as of Jan. 20, United is requiring that the customer name used to book tickets matches the name used for Secure Flight in all reservations. Customers can expect messages on united.com and United's mobile app to alert them that the names on their reservations must match the names on their IDs.

Meanwhile, United implemented a requirement for MileagePlus members to ensure that the names on their accounts match the names on their reservations and IDs. The company set up a system on united.com and its mobile app to help customers update their information if their names don't match the Secure Flight information that United has stored.

United is alerting customers about the requirement through MileagePlus messages and other communications channels. The company is providing information to its Airport Operations and Customer Contact co-workers so that they may explain the process to customers.

In the coming weeks, United will provide co-workers and retirees with instructions on how to ensure that their Secure Flight data in employeeRES and their names in our Human Resources system meet the TSA requirements.

United plans to install Split Scimitar Winglets on its 737NG fleet



United announced plans to install new Split Scimitar Winglets designed by Aviation Partners Boeing (APB) on its 737NG aircraft. This new winglet design demonstrates significant aircraft drag reduction over the basic blended winglet configuration the company uses on its current fleet. APB estimates that, once Split Scimitar Winglets are installed, winglet technology on United's 737, 757, and 767 aircraft will save United more than \$250 million per year in jet fuel costs.

"Fuel is our largest, most volatile expense and we are always looking for opportunities to improve the fuel efficiency of our fleet," said Fleet VP Ron Baur. "The Next-Generation 737 Split Scimitar Winglet will provide a natural hedge against rising fuel prices while simultaneously reducing carbon emissions."

The fuel savings can enable a 737-800 to increase its payload up to 2,500 pounds or increase its range up to 75 nautical miles. APB expects to certify the Split Scimitar Winglet for the 737-800 in late 2013 and for the 737-900ER by March 2014.

United started work on new EWR Tech Ops hangar



Construction on a new wide-body hangar for EWR will begin this week. The 90,000 square foot hangar will be completed in the fourth quarter of 2013 and will cost \$30 million to

complete.

"This state-of-the-art facility will be the workplace for more than 700 United aviation maintenance technicians," said Line Maintenance VP Joe Ferreira. "From this hangar, they will work together to ensure the safety and reliability of United's fleet and the comfort and convenience of our customers."

United's EWR investment includes partnering with the Port Authority of New York and New Jersey on a taxiway relocation project and related infrastructure improvements. Corporate Real Estate VP Kate Gebo said this underscores our commitment to Newark, the state of New Jersey and the region.

Elsewhere at its hubs, work is under way on a new 125,000-square-foot widebody maintenance hangar at IAD, for which United broke ground last October, and at IAH this spring, United will complete a \$2 million tooling facility adjacent to Hangar B that will enable the company to centralize Boeing 787 tooling.

United launched new baggage delivery service with BagsVIP



United recently launched a new baggage delivery service in partnership with BagsVIP. This new product gives customers the option to have their checked bags taken straight from the carousel to

their final destinations. Co-workers are eligible to use the service, too.

BagsVIP delivers within 100 miles of participating airports, enabling participating customers who depart from any U.S. domestic airport to forgo the baggage

claim at BOS (Boston), ORD, HNL (Honolulu), IAH, LAX and MCO (Orlando, Fla.). United plans to expand to nearly 200 additional domestic stations in the near future.

Co-workers involved at our six initial stations are gearing up as orders begin this week.

Torgy's Travel Tips

Last month's article by **Jim Morehead** on the computer-based training modules called Webinars, located in the Travel section of Flying Together, was an excellent introduction to the new method that the Company has adopted to assist us with pass travel booking and ticketing. If you have not yet taken these lessons, I would encourage you to do so. Lesson 6 on

interline travel is particularly timely, as 15 more carriers have joined ID90T since the lesson was recorded. More carriers are expected to follow, soon.

The TSA has tightened their requirements in 2013 regarding the name on your ticket matching exactly with the name on your ID. Whenever you list for a UA flight (or book a revenue ticket) your "Secure Flight Information" is automatically handed off to the TSA. This information contains your name, gender and birth date and needs to match the way that data appears on your driver's license or passport.

For example, if your driver's license includes your full middle name and not just an initial, your Secure Flight Information must reflect that as well as your ticket. You can review the data in your Secure Flight Information by accessing flyingtogether.ual.com>Quick Links>Employee Profile. You may decide to have both a driver's license and a passport stored so that when you travel internationally you will already have that info available. Just click on the "edit secure flight info" area, highlight your name and click on the tiny pencil icon to change already stored info, or click on the + sign to add new info. In the coming weeks, the Company will provide us with instructions to ensure that Human Resources (who control what name actually appears on the ticket) and the data stored in your Secure Flight Information meet the new TSA requirements. Stay tuned.

Speaking of international travel, did you know that you are entitled to use the airport lounge if you have been issued a boarding pass with a seat in United Global First or Business First cabins? Since standby lists are now to be cleared 60 minutes before departure for international flights (or possibly earlier if the flight is booked to less

than 75% capacity), you just might have time to enjoy the lounge. Remember, though, you **must** be onboard no less than 30 minutes before departure, or your seat assignment will be taken away. Don't let that happen!

One other tip regarding international travel concerns the use of cell phones overseas. Many US cell phones either cannot be used in other countries or the charges to use them are extremely expensive. Good news – check out this website: www.ekit.com where you can order a phone, with 30 min free incoming international calls and no charge to listen to voicemails, texting and \$20 outgoing phone credit. The costs are \$39 for a basic dual-band phone, \$119 for a quad-band phone and \$229 for a smart phone.

Are you or your travel companion a veteran? Well if you are cruising with Princess Cruises, you will be glad to know that can apply for up to \$250 of onboard credit – free money, folks! My husband did just that on our last cruise through the Panama Canal. Princess offers \$50 for cruises less than 6 days, \$100 for 7-13 day cruises and \$250 for cruises that are 14 days or longer. You simply fill out their application form and fax it along with your DD214. The onboard credit can be used for anything on-board, even tipping. Check it out on princess-cruises.com>military benefit program.

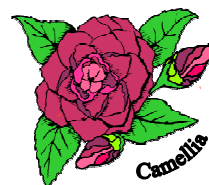

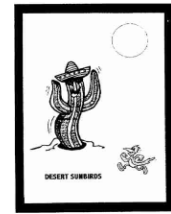

An updated program on Flying Together/travel was posted on Flying Together and Dale Harper’s site titled “UA Personal Travel Guide”. The content is 31 pages although if printed, several pages could be skipped. One of the changes for Blue Cross/Blue Shield will be a separate ID card for medications/prescriptions. Once the card is received, you have to have the information changed at any local pharmacy you have used. The current information will not be valid. Subscribers to the RUAEA Newsletter that enrolled with the three year subscription need to watch for the renewal notice; time is up or will be up soon. A new chapter has

been formed in Vacaville, CA. **Alan Pochop** is President. Southwest has introduced a \$40 fee to board the plane as part of the first 15 people to board. UA has cut 600 jobs or 6% of management/administrative positions. This will include buyouts and layoffs. Also some open positions will not be filled. This is due to a \$723 million loss last year and to the reduced flying scheduled for 2013.

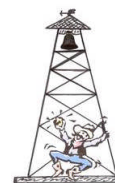

President ~ This section also covers our RUAEA report: Rudy brings a reminder to our members that you need to check into the Flying Together website during each year. When an UA retiree logs into Flying Together and receives one of these messages; "Employee ID/Password Failed" or "Profile has been Deactivated", it means they have not logged into the system for over a year and their profile was turned off. They are still eligible for pass travel privileges; however, they must contact the employee Service Center (ESC) to have their profile reinstated. If you get questions regarding this, please provide them with following instructions: 1. Send an email to the ESC at esc@united.com with the subject line "Retiree resync". 2. The email should include: * The retiree's name, ID #, addresses on file, phone number and e-mail address * Or, they can call the ESC at 877-242-0075, option 4 and ask to have their profile reinstated. He also reported that United is enhancing seat assignment procedure for pass riders. Since United introduced its new pass travel privileges last spring, the company continues to make enhancements that help you get more out of the program. Your feedback was heard, and now United assigns pass riders to seats toward the front of its aircraft cabins before filling seats in the back. With this SHARES enhancement, effective November 14, co-workers and retirees with higher seniority are more likely to receive seats in Economy Plus, if any of those seats are available.

Rudy informed us that our discount with Fed Ex is about to be reinstated. Although it won't take effect until the first quarter of this year (it is believed by mid-February) when the badge issuing machine arrives, but retirees will then be able to take advantage of the 75% discount with FedEx by providing their retiree photo ID badge. It is reported that when that machinery arrives, they will communicate the news via the internet and as many communication avenues as possible to get the word out. Please know that the badge will be valid for approximately 20 years and will cost between \$25-\$35. Additionally, there will be a form online that you must complete and mail to them along with a passport-type photo, but again, more details will be provided closer to its arrival.

This information came from "General News" of the RUAEA Newsletter and from Dale Harper's website; dtharperster@gmail.com. You can access these websites yourself to learn more about what is going on with UAL.

Frank Dellinger asked how we get buddy passes. While employees still receive buddy/companion passes,

retirees do not. Retirees are eligible for enrolled friends. Keep in mind that you are only allowed to have 2 enrolled friends listed in a calendar year. Once you name someone, you can't change the names until the next year. Also, when you enter a name, it takes 24 hours for their name to show up in the system. In the January issue of the RUAEA newsletter, on page 4, there is a paragraph or two about enrolled friends.

Jon Somplack inquired about the sweet deal that we used to get with Southwest - \$25.00 a leg! We still get a deal but it is called "ZED Fare" now.

Bob Ames related a harrowing experience on a trip he and **Dorean** took to Hawaii. He said to be vigilant when making your arrangements. Apparently the computer has different fares that come up and you need to be sure that your fees are quoted from the UAL column. The fees he was quoted went from \$30 to \$300! However, the last contest was in 1941, at which time "gambling" had become illegal. In 1965, the Winter Carnival was revived and morphed into the Carnival we know today. Favorite events such as the snow sculpture competition, Mardi Gras Parade, and Torchlight Parade were added, as well as an ongoing effort by local businesses to host new, fun events each year. The Winter Carnival has grown to encompass over 100 events over the course of the 10-day event!

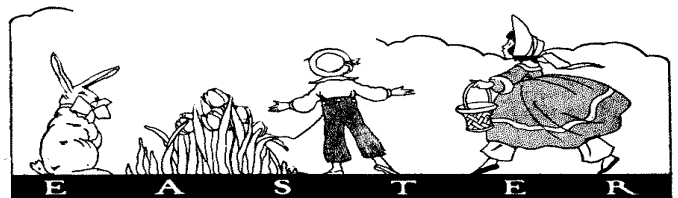

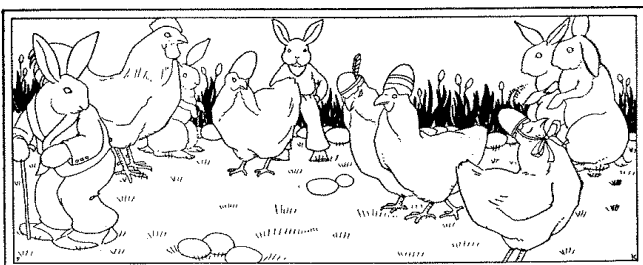

Messages arrived from 82 cities via teletype and telephone. The Denver "Communications Center" was the nerve-center of United's 13,000 mile-long private telephone and the 26,000 mile-long private teletype system linking every Mainline airway city. "Space Control" advised the stations as to Space Available for connecting or originating passengers, air mail, express and freight. For instance, on Chicago-bound flights "Payload Control" determined the name and destination of each passenger aboard a flight and also received a list of
