#### **RUAEA 2017 Convention**



Las Vegas here we come. The last time RUAEA had a convention in Las Vegas was 1989 and much has changed since then. There are many more large and sprawling hotels and casinos. Hoover Dam is nearby along with many other interesting sights. Our local committee is hard at work planning tours and other events for our annual Convention.

This year we will have a slight change in our timing. The Convention will begin on Monday September 25<sup>th</sup> and conclude on Thursday September 28<sup>th</sup>.

The location as previously announced is the Palace Station Hotel & Casino. The nightly room rates are as follows ~ Sunday through Thursday \$68.01, tax and hotel service charges are included. The rate for Friday and Saturday is \$140.58 again inclusive of tax and hotel service charges.

The Palace Station is located a little off the Strip at 2411 West Sahara Avenue, Las Vegas, NV 89102. The hotel does have scheduled shuttle service from and to the airport as well as scheduled shuttle service to and from the Strip. Reservations can be made by calling the hotel at 1-800-634-3101 and be sure to use the Convention code of PCIRUAE or identify that you are with RUAEA. Online reservations cannot be made at this time due to a problem with the system recognizing the discount code. So plan ahead and lets all have a great time in Las Vegas.

# Pass Travel Updates Compiled by Kirk Moore, RAFA Travel Benefits Committee



#### 1) 1099 Forms mean Imputed Taxes

If you receive a 1099-Misc form from United in February, it means your "taxable pass riders" accrued more than \$600 in pass tax value during fiscal 2016. You must declare that value on your 2016 income taxes. To see who flew when and where, you may generate a Pass Travel Report by going to FlyingTogether>Travel>Pass Travel Report. #### 2) Why should I join MileagePlus?

You'll accrue miles towards upgrades/free flights when you buy myUAdiscount tickets. It's free; anyone can join and you do not need a United Mileage Plus Explorer

#### Visa card to be a Mileage Plus member.

**BEST REASON for retirees to join**: If you link your MileagePlus number with employeeRES then you can use the **United app** on your smartphone/tablet to *book space-available flights* and to *buy myUAdiscount tickets*. The app is easier and more convenient than using employeeRES. After you have linked your MP number in employeeRES, simply sign into the app with your MP number and password.

**FYI ON BAGGAGE:** Remember, we get TWO FREE CHECKED BAGS (up to 70 lbs each) when flying space-available *and* when flying on myUAdiscount tickets.

#### 3) International SOS for retirees!

"International SOS" is a 24/7 global infrastructure of 27 call centers staffed by doctors and nurses, 32 clinics, 8,000 professionals and 60,000 providers. Free advice (both medical and security) for United employees and retirees is available online, via their app or just a phone call away. This could prove invaluable if you have an emergency when traveling the world. Visit the webpage on FlyingTogether>Travel>TravelPrograms (left column) >International SOS.

Print the cards with United's member number and International SOS phone numbers. Put the cards in your passport! Download the app to have on your mobile device.

Check medical and security status of the country/countries BEFORE you go visit.

<u>Note</u>: Intl SOS may pay for emergency medical treatment of *working crew-members*, but not for retirees. However, the free information and advice they can provide us could be priceless; especially if something bad happens. Click for <u>International SOS Q&As</u>.





There's something very special about a Boeing 747. It's the one aircraft that even casual travelers can easily identify. And we know that the experience of traveling on one, or flying one, is unforgettable.

As deeply connected as we all are to this iconic aircraft, the time has come to retire our 747 fleet from scheduled service. Last March, we announced that this would occur by the end of 2018; now we plan to operate our last 747 flight in the fourth quarter of this year.

It's a bittersweet milestone - this jumbo jet with its unmistakable silhouette once represented the state-of-the-art in air travel. Today, there are more fuel-efficient, cost-effective and reliable widebody aircraft that provide an updated inflight experience for our customers traveling on long-haul flights.

For these reasons, we're saying farewell to the Queen of the Skies, which has been part of our fleet since we first flew the aircraft between California and Hawaii in 1970.

We'll be working with all of you who fly or work on the 747s to ensure a smooth transition to other fleets. Our forward-looking fleet plan will cover 747 replacements and anticipated growth opportunities. And of

course, we'll honor the 747 with an unforgettable retirement celebration - we'll keep you posted with more details on her final flight in the months ahead.

In the meantime, we've prepared a Q&A with questions you may have about this decision. You can read more on our Wingspan leadership blog.

Thank you for all that you are doing. I am so proud and excited about the great future we're building together as we create the best airline in the world.

#### 747 Retirement Q&A

**Q**: When will we operate our final 747 flight?

**A**: We will cease operating the Boeing 747 during the fourth quarter of this year. We will announce an exact date within the next few weeks.

**Q**: Why are we retiring the 747?

**A**: While the 747 has been a cherished part of the United family for nearly half a century, today there are more fuel-efficient, cost-effective and reliable widebody aircraft that provide an updated experience for our customers traveling on long-haul flights.

**Q**: Why are we now retiring the 747s even earlier than originally intended?

**A**: The 747 has been an iconic aircraft for decades. However, as our 747-400s have aged in recent years, the fleet requires routing limitations, extra Tech Ops attention, burns 20 percent more fuel per seat than the 777-300ER and has the lowest customer satisfaction scores in our fleet. Additionally, most carriers have already retired these aircraft, making parts availability a challenge.

**Q**: When will these fleet changes be reflected in the schedule?

A: We'll be sure to share the final flight timing with you within the next few weeks before any aircraft changes are reflected in the schedule.

**Q**: What aircraft will replace the 747 on the routes we currently deploy it on?

**A**: We intend to replace the flying with other widebody aircraft. Our forward-looking fleet plan will cover 747 replacements and anticipated growth opportunities.

**Q**: Can you update us on the plan for 747 flying, as well as other long-haul international widebodies, for 2017? What's going to happen in 2018?

**A**: Our Network Planning and Operations teams, working in close collaboration with our operating departments, are still developing those plans and we will share updates when available.

**O**: Will this result in base closures for pilots and flight attendants?

**A**: Our current base structure will remain the same; however, pilots who currently operate the 747s out of our SFO base will transition to other fleets. For flight attendants, there are no plans to surplus from stations we currently operate the 747 from. We will make these transitions as smooth and seamless as possible, in accordance with the CBA, for our people.

**Q**: What impact will this retirement have on the San Francisco Maintenance Center and our San Francisco Line Maintenance operation?

**A**: This will have no effect on staffing at the SFO Maintenance Center. Our Line Maintenance team will continue to work on the widebody aircraft that replace the 747s. Furthermore, we will have fewer PW4000 engine overhauls as a result of the retirement of the fleet.

**Q**: When and how will we be celebrating our 747's retirement?

**A**: You can be sure that we will be honoring this iconic aircraft's retirement with a celebration worthy of its legacy. While the final flight will not be until the fourth quarter of this year, we have already started planning for an appropriate sendoff. We'll be sure to share more about our plans in the weeks ahead.

**Q**: What's going to happen with military charters?

**A**: United remains committed to our American troops and to working with our U.S. Government partners to facilitate their moves around the country and the world.

**Q**: Where will the retired aircraft go?

**A**: We have a combination of owned and leased 747-400s. The leased aircraft will be returned to their leasing companies at the end of the leases. Once the United-owned aircraft are retired from service, the aircraft will be placed into storage, where they will either be sold or parted out.

#### <u>Torgy's Travel Tips – March 2017</u> Trusted Traveler Programs



Three years ago, I wrote an article for this column describing TSA Pre√, which was somewhat new at that time. Many of you may have periodically experienced the benefits of this program since then, even though you have never enrolled. That is now about to change as Customs and Board Protection (CBP) has announced the elimination of random selection, meaning only enrolled participants will qualify for this expedited security program. So, I'd like to assist you with what choices you have to make your airport security and international border crossing experiences work the best.

There are 5 programs to choose between if you'd like to bypass long waiting lines. All have costs, all require an application and some require an in-person interview. Take a look:

#### **TSA Pre** $\sqrt{\ }$ ~ \$85, valid for 5 years

- ✓ Logo on your boarding pass allows entrance to expedited security lines at 160 US airports
- ✓ Shoes and jackets stay on during security
- ✓ Laptops can remain in your carry-on bag
- ✓ Liquids/gels/creams can remain in your carry-on bag
- ✓ 30 airlines participate (including 6 international carriers) during check-in process
- ✓ Quickest program to qualify for, usually 7-21 days
- ✓ <a href="https://www.tsa.gov/precheck">https://www.tsa.gov/precheck</a>

#### **Global Entry** ~ \$100, valid for 5 years

- ❖ Includes all benefits of TSA Pre√plus expedited re-entry to USA from foreign ports
- Upon arrival into USA, proceed directly to kiosk for fingerprint verification and electronic customs declaration.
- \* Receipt prints and you proceed directly to bag claim and exit
- \* Requires rigorous background check and in-person interview
- \* Takes 4-6 weeks for entire qualification process

#### **NEXUS** ~ \$50 valid for 5 years

- Includes all benefits of both TSA Pre√ and Global Entry *plus* expedited land crossing between USA and Canada.
- Requires rigorous background check and in-person interviews with both US and Canadian Border Protection agencies
- Can also include free iris scan to qualify for expedited air arrivals into Canada, if desired
- Primarily beneficial for those living near the Canadian border who cross by car frequently
- All vehicle occupants must have NEXUS when using these special lanes at the border
- Takes up to 4 months (sometimes longer) to clear qualification process

#### **SENTRI** ~ \$122.50 valid for 5 years

- Includes all benefits of both TSA Pre√ and Global Entry *plus* expedited land crossing between USA and Mexico. Similar application procedures as NEXUS.
- https://goes-app.cbp.dhs.gov

#### Clear ~ \$179 valid 1 year only. Non-governmental company vetting your ID only

- ➤ Proceed through blue "CLEAR" lanes at 22 US airports for fingerprint and iris scan
- $\triangleright$  Escort will take you to beginning of regular (**not** TSA Pre $\sqrt{\ }$ ) bag screening line
- > Operated by a private company, partially owned by Delta Airlines
  - Note: This service bypasses the normal TSA ID check line only.
  - All normal screening rules apply, i.e. take off shoes and jackets, take out laptops, etc.

How To Apply:

The process to apply for TSA Pre vinvolves an online application that takes about 5 minutes to fill out.

- ✓ You must pay the non-refundable \$85 fee with a credit card at the time you submit the application.
- ✓ (There are discounts available through Mileage Plus as well as several other credit card companies and loyalty programs, such as Hilton HHonors, Chase Sapphire Card and select American Express cards.)
- ✓ You select the time and location (usually an airport) where you wish to be interviewed by CBP personnel.
- ✓ Following your interview, you will receive an email, usually within 7 to 21 days with your "Known Traveler Number (KTN)" if you have been approved.

Global Entry, NEXUS and SENTRI applications take about 30 minutes to fill out online.

- Payment of the non-refundable fee must be made at the time you submit your application and there are NO discounts.
- Wait for an email granting you "Conditional Approval" which can take anywhere from 7 days to 4 months.
- Select a time and location for your in-person interview once Conditional Approval is received.
- During your interview, your Known Traveler Number (KTN) will be issued if you are approved and you may use it immediately for air travel.
- The physical plastic card for NEXUS and SENTRI arrive by mail about 10 days later. You cannot use the NEXUS or SENTRI driving lanes at the border without the card.

Lastly, once you have your KTN you need to enter it into your employee profile.

- Go to flyingtogether.ual.com>employee res>quicklinks>employee profile
- Select the blue line titled: Add/Edit Secure Flt Info and Travel Contact Info
- Highlight your name and select the tiny "pencil" icon which means edit
- Scroll down to Known Traveler Number, type in your number and select Submit.

Each time you fly, whether on a pass or with your 20% MyUADiscount ticket, the TSA Pre√ logo will appear on your boarding pass granting you access to a quicker departure! When flying on other airlines, enter your KTN when your make your listing or reservation.

Officers of our chapter had a delightful meeting and lunch at President **Boyd** & **Merle Sweet**'s home on January 18. Plans are underway for the year and we're anticipating great opportunities for making memories together. See Calendar below for events planned thus far for the year.

In keeping with my goal this year of having our members tell about their work experiences, I recently talked to **Donald Nessling** about his service with United. He actually began his career in the airline industry with Pennsylvania Central Airlines (PCA) back in 1941. At the time PCA had 15 B-247Ds. Two of them remain in museums today—one at the National Aviation Museum at Ottawa, Ontario, Canada, and the other, the City of

Renton, is in flying condition and is located at the Museum of Flight, Boeing Field, Seattle, Washington. Perhaps some of you saw the City of Renton when you were in Seattle for the United RUAEA convention last year. By 1947 PCA's route network no longer reflected their name and on April 21, 1948 the airline adopted a new insignia, colors, and the name Capital Airlines. Donald recalled his almost 44 year experience fondly remembering the many repairs that took him traveling to do the job. He was a junior mechanic while on his first trip which took him to Roanoke, Virginia (ROA). This was to repair an engine nacelle on a Navy R3D that had been burned. His next trip was to La Guardia in New York (LGA) for a temporary repair of a Constellation that had a dented left leading edge. Other trips took him to Baltimore, MD (BWI); Newark, NJ (EWR); Pittsburgh, PA (PIT), and Lansing, MI (LAN). Repairs included a DC-4 that had been struck on its leading edge when the #1 engine propeller sheared off, two Vickers Viscount fuselages that had caved in on their left sides when hit by the stabilizer of a passing airplane (LGA), the repair of a Viscount lower fuselage when it had come in for a belly landing (BWI), the temporary repair of a six foot hole in the left side fuselage of a Viscount (EWR), replacing a right wing tip on a DC-3 (PIT), the repair of three Viscount fuselage nose sections when nose gears collapsed (3 cities), and replacing spars on DC-6s. His most memorable repair was the replacement of a Viscount RHI lower spar cap. At this time he was a foreman. With 11 mechanics working, six on days and five on swing shift, it took three weeks to complete the repair (LAN). In the late 1950s, Capital began to struggle financially and in May 1960, Vickers foreclosed on Capital's entire fleet of Viscounts. Bankruptcy for the airline seemed certain. However, on July 28, 1960, a merger with United Airlines was announced. And as they say, the rest is history. Donald retired on October 1, 1985 and is the senior member of our chapter having now been retired 31 years. We are very pleased to have Donald in our midst for our weekly meetings and extra events during the year.

**Don Burbank** is headed to Arizona for a couple of weeks to work on the B-17.




