#### Centenarian - Uel U. Soward (AKA Bud Soward)



I was employed by United Airlines on September 15, 1952 and retired at age 65 on April 29, 1975. While there, I spent many hours in extra duty. I was elected Shop Steward in the Machine Shop by a vote of 69 percent of the ballots cast. I was Shop Steward for one year, presented only 12 grievances and won every one of them. Some went to the third state of consideration. I was elected president of the newly formed Camera Club about 1955.

About the same time, I started serving as Cameraman for Local 1781, IAM and resigned that position years later because I had stopped smoking cigarettes and smoking was allowed at meetings. I was assigned to duty ten years in the Machine Shop.

Approximately in 1957, there was an earthquake which really shook the building. Water and electric lines were broken. I slid under a substantial workbench and watched other employees running by.



In 1962, I bid a position in the Instrument Shop. I received good pay for the many suggestions I made during my years at United. I received a bronze plaque showing that I had been elected Mechanic of the Year, 1972. I spent three years in the Engineering Test Center, and then returned to the Instrument Shop, where I retired.

After retirement, I assisted in the installation of a chapter of the RUAEA Newsletter based at the Central Coast of California. I was the one who furnished the dolphin logo which was very well liked by every one involved, especially **Jo Madden**.

#### The Writers' Column – Ed Clay's Story by Gayla Powell Kanaster



"A Jack of all trades, a master of none", jokes **Ed Clay** when I comment on the many different positions he held during his 42 year career with United.

Apparently, United thought he mastered his trades quite well, assigning him various management positions until he completed his career as LAX Station Manager in 1981. My husband I were both based there at different times (LAXSW and LAXFO) and knew of his reputation, Ed was very well liked and respected for his overall knowledge of operations and kindness to others.

Ed graduated from the University of Wyoming with a BA in commerce and business and an R.O.T.C. commission. He entered active duty in 1941 as an infantry lieutenant and was a Lt. Col. at war's end.

He was hired in Cheyenne in 1938 as a steward, which in those days, was more like a ship's steward. After serving in the military, he returned to United as a steward in SLC, then passenger agent in BUR. From there, he went to Chicago's

Midway airport as assistant superintendent of stewardess service, chief passenger agent and station service

manager. He then became superintendant of regulations at EXO; staff assistant - contracts and legal agreements, DEN; cargo and ramp service manager, LAX; operations planning, EXO; passenger service manager, HNL; regional vice president of customer service, and later, vice president NW marketing, SEA. His last position was LAX station manager, in 1973.

After "retirement", Ed worked for the Office of International Students at USC and 10 years at Harbor Travel in Palos Verdes, CA assisting owner **Gary Tossell**, another former UAL employee. He was the manager of Peninsula Racquet Club in Palos Verdes, CA. He served as president of the Los Angeles Airport Rotary Club and upon retirement transferred to Palos Verdes Peninsula Rotary where for many years, he chaired their annual fund raiser, the Concours d'Elegance, a classic automobile show, which raises thousands of dollars for local charities. He was named "Rotarian of the Year" for this work. He also was on the Board of Directors for the Salvation Army's Crestmont College for Officer Training. In 1990, he received the Army's highest civilian "Others Award" for outstanding community service. While working in Seattle, he belonged to the Rotary there, where he served on the Board of Directors of the Seattle King County Convention and Visitors Bureau, receiving a community service award.

Ed had a distinguished military career. He was chosen for the first Special Service Force (a precursor to the Green Berets). It was made up of 1000 Canadian and 2000 U.S. army personnel, the only one of its kind. The movie, "The Devil's Brigade" was based on it. Ed was part of the military force that landed in Italy. After the breakout of the beachhead at Anzio, his unit was the first to reach Rome. Their assignment was to remove all demolitions from the bridges over the Tiber River so that they couldn't be blown up by enemy forces. They were part of the invasion of Southern France on D-Day and in active action against the Germans until Nov. 1944, when the special force disbanded. The outfit became the 474<sup>th</sup> infantry regiment and was transferred to Northern France. He finished the war with Patton's 3<sup>rd</sup> Army in Germany. His last assignment in Europe was occupation duty in Norway.

He & Virginia raised four children. Virginia was a member of LAX Clipped Wings and they both were active supporters. Ed was instrumental in procuring a much needed fork lift for the Clipped Wings charity, South Bay Vocational Center. The developmentally disabled clients are taught trades working at jobs coordinated and supervised by the center.

A new, improved SkyNet intranet is now available for employees/retirees to browse alongside the original SkyNet. New features, tools and sections are added in phases over a four-week period.

When you open the original SkyNet, a banner in the upper right corner will take you to a page where you can find information about some of new SkyNet's features and a link to the site.

Once on new SkyNet, you'll see the result of tremendous effort by hundreds of employees across all departments. This cross-functional team has been working hard not only to create new content, but to take part in some long-overdue spring cleaning, in the process of remodeling or disposing of outdated links and pages.

New SkyNet presently features a new homepage; tabs for Our United, NewsReal, Employee Services and Travel; and links to several "communities," which are similar to the current department sites today. Some micro-sites, such as Focus on 5, Employee Discounts, OPC Relocation and United Uniform Design, have already been transferred to the new platform.

Over the next few weeks, adding new functions will include communities, tools and features. The current SkyNet will remain available until all the information is ready. All employees/retirees are encouraged to take the following steps between now and the final cutover date in late April:

- 1. Once your department's community site is available, visit that site to locate the news, information and work tools you need. Create new bookmarks as necessary.
- 2. Access the SkyNet Help and Feedback section for tools and tips to get the most out of new SkyNet.

#### United Implements Travel Listing Improvements as Phase II of Secure Flight Program

As part of the Transportation Security Administration's (TSA) Secure Flight program to enhance the security of domestic and international commercial air travel through improved watch list matching (See Nov. 30, 2009, NewsReal), United added a new passenger information page on WebList in December.



United now has the functional capability through WebList and Apollo to store, edit and delete Secure Flight Passenger Data (SFPD). Effective March 31, 2010, when you list for flights, you have the option to save the SFPD - eliminating the need to re-enter the same information for each Passenger Name Record (PNR) created. You will also have the capability to edit stored information for yourself and your travel eligibles - excluding companions - at this time.

#### United Airlines Launches Mobile Check-in Capabilities, Mobile Boarding Pass



Just in time for the start of the busy spring break travel season, United Airlines (Nasdaq: UAUA) has introduced mobile check-in and mobile boarding passes, enabling customers on the go to check in using a mobile phone or Web-enabled mobile device and proceed through security and boarding without needing to present a paper boarding pass.

Customers flying on any United or United Express-operated flight within the United States, Puerto Rico and the U.S. Virgin Islands may check in at the new <a href="mobile.united.com">mobile.united.com</a> beginning 24 hours before departure. Mobile check-in is especially helpful to customers in hotels or in business meetings who want to check in before arriving at the airport.

United's additional mobile boarding pass feature is available to customers departing from the airline's five hubs – Chicago O'Hare International Airport, Denver International Airport, Los Angeles International Airport, San Francisco International Airport, and Washington Dulles International Airport – and from airports in Dallas-Fort Worth, Las Vegas, New York

LaGuardia, Orlando, Philadelphia, Phoenix, Portland, Ore., and Seattle. United plans to introduce mobile boarding passes at additional airports, including in Atlanta, Baltimore, Minneapolis-St. Paul, Salt Lake City and Orange County-Santa Ana, in the coming weeks.

After checking in at <u>mobile.united.com</u>, customers can receive an email link to access a mobile boarding pass that includes a two-dimensional barcode. The barcode can be scanned at airport security checkpoints and at the gate during boarding. A refresh of the mobile boarding pass will reflect any changes to seat assignments, gate changes and upgrade confirmations.

"Mobile check-in and paperless boarding give our customers more choice and control over their travel experience," said Cindy Szadokierski, vice president of airport operations planning and United Express. "These options enable travelers to have greater flexibility and efficiency in their travel day, particularly as we enter the busy spring break travel season, where thousands of additional customers will pass through airports every day."

#### Tilton Meets With President, Chicago Business Leaders at White House Luncheon



At the invitation of the White House, CEO Glenn Tilton was asked to join President Obama, his senior advisers and other key business leaders for lunch recently. Glenn Tilton joined McDonald's CEO Jim Skinner, Motorola CEO Greg Brown and TransUnion CEO Penny Pritzker. The meeting was part of the White House's ongoing effort to reach out to the business community on economic issues. Topics covered included economic recovery, business performance, employment, education, healthcare, energy and infrastructure.

"We very much appreciate the opportunity to discuss these issues so important to our company and our country with the president, his senior advisors and our Chicago business colleagues," Glenn Tilton said.

#### March 2010 Traffic and Revenue Update



United reported in its monthly traffic update a 3.2 percent increase in consolidated revenue passenger miles (RPM) for the month of March over the prior year despite a 2.7 percent decrease in available seat miles (ASM) for the same period. This resulted in an 83.5 percent consolidated load factor, which is 4.8 points higher than in March 2009.

In March, passenger revenue per available seat mile increased an estimated 21.5 percent to 23.5 percent over March 2009 and estimated 3.2 percent to 5.2 percent over March 2008.

"Our revenue improvements reflect both the improving economy and the work we have done to reduce capacity, better matching supply and demand, which allows us to more effectively manage our seat inventory," says John Tague, President, United Airlines. "Our monthly revenue results have continued their positive trend compared to the same periods in both 2009 and 2008 that we have seen in the first three months of the year. More importantly, despite the challenges of the first quarter, we have continued our focus on cost control and were the only major network carrier to maintain our cost guidance."

United reported to the U.S. Department of Transportation an on-time arrival rate of 83.8 percent in March.

"Our strong on-time performance reflects our collective work to get our customers to their destinations safely and on time," says John. "We expect March will mark the fifth consecutive month that we will be No. 1 among the five major network carriers."

United's average mainline fuel price for March 2010 is estimated to be 2.21 dollars per gallon, which includes gains or losses on settled fuel hedges and excludes non-cash, mark-to-market fuel hedge gains and losses.

#### Employee Volunteers Share Their Experiences From This Year's Holden Hugyou Deliveries



When delivering a Holden Hugyou teddy bear to the mother of an infant battling cancer, Chicago O'Hare Ramp Service Employee Kathy Dvorak understood just what sort of impact the seemingly small gesture had on that mother.

"I had to wear a gown and mask to enter the room," she says. "After I spoke with the mother for a while, she told me she was very tired and was only able to get a couple hours of sleep a night. As I went to leave, the mother asked

if I could remove my mask - she said she wanted to see what an angel looks like. I will carry this memory with me forever."

In February and March, United's employees delivered Holden Hugyou teddy bears to young cancer patients in hospitals in all five of its hub cities. In this 3<sup>rd</sup> year of delivery – in partnership with the American Cancer Society (ACS), United delivered more than 7,500 teddy bears, raised more than 100,000 dollars for cancer research, and gathers 27 million Mileage Plus miles to fly families in need to treatment centers across the country.

As one of the winners of this year's bear naming contest, Brazil Customer Service Representative Renata Nogueria was thrilled to know that she would finally have an opportunity to take part in the bear deliveries. "I've read the stories about the past deliveries, but never thought I'd be able to participate – as I am based in Brazil – but when I saw "Holden" was the winning name, I knew I'd finally have my opportunity". Reflecting on her experience delivering bears in Washington, D.C., she says that while it was not easy to see the young patients fighting for their lives while trying to stay brave, to see the smiles on their faces when then received the teddy bears mad her journey worth it. "The whole experience makes you change your perspective and pay attention to what is really important in life", she says. Dulles-based First Officer Julie Callens came away from her bear delivery experience with a similar sentiment. "Talk about putting things in perspective", she says. "We all get so wrapped up in our own lives and our own troubles, that we often forget how truly fortunate we are". For Los Angeles-based pilot Tony Lee, whose own daughter endured a life-threatening disease as a child, his experience volunteering for the bear deliveries was one that had a very personal impact. "When my own daughter would ask me "Why is this happening to me, Dad?". I was supposed to have the answer, like I did for everything else in life ... but I didn't", he shares. He says the reason he volunteered was simple – that he wanted to bring some peace to families suffering that same kind of anxiety he and his family suffered so many years ago. First time volunteer and San Franciso-based Flight Attendant, Masumi Hargis, concludes, "The kids were surprised when we came into their rooms with bears instead of needles, and with smiles instead of doctor's orders. We received smiles of joy instead of frowns of sorrow. Ultimately, we received much more than we gave – and in the end, we wondered just who was helping whom that day."

#### **Easy Does It**



These 2 recipes may sound a bit quirky but both are taste bud tempting (only 4 ingredients).

#### EASY DOES IT - "Cranberry Chicken"

One 8 oz. bottle of "Catalina" salad dressing (any brand)

One 16 oz. can whole berry cranberry sauce

One pkg. dry Lipton onion soup mix (*not* Cup-A-Soup)

8 - 10 (or 12) pieces chicken

*Mix* ingredients together. *Dip* each chicken piece in mixture.

*Place* in baking dish. *Pour* remaining sauce over chicken.

**Bake uncovered** 2 hours at 275° F.

*Increase* oven temperature to 325 ° F.

Continue baking additional 30 minutes. (Devour!)

#### EASY DOES IT - "Begging Good Cocoa Peanut Squares"

1 cup Karo corn syrup (light or dark)

1 1/3 cup brown sugar

1 1/3 cup peanut butter (any style)

11 oz. box Cocoa Krispies cereal (approx. 9 cups)

#### Preparations:

Generously butter two 13"x9" rectangular pans. Have ingredients premeasured as follows:

- ✓ Cereal in largest bowl;
- ✓ Karo & brown sugar together in pan on stove;
- ✓ Peanut butter in cup.

Gently cook Karo & brown sugar 'til mixture bubbles around edges, stirring constantly.

**Remove** from heat. **Add** peanut butter immediately **with** cereal, mixing thoroughly. (Mixture will be very stiff.)


- A service fee of 5% annual percentage rate or APR will apply. This will be charged to your second and third payment.
- If you decide to cancel EPP at anytime, payment for the remainder of your current prescriptions will be your responsibility.
- If the payment plan ends, invoices incurred while enrolled in EPP will continue to be charged in three installments. New invoices will require your regular co-payments in full.

If you're a first-time visitor to our website, please take a moment to register with a recent prescription number and your member ID. Once at medco.com, Click "Update your profile" from the left navigation menu on **medco.com**. On "Your profile," click "Update your credit card information." Then select the "change" button in "Your credit card information." At the bottom of the page, you will see a link to more information about the program and the service fee. The service fee is applied if the balance of the prescription is not paid in full before the second installment payment is due.



Many wonderful memories will stay with Pamela, Luxor, Alexandria, Cairo, Aswan, The Pyramids, etc.

In February 2010, **Jack Lawlor** (IADMK/IADRR) travelled to Vietnam with a buddy via Chicago/Hong Kong and arrived 25 hours later! By coincidence, they met an old friend formerly in cabin service, who was now a Hong Kong based flight attendant. The first tour from Saigon was to see the Cu Chi tunnels, used by the Viet Cong during the war. The tunnels were at least 100 yards long and three levels down. The next day, the tour guide took them by taxi to the New Years celebration in her village!

They finally got to see the infamous Hanoi Hilton: This notorious prison was first used by the French and later became a prison for American POWs. 

# United Airlines Historical Foundation

The most noticeable exterior difference between the "SkyTrain" and the "standard" DC-3 / C-47 was this front-opening "barn-door" combined with a rear-opening "standard" door. The large "hole" required strengthening the fuselage structure and also "beefing-up" the floor to support the weight of a jeep (or two). "Cabin" differences included fold-up aluminum & canvas "bucket-seats".

Cargo loads to Alaska included: nitroglycerin, dynamite, TNT, tractors, jeeps, field kitchens, gas tanks, tires & tubes, welding machines, acetylene tanks, fresh meat, fresh water, clothing, gasoline and oil.

Guns, ammunition, high-octane gasoline, tools, clothing and other supplies were flown to Naknek, Cold Bay, Umank and Kodiak Island. The ATC pilots frequently took off in the face of highly unfavorable weather and then worked their way through narrow mountain passes, often without radio aid, to the north side of the Aleutian Peninsula. Then, often only a few hundred feet above the water, they would continue to their destinations.



Round-trip flights ranged from 1,000 to 2,000 miles and required three to six hours on each leg.

In addition to the cargo, a considerable number of construction workers for the new Al-Can Highway were brought in, often as many as 28 per planeload.
