



#### **Letter From The President**

#### Flying Together Obituaries

The obituaries previously known as SkyNet obituaries are not available this month.

United wants to continue the practice of publishing milestones and obituaries for both active and retired employees; however they need to publish this information for both Continental and United subsidiaries.

Posting accurate information for both subsidiary Continental and subsidiary United requires pulling information from two separate data systems that have not yet been integrated. They are consulting with the internal IT resources to determine short and long term options.

#### Make Travel tab your first stop when planning pass travel

With the launch of United's combined pass travel program on March 3, the company recognizes that coworkers have a lot of new information to learn so that they can enjoy pass travel.

To help, United has continued to post updates to the Travel tab over the past few weeks. Some of the most frequent questions co-workers ask are about <u>board priorities</u>, <u>service charges</u> and <u>eligible pass riders</u>. #### **Hobby proposal bad for Houston**



You may have seen news reports about Southwest's (WN) proposal to begin international flights out of HOU (Houston's Hobby Airport). United is opposed to this plan and the

company is reaching out to Houston co-workers to help United send that message to Mayor Annise Parker and the City Council. The proposal would negatively impact United's IAH hub operation and result in less international flying by all carriers out of IAH, hurting the city of Houston.

One of the reasons that Houston's economy is so strong is the connecting air passenger traffic that powers IAH, filling planes to destinations around the world on flights that the city's local traffic alone couldn't support. Those flights create jobs. A second international airport would dilute IAH's international traffic, stretch scarce federal customs resources and make Houston an unattractive destination for passengers and a more costly one for carriers. United welcomes new international flights at IAH, where the international gates and existing customs facility can easily accommodate more flights.

Congressmen Kevin Brady and Al Green wrote a letter to Mayor Parker opposing the idea of a second international airport in Houston, saying, "Doing so will ultimately reduce the benefits of Houston's prior strategic investments in both airports and turn this into a competition with itself for customers and limited federal resources." The congressmen also pointed out that IAH drove the equivalent of 172,000 full-time jobs in 2010.

#### UAL flew veterans back to Iwo Jima



Iwo Jima allows visitors once a year for memorial services in honor of those who served during one of World War II's longest and fiercest Pacific battles. This year, U.S. veterans of

the Feb. 19-March 26, 1945, battle were among visitors United flew to the island on March 14 on two chartered Boeing 737s from GUM.

The veterans and travel companions were part of a tour that also included stops at the battle sites, bunkers, monuments and landing beaches on Guam, Saipan and Tinian. Ten veterans began their journey at LAX. United co-workers, the Transportation Security Administration Choir, a U.S. Marine Corps honor guard, the USO, airport officials and others honored them.

Airport Sales Agent Cindy Good has worked on this event for each of the past 17 years. "It is an honor to work with these heroes each year as they pay tribute to their fallen comrades by returning to Iwo Jima," Cindy said. United co-workers lined up alongside the aircraft prior to departure to salute the flight as it pushed back from the gate, and the Los Angeles Airport Fire Department paid its respects with a water cannon salute as the aircraft taxied to the runway for the first segment of the trip.

#### United announced adjusted 2012 capacity



On March 13<sup>th</sup>, United announced that it expects its 2012 capacity to fall by 0.5% to 1.5% compared to 2011, versus earlier guidance for a year-to-year change that could range

from a 0.5% increase to a 0.5% decrease.

Jeff briefed investors on the adjustment as part of his presentation at the J.P. Morgan Aviation, Transportation & Defense Conference in New York. He said with United's conversion to a single passenger service system, the company can now focus on being consistently profitable and being the world's leading airline for investors as well as for co-workers and customers.

Consolidation has been good for the airline industry, Jeff noted. "We now have a single, market-driven focus on creating value," he said. UAL is in a great position, he told investors, thanks to factors including United's co-workers, network, fleet, facilities and product improvements, and United's capacity discipline as it deals with high fuel prices or economic changes.

"We will continue to respond to higher fuel prices," Jeff said. "With our disciplined approach to capacity, we can focus on making money." He said UAL is making good progress on building the right workplace culture. "It's simple," Jeff said. "If co-workers trust each other and trust management, if we invest in them and give them the tools they need, they will deliver better service to customers, customers will continue to fly us, and we can deliver to you, the investors."

When asked what United would like to see from the U.S. government, Jeff said UAL supports modernization of the air traffic control system and would like to work towards a rational national airline policy.

"We don't have one today, unless that policy is destroying airlines with high levels of taxation and regulation," Jeff said. Middle East carriers, by contrast, have the "total and absolute support of their governments, the exact opposite of what we have here," which is why they are successful and pose a clear and present danger to U.S. carriers, including United. #### United to exit some markets, reduce flying in others

Consistent with United's previously announced capacity guidance and due to high fuel prices, the company is discontinuing some routes that are underperforming financially and reducing flights on other routes based on seasonal demand.



As of July 1, United will stop IAD-ACC (Accra, Ghana) service and as of Sept. 23, it will halt EWR-CPH (Copenhagen, Denmark) service (last east-bound flights). Where

possible, United will offer affected employees other positions within United. United will also suspend service for the winter season for some other trans-Atlantic markets, such as EWR-FCO (Rome) and IAD-DME (Moscow). In addition, about two dozen city pairs will see seasonal reduced day-of-week flying.

United puts these changes into the system and will contact affected customers to offer alternate travel plans or refunds. United expects to redeploy some of the Boeing 763s freed up by these changes to replace Boeing 757s now on certain trans-Atlantic routes such as EWR-FRA (Frankfurt, Germany), IAD-AMS (Amsterdam) and one EWR-LHR (London) aircraft.

#### <u>United will continue to put</u> <u>right aircraft in right market in 2012</u>



Ensuring the right aircraft serves the right market is critical to supporting United's sustained profitability. Redeploying aircraft allows United to capture more of the revenue

synergies it expects as a result of the merger.

So UAL will continue in its April schedule and beyond to use subsidiary CO and subsidiary UA aircraft on routes the other subsidiary previously served where it makes economic sense, a process the company began in domestic and international markets last year.

There will be some changes in the April schedule and more in May. United will see increased Boeing 737 flying out of ORD and DEN and Airbus flying out of IAH as a result of the changes. The level of redeployment will remain relatively stable throughout the summer then increase further in the fall.

Redeploying aircraft affects several of United's employee groups throughout the company. Our move to a single passenger service system (PSS) on March 3 made it easier for agents to handle customer issues specifically related to the redeployment of aircraft in different markets. Look to May's edition of World for more detailed information about redeployment-related changes.

#### More professional sports teams rely on United

United will provide charter flights for nine of the 30 Major League Baseball teams for the 2012 season,

meaning its chances of flying at least one World Series team are pretty good - .300 if expressed as a batting average. United's customers in the "show" include all its hometown teams, the Chicago Cubs and Chicago White Sox, Cleveland Indians, Houston Astros, Los Angeles Dodgers, San Francisco Giants and Washington Nationals, as well as the Kansas City Royals and Milwaukee Brewers.

Beyond baseball, United's charter client roster is expanding steadily among other pro and amateur sports, and the company is actively recruiting new clients year-round, Network Planning-Charters Director Kevin Ross said. In fact, Senior Manager Michael O'Brien's sales co-workers opened contract talks with teams for this baseball season right after the end of the last season.

"Our ability to sell and operate charters is one of the areas that benefited most from integration," Kevin noted. "We have reach now in so many more markets."

As the regular season approaches, United's co-workers on Charter Operations Senior Manager Ron Ward's team are making road trips of their own, meeting with each client club to work out the game plan. United also has representatives from Airport Operations, Food Services and Inflight Services taking part in the pre-season workouts. At the same time, Manager of Charter Scheduling Joe Williams is lining up the aircraft United will use for the teams and making sure each has adequate block time, and other co-workers are working with stations around the network to make sure everything goes smoothly for each team on each trip.

As part of the Network team, Kevin said, Charters can coordinate more effectively with other groups that need to schedule aircraft.

At the home airports of United's teams, ground charter coordinators such as AO Supervisor Ashby Scott in CLE hold meetings with departments that will be involved with charter operations during the season and sometimes make advance visits to destination stations to "make sure everybody is on the same page."

#### First two-class B767-300 modification



As part of the onboard product improvements that United announced last September, the company is renovating 14 two-class domestic Boeing 767-300s to match the style of the

newly renovated international B767-400s, which feature flat-bed BusinessFirst seats, Economy Plus seating and audio and video on demand in both cabins.

The first airplane is currently undergoing modifications in Asia and will return to service by this summer primarily on routes from the East Coast of the United States to Europe and South America. The plane will also get winglets and engine improvements for improved fuel economy and efficiency, new galleys and other interior upgrades.

United will convert all 14 of the B767-300 MD aircraft to the new ME configuration by the end of 2012. The new configuration has 30 BusinessFirst lie-flat seats, 49 Economy Plus seats and 135 Economy seats.

#### Flight 93 Memorial Chapel

Four members of the Philadelphia Independents attended the commemoration of the Flight 93 Memorial Chapel's 10<sup>th</sup> Anniversary in Shanksville, PA. President **Joseph Bradley** and his wife **Gail**, officiated at the noon service prior to the dedication ceremony which followed at 3PM, Sunday, March 11<sup>th</sup>.

A donated 1902 Grand Piano was dedicated to the Chapel. The concert which followed was outstanding. One teenager whose feet just about reached the pedals was really great, as were those who preceded him.

The Independents had front row reserved seating. There was a four by five foot picture of how the new Chapel will look in the future. All in all, it was a beautiful day.

#### Easy Does It – Baked Ham (very tender)



The easiest baked ham recipe I've ever come across is for a small boneless ½ ham approximately 3½ lb. and only uses brown sugar and Coca Cola (weird, huh?) It works great for company one night, and sandwiches the next. I still had some ham left over so fixed myself an egg and the leftover mashed potato (fried in butter like a pancake) for

my dinner the next night.

Baked Ham:

3 ½ lb. ham

1 cup brown sugar

- 1 ½ cup Coca Cola
- 1. Rub fat side of ham with brown sugar. Mine had no fat showing so I cut down to wherever there was some fat.
- 2. Place ham on a rack (metal or ceramic) in a

- non-stick oven-proof pan/pot with high sides.
- 3. Pour Coca Cola over.
- 4. Bake for 2½ hours at 450 degrees. That's it ... you're finished.

For my sweet tooth, I needed my sliced pineapple and canned peach halves so added them (slightly-warmed via microwave) to my platter with the sliced ham. For an easy finish, add mashed potatoes and/or refrigerated biscuits and a green salad. Depending on the number of your guests, you can combine part of a head of lettuce with one of those small already prepared salads in your grocery store's vegetable section.

Nuts to you ~ - If you're like me and trying to shed a few of those holiday pounds, "Go Nuts". Nuts of all kinds are some of nature's top sources of disease-fighting antioxidants, protein, fiber and monopolyunsaturated oils. Want a Calorie Count Per Ounce? 10-12 Macadamia nuts (204), 19 Pecan nut halves (196), 14 Walnut nut halves (185), 22 Almonds (169), 49 Pistachios (161), 25-28 Peanuts (166), ½ cup Sunflower seeds (166).

For over 28 years, he kept the equipment operational and presentable to our customers, and often to the envy of our closest competitors. He painted, mechanically maintained, and serviced over 16 pieces of ground equipment to accomplish this. Bill was also a competent fueler, which included servicing the fuel farm and performing the aviation fuel checks mandated by the FAA. After his retirement, Bill continued his primary goal in life, to proclaim the Christian faith by which he has lived and ministered. Bill has a radio ministry for over a quarter century and is not hesitant to proclaim the faith he demonstrates daily as an active ordained minister. Many have been touched and helped by his work in this area. His faith helped Bill through the tragic loss of his 48 year old son this year. We all shared his loss with him.

A wise coworker once said "never be ashamed of the dirt you get on you from honest work". Bill Preston would do this hard, greasy, and sometimes unrecognized honest work, without complaint and helped make BHM a great line station. His extraordinary friendly nature, his integrity, and his superb work ethic, have certainly earned Bill recognition as our Employee of Interest for this month.

It seems that if you're not accommodated on the outgoing flight, the Res system automatically cancels your return listings! That happens with revenue bookings and with standby listings as well. Apparently, even if the gate agent rolls over the standby list to the next flight, any ongoing booking/listing is cancelled because you weren't on board the flight when it departed.

Get used to the fact that almost all communication with the Company from this point forward will be electronically. The MSP chapter is trying to help as much as possible those who have trouble in the computer department. There will be annual re-certification of eligibles for health care & pass riding, probably in November. If you are still covered under the BCBS health insurance or intend to use the travel benefits, it will be necessary to use the Company website to recertify eligibles & to set up & pay for your travel.

Since many of our retirees have served in the military and I know most, if not all, our pilots had Air Force or Navy backgrounds, I thought this letter would be interesting news to share. Because of my husband's family and his own Military background, I wanted to write about the pride he would feel for his grandson, Andrew. My husband, Chic, died of bone cancer in 2008. He had 36 years with UAL.

My letter to the RUAEA Newsletter ~ Many thanks for the wonderful RUAEA Newsletter that keeps my memories renewed of my time with United Airlines. I was hired January 1953 in DEN and worked in DENRR. then SLCSS, and finally SLCRR. Our RUAEA Conventions help strengthen my memories when I get to visit with old friends. Since my husband's death I rely a lot on my friendships with my airline family to keep me adventuresome. As most of my close friends know, Chic was serving in the Military when I was attending college, trying to become a nurse. In 1954, after working in DENRR for about a year and a half, I was accepted into UAL's Stewardess School in CYS. After graduation I got domiciled in SLC. Chic had finished his Navy time, 1945/47, serving on the Destroyer USS Stribling DD867 in the Atlantic. When he returned to SLC he registered at Westminster College and took flying lessons. He got his private license at age 20 years 3 months. When he turned 21, he went to work for United and did not return to Westminster, but joined the Air Force Reserve to earn his Commercial Pilot's license. He got his Commercial license just as the Korean War broke out and he got stationed with the 1973rd AACS Squadron at Taegu, Korea. His rank was S/SGT and he worked Air Traffic Control until 1952, finishing in Japan. He came back to his job with United in SLC and we met in 1954, when I was flying out of SLC. We married in April 1955 and had been married 53 yrs. 1 month when he passed away. In 1988, our youngest daughter, Cordi, was 22 when she was killed in a car accident riding as a passenger. Her son, Andrew, was 5 months old. He is now 23 and his home is in Maribel, Wisconsin. He enjoys hunting, fishing and sailing.

Chic would be very proud of his grandson for his choice of Military service. After graduating from Valparaiso University Indiana, Andrew has chosen a Military career, following in the steps of his great grandfather Charlie, who served in the Army during WWII. Chic's brother, Robert, served in the Merchant Marines, Chic in the Navy and then Air Force. Now it's Andrew's turn; he has chosen to enroll in the Linguist program to do Cryptologist work for Military Intelligence. After graduating from his training at Ft. Leonard Wood in St Louis, he flew (UAL) to Monterey, CA for more training at the Defense Language Institute, the primary foreign language school located at the Presidio of Mon-

terey. Military service members study foreign languages in classes at highly accelerated paces, ranging from 24 to 64 weeks in length. There are U.S. Army, Navy, Marine Corp and USAF presences on post and all branches provide their own students & instructors. As of 2009, over 40 languages are taught at the DLL. Andrew has chosen Pashtu, a language spoken in Iran, Pakistan & Afghanistan. After his DLI training he goes to a Military Base in Texas before he is given an assignment. I flew to STL for Andrew's graduation from Ft. Leonard Wood. While in St. Louis I visited the Gateway Arch and rode the Tram 630 ft. to the top. It was a thrill for me to see the mighty Mississippi River, through the windows at the top, and watch the tugboats pushing 4 & 5 barges up the river.

P.S. When the wind blows, the Arch sways and it is hard to walk around up there, but I did get photos of the city and the Mississippi River with its many bridges.

My BOI-STL connection in DEN was perfect, but the return flight connecting at ORD was another story. Weather was delaying flights in and out of ORD, so the agents in STL were trying to get the passengers on earlier flights out of STL to ensure we made our connection out of ORD. #### United Airlines Historical Foundation



"Preserving the Past, Inspiring the Future"



November 1, 1945, marked another United Air Lines First in airline history when this "Flying Refrigerator" DC-3 Cargoliner began a coast-to-coast round-trip. It was equipped with five insulated containers, each capable of accommodating 1,600 pounds of perishables.

Dry Ice kept container temperatures between 35 and 40 degrees Eastbound and between 22 and 30 degrees Westbound. The DC-3 cabin temperatures ranged from 74 to 30 degrees during the flights.

The eastbound flight departed the West Coast loaded with Gardenias, Crabs, Corn, Grapes & Emergency Serum. Celery was added at Salt Lake and Carnations at Denver before continuing on to New York City.

After unloading at New York the flight continued to Boston where 2½ tons of choice Haddock Filets were loaded and flown to Chicago. The Fillets were in the

Chicago markets less than 12 hours after fishing boats had docked at South Boston.

In Chicago, 4,000 pounds of fresh Lake Superior Whitefish and other Great Lakes fish were loaded for nine Los Angeles markets.
