UA updated Pass Travel Board Date to include retirees, early-out participants



The following news item on Pass Travel Board Date was posted by United Airlines on Flying Together on April 5, 2013.

Like active co-workers, starting April 5, retirees, early-out participants and their eligible pass riders will clear for flights in order of their “board dates,” which we calculate by subtracting one’s length of service from the travel date. This replaces our interim way of boarding pass riders that was based on the retiree’s completed years of service or the current year for an early-out participant.

Retirees and early-out participants who have pending travel plans should cancel those plans and create new ones to take advantage of the new board date calculation. Over the next several days, retirees and early-out participants may view the calculation of their board dates on the Employee Profile page under Quick Links on employeeRES.

When we introduced the pass travel program in March 2012, we could not implement boarding by day, month and years of completed company service due to system limitations. However, we recognized that this is an important feature so we worked with our technology team to change the board date as soon as possible - first for co-workers last July and now for retirees and early-out participants.

SFO Museum Receives Gift of Historic United Airlines Uniforms, Now on View in New Exhibition



SFO Museum at San Francisco International Airport has received fifty-five flight attendant uniforms donated to its aviation collection by the United Airlines Historical Foundation. This major gift represents the full history of the airline's company-issued cabin crew attire. Both female and male outfits are included in the donation that spans seven decades of uniforms—from the 1930s and the military-styles of the WWII era to the designer fashions worn in the 1950s, '60s, and '70s, and up to the present.

In 2007, at the request of the United Airlines Historical Foundation, United Air Lines Inc. generously donated their large collection of extra flight attendant uniforms and accessories to the Foundation for distribution to select aviation museums across the U.S. "*We felt the museum program at SFO was the right home for this important collection of United's history and the preservation of that legacy.*" said United Airlines Historical Foundation President Tom Goodyear.

SFO Museum, which is accredited by the American Alliance of Museums "*has the professional staff, including conservators, needed to support these artifacts.*" said Goodyear. SFO Museum Director and Chief Curator Blake Summers expressed appreciation, "*For the generosity of the United Airlines Historical Foundation in enabling SFO Museum to further its mission of sharing aviation history with the public it serves.*"

Eighteen of the female uniforms from the collection are now on exhibition at San Francisco International Airport in the Louis A. Turpen Aviation Museum. Included are the ensembles created by Raymond Loewy, and the fashion houses of Ben Reig, William Travilla, and Jean Louis, many with hats made by famed milliner Mae Hanauer.

The individual at UA responsible for the retiree badge project has advised us as follows; *"I can assure you that getting the retiree badge program up-and-running is my top priority. We have continually been engaged with Information Technology to*

load the layout of the actual badge into all of our badging systems, that being said, we have recently run into the issue of needing an upgraded server to actually print these badges. We are working to get this issue resolved, as well as perusing alternative means of printing the physical badge in an effort to expedite the release.

Again, I would very much like to reiterate that getting the retiree badge program up and running is my team's and my foremost concern. We will continue to work diligently to get this process in place and then work to improve the experience as we learn what meets the needs of all stakeholders."

Update Your ID 90T Profile by Jim Morehead

I recently received the following from a friend. Here is his message for any members who plan to use ZEDS. You should update your profile before you do so.

"I thought you might wish to pass on my experience with IFC ID 90T to RETUP. They are located in Cordova, Argentina. They have two people answering the phone and thus you can wait hours on hold if you wish to ask a question and both are busy. They or the website have no opportunity to update your profile. It must be done through United."

ID 90T is one of the main companies that handles our ZED tickets on a contract basis. 90T has the majority of the Carriers for interline travel and it is electronic. It should be noted that Hawaiian is the only carrier that I know of that allows one's Enrolled friends to travel. There are, of course, a handful of Star Alliance Carriers that allow Companion Fares, but they do NOT have to be enrolled friends. On the Star partners, the employee/retiree has to travel with them.

ID90T collects the money and it does the listings in most cases. Some still require a paper ticket and others do not. You will see the list. Some may complain about the \$2 service fee, but this is a bargain considering you can get it done very quickly and do not have to request a paper ticket in many cases. IF YOU NEED A PAPER TICKET, you will still have to drive to the airport to pick it up in advance of your flight! Each Company is slightly different.

You will note there is a little homework to do on a profile. Of all of the ID90T carriers, some require you to go back to the profile for an update and it is clear when you go to the website. On this website, you pick your own unique password.

I had gotten a refund a year ago and needed to arrange for it. When I called, the lady said they were in Argentina and I could tell by the Spanish accent. I had no trouble getting through and my refund was promptly handled.

First-quarter revenue, costs to increase



On March 28, UA issued an investor update stating that the company expects its first-quarter unit revenue to increase, but UA expects its first-quarter and full-year unit costs to increase even faster.

UA's first quarter consolidated PRASM (passenger revenue per available seat mile) is expected to increase between 5.4 percent and 6.4 percent compared to the same period in the previous year. UA's increased unit revenues reflect its focus on higher reliability and service levels, areas where every co-worker is contributing.

UA also expects that its first-quarter consolidated non-fuel CASM (cost per available seat mile) will increase 11.4 percent to 12.4 percent year-over-year, approximately 3.5 points higher than the guidance the company provided in January.

Much of the first-quarter cost increase versus prior guidance is due to winter storm activity, increased investment in aircraft maintenance, higher salary and wage expense caused in part by a tentative collective bargaining agreement with its agents represented by the

IAM, and accelerated depreciation associated with the previously announced sale of some of its 757 aircraft to FedEx. Although many of these costs are disproportionately affecting the first quarter, UA nonetheless expects consolidated non-fuel CASM to be up 5.5 percent to 6.5 percent for the full year, one point higher than its previous guidance.

To counteract the effects of its higher unit costs, it's important that UA operate its airline more efficiently than it has in the past. The company's goal remains to achieve at least a 10 percent return on its invested capital this year, which equates to earning at least \$1 billion in profit.

UA makes additional 787 schedule changes



UA is making additional adjustments to its published Boeing 787 flight schedules as Boeing and the FAA work to certify a solution that addresses the FAA's Airworthiness Directive (AD) for the aircraft.

UA plans to update its schedule on April 6 to show Boeing 777s in place of its six 787s on three international 787 routes: LAX to NRT, LAX to PVG (Shanghai) and IAH to LOS (Lagos, Nigeria). The company currently plans to put the 787 back on these routes in early August. UA previously announced that it plans to start its new 787 DEN-NRT service on June 10.

UA may return the 787s to service sooner if the issues outlined by the AD are resolved, but it chose to publish these schedule changes so customers know what aircraft to expect when flying with UA.

The company remains confident in the 787, believing that customers will quickly return to the aircraft once it goes back into service because of the enhanced travel experience it provides. UA is equally confident in Boeing's ability to work with the FAA to address the issues covered by the AD.

Torgy's Travel Tips

Starting off this month's column is some information from the Company regarding pass travel. If you have enrolled friends who use your vacation passes, please note: When UA deposits 8 vacation passes into your account each January, those passes have a 5-year validity, EXCEPT if you allow an enrolled friend or same-sex domestic partner to use them. In those instances, only current year passes are valid. Unused passes from previous years can only be used by the retiree and/or spouse or eligible children, if any.

If your travels include HKG this year, it may be

more difficult for pass travelers due to the downsizing of the ORD-HKG flight 895 aircraft to a 777-200. The resulting weight restriction began March 30th and is expected to last all summer. Indications are that it may also impact the return flight HKG-ORD. You may want to route yourself via EWR or SFO instead.

Check out the new Pass Travel Calculator on the Flying Together website. It's easy to use and clearly displays a breakdown of all the taxes pass travel can incur as well as the dreaded "inputted taxes" that will show up on a 1099 form for your income tax if you have lots of enrolled friend travel. Speaking of websites, two popular interline travel companies have been listing some amazing bargains recently. PERX.com and Airlineemployeetravel.com have many cruises, resorts and tours at interline rates that are easy to book.

Letters of employment verification are often needed when requesting discounts (such as the interline cruises and resorts, above) and I'm happy to say we can easily obtain them from the Flying Together website. You can print out the letter instantly and either email or mail it to the vendor. Go to: flyingtogether.ual.com>EmpRes>QuickLinks>EmpProfile. Look in the "Saved EmpRes Information" box for the blue word "click here for verification letter".

If staying closer to home is just the ticket, why not try Amtrak. Travelers age 62 and over enjoy a 15% discount. Amtrak's website is easy to navigate and you can purchase your ticket online and print the ticket at the station, if you don't have access to a printer.

And lastly this month, a travel tip for Canada. The Canadian treasury has eliminated the penny from distribution, so don't be surprised to see the price of your purchase rounded up (or down) to accommodate this change. It only applies to cash transactions, not electronic purchases made with credit or debit cards. Secondly, the treasury is now printing the Canadian \$20, \$50 and \$100 bills on polymer not paper. The new bills have a slight tendency to "melt" if exposed to very high heat, like being left in direct sunlight on a beach or inside a hot car. So keep those bills in your wallet for more than one reason!

Did you know? Emergency personnel who responded to the crash of United Airlines Flight 93 near Shanksville made a discovery that shocked and inspired them.

Resting not far from the smoldering crater where forty crew and passengers perished, firefighters found a Bible that was barely singed. Only minutes before, the area had been a raging inferno, as the fuel ignited into a fireball when the plane plowed into the earth. The leather cover on the Bible was singed, but none of the pages were burned. It is believed the passenger belonging to the Bible was a twenty year old Japanese man, Toshiya Kuge.

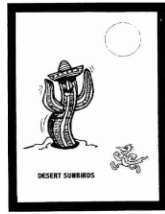

Most can be checked out at RUAEA website www.ruaea.org. At the March RUAEA Board meeting, the website Managers indicated they were trying to stay current with updated information.

The instructions for using the new pass program are available on RUAEA.org. An updated program on Flying Together/travel was posted on Flying Together. The content is 31 pages, although if you plan to print it out, several of the pages could be skipped.

One of the changes for Blue Cross/Blue Shield will be a separate ID card for medications/prescriptions. Once the card is received, you have to have the information changed at any local pharmacy you have used. The current information will not be valid.

Subscribers to the RUAEA Newsletter who enrolled with the three year subscription plan, you need to watch for the renewal notice adjacent to your address. Time is up or will be soon!

Southwest has introduced a \$40.00 fee to board the plane as part of the first 15 people to board. Not sure if you can do this ahead or if the Zed Fare is included.

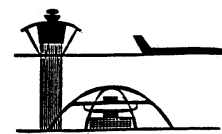

Hal Burdick won the 50-50 raffle. **Carl Franke** won the \$15.00 lunch gift certificate.

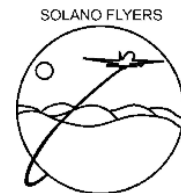

Again it has been a great year. We had a wonderful trip to New Zealand. It is so beautiful.

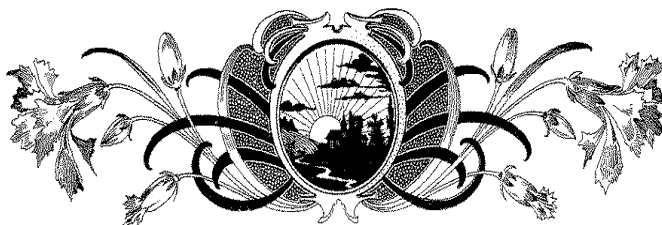
I am still working at Onizuka Space Center and doing taxes for AARP.
