STATUS PENSIONS

We have been receiving a lot of calls, e-mails & questions about United Airlines pension fund. With what you read in the newspapers, magazines and hear on the radio, TV and from other people, there is a lot of speculation and anxiety. Elizabeth Roch

of WHQPR wrote a comprehensive summary of the issues, United's position and action it is taking. It is the best summary of the situation that we have seen. Following is her letter:

(Note: In 1985 United Airlines purchased a paid up annuity for ALL pension liabilities as of that time. The Group Investment Trust with Northern Trust Bank of Chicago was established for pension accruals subsequent to 1985. Elizabeth's letter pertains to this Trust fund. Any retiree who retired in 1985 and prior to that is not affected. For all retirees who retired since 1985, their pension accruals up to 1985 is paid up in the annuity; accruals after 1985 are covered by The Group Investment Trust.)

<u>U.S. Pension Key Points</u> <u>Final 9/9/03</u>

1. Through the collective bargaining agreements it reached with U.S. based represented employees - and agreements with other employees - earlier this year, the Company has significantly reduced its on-going pension costs.

This did not resolve the most significant pension issue still facing the Company.

2. The most significant remaining pension issue facing United in the U.S. is the accelerated payments now needed to address the past underfunding of the Company's pension plans. This is required in part by pension law changes made by Congress in 1987 & 1994.

In 1987, Congress adopted the "deficit reduction contribution" (DRC) - a special funding surcharge assessed when a pension plan's funding status drops below 90% (or 80% in some cases).

This requires companies with under-funded pensions plans to make significant accelerated payments to improve the funding of their pension plans as quickly as possible.

In 1994, the DRC was tightened in several ways, including by requiring that the plan liabilities be measured based on even more

pessimistic interest rate assumptions and further shortening payment periods for any unfunded liability.

In face of the recent downturn, the DRC has proved onerous and inflexible, particularly for cyclical industries like the airline industry. If DRC did not exist, United would be able to meet all its pension and other obligations.

These accelerated payments come at a time when operating expenses and other obligations already place substantial demands on cash flow.

In the current economic environment, with negatively pension plans affected historically low 30-year Treasury bond interest rates and the decline in stock market values, the accelerated payments required under law are the unintended having consequence threatening the financial health of many companies - not just United - and their pension plans; however, this is a short-term problem, affecting United's ability to make payments in the next few years.

As recently as several years ago, United's pension plans were fully funded.

3. In United's case, the accelerated payments are creating a significant "cash crunch" that we must address in order to exit bankruptcy on a timely basis.

Making the payments would dramatically reduce cash flow in the near-term - threatening our ability to fund our business and complicating our exit financing, including our planned application for a loan guarantee from the ATSB.

- 4. We are going to fix this problem. There is not a single solution, but instead we must do a lot of hard work on a number of fronts to address United's short-term funding issues.
- 5. First, we've been working closely with other airlines, airline unions & the AFL-CIO in support of a pension reform proposal introduced by Reps. Dave Camp and Earl Pomeroy, specifically for our industry.

This proposal would allow affected airlines to defer certain accelerated pension funding contributions and would smooth out minimum funding requirements over a longer period of time. This would help the airline industry get through this extreme and very unusual economic cycle.

This initiative will help United, also provide assistance to other airlines whose pension funds are underfunded.

By spreading out payments over time, the Company will be in better financial health, also will be able to pay these and its other obligations.

We are pursuing this initiative with labor and others because we know how important pensions are to our employees, to United and to the industry.

This legislation reform is our preferred course of action, but other initiatives (described below) would be very helpful to us.

6. Second, if Congress decides not to enact broader pension reform like the Camp-Pomeroy legislation this year, the Company is also advocating for legislation that (a) gives companies more time to make their accelerated payments on their past obligations and/or (b) reset the rates which determine corporate funding requirements for these obligations.

A three-year suspension of the Deficit Reduction Contribution would help to resolve this underfunding issue for many companies, including United. The DRC requires accelerated payments when plans become underfunded, escalating pension payments in the short term.

The rate that determined current liability needs to be renewed or replaced. Congress needs to renew the temporary rate (based on 120% of Treasury Bond rates) - which expires at the end of the year - or replace it with a rate based on corporate bond rates. The latter would more accurately reflect the prevailing economic environment.

7. Third, United will apply to the IRS for waivers that would allow United to delay and reschedule over a five-year period, some payments for its pension plans.

We are applying to reschedule all payments to United's defined benefit pension plans.

These waivers would not affect existing

benefits or the payment of existing benefits.

- 8. The Company believes that this relief is achievable in time for us to exit bankruptcy in less time than our original estimate of 18 months. The most likely scenario in the first quarter of 2004.
- 9. These solutions would have no impact on pension benefits nor would they impose any additional costs on pension participants.
- 10. While we are primarily focused on achieving these three reasonable solutions, their outcome and timing is far from certain. As a result, we are actively exploring a range of additional options that may be required to ease our pension burdens.
- 11. Through the bankruptcy process, we have fixed a number of difficult problems, and we will fix this one.

U.S. SECURITY SERVICE FEE REINSTATED

On Oct. 1, 2003, the U.S. government reinstated its \$2.50 security fee for all airline travelers, including employees, retirees & companions, for each airline departure from a U.S. airport. Revenue customers will have a maximum security fee limit of \$10 per ticket; airline employees, retirees & companions will be charged \$2.50 for each segment traveled.

The passenger security fee was enacted by Congress to help offset security costs after the government took over passenger & baggage screening post 9/11/01. Congress then temporarily suspended the fee when the war in Iraq & increased government security mandates conspired to threaten the financial stability of many carriers.

All systems, including fare quote & ticketing, will be updated to include this fee. The U.S. government will apply the fee toward screening, construction of security projects & other important security functions at U.S. airports.

UNITED TO BEGIN FLIGHTS BETWEEN IAD & CANCUN

United announced that it will launch exclusive Sat.-only service to Cancun, Mexico from its East Coast hub at Washington Dulles International Airport on Feb. 14, 2004, pending U.S. & Mexican government approval.

The Cancun service complements United's other flights to the regional leisure destinations of Aruba, St. Thomas, U.S. Virgin Islands.

The new flights will be flown using Airbus A320 or similar aircraft with 138 seats, configured with 12 seats in United First & 126 seats in United Economy. The southbound flight will depart Washington Dulles on Sat. at 8:30 a.m. & arrive in Cancun at 11:09 a.m. The return flight will depart from Cancun 12:00 p.m. & arrive in Washington Dulles at 3:59 p.m.

UNITED WILL EVALUATE "BUY ON BOARD" CONCEPT

Why should customers buy fast food in the terminal when they can buy on board? On Oct.31, United began a 90-day trial period, providing reasonably priced, restaurant-quality food on board. Flight attendants & passengers in the United Economy on more than 200 daily CHI & DEN flights will participate in the evaluation.

Offering branded, restaurant-quality food on board provides our customers with additional choices, also helps eliminate the hassle for customers who may be struggling with a laptop, carry-on & a meal during boarding.

If the results are favorable, United is prepared to extend the "Buy on Board" concept to additional North American markets, which would reduce the current costs associated with providing free meals & shift the meal-expense risk to United's caterers.

United will conduct this evaluation in partnership with Gate Gourmet & LSG SkyChefs. Customers will be able to choose from signature meals, a-la-carte items from branded & well-known restaurants such as Hard Rock Café, Bennigan's & TGI Friday's. Sample meals include such TGI Friday's offerings as apple crumb cake, a ham-and-Swiss croissant, Southwestern Cobb salad, & a chicken pesto sandwich.

On flights 3.5 to 5 hours in length, customers in United Economy will have the option of either a complimentary snack or purchasing a meal on board. Breakfast will be offered for \$7.00, lunch & dinner for \$10.00. On shorter flights, 2.5 to 3.5 hours in length, which currently do not offer a meal service, customers will be able to purchase various a la carte items for less. Complimentary meals will continue to be offered in United First & United Business classes.

Based on feedback from previous tests, United flight attendants will have hand-held computers to expedite & allow for cash & credit-card transactions. At this time, cash will continue to be the only acceptable form of payment for alcoholic beverages.
