

**HOORAY FOR HOLLYWOOD!** When you attend the RUAEA Convention 2005 (dates are May 22-29, 2005) you will be within walking distance of many famous locations that you have seen in movies or viewed on television. Immediately adjacent to Hollywood and Highland is Grauman's Chinese Theater, reputed to be the most famous movie theater in the world. Millions of visitors flock here each year, drawn by its famous forecourt with its hands and footprints of many stars in cement. The theater, built in 1926, resembles a giant red Chinese pagoda, and features a huge dragon across the front with two stone lion-dogs guarding the main entrance. The theater itself has appeared in several movies, including "Singing in the Rain" starring Gene Kelly. Currently there are over 200 imprints of Hollywood Stars, a virtual "Who's Who" of Hollywood Legends. Among the notables are: Groucho Marx, Betty Grable, John Wayne, Al Jolson, Jimmy Durante and Whoopi Goldberg's hair braids. The theater is the location of many movie previews.

About a block to the west of the Chinese Theater lies the Hollywood Roosevelt Hotel. In 1929 the inaugural Academy Awards ceremony was held in the Blossom Room of the Hollywood Roosevelt Hotel. You can walk through the lobby of the hotel and see a lot of memorabilia.

A short block to the east of Hollywood and Highland is the Hollywood Wax Museum. The Wax Museum contains wax statues of the likeness of many movie and TV stars, as well as the US Presidents, and also contains a "Chamber of Horrors" along with areas devoted to sports figures and super heroes. A very interesting place to visit.

On the south side of Hollywood and Highland is the old Max Factor building, which now houses the Hollywood Museum. This is the ultimate destination for movie fans, and has four floors with 5,000 exhibits of the most dazzling movie costumes, props, photos and other memorabilia ever assembled in one place.

There are **SO** many areas of interest within a few blocks in virtually any direction from the Renaissance Hotel and the Hollywood and Highland it boggles the mind. Yes, this is the film capital of the world with so much so see and do.

There will be much more information forthcoming in the future newsletters, so keep your eyes peeled & start making your plans for RUAEA Convention 2005. You know you will have a great time!

#### **FROM THE PRESIDENT**

Every retiree group I meet asks about our pension. Most e-mails & letters I receive are about our pension. Newspapers are rife with items about United & the pension plans. There is a lot of information, misinformation, partial information, rumors, etc. I have shared what I know & my understanding about our pension with many individuals & groups. I'll try to briefly summarize what I know.

I am not going to get into: how much the pensions are under-funded; why United Airlines got into this position; the legal implications of United not making pension payments, etc. I will focus on a very narrow specific area: If the company's pension plans are terminated, how will that affect us who are already retired?

When a pension plan is terminated, all the assets of the plan are transferred to the Pension Benefits Guarantee Corporation - PBGC. The PBGC is then responsible for making pension payments under the "old" plan.

Anyone who retired in 1985 & prior would not be affected one iota. United purchased paid-up annuities for all pension liabilities as of that time. Retirees would continue to receive their pension payments from the insurance company; the PBGC would not be involved.

Anyone who retired after 1985 receives pension payments consisting of the 1985 annuity, plus accruals post-1985 from the pension trust fund.

United's pension plans are "defined benefit" plans. That means a specified monthly benefit is paid to you & me as long as we live; if you selected a contingent annuitant the option you selected is paid to that person as long as he/she lives. That benefit is guaranteed by the PBGC. United has paid premiums over the years to the PBGC to "insure" that benefit.

Benefits are paid to you and me whether the assets in the plan are sufficient or not - up to the maximum guaranteed by the PBGC. The guaranteed amount is based on your age on the date the

plan is terminated. For example, the guaranteed amount if your age is 70 is approximately \$72,000; age 67 approximately \$52,000; age 65 it is \$44,386, age 62 approximately \$35,000, age 60 approximately \$29,000 & age 55 approximately \$20,000. (Source: PBGC)

Many retirees would not experience any pension reduction at all. Retirees currently receiving payments above the guaranteed amount for their age would experience a reduction.

# TICKETING FEES WILL BE WAIVED FOR EMPLOYEE DISCOUNT 20 TRAVEL PROGRAM

Effective Sept. 17, employees, retirees & their travel eligibles who purchase revenue tickets for travel on United using the 20 percent off employee implemented ticketing fees.

As announced on Sept. 9, United recently began adding a \$10 fee to domestic & international tickets purchased at U.S. airport ticket counters & a \$5 fee to tickets purchased through United reservations centers for calls originating in the U.S. & Canada. Customers purchasing tickets through united.com do not incur the fee. Retirees who have purchased discount confirmed tickets since Sept. 9 will not receive a ticketing fee refund.

The ticketing fee is being waived because, at this time, retirees can only book revenue travel using the 20 percent discount through Reservations or airport Customer Service; however, United is working toward a future online purchase option for employees & retirees.

Industry Discount tickets (ID90, ID95, ID75), which are purchased for travel on other airlines, United Express or United, have been exempt from the ticketing fees since this fee policy was implemented.

The Employee Discount 20 Travel Program applies to confirmed pleasure travel only & is available to employees & retirees, who are eligible for travel benefits,& their immediate travel eligibles. Companions are not eligible to purchase tickets or travel on this discounted travel program.

### NONSTOP SERVICE BETWEEN SAN FRAN-CISCO & NAGOYA, JAPAN

United announced plans to introduce daily, nonstop service between SFO & Nagoya, Japan, effective June 1, 2005. The service will begin at new Central Japan International Airport - opening in Feb. 2005 - where Star Alliance partner All Nippon Airways (ANA) plans to launch an additional 115 flights to destinations throughout the country, adding several new cities to United's route network.

Nagoya is Japan's third-largest city with a population of 20 million, also a strong & growing industrial economy. The home of worldwide brands such as Toyota, Noritake, Yamaha & Suzuki, Nagoya also offers strong potential as a cargo market for United.

### UNITED ACCELERATES PLANS TO OPTI-MIZE WORLDWIDE NETWORK

United is substantially accelerating the company's plan to expand its international leadership & reduce the size of its mainline fleet.

By March 2005, the company's fleet modifications will:

- Reallocate assets to more profitable routes, expanding & strengthening international routes, which will account for more than 40% of United's global capacity & 50% of mainline revenue when fully implemented, shifting some domestic routes to United Express.
- Reduce United's mainline fleet to 455 aircraft -- 68 fewer aircraft than United flew in Aug. 2004, & a reduction of 112 aircraft, or nearly 20% of the fleet since 2002.

These changes will result in international ASMs (available seat miles) increasing by 14% with United mainline U.S. Domestic ASMs declining 12% for a total systemwide ASM decline of 3%.

Steps the company has already taken:

- Launched 30 new international routes since Feb. 2002 --- 70% of those announced this year;
- United Express service has expanded to 21 new destinations;
- Ted now flies to 8 leisure markets from all 5 United hub airports.

She is an election judge for Cook County, also serves on several committees in her church.

### The Swallow Takes Flight

United Airlines Historical Foundation (UAHF) offered local United employees & retirees the opportunity to fly in a Swallow biplane, of the type United's predecessor, Varney Air Lines, flew on April 6, 1926 from Pasco, Wash., to Elko, NV., via Boise, marking the birth of our company. Through the generous financial support of UAHF, retired pilot, Clay Lacy, & others, the Experimental Aircraft Assn. (EAA) was able to restore their plane. On Sat., September 25 at the Aurora Airport in Sugar Grove, IL., the magnificently restored EAA Swallow took flight 17 times. Seventeen United active and retired employees, wearing a leather aviator jacket, helmet & goggles took to the air in this open cockpit biplane, received the thrill of a lifetime. They were all "wowed" by the experience & expressed their delight & gratitude after climbing out of the cockpit. Some were offering the next rider an opportunity to buy their ride so they could ride again! The sunshine, blue skies, the flawless smooth running engine & skillful EAA pilot, Ted Beckwith, added to the perfect day.

The following day, Sun., Sept. 26, UAHF participated in the Schaumburg, Ill., "Family Aviation Celebration" at Schaumburg Regional Airport. The Swallow was on static display along with exhibits tracing the flight of the original Swallow in 1926 in addition to an airmail pilot winter & summer flying suit - all provided by Barb Hanson, United's staff archivist who is on the UAHF board. United also set up its newly refurbished traveling history exhibit under one of the two large tents that UA occupied. UA retired pilot "Buck" Hilbert was the celebrity guest both at Aurora & Schaumburg where he spent the better part of each day signing autographed pictures. Buck restored a Swallow for UA's 50th anniversary 1976 & actually test flew the EAA's plane 28 years later. He had people lined up waiting for his autograph & a chance to chat about his career experiences. Many of those in line thought he was 1926 Varney pilot Leon Cuddeback!

Ted, UA's new low-cost airline, was represented with a brightly decorated table and giveaways compliments of our advertising dept. The World Headquarters "1200 Gift Shop " attracted many customers selling UA branded items. A retired pilot and two mechanics handed out UA aircraft trading cards. We also invited Southern Illinois and Lewis University, 2 Illinois aviation schools, to participate in a career awareness exhibit. The Clipped Wings Association drew much attention modeling vintage UA flight attendant uniforms & selling items to benefit their cause - Special Olympics.

The mission & motto of the United Airlines Historical Foundation is "Preserve the Past" and Inspire the Future" was certainly fulfilled at these events.
