

Historic Old Sacramento dates back to 1848 when gold miners came in search of riches. Today it is a wonderful visitor destination that continues to fascinate people from around the world. **The California State Railroad Museum**, the largest attraction in Old Sacramento, is also the most popular interpretive railroad museum in North America. A variety of shops, restaurants & nightclubs have established the area as one of California's most popular visitor destinations. But what are some of the hidden treasures to be found in Old Sacramento?

Sacramento has two rivers running through so it's a good place to go looking for treasure. **The Riverboat Delta King** which is permanently docked off Front Street is the well-known crown jewel of Old Sacramento, but within its walls there are many lesser known treasures to be found. **The "Captain's Quarters"** is a two story hotel suite, is a one-of-a-kind lodging experience. Created in the wheelhouse of this nearly 80-year-old paddle wheeler is a beautiful & unique lodging experience which provides its guests with panoramic views plus their very own steering wheel. While on the boat you can dine at the **Pilothouse Restaurant**, enjoy live jazz singers at the piano bar in the **Delta Lounge** or take in a show at one of the boat's two theatres: the **Delta King Theatre** or the **Suspects Murder Mystery Dinner**.

Back on land, a short walk down the street will bring you to the **Back Door Lounge** which takes you back to 1960's Las Vegas. This old-fashioned lounge features dim lights, red velvet wallpaper; on some nights, lounge singers.

One of the most beautiful buildings, as well as the oldest, in Old Sacramento is the **Lady Adams Building** which was built in 1849. It was the only one that didn't succumb to the various floods and fires of the early days, including the devastating fire of 1852 which wiped out pretty much every thing else in town. The **Eagle Theatre**, the first structure built specifically to be a theatre in California, opened in 1849, but was closed less than a year later due to its tendency to fill up with water. This consistent flooding of the early 1860's forced the city officials to raise the entire city 10 feet by filling the streets with dirt. Some building owners paid the cost to lift their buildings, but others decided to save the money & just convert the first floors of their buildings to basements. Today most of the old city has been buried never to be seen again, however, there are several locations in Old Sacramento where the buried city lives on.

OTHER CONVENTION NEWS

Our tour committee is working on a preconvention & a post-convention tour. The preconvention tour will begin from a hotel near SFO, will include sight-seeing & a layover en route to Sacramento. The post-convention tour will leave from Sacramento, involve sight-seeing & possible entertainment en route back to the SFO area. Other tours that are being worked on include local museums featuring arts, mansions, aviation, gold mines in the area, wineries & river cruises.

But don't forget flying in & out of SMF is still

a great option. United has a good schedule with 27 daily flights. Also there are many other carriers that offer us a 90% or 95% discount, these include: Alaska/Horizon, Aloha, American, Continental, Delta, Frontier, Hawaiian, Mexicana, Northwest & US Airways/America West. American offers ZED (Zonal Employee Discount) fares that are based on mileage. An example is DFW to SMF is \$31 each way.

To obtain ID90, ID95 or ZED fare tickets contact the Interline Ticketing Desk at 1-888-874-1581. Their hours are 0700-2100 CT Mon-Fri, 0700-1900 CT Sat & Sun. Last but not least, Jet-Blue & Southwest offer retirees standby fares at \$25.00 OW, \$50.00 RT plus tax. For both of these carriers you will need a letter of introduction that may be obtained by calling United's Benefit Dept. at 1-888-825-0188. Note: If you plan on using these other carriers, contact United's Benefit Dept. at least 3 weeks prior to departure date.

FRIENDS PLUS DISCOUNTS NOW AVAIL-ABLE TO EMPLOYEES & RETIREES

United is now offering 2006-2007 Friends Plus e-certificates to employees & retirees. The Friends Plus program provides employees & retirees an opportunity to generate revenue on United, United Express & Ted flights by offering a 10% discount on select United Economy fares to friends & family. Employees & retirees can find their ecertificate numbers in the "My Coupon" section of Weblist; the e-cert number may be given to 5 separate individuals, each individual may use the e-cert for up to 4 passengers (traveling on the same itinerary).

STOUT AIR SERVICES Cont.

By April 1930, Stout Air Lines had carried 105,000 passengers & was flying 14 daily flights (except Sunday) between Cleveland, Detroit & Chicago with stops at Toledo, Battle Creek, Kalamazoo & South Bend. These en-route stops were allowed "if reservations were made one half hour before the plane was due to arrive" (pilots were notified in flight by radio).

The fare included Stout Company Bus transportation to the airports in Detroit, Chicago & Cleveland and 30 free pounds of luggage.



Other Stout innovations included: the first Uniformed Pilots (photo), the first Passenger Terminal (at Ford Field), the first hotel Ticket Centers, refunds for cancellations (if made two hours before flight), America's first "Aerial Couriers" (stewards), infants-in-arms carried free and 48-hour stopovers allowed (except at Chicago and Cleveland).

In June 1929, Boeing's United Aircraft &


Transport Corp. bought Stout Air Services. Stout Air Lines continued to operate under its own name until Sept. 1930, when it became a division of NAT.

Regarding the Stout acquisition, United's President Fredric Rentschler stated, "We didn't buy airplanes, we bought a company that has developed the idea of running an airline as a commercial organization".

TRAVEL TIPS BY BOB

- → Customer Service at Baggage Check-In needs your help with preventing Baggage Tag "switching" to someone else's luggage. Please make sure that **your** correct baggage Tag is attached to **your** baggage. The Agent will often call out your name to tag your bags. Make sure it is the correct baggage tag.
- As a result of the London security scare, travelers are putting more items into checked baggage & taking less carry-on items. These items add weight to your checked bags. The weight limit per bag is 50 lbs. Excess baggage charges for over 50 lbs starts at \$50.00! Use your bathroom scale to weigh your bags before leaving home.

- You are allowed to check 2 bags per person. Extra bag charges begins at \$85.00. **NRSA** travelers are not exempt from these charges.
- On a recent flight after carry-on rules had been relaxed & travelers resumed taking much more aboard, the over head bins filled to capacity & the last customers had to check carry-on as they boarded. Even though rules have been relaxed, it is still a good practice to limit your carry-on items.
- → Directory Assistance: Telephone companies charge \$1.00 or more for 411 information calls, when they don't have to. When you need to use the 411 for information, to avoid charges, simply dial 1-800 FREE-411 or 1-800 373-3411 without incurring a charge.

ATTORNEY'S ADVICE - NO CHARGE (SUBMITTED BY TOM GOODYEAR)

Read this and make a copy for your files in case you need to refer to it someday. Maybe we should all take some of his advice! A corporate attorney sent the following out to the employees in his company.

- 1. Do not sign the back of your credit cards. Instead, put "PHOTO ID REQUIRED".
- 2. When you are writing checks to pay on your credit card accounts, DO NOT put the complete account number on the "For" line. Instead, just put the last four numbers. The credit card company knows the rest of the number, anyone who might be handling your check as it passes through all the check processing channels won't have access to it.
- 3. Never have your SS# printed on your checks. (DUH!) You can add it if it is necessary. But remember, if you have it printed, anyone can get it.
- 4. Place the contents of your wallet on a photocopy machine. Do both sides of each license, credit card, etc. You will know what you had in your wallet & all of the account numbers & phone numbers to call and cancel. Keep the photocopy in a safe place. I also carry a photocopy of my passport when I travel either here or abroad. We've all heard horror stories about fraud that's committed on us in stealing a name, address, Social Security number, credit cards. Unfortunately, I, an attorney, have firsthand knowledge because my wallet was stolen last month. Within a week, the thieve(s) ordered an expensive monthly cell phone package, applied for a VISA credit card, had a credit line approved to buy a Gateway computer, received a PIN number from DMV to change my driving record information online, & more. But here's some critical information to limit the damage in case this happens to you or someone you know:
 - We have been told we should cancel our credit cards immediately. But the key is having the toll free numbers & your card numbers handy so you know whom to call. Keep those where you can find them.
 - File a police report immediately in the jurisdiction where your credit cards, etc., were stolen. This proves to credit providers you were diligent, & this is a first step toward an investigation (if there ever is one). But here's what is perhaps most important of all: (I never even thought to do this.)
 - → Call the 3 national credit reporting organizations immediately to place a fraud alert on your name & also call the Social Security fraud line number. I had never heard of do-

ing that until advised by a bank that called to tell me an application for credit was made over the Internet in my name. The alert means any company that checks your credit knows your information was stolen, & they have to contact you by phone to authorize new credit. By the time I was advised to do this, almost two weeks after the theft, all the damage had been done. There are records of all the credit checks initiated by the thieves' purchases, none of which I knew about before placing the alert. Since then, no additional damage has been done; the thieves threw my wallet away this weekend (someone turned it in). It seems to have stopped them dead in their tracks.

Free parking at the maintenance base for retirees. They have some slots reserved for us along the San Bruno Av. & West lot area. If all the slots are full, just park in an OPEN spot. DO NOT PARK IN A HANDICAP, RESERVED SPOT, ETC.

Go to the SFOMB lobby & get your pass [you will need your retiree ID badge]. If the lobby is closed, press the button, they will send the guard

around who is cruising in the truck to get you a pass. (I picked mine up the day before), I think the limit is 21 days. One note on the directions: you can only get into that lot West bound on San Bruno Av. Either circle through UAL round about, [lobby] make an illegal U-turn, or come in from the 380 freeway on to Airport Blvd, then turn right on San Bruno Av. (going West).

If you pick up your pass, go straight to the lot from the lobby, don't worry about the turns.

After you leave the parking pass on the dash, walk to the corner of San Bruno Av. & Airport Blvd, cross the street, follow the fence line South, get into the public long term parking lot, go to one of the bus stops, take the shuttle bus to the terminal. (aprox. 1/8 to 1/4 mile walk).


