### **FRIENDS PLUS DISCOUNT PROMOTION EXTENDED THROUGH OCTOBER 2008**

Friends Plus - the promotion that offers a 10% discount on select United Economy fares, for your friends and family members - is being extended through October 2008.

The promotion is available on United, United Express and Ted and applies to bookings made between Oct. 4, 2007 and Oct. 31, 2008 for travel between Nov. 1, 2007 and Oct. 31, 2008.

Each employee is assigned an e-certificate number that can be forwarded to five separate individuals. Each recipient may apply the discount to fares for up to four passengers (traveling on the same itinerary). ### **UNITED ANNOUNCES NEW SERVICES BETWEEN LOS ANGELES AND FRANKFURT**

In response to increased customer demand for more frequent flights to Europe, and supporting our goal of strengthening our international network, United Airlines announced that we will offer new daily passenger and cargo service between Los Angeles (LAX) and Frankfurt (FRA).

Service to FRA will begin on December 15, 2007 and service from FRA on December 16, 2007. Flights are currently opened for sale.

This addition represents our eighth daily flight to FRA, and the new service from LAX means we now serve Frankfurt from all four of our international gateways.

### **FIRST NEW HIRE PILOT CLASS STARTED**

Twenty new hire pilots have begun training at the Denver Flight Training Center. Approximately 100 pilots will be hired and begin training in 2007, to accommodate increases in United's international flying, ensure appropriate staffing levels and provide more options for schedule flexibility.

United's six-week, scenario-based training requires these first officer candidates to be trained as a crew. Individually, candidates need to demonstrate at various checkpoints throughout the training that they have mastered the same skills required of line pilots by the FAA. The last two weeks of training involve extensive time in the simulators at our world-class training facility.

"Our new employees show a real commitment to safety, leadership and customer service," says Senior Vice President - Flight Operations, Sean Donohue. "Once they successfully complete training, we will welcome them in joining some of the best trained pilots in the world and look forward to seeing them on the flight deck later this year."

Six members of the first new hire class of pilots since 2001 are children of United employees and 14 others were referred by United employees as part of the online application process. Other members of the first class interned with United or were pilots for other airlines and the U.S. military.

### **CREW'S CONCERN TAKES EDGE OFF SUMMER TRAVEL DELAY**

One of United's best customers, 1K Ari Stone, sent Customer Relations a letter and photos about excellent service he received from United this summer:

*"I was a passenger in first class on United Flight 1291 from Austin to Denver. As we approached DIA, the airport ceased runway operations due to wind shear and bad weather. Our captain informed the passengers of the situation and kept us abreast of developments every 5-10 minutes.*

*After about 30 minutes, our pilot requested an alternate landing in Cheyenne, WY, as we were running low on fuel and there was no ETA as to when DIA would reopen or we'd be able to land. Upon landing in Cheyenne, the flight attendants immediately put in a movie, when news from Denver came back that we could be on the ground for more than an hour. At the same time, the pilot said he had just ordered pizzas for the entire plane.*

*Well, after about 45 minutes, we had not been cleared for takeoff, but, sure enough, about 30 Dominos pizzas were delivered to the tarmac and carried onto our plane, which flight attendants began distributing to all of the passengers. My fellow passengers and I took pictures and marveled at what was going on.*

*I have been a 1K flier now for about 8 years and I have never heard of something like this happening on a delayed or re-routed flight for any airline. We ended up taking off shortly after eating our delicious pizza and arrived in Denver two-and-a-half hours late. Many of the passengers had missed their connections and probably had to stay the night in Denver, but they walked off the plane with smiles on their faces and hugging and thanking the flight crew of Captain Charlie Dadoun, First Officer John Kane and Flight Attendants Cathleen Cooney, Lance Jones and Nancy Aguirre.*

*My assumption is this act of graciousness cost United a couple hundred dollars, but based on comments from my fellow passengers, it may have helped earn some customers for life. I and the other two 1K passengers sitting next to me were all quite impressed. Again, thank you to the crew of United Flight 1291."*

### **YEAR-ROUND MAINLINE SERVICE RETURNS TO JACKSONVILLE; UNITED TO RESUME GROUND HANDLING FLIGHTS**

With year-round mainline service between Jacksonville, FL (JAX) and Chicago (ORD) beginning October 28, United will resume ground handling of all JAX flights in late November. As a result, United will end its contract relationship with Delta Global Services (DGS) in JAX, and will offer recall to furloughed JAX employees over the next few months.

JAX customers have been served exclusively by United Express since July 2001. With the addition of three flights from JAX to ORD in October, JAX will begin offering mainline service year-round. Resuming ground handling will help us more fully serve these flights.

This most recent conversion to year-round mainline service further demonstrates how United Express service can increase a market's demand for mainline flights over time.

"We are delighted to welcome United employees back to Jacksonville, the third station in as many months that we have converted back to year-round mainline service", says Jeff Helfrick, regional manager Airport Operations and Cargo. We look forward to once again meeting the air and cargo needs of our Jacksonville customers.

Over the next few months, United will conduct the recall process to fill available ground handling positions at JAX. United and the IAM will work together throughout the recall process. Employees should contact their supervisor or IAM representative with any questions regarding the recall process or their eligibility.

DGS employees will be welcome to view and apply for open JAX positions once the recall process is complete.

### **UNITED DISCONTINUES SERVICE BETWEEN HONOLULU AND OSAKA**

As part of the company's efforts to reduce costs and optimize its network, United will discontinue point-to-point service between Honolulu, Hawaii (HNL) and Osaka, Japan (KIX) as of Sept. 30, 2007. United remains committed to Japan, and the cessation of this service does not affect our commitment to serving KIX via San Francisco (SFO).

United discontinued booking flights on this route in April. Customers who had booked flights on this route for travel after September 30, were rebooked on other flights or airlines, or received refunds.

Employees were advised of the change in the spring; however, United does not foresee any significant staffing changes as a result.

### **TRAVEL TIPS BY BOB**

Travel in another country with different currency can pose a number of options and COSTS ... and problems. Some advanced planning is called for. Some points for your consideration:

1. I suggest you take two different Credit Cards such as a "Visa" and "Master Card" or "American Express" which is widely known and great for transportation and hotels. The Visa and Master Card seem to work better for shopping and restaurants. I do not recommend department store or brand name cards as they may not be recognized in a foreign country. It's wise to use your credit cards for everything you can since the rate of exchange will normally be better. **Note:** Check with the card companies you plan to use for the best conversion/exchange rate. Conversion or exchange fees do vary and you might as well take advantage of the best rate. You will pay an exchange fee whether you use cash or card. But typically the card rate is less. The last time I checked, Capitol One had the best rate. They wave all fees. Others charge up to 3%. So, do some investigating. You may also consider having a major company debit card with you.
2. At departure, be sure to have enough foreign currency with you, to handle your personal needs, like getting you from the airport to the hotel and etc. Some banks have stopped selling foreign currencies, so you will have to do some pre-planning. Most major airports have exchange booths, but you will pay a higher rate there. So, it's best to get foreign currency at a major bank, before you leave.
3. When shopping, it is wise to use your Credit

Card rather than cash - The credit card companies have mass usage that get better rates. Avoid attempts by foreign merchants to convert your purchases from dollars on the spot - they may add 3 to 5 % more than what your credit card companies get.

4. ATM – Withdrawing funds from an ATM is probably the easiest and least costly way to obtain immediate cash, once in the foreign country, but it can be costly. The foreign banks do not always specify the cost of the transaction, as is done in the states. If you are going to use an ATM, I suggest you find one away from the tourist traps, as you'll probably incur a lesser charge. **Note:** Bank of America (maybe others) charges \$5 per foreign ATM withdrawal plus a 1% fee. Bank of America waives this charge if you use one of their affiliate banks - Scotiabank, Barclays, BNP in France, Deutsche Bank in Germany. Call your bank and ask for affiliates in the countries you will be visiting. Also, before you leave, ask your bank or credit union to raise the amount you can withdraw each time. If your limit is \$200, ask for \$400, at least temporarily.
5. It's wise to carry a backup card linked to another account i.e., bank and or credit union. This is your ace in the hole, if one system should go down in a country that doesn't have the redundant financial systems we enjoy in this country. Having some Traveler Checks is also a nice back up, if the power goes out in some far off island or small country and you need cash in a hurry. Do everything you can to keep from using a credit card to obtain foreign cash, unless there is an emergency. You will pay high fees plus interest on the advance. Use that check or debit card for foreign cash from an ATM.
6. One last thing: The object is not to have a lot of foreign currency, when you leave that foreign country. Converting back to the Yankee Dollar is expensive, so don't buy more foreign currency than you need. That's why Traveler Checks (US Dollars) are a good option for taking cash because what is left over won't cost anything to deposit back into your account.

Advanced planning for your financial needs will help you to have a good time on your foreign trip. Remember, it never hurts to ask questions and do some shopping around. You will probably save some money and have more to spend on gifts for your grandchildren.

### **FROM THE DENVER OFFICE**

**Obituaries:** If you have read the notice at the beginning of the Obituary Column, you see that United no longer sends RUAEA the official death notices of **retirees** or **spouses**. We have been accepting notices for the Newsletter and publishing them in addition to the current Employee/Retiree Obituary listing in SkyNet.

We have had some problems with the accuracy of submitted information which requires a new standard to be established regarding the method in which we accept information for an obituary (retiree or spouse). Therefore, the policy of the Denver Office is: *Death notices sent to the Denver Office for publication in the Newsletter Obituary Column will be accepted only from a family member or personal representative in writing.* The information sent concerning the deceased must include:

- 1) First and Last Name
- 2) File Number (if the deceased was an employee)
- 3) Last Station the employee worked
- 4) Surviving Spouse or Next of Kin (if applicable)
- 5) Address

In addition, contact information must be included for one sending the information. If the obituary is received hand written and there is a question regarding clarity, it will not be published until a clear and readable document is received in the Denver Office. The information may be sent by e-mail (preferred), fax or US Mail. Sorry, the information will not be accepted over the phone!

***Please note that the above policy only applies to death notices submitted to be published in the Obituary Column of the RUAEA Newsletter.***

**Letters for the "Letters" column:** We continue to encourage the membership to send in letters for the Letters column. If possible, please send your letters to us via email or send the letter typed on a white piece of paper so we can scan it into a word document. Send it, "Attn. Letters Column", in the subject line. By sending the letters to us in a digital format (email) or typed, we don't have to manually retype them. But, if you are unable to send your submission to us other than hand written, we will gladly accept it but it needs to be legible/readable. The "Letters" section is popular as it is a means of letting our friends know what is happening with us.

Also, if you have an e-mail address and want it posted along with your name and address, include it. Many have expressed a desire to have the email address included.

**Note:** If you sent a letter and you don't see it in the next Newsletter, it is because we received it after the cutoff date (listed in the Newsletter Correspondents column) for material to the Denver Office. Or, it may be because of space constraints in the current Newsletter. If this is the case, it should be printed in the next Newsletter.

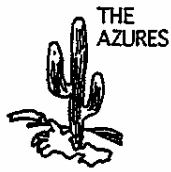

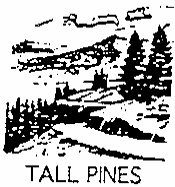

Harry had all of those celebrating a birthday recently or in the near future to indicate so and we sang to all with birthdays and anniversaries.

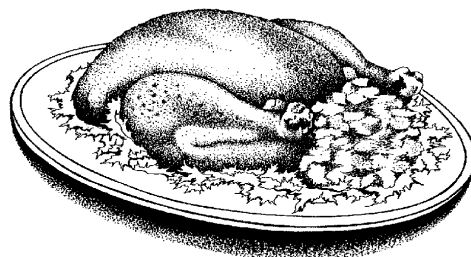

## BOEING (Continued)

During WWI the Boeing Airplane Company accepted a government contract to build 50 Curtiss-designed HS-2L flying boats for the U.S. Navy.

Following the November 1918 Armistice, military spending was drastically cut. The Navy canceled half of Boeing's HS-2L order and hundreds of war-surplus aircraft flooded the civilian market.

With the entire aircraft industry faltering and attempting to retain his employees, Bill Boeing reverted to non-aircraft activities such as power-boat building, furniture and cabinet manufacturing.

In 1919, having had a moderate success with the

Model C aircraft, Boeing began developing a new series of small flying boats. The result was the B-1 (Model 6) and BB-1 (Model 7). Neither the B-1 or BB-1 went beyond the prototype stage until 1927 (following Lindbergh's flight). Also developed in 1919 was the BB-L6 (Model 8) a land-plane with a front-mounted 214 h.p. Hall-Scott L-6 engine.

In 1920 the Boeing Airplane Co. lost \$300,000. Then it received a military contract to modernize a large number of the wartime Liberty-engined De Havilland DH-4 aircraft (shown). This contract probably saved the company.
