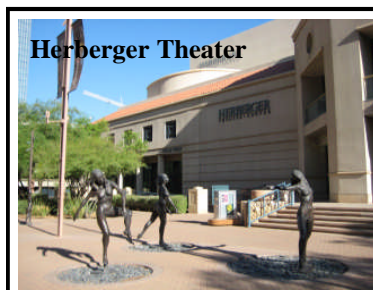
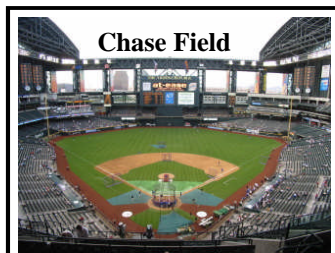

United Increases Domestic Fees for Flying Unaccompanied Minors and Certain Baggage Checking Services

In order to be able to continue to offer competitive fares for all customers as it faces a challenging economic and volatile fuel environment, United finds it necessary to increase domestic fees for some of the special services that its customers request.

Effective October 2, United is increasing the fee to fly an unaccompanied minor from \$99 one way to \$150 one way. This change applies to tickets purchased on or after October 2 for travel on or after December 3.

Additionally, United is increasing the cost of checking a fifth or sixth bag, checking bags that are excessively heavy or large and transporting some items that require special handling. The following fee increases apply to tickets purchased on or after October 2 for travel on or after November 10:

Ted Airplanes Being Painted with Mainline Livery

As United announced in June that it will be eliminating its Ted product, in order to place those 56 Airbus 320 aircrafts on the most profitable routes in this challenging economic environment. The A320 reconfiguration work will occur in stages, with the exteriors being painted in the United mainline livery beginning this month, and interior work, including adding a United First cabin, taking place in the spring and continuing through 2009.

The exterior painting will be completed within the normal paint cycle for Ted aircrafts, and the first eight planes are being painted this month. As a result, the interiors and exteriors of these aircraft will not match for a period of time, and this may lead to confusion for employees and customers, especially in cities served by both Ted and mainline. When serving customers and loading and unloading planes during the transition, employees are asked to check the flight number and destination, rather than relying solely on visual identification to determine whether an aircraft is mainline or Ted.

Voluntary Furlough Update for Flight Attendants

Onboard Service will achieve its manpower reductions through voluntary means, as a sufficient number of flight attendants came forward and volunteered for furlough during the offer period. Many people were involved in the preparation of the voluntary bid process. This voluntary program mitigates the need for involuntary furloughs.

As of Oct. 31, 2008, United will reduce its flight attendant workforce by 1,550 people, in addition to the affected regional flight attendants, based on the November flight schedule. Flight attendants across the 14 domiciles were able to take advantage of the voluntary

offering.

Voluntary furloughs were awarded in increments of 6, 9, 12, 18 and 21 months. The most junior flight attendant with a voluntary furlough award has an Onboard Service seniority date of Aug. 30, 1997. Flight attendants will receive a voluntary furlough confirmation letter at their permanent addresses, along with detailed instructions for completing the voluntary furlough checkout process.

Employees from many Onboard groups, Human Resources, Labor Relations and the Association of Flight Attendants worked to put this package together, and all contributed to a successful outcome. *"I'd like to offer our sincere thanks to flight attendants who participated, mitigating the need for involuntary reductions. This again demonstrates the commitment among our team to take necessary actions to ensure our continued success,"* Alex Marren, Senior Vice President - Onboard Service, concluded.

UAL Corp. Boosts Liquidity by Approximately 1.2 Billion Dollars, Completes Chase Agreement

United completed the amendment of its co-branded card marketing services agreement with Chase Bank, as well as amended its credit card processing agreement with Chase/Paycomtech LLC. These agreements boost United's liquidity by approximately 1.2 billion dollars, including 1.0 billion dollars in the short term and an additional 200 million dollars over the next two years.

"This is one of the many steps we are taking to improve our liquidity and increase the amount of cash we have on hand to strengthen our business for all our stakeholders in this volatile fuel environment," said Jake Brace, EVP and Chief Financial Officer.

Under the terms of the agreement, United received an additional 600 million dollars from Chase in consideration for the advance purchase of frequent flyer miles and for extending the agreement. As part of the transaction, United granted a security interest in various assets, including specified intangible Mileage Plus assets. United continues to have more than 3 billion dollars in unencumbered hard assets to use to raise additional liquidity if needed.

With the amended credit card processing agreement, United will realize a return of more than 350 million dollars of restricted cash back compared to its prior reserve requirement.

Denver Flight Training Center Celebrates 40 Years of World-Class Service

The Denver Flight Training Center (DENTK) first opened its doors in Denver during an era of B-720 and DC-8. Since then, the center has grown to be an indus-

try leader in flight training.

The DENTK team, with nearly 600 professionals, dedicates their time and expertise to training pilots and maintenance personnel, and supports training of United flight attendants and dispatchers. Additionally, the Center has conducted flight training for other airlines, military and government entities for more than 200 aircraft operators worldwide. The DENTK team even had the responsibility of training the crews for Air Force One.

With safety as the foundation of everything United does, the DENTK team maintains and continues to develop the best training programs available in the industry. And while they are proud of the work they do for United's outside customers, the main priority at the Training Center is a commitment to the people of United.

The Training Center recently celebrated its 40th anniversary with a 1960's-themed party to honor the decade they opened. More than 500 employees and retirees attended the festivities which included a BBQ. In the spirit of the event, many came dressed in 1960's attire - including a 1960's-era United "stewardess" uniform.

A 40th anniversary display was showcased in the Training Center lobby, with pictures and videos of the facility from the opening year - giving retirees and long-time employees the chance to reminisce and current employees to see how it all began.

"The anniversary event was a great way to celebrate 40 years of being an industry leader in flight training," says Captain Bob Mackay, acting Managing Director - Flight Standards and Training. *"In addition to the festivities, employees enjoyed the opportunity to honor the legacy of the Training Center and all of our dedicated employees throughout the years."*

United to Continue Complimentary Hot Meals in United Economy on Trans-Atlantic Flights

After hearing from many of its customers and flight attendants that the Corporate and Elite customers value hot meal service in United Economy on Trans-Atlantic flights, United has decided not to move forward with the test announced last month of offering customers Buy on Board options for those flights. Instead, United will continue to offer complimentary hot meals.

In this environment, where higher costs driven by volatile fuel prices are now the norm, United must continue to tailor its products and services to what customers value and are willing to pay for, as such, United will continue to be proactive in testing new ideas.

On October 1, United proceeded with the test of new complimentary options for United Business cus-

tomers a three cabin aircraft used for U.S. domestic routes, which represent 16 daily flights. Customers on those flights will receive complimentary fresh sandwiches, salads, breakfasts, snack boxes or snacks, depending on the length of the flight and time of departure. They will continue to enjoy complimentary beverages, including beer, wine and cocktails. United will evaluate the results and determine next steps by the end of the year.

Full meals will continue to be served on all of its P.S. transcontinental flights.

ASK YOUR PHARMACIST: Dispelling common cold and flu myths

According to the U.S. Food and Drug Administration, Americans suffer from approximately 1 billion colds annually,¹ making it the most common ailment in the country. Each year, on average, from 5 to 20 percent of the U.S. population is infected with influenza. That results in approximately 36,000 deaths and more than 200,000 hospitalizations from flu-related complications, according to the Centers for Disease Control and Prevention.²

Consumers may hear many common myths about colds and influenza. However, those myths can result in misdiagnosis, miscommunication, and mistreatment.

In general, the flu is worse than the common cold, and symptoms such as fever, body aches, extreme tiredness, and dry cough are more common and intense. People with colds are more likely to have a runny or stuffy nose. Colds generally do not result in serious health problems, such as pneumonia, bacterial infections, or hospitalizations.³

Armed with the proper information about the differences between the two illnesses and the appropriate treatments for each, many people would be able to avoid or effectively treat their condition. Here are some common myths, along with facts, about colds and flu:

Myth: *The flu shot causes the flu.* The flu shot vaccine is made from an inactive virus, which means you cannot catch the flu from the vaccine.

Myth: *Antibiotics should be used to treat the flu.* The overprescribing of antibiotics could create a global healthcare crisis. Disease-causing bacteria are quickly becoming resistant to many of these medications. Influenza is a viral infection, so it does not respond to antibiotics.

Myth: *Chicken soup and herbal remedies are great treatments for cold and flu.* Though chicken soup may make you feel better, it has never been clinically proven to be effective in treating colds or flu. Appropriate treatments include plenty of fluids - including soup - and lots of rest. A variety of nonprescription medications - such as analgesics, decongestants, expectorants, and antihistamines - are available to help relieve some cold and flu symptoms. For some patients, those products may provide modest benefits.

Myth: *You can catch a cold from going outside in cold weather.* With apologies to grandmothers everywhere, you cannot catch a cold by going outside without a jacket during the colder months. However, by touching common surfaces or through face-to-face contact, you can catch a cold from other people who are infected.

TRAVEL TIPS BY BOB

This month's Travel Tip will discuss baggage and the fees we have all heard about.

NRSA and Companions are **NOT** charged for checking luggage, whether one bag or two. Fees pertaining to the number of checked bags apply to Economy Customers, not NRSA or Companions.

Overweight bags, 50lbs or more, will incur an additional fee. If your bag weighs more than 50lbs, all travelers, including NRSA and Companions, will be **charged** for oversized/overweight bags and the cost is hefty! It starts at \$125. And be **WARNED** that on November 10, 2008, the rate goes up to \$175. The charges are applicable to a maximum of 100 pounds. Bags over 100 pounds are NOT accepted. Such things as bicycles in a box are considered oversized. These charges are applicable ONE WAY only. Free weight is 50lbs per bag.

Oversize bags, 60-80 linear inches, (length + width + height) will incur an additional fee of \$125 to \$175.

Oversize and overweight bags, a bag that is both oversize and over weight jumps from \$250 to \$300. Ouch!

It's wise before going to the airport to check the

weight of your bags as you may be able to adjust items and keep all your bags under 50lbs. If not, you may be able to adjust items and have just one bag overweight. The best way to check the bag weight is to step on your scales, record your weight and then weigh yourself with the bag in hand. Simply subtract your weight and you will have an accurate bag weight.

NOTE: The most current company regulations (at the time of publication) regarding bag fees and also an increase for unaccompanied children are located in this issue. Take the time to read it and do your homework before going to the airport.

Things are rapidly changing in our world and especially in our industry. Regulations are constantly adjusted as the market dictates. If you are not already familiar with SkyNet, I strongly suggest you become so. You may need some help to learn how to access it, your children and grandchildren would be an excellent source of help as they are probably familiar with the computer. All these rules and regulations are posted in SkyNet for our use and understanding.

Three additional items:

1. ***Your travel card ... don't leave home without it.***
I would like to have some feedback from those who have ordered a new or replacement card. Was the request successful or did you have complications? Please send your comments to my email address listed below.
2. ***Shingles:*** It seems that some of our folks are coming down with "Shingles" when they travel and end up having to cancel out on tours or a cruise. This causes me to suggest that you talk with your medical advisor about shots/vaccinations before you travel.
3. ***Aircraft cleanliness*** is now a big customer acceptance item and is tracked by those who rate the carriers. With this in mind, since we all have a stake in UAL, let's make it a habit to leave our seat cleaner and in better shape than we found it. In other words, simply pick up after ourselves. I know it will be appreciated by the next customer and those who are responsible for cabin appearance.

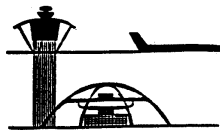

The international group of people aboard, the Russian people themselves, the folk dancing, the weather, both shipboard and local food, beautiful scenery with acres of birch trees, evergreen forests and numerous castles and churches along the way were all a welcome surprise and special treat for the eyes, emotions and soul. This trip, however, is not for the faint of heart, spirit, feet ... or the impatient! There was a great deal of walking, far more than I had anticipated even though I had brought along two pairs of comfortable walking shoes. (And be forewarned: Most Russian long distance tour buses do not have W.C.'s aboard.)

My opinion: Neither the **Moscow** or **St. Petersburg Airports** are ready for tourists. After a great shipboard breakfast at the end of our tour, we were expeditiously bused from the ship to the **St. Petersburg Airport**, arriving at 9 a.m. Neither Passport Control or Security were open for another 1½ hours ... we stood in line, no chairs available while we waited. After crossing that obstacle, plus our first Security check (shoes off and, like each would-be passenger, a very thorough patting down), there were two additional Security checks (shoes off and more patting down) en route to the departure gate. Reaching that last gate and spotting still more lines through a glassed-in window, I grabbed one of only eight wooden chairs in an outer hallway and again, waited. As the crowds gradually seemed to move, I gave up my "valuable" wooden chair and proceeded to go through that last Security check and pat down. This time there were a few long wooden benches on the other side ... wheeee! Later on, after we had waited another 1¾ hours to board the plane, I queried one of the counter agents as to whether or not all this **waiting** was

normal. And I also mentioned the late opening of Passport Control and three Security checks. I just got a blank look, no answer. I was expecting some sort of explanation ... silly me! And of course we were late getting into JFK. I have learned one lesson however: If I ever go back to beautiful Russia, despite the awkwardness and weight of my cane that has a folding seat attached to it, I shall bring it!

The "unmerger" proved to be a good thing for "Pat" Patterson and the airline. He no longer had to answer to Hartford or New York regarding management or purchasing decisions. It was no longer necessary to fly only Boeing planes or to buy Wasp engines if other companies offered better planes or equipment.

Thus, in 1934, management decisions for running the airline moved from Park Avenue, New York to the LaSalle-Wacker building in Chicago where the airline headquarters had grown from one small office in 1929 to occupy two entire floors.

Harold Crary, who had opened the original office became the Director of Traffic, Advertising & Publicity. Duard B. Colyer, a veteran of the Post Office Air Mail days as Superintendent of Operations for Boeing, be-

came Vice-president in charge of Operations.

Other new officers were Cyril B. Thompson, Secretary and Charles E. Brink, (who refused to fly) Treasurer. Moving into Technical and Executive positions were line-pilots Jack Herlihy, Bert Lott, Walt Addems and Russ Cunningham.

United was left with 6000 miles of airways. Harold Crary advertised United as "Air Transporta-

tion at its Best with passengers flown in Heated, Comfortable Cabin-Planes Coast-to-Coast in 20 hours for \$160 (\$288 round-trip)". United advertising boasted of "fifty-million miles of flying experience and 4 experts on the ground for every pilot aloft".

With the new government regulations and restrictions on the air mail, United's revenues for 1934 fell below those of 1932. This forced stringent economies and resulted in the cancellation of the Chicago-Kansas City passenger run.

Patterson sought relief, petitioning the Interstate Commerce Commission for hearings. It was 2 years before the ICC made an adjustment in the rates.

As Patterson remarked later, "... *the air mail cancellations ... were a blessing in disguise ... it was a spanking that made us better boys*".

Traffic staffs hustled as never before to find passengers and cargo and they got results. In 1933, on the Chicago-New York run, passenger revenue had constituted 40 percent of airline income, by 1936 it had risen to almost 58 percent of United's total earnings.
