The Writers' Column - September 11th Tenth Anniversary in Shanksville by Ron Bertacini

September 11, 2001 ... Most everyone remembers where they were and what they were doing that fateful morning. Barbara and I were at home in Roseville, CA when we got a call from my son in Atlanta that something bad was happening in New York. Barbara had returned home from Boston via San Francisco on United on September 10th. She remembers what a beautiful day it was in New England. Barbara also remembers that there was an unusual calm in the airport that day.

Now ten years later, we went back to Pennsylvania for the 10th anniversary ceremonies that were being held near Shanksville near the site of United's Flight 93's impact. This was a two-day event and Barbara and I along with Cheryl Jensen were attending with over 100 Clipped Wings. Actually, there are two memorials in the area. The federal government is establishing the Flight 93 Memorial National Park at the impact site and the surrounding area. A few miles away is the Flight 93 Memorial Chapel.

Somerset, PA is the closest town with accommodations and all were sold out by early February. We ended up in Johnstown, PA about 30 miles away. Johnstown is quite historic in its own right. It was ahead of Pittsburgh for many years in steel production and the site of three devastating floods. The first was in 1889 when a dam burst up river and the town was hit with about a thirty foot wall of water.

On Saturday September 10, 2011, there was a ceremony dedicating the Flight 93 Memorial National Park with Presidents Bill Clinton and George W. Bush speaking along with Vice President Joe Biden. Unfortunately, due to congestion on the roads surrounding the site, we were unable to attend that ceremony. All reports were that the three dignitaries made beautiful and meaningful speeches. With so many dignitaries in the area, there were reports that 2200 Secret Service people were in western Pennsylvania that weekend. Since we could not get to the Flight 93 Memorial National Park, we did manage to go to the Flight 93 Memorial Chapel. The visit turned out to be very beneficial and informative.

We were able to meet and spend time with Father Al Mascherino, the founder of the Chapel. Father Al has been battling cancer over the last couple of years. Actually, he had three different cancers and through treatment, was declared cancer free just a couple of months ago. Another piece of good news was that Fa-

ther Al has been hoping to acquire a 757 beverage cart to be displayed at the Chapel. This would be the type of cart that the passengers used to smash into the cockpit door. Someone at United got the message and a cart was delivered to the Chapel at about midnight on September 9th.

A few words about the Chapel. It is a small building that many years ago was a church. The building fell into disrepair and was being used to store seed and other things for the local farmers. After the events of 9/11, Father Al decided he had to do something to honor the memory of the brave souls on Flight 93. He was able to acquire the property selling some of his personal belongings. Through donations and hard work along with assistance from the 84 Lumber Company, the Chapel was completed by the first anniversary of the September 11th attack. More information can be found on their website www.flight93memorialchapel.org.

On Sunday the 11th, we started early as the proceeding at the Flight 93 Memorial was to begin at 0830. We arrived at the entrance to the park about 0630 and were moving quite well then suddenly we were creeping for the next few miles. We with the thousands of others parked in a field and were then bused to the ceremony site. Unfortunately, not much has been done in the last ten years. Some walkways have been installed and a low wall with the names of each of the 40 individuals on the flight has been erected. The wall is in relation to the flight path the plane was on before impact. Two bells have been installed near the pathway, one large and next to it one not so large. A temporary stage and seating for a few thousand people had been set up. There was background music and at 0846, we were called to a moment of silence to remember those on American Flight 11 (North Tower). At 0903 we were called to a moment of silence for those on United Flight 175 (South Tower), again at 0937 were called to remember those on American 77 (Pentagon), and then at 1003 we were called to remember those on United Flight 93. After a pause, the names of the 40 passengers and crew of Flight 93 were read with bells being tolled after each name. This was followed by speeches by the governor and many other local political figures. Along with all the Clipped Wings were many current Flight Attendants in uniform ... there were also many other attendees in their respective uniforms.

We then headed over to the Flight 93 Memorial Chapel where ceremonies were to begin at around noon. The ceremonies got under way about 1300 since traffic conditions delayed some folks. Father Al started with some introductory comments followed by the Presentation of the Colors and reciting the Pledge of Allegiance. The North Star Choir was on stage to sing hymns. These are school children from the area, I would guess between nine and thirteen years old. The most moving

part of the ceremony was when the North Star Choir sang the hymn You Are Mine and in between stanzas, one of the members came forward to recite a short bio on one of the passengers or crew member of Flight 93, this continued until all forty names had been mentioned. Many tears were shed on and off the stage. It would be great for those interested to go to www.youtube.com/user/TheNorthStarKids which gives a 14 minute video of them singing at the Chapel.

Father Al then acknowledged the Flight Attendants from Newark, 55 had come by chartered bus. These Flight Attendants with their associates in the CAUSE Foundation financed the donation of Flight 93 Crew Memorial. It is a 16 ton black granite obelisk with the names and likenesses of each crew member etched on its six sides. There are also 4 black granite benches with the names of each passenger engraved on them. The monument is situated in the garden behind the Chapel. Father continued by thanking Clipped Wings for their ongoing donations and President Barbara Vincent said a few words. Next was Frank Egges, a member of the Philadelphia Independents ... Father wanted to thank him for his collecting of donations on behalf of RUAEA and the retirees from United. Frank was able to give Father Al a check for \$500 which put the combined retirees' donations through Frank to over \$20,000. Frank introduced Joe Bradley, President of the Independents and me as President of RUAEA.

The last two on the agenda were Mrs. Lois Dupre Shuster of the National Garden Club who dedicated a Blue Star Memorial Marker as a tribute to the Armed Forces that have defended the United States of America. The marker is adjacent to the Chapel. The last speaker was Colonel Joseph Retta, USMC (Ret). His speech was a fitting finale to a memorable and emotional day.

Both the Flight 93 Memorial and the Flight 93 Memorial Chapel are in need of donations. President Clinton is heading a fund raising campaign for the Flight 93 Memorial. The Chapel does not have that same clout. The facility is small and there is nowhere to expand at the present location. A plan is afoot to acquire a large parcel closer to the Memorial site. The next step would be to move the existing Chapel along with monuments to the new location and build a more fitting memorial around it. To quote from the Flight 93 Memorial Chapel Complex Foundation, *"Completed in November 2001, the Chapel serves tens of thousands of visitors annually. However, the Chapel lacks both the facilities and adequate capacity to display the Collection or provide for visitors' needs. Additionally, the Chapel is structurally fatiguing, endangering the sacred memories which it preserves. The Foundation is dedicated to the construction and ongoing operation of a new Flight 93 Memorial Chapel Complex, that will preserve the original Chapel, include a new Heroes' Museum to display*

portions of the Collection and exhibits addressing the events of September 11, contain a new enclosure for the United Employees' Flight 93 Crew Memorial, and provide the basic facilities; such as parking, restrooms, kitchen and dining area, and gathering spaces; necessary to meet visitors' needs." The Chapel is non-denominational. With both memorials the need is great ... millions of dollars are needed for both. The websites for both have information not only about the respective sites but how to donate for those that are so inclined.

Enhanced Flying Together coming soon for all co-workers



Flying Together became the common intranet homepage for all co-workers in October, marking another level of integration as United nears the one-year anniversary

of its merger. Currently, there are three homepages, making the online experience cumbersome and inconsistent for co-workers. Getting everyone on the same page — literally — is the next logical step for the intranet as United works toward operating as a single airline.

All the tools and information you need from Inside-coair and SkyNet will still be accessible, but now directly through Flying Together.

The updated, enhanced Flying Together will offer better navigation, customization options and a comprehensive search tool.

Save more on CO, UA premium, international pass travel



All UA and CO co-workers, retirees, early-out participants and eligible pass riders will now receive a 50 percent discount off zonal employee discount (ZED) fares for

travel in premium classes on the other subsidiary's U.S. domestic flights, including Alaska and Hawaii.

The discount was previously set at 33 percent off standard ZED fares. The new discount reduces service charges in the interim pass travel program that UA pass riders pay to fly on CO flights, as well as the charges CO pass riders pay for travel on UA flights.

The increased discount also applies to all classes of service on international flights, flights within the Micronesian islands and between GUM and the Micronesian islands.

UA and CO pass riders will continue to pay applicable service charges for traveling in international economy and all premium classes on their respective subsidiary carriers.

United urges all pass riders who have pending reservations for CO flights to cancel the bookings in employeeRES and re-list to get the deeper discount. Pass riders will not need to re-list for UA flights, since discounts are applied on the day of travel.

Service charges for buddy passes/companion passes remain the same for flights on both subsidiaries.

The increased discount is part of a series of pass travel enhancements United has introduced in recent months, including fee-waived domestic economy travel for eligible pass riders and combined UA and CO flight schedules in employeeRES. The changes are an interim step until the company introduces its integrated Pass Travel program which will coincide with its single Passenger Service System (PSS) starting next March.

Government awards United record number of city-pair contracts

The United States government recently awarded United more than \$974 million in estimated contracted revenue from travel by government employees and contractors during fiscal 2012 on 1,741 city pairs.



"This is the largest amount of revenue and largest number of city pair awards ever awarded to a single carrier," said Military and Government Sales Manager Tom Billone. United

won the contracts for 975 domestic and 766 international city pairs.

The General Services Administration (GSA) has been managing the program for more than 30 years. It has grown from 11 markets to more than 5,000. Airlines compete to win these contracts on a route-by-route basis. In awarding city-pair contracts, the GSA considers the availability of nonstop service, total number of flights, flight availability, average elapsed flight time, availability of jet service and price of service.

Fitch upgrades United's credit rating



On September 15th, Fitch Ratings upgraded the issuer default rating (IDR) of United Continental Holdings, Inc. (UAL) and its two airline operating subsidiaries to "B" from

"B-". Fitch credited United's performance since the closing of the merger last October.

"In the face of heavy fuel cost pressure during the first half of 2011, UAL has consistently reported industry-leading revenue per available seat mile growth while funding heavy debt maturities out of internally generated cash flow," Fitch Ratings reported.

The agency said an upgrade to "B plus" is possible over the next one to two years if United continues to generate positive free cash flow and reduce adjusted debt levels. It also cautioned that a downgrade could occur if the global economic stress reduces demand and revenue or if the industry experiences a "large fuel price shock."

The IDR reflects United's ability to meet financial commitments on a timely basis.

"We will never forget"



One by one their names were called.

On a clear morning and under a brilliant blue sky, the names of the 18 crew members on flights 93 and 175 rang out across the south lawn of the Operations Center in Elk Grove where more than 200 United co-workers, retirees, for-

mer co-workers, families and friends gathered for our 9/11 remembrance ceremony.

Standing in front of the 9/11 memorial garden planted on the first observance of Sept. 11, Jeff and Pete McDonald alternately read the names. After the last name was called, everyone joined together for a moment of silence to reflect on the tragic events 10 years ago.

Afterward, Ellen Maisel, a United retiree, made her way through the crowd to the front of the garden. She placed a bouquet of flowers at the base of the plaque at the center of the 27 bushes planted in remembrance of those who were killed or who lost family members that day. *"I don't want to ever forget them. That's why I came and the flowers were a small tribute,"* Ellen said afterward. *"I was in flight crew planning at the time. I knew the captain on flight 175, and he sent me a note that morning that he would talk to me when he got to Los Angeles."*

Others brought flowers as well, and many filed past the memorial garden to pay their respects.

Earlier, Pete welcomed everyone who came to honor and remember colleagues who died on flights 93 and 175. *"Today, we take time to grieve for those we lost and we remember that they died in service to our airline,"* Pete said. *"September 11 had a profound impact on United, on our industry and our nation,"* Jeff said. *"We will never forget the co-workers, friends and family we lost on that day."*

9/11 memorial garden dedicated at new site



United recreated its 9/11 memorial garden on the grounds of the Friendship Park Conservatory, near the Operations Center at Elk Grove. This ensures that the garden will en-

dure and be well tended after the Elk Grove property is sold. United has relocated most of its co-workers from the Elk Grove Operations Center to offices in Chicago and the property is listed for sale.

Jeff and Pete McDonald dedicated the new garden in memory of those who died on Flights 175 and 93. A number of current and former co-workers who headed up United's humanitarian response following the 9/11 attacks attended the dedication.

"The park district will take expert care of our memorial garden for years to come," Pete said. *"The new location is close to O'Hare, our Chicago reservations center and in the area where many United co-workers and retirees reside."*

Like the memorial garden at Elk Grove, the new garden consists of 27 bushes and a maple tree. The bushes represent each United employee who died on

Jeff meets co-workers at first-ever Hawaii CEO Exchange



Responding to co-worker requests since the merger close, Jeff hosted a CEO Exchange on September 30th, in Hawaii. More than 300 co-workers from the Hawaiian islands came

to hear a business update from Jeff and ask a number of questions, ranging from intra-island flying to the outlook for the Hawaii reservations center to the culture of the new airline. *"We are building a new culture, taking the best of United and the best of Continental,"* Jeff said. *"We want to make this a company you want to work for, customers want to fly and investors want to invest in."* Responding to a question on the feasibility of intra-island flying, Jeff said United won't do it. He said United will be more successful adding non-stop flights from the West Coast to the various Hawaiian islands, like its recently added LAX to Hilo (ITO), Hawaii, route.

Asked about healthcare benefits, Jeff said that United wants to give co-workers an array of choices to select a plan that's best for them and their families.

Co-workers join the fight against proposed U.S. tax increase



Four CLE employees spent a day in Washington, D.C., lobbying against a proposed increase in aviation taxes. Capt. Doug Eades, Flight Attendant Kayla Steiner,

Customer Service Agent John Adams and Airport Sales Agent Jerry Wang joined four Delta employees based at Cincinnati, Ohio, in meetings with Sen. Rob Portman, Sen. Sherrod Brown, Rep. Steven LaTourette, Rep. Pat Tiberi, Rep. John Boehner and Rep. Steve Chabot or members of their legislative staffs.

"Co-workers help us personalize the process," said Congressional Affairs VP Nancy Van Duyne. *"After the co-workers met with the Ohio members, they had a real appreciation for how bad these taxes could be for jobs and service in the state of Ohio."* This is part of an effort by United and the ATA member airlines to stop a

new \$100 departure tax and prevent passenger security taxes from being raised from \$2.50 a segment to \$7.50 a segment. United encourages all co-workers to tell their elected officials - by email, Twitter or Facebook - that they're against this aviation tax proposal. The US airline industry already has 17 different taxes and fees imposed upon it and its customers - more than any other industry. Now the administration is looking for number 18. Airlines drive \$1.2 trillion in economic activity, and it's important to the health of our economy. If these major fee increases occur, airlines may be forced to cut service to small communities, costing jobs not only in the industry but in all the businesses that depend on air travel. United will continue to report on the steps it's taking to combat this tax.

In September, United announced the 2012 MileagePlus program features, which emphasize extra recognition for its best customers.

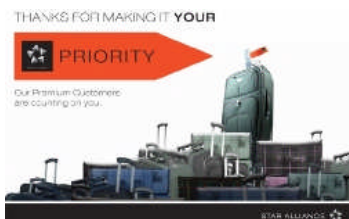

United targets Priority Baggage delivery improvements

service. Priority baggage handling is one of many ways United treats these customers extra special, and it's important to get it right. According to Star Alliance, premium customers say they currently receive their bags first about half the time. In addition to an awareness poster campaign at its hubs and other select locations, United's Baggage Performance team is pleased to introduce more ways to measure whether the company is meeting its priority delivery goals - visibility that will help drive improvements.

"We are investing more than \$7 million in new technology including permanent photo eye scanners that will provide a high level of tracking at all large hub carousel locations," said Baggage Resolution Service Center Director Brian Keene. "We will also roll out our handheld scanners at additional stations so we can accurately track the progress of these important bags."

United encourages co-workers to continue to tag Elite/Premier and Star Alliance Gold and Silver member bags with the brightly colored "priority" tags, and co-workers loading and unloading baggage should continue separating these bags to facilitate quick access and delivery upline.

Flight Ops to implement new procedures



United will implement the next phase of its revised flight operations procedures as scheduled as a next step toward obtaining a single operating certificate (SOC) from the Federal Aviation Administration (FAA).

United's training for its pilots relating to the single operating certificate is safe and professional, and United is a safe airline. The FAA, the federal agency that oversees airline safety, has carefully and professionally reviewed and approved United's training.

On September 29th, a federal court in New York denied a request by the Air Line Pilots Association (ALPA) master executive council at its UA subsidiary to delay implementation of the new procedures.

As United expected, the court did not agree with union leadership and denied the union leaders' attempt to delay United's single operating certificate. The judge's ruling said the FAA's earlier approval of United's training plan negated ALPA claims that allowing implementation to proceed as scheduled would jeopardize safety. "There is nothing in ALPA's submission to support a finding that the FAA has somehow been

negligent in carrying its regulatory mandate," U.S. District Judge Sterling Johnson, Jr. wrote. "In light of the FAA's regulatory authority and ongoing oversight of all phases of the United and Continental merger, the court has no choice but to deem the increased risk to safety ALPA alleges as being too 'remote and speculative' to lift the union's TRO application off the ground."

The judge labeled as "specious" ALPA's arguments that a System Board of Adjustment (where a grievance is pending on this issue) could not remedy a dispute over this matter.

United continues onboard menu alignment



United aligned special meal offerings on UA flights with current CO offerings on October 1 as part of its plan to streamline products and create a consistent travel experience for customers. With the alignment, United eliminated five dietary meal categories due to historically low order volumes. Diabetic, low-calorie, low-fat/cholesterol, low-sodium and lacto-ovo vegetarian meals will no longer be available. United will also streamline special meal pre-order availability. As of October 1, special meals will only be available in premium cabins for pre-order on its non-stop flights between EWR/New York-Kennedy (JFK) and LAX/SFO and between the U.S. mainland and Hawaii. Special meals will remain available for pre-order for customers traveling in all cabins on trans-Atlantic, trans-Pacific, intra-Asia and most South American flights.

United Clubs made their debut October 1



United's 50 United Club lounges in 39 airports worldwide made their public debut on Saturday, October 1, the one-year anniversary of the close of the merger. All former CO Presidents Clubs and UA Red Carpet Clubs will feature the new branding and signage. "This is another significant milestone in the integration of our products," said Product Marketing Director John Yeng. "It is important for our customers to experience a consistent lounge product across both subsidiaries."

United has been working throughout the first year to standardize the offerings inside the clubs. The company offers members and their guests complimentary bar service, light snacks and beverages; business amenities; and personal assistance with reservations, seat selection,

upgrades and boarding passes. United plans many more improvements in the coming months.

Known Crew Member expands to SEA, MSP



Known Crew Member (KCM) has expanded its screening program for flight crew members to include Seattle (SEA) and Minneapolis - St. Paul (MSP). CO and UA are

participating in the test, so its cockpit crews are eligible to go through the exclusive new lanes. In addition to being in uniform, all pilots must have their airline badges and government-issued photo IDs to be eligible.

The program started as a proof of concept at ORD August 8 and includes Miami (MIA). KCM will add three more airports in the coming weeks - IAD, Boston (BOS) and Phoenix.

Andrew Chen, line operations manager in Flight Operations, said the program has been very popular with pilots who enter ORD from outside security.

Cholesterol is a waxy, fat-like substance that's found in all cells of the body. It has both good and bad effects on your overall health. Your body uses cholesterol to make hormones, vitamin

D and substances that help you digest foods.

Too much cholesterol in the blood, or high blood cholesterol, can be serious. People with high blood cholesterol have a greater chance of getting heart disease. High blood cholesterol on its own does not cause symptoms; so many people are unaware that their cholesterol level is too high.

When your body has too much cholesterol, deposits of fat, called plaque, form inside blood vessel walls. The blood vessel walls thicken and become narrower (a condition called atherosclerosis). This change reduces blood flow through the blood vessels. Fatty plaques caused by high cholesterol can rupture, possibly leading to heart attacks or strokes.

What are your cholesterol numbers? It's important to find out what your cholesterol levels are, because lowering cholesterol levels that are too high lessens your

risk of developing heart disease. When you get your cholesterol checked, your healthcare provider will give you a number for your total cholesterol level.

- ✓ A total cholesterol level of less than 200 is considered desirable.
- ✓ A total cholesterol level of 200 to 239 is considered borderline high.
- ✓ A total cholesterol level of 240 or above is considered high.

When your cholesterol is found to be high, your healthcare provider may also check the amount of LDL (low-density lipoprotein) and HDL (high-density lipoprotein) in your blood. LDL cholesterol is called bad cholesterol. HDL cholesterol is called good cholesterol. It's good to have low levels of LDL and high levels of HDL.

Lowering your bad cholesterol ~ Eating right, exercising and not smoking can often control cholesterol levels. If you have a high risk for heart disease, your healthcare provider may prescribe cholesterol-lowering medication and recommend changes in lifestyle. Many cholesterol-lowering medications are available as generics. If your doctor recommends a cholesterol-lowering medication, ask about an available generic medication that may save you money. Here are some tips for lowering high cholesterol levels:

- ✓ Increase your dietary fiber by eating more fruits, vegetables and whole grains.
- ✓ Lose weight.
- ✓ Increase physical activity.

“EASY DOES IT” Recipe Column - Two more Dump Recipes

Preparation: Our fast-moving “holiday” predict oncoming busy days. So, methinks it's time for a couple very simple “Dump” recipes. For those of you with a quick wit, I must explain: “Dump” means that you will first thoroughly blend the sauce ingredients in a small bowl. Then, transfer chicken pieces & sauce into a one-gallon freezer baggie. Seal the bag, then place, uncooked, in the freezing compartment of your refrigerator.

When you are ready to eat: Completely thaw overnight in your refrigerator. Remove from refrigerator & discard plastic bag. Dump chicken pieces & sauce into an appropriately sized oven baking dish (glass if possible but metal is OK) that has been lightly brushed with butter or sprayed with Pam or similar non-stick cooking spray. Bake in preheated 350 F. oven.

Baking Instructions Using 4 – 8 pieces of chicken: For **boneless skinless breasts**: Bake approximately 25-35 minutes. For **wings, thighs, drumsticks**, bones in or out, skin on or off: Bake 45 minutes or until done.

#1. Dump Honey Ginger Chicken

1½ Tablespoons honey

¼ cup chopped onion
 1 Tablespoon soy sauce
 1½ teaspoons ground ginger
 2 Tablespoons sherry, regular or cooking sherry. (Taste to insure quality, of course!)
 ¼ cup fresh chives, finely chopped (or 2 Tablespoons dried & minced chives from a bottle.+))

#2 Dump Honey Glazed Chicken

2 teaspoons garlic, finely chopped (or 1 teaspoon already prepared bottled crushed garlic.)
 2/3 cup apricot preserves/jam
 1/3 cup soy sauce
 1/3 cup catsup

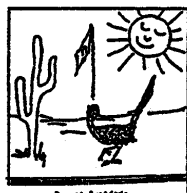

We had a great raffle with many bottles of wine and boxes of chocolates.

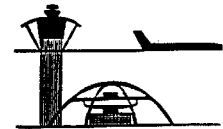

Personally Speaking:

(1) Do you dispose of your prescription drugs (pills/liquid forms) properly? Millions of us are flushing unused medications down the toilet. Sewage treatment plants and septic systems are not designed to deal with such contaminants and are not required to be equipped with pharmaceutical filter devices. Researchers have identified traces of pharmaceutical drugs in the drinking water supplies of some 40 million Americans. Low levels of pharmaceuticals, including antibiotics, hormones, contraceptives and steroids have been found in 80 percent of the rivers and streams sampled. These drugs can alter the behavior and reproductive functions of fish and mollusks. Some fish species in New York's Jamaica Bay are experiencing "feminization" - the ratio of **female** to male winter flounder was 10-to-one in the studied area. If there are no "Take-Back" programs in place near you or at your pharmacy, throw the drugs in the household trash. But first, take them out of their original containers and mix them with an undesirable substance, such as used coffee grounds or kitty litter. Up to you: put the medication into a sealed bag or other container to eliminate leakage, and then, into your kitchen garbage.

"September 11, 2001, morning: Four commercial airliners are hijacked by Al Qaeda terrorists in a planned attack against the United States. Two are flown into the World Trade Center's twin towers in New York City. A third is flown into the Pentagon in Arlington, Virginia. A fourth plane, United Flight 93, a Boeing 757 bound from Newark, New Jersey for San Francisco, California, is delayed for 25 minutes before its scheduled takeoff. After 46 minutes flying, when over eastern Ohio, hijackers in first class attack at 9:28 am, incapacitating the captain and first officer. Hijackers turn Flight 93 southeast, headed for Washington, D.C., most likely the U.S. Capitol. Just before 10 am the plane is seen flying low and erratically over southwestern Pennsylvania. At 10:03 it crashes, upside-down, at 563 miles per hour in this Somerset County field. There are no survivors. All 33 passengers, seven crew and four hijackers are killed."

Flight 93 National Memorial Pennsylvania ~ These horrific events continue to draw us together to remember and honor the heroes that were exposed that awful day. May we never forget the passion of the patriotism that was ignited through the brave and courageous reactions of the Americans.

The Tenth Anniversary of the crash of United Airlines Flight 93 brought over 100 Clipped Wings members and friends together in the Pennsylvania country side for the Flight 93 National Memorial dedication ceremony, the Tenth Commemorative Service at the national site, and the Flight 93 Memorial Chapel Anniversary Service.

We are truly a caring, sensitive and unique group. I am so proud that Clipped Wings® was so well represented by so many of us from all over the country. It was a personal emotional journey for each of us. We all process these events in our own way and in our own time. There was a certain comfort in experiencing all of this with people who understand. I will always remember being so grateful to be in the company of my friends as it was announced when each airplane crashed that terrible day. The impact of the announcements and moments of silence at the Memorial site created the same chilling fear as I had ten years ago.

There are two different memorial sites for United Airlines Flight 93. The flight 93 National Memorial is at the impact site and operated by the National Park Service, a division of the U.S. Department of the Interior. We attended two services at that location. On Saturday, September 10, 2011, the Dedication of the Flight 93 National Memorial featured an impressive list of speakers. President George Bush, President Bill Clinton and Vice President Joe Biden all emphasized the actions of the 40 passengers and crew as heroes as the first act in the war against terrorism. After the service, these men personally visited with the family members at the base of the beautiful Wall of Names as they viewed it for the first time.

The Tenth Commemorative Service was held at the National Memorial site on Sunday, September 11th. All Clipped Wings® members, EWR Flight Attendants, American Flight attendants were seated together. Family members personally announced each of the 40 names of those who perished, followed by the ringing of the Remembrance Bells. Sharing this day with the families is a bond that we all cherish.

The second memorial site is about three miles away from the crash site on a tiny country road lined with old wooden farm houses and corn fields. The Flight 93 Memorial Chapel is housed in an old one-room church building that was originally purchased by Bishop Alphonse Mascherino, familiarly known as Father Al, with his life savings in early 2002. Private donations of money, supplies and memorabilia have given this memorial a personal feeling. United Airlines EWR Flight Attendants have donated a beautiful monument for the garden among other things to support the existence of this Chapel of remembrance. Clipped Wings sent a \$4000 donation to the Memorial Chapel last month. There are plans for a future new chapel building to be erected on a yet undetermined site.

Father Al invited us to a special service at the Memorial Chapel on Sunday afternoon. He arranged for the 100 EWR Flight Attendants and the almost 100 Clipped Wings members and friends to have preferred seating. Pat Morris (EWR) hosted the service, Father Al presided, and the delightfully professional North Star Kids Chorus entertained us all with heartfelt musical arrangements. As they, in turn, gave us a few personal insights about each of the 40 people on Flight 93, we felt closer to the lives represented there than ever before.

As the President of Clipped Wings, I gave a few personal thoughts of the day at the chapel: "It is so humbling to be here in this peaceful place. I am in awe of the 40 courageous people who have brought us all together. As the National President, I am honored to represent Clipped Wings. We are a group of over 1200 current and former United Airlines flight attendants throughout the country. As part of the United family we

share this loss. I speak for all Clipped Wings members as I give you our message of love and support to the memories of the crew and passengers of United Airlines Flight 93. We all are truly blessed to know Father Al. For his spirit and dedication to this Chapel of Remembrance - and all that it stands for - We thank you."

Flight Planning

By late 1943, United Air Lines had started planning for post-war expansion. New radio equipment, improved flight planning and an expanded personnel base would serve United's high-speed, long-range transcontinental flights (with only one or two stops from coast-to-coast).

Immediately following the war, new equipment such as four-engined, 40 to 50 passenger, 220 mph planes would supplement United's

war-time fleet of twin-engined 21 passenger planes.

Within five years after the war, United engineers expected the development of a four-engined, 100 passenger, 250 mph plane with a range of 3,000 to 3,500 miles (for over-ocean service); a four-engined, "deluxe-sleeper" plane with a moderate range (for domestic service); a slightly smaller four-engined, passenger and/or cargo plane and a twin-engined, "flying freight car".

United was the first airline to adopt a full-scale program for its returning veterans. Following their honorable discharge, returning employees on military leave were to be placed on the payroll, given free airplane transportation to Chicago for a reindocination program and given seniority credit for time served in the military.
