

#### **Annual Benefits Enrollment Reminder**

The 2013 Annual Benefits Enrollment period is **October 24 through November 9** for retirees. The enrollment package was sent in mid-October and for some, the enrollment worksheets were mailed separately. However, beginning October 24, you may access the Your Benefits Resources site 24 hours/7 days a week to view plan rates and your plan options. This is your opportunity to view benefit options and make elections that are effective January 1, 2013.



Dependent Certification is now a part of this year's enrollment process. This annual process involves confirming dependent relationships and their eligibility for benefits. Certification will be completed with just one click via Your Benefits Resources, at the "complete enrollment" step of the election process. Co-workers and retirees who do not complete enrollment during the enrollment period will be required to certify dependents at the start of 2013.

If you will be adding dependents or changing beneficiaries, you will need their names, birth dates and Social Security Numbers. Per federal regulations, you will be required to provide your dependents' Social Security Number(s) (for U.S. citizens and residents).

Beginning October 24, please visit Flying Together at <u>flyingtogether.ual.com</u> and select the Employee Services tab > Benefits or call the United Airlines Benefits Center at 1-800-651-1007, M-F, 7 a.m. – 7 p.m. Central time for assistance. For prescription drug questions, call Express Scripts/Medco directly at 1-877-701-9945.





Eligible co-workers, retirees and pass riders may buy electronic Zonal Employee Discount (ZED) tickets on Alaska Airlines (AS) for a small processing charge per segment through the ID90T website, available through employeeRES and Flying Together.

Co-workers and retirees also may use ID90T to buy ZED eTickets for travel on Frontier Airlines (F9), Hawaiian Airlines (HA), Era (7H) and Spirit (NK). Paper tickets are no longer issued for interline travel on these carriers.

Information on ID90T and eTicketing procedures – including new instructions for resetting passwords on the ID90T – is available

on the Other Airline/Interline Travel page on the Travel tab.

#### TSA PreCheck helpful tips and Q&A



TSA is expanding TSA PreCheck, an expedited security screening program for eligible customers, at <u>EWR and IAD hubs</u>. This brings United's total number of airports with TSA PreCheck lanes to 13.

MileagePlus members, including co-workers, may sign up for TSA PreCheck at <u>united.com/tsaprescreening</u> for travel on revenue tickets. However, bookings for co-workers traveling on passes are not linked to their MileagePlus numbers. To be eligible for TSA PreCheck when traveling on an employee pass, co-workers need to enroll in a Trusted Traveler program such as Global Entry, NEXUS or Sentri, to have the information included in your pass travel

boarding passes. To learn more and to enroll, visit Global Online Enrollment System (GOES).

United has received several questions about enrolling in these security programs. See below for some helpful tips and answers these questions:

**Q**: I am already enrolled in a Trusted Traveler program such as Global Entry; how do I update this with my pass travel information?

**A**: You may include your Known Traveler number in your employee profile. In employeeRes, go to Quick Links > Employee Profile > Add/Edit Secure Flight Information. Highlight the Secure Flight Document and click the pencil icon to edit the selected row. Select the "Known Traveler Pass/ID field" and enter the Known Traveler number.

Tip: Be sure that the name in your Global Entry profile matches the name in your employeeRes Secure Flight Document fields. TSA requires the names to match exactly, or you will not be selected to use the PreCheck lane. To verify the name in your Global Entry profile, log into Global Online Enrollment System (GOES) <a href="https://goes-app.cbp.dhs.gov/main/goes">https://goes-app.cbp.dhs.gov/main/goes</a> and select "Change Profile."

**Q**: I've entered my Trusted Traveler information into employeeRES; why have I not been selected?

A: Updates made to your employeeRES profile do not carry over to existing PNRs, so you must cancel and rebook the listings to include the Known Traveler number and any name updates. You should also double-check that your name, date of birth and traveler ID number match exactly.

**Q**: How will I know if I can use the TSA PreCheck lane for my flight?

A: Before you fly, check to see if the airport has a PreCheck lane. Visit <u>united.com/tsaprescreening</u> for a list of airports where TSA PreCheck is offered and determine what checkpoint you must enter through. When you reach a TSA agent at the checkpoint, your boarding pass will be scanned. If TSA selected you for TSA PreCheck on the flight, the agent will let you know and direct you to the TSA PreCheck lane. Please note, the TSA uses random and unpredictable security measures. Therefore, you are not guaranteed expedited screening for every flight, even if you have applied to the program.

#### New tool helps re-book customers from some over-booked flights



A new tool may help alleviate the need for United's airport coworkers to solicit volunteers or to deny boarding to ticketed customers on flights over-booked due to operational issues. Contact Center representatives can now query these flights, identify customers who might benefit from changing their itineraries and offer to change customers' plans before they come to the airport.

In most cases of over-booking, flights actually depart at or under capacity. From time to time, customer service representatives need to solicit volunteers to take a later flight due to operational issues. They can be difficult flights for customer

service representatives to manage, so the new tool has the potential to mitigate the impact in the airport.

"We target customers on over-booked flights, send them an email and route their calls to our specially trained Contact Center co-workers," said Quality and Tactical Performance Managing Director Leslie Colbert. "We have had amazing success with the call-in rate and folks who are willing to move with our offer. Making these changes is always more customer-friendly and cost-effective for us than handling the issue at the airport on the day of departure."

In the first three weeks of operation, the database helped UAL identify 720 customers who made use of the service to change their flights, with an average customer acceptance rate of 79 percent. United plans to expand the use of this process to assist with day-of-service recovery needs in the future, including proactively notifying customers when there is an aircraft substitution.

#### Current performance well above stats DOT reports for July



While United continues to run at its on-time goal so far in September, the DOT released its Air Travel Consumer Report for July and, United's on-time performance was not what its customers expect or what the company wants to deliver.

United has taken aggressive action to improve since July, when the company finished at 64.2 percent arrival :14 (A :14). Those actions include adding spare aircraft and more ground time between

flights and making changes to its technology to give co-workers and customers a more reliable product. The improvement trends United is seeing are very strong - its August performance (72.2 percent A:14) was eight percentage points higher than July. Through Sept. 16, its domestic A:14 was 80.3 percent, eight points higher than in August.

The DOT report also reported an unusually high number of customer complaints for United. About a third of the complaints DOT noted for July resulted from the programming error that caused United's website to display four miles as the total, roundtrip per person price for MileagePlus travel awards to, from and via Hong Kong, although the correct number of miles was displayed on the same screen, on previous search and flight-selection screens and on United's mileage-award charts. UAL corrected the error and, for those customers who were issued tickets without sufficient miles in their accounts to complete their transactions, the company canceled their tickets at no cost and waived all fees. United provided return air transportation to customers who had already begun their travel. For customers who had sufficient miles in their accounts to complete their transactions, United deducted the correct number of miles at the time of booking.

#### **Inflight recycling helps the Earth, helps co-workers**



In an effort to reduce landfill waste and assist co-workers in need, Chelsea Food Services partners with Inflight Services to donate a portion of funds from recycling the aluminum cans flight attendants collect on board to the United We Care Employee Relief Fund. United recycles aluminum cans on eligible flights across the U.S.

Through August 2012, United has donated \$43,600 and expect to make further donations to United We Care from its Inflight recycling efforts for the remainder of the year. Last year, United donated approximately \$63,000 to the fund.

United We Care provides confidential, timely, short-term crisis relief to those in the United family needing basic assistance unavailable through other resources.

Chelsea is part of the Food Services Division of United, with six kitchens in five cities (Cleveland, Denver, Newark, Houston and Honolulu). United's Inflight recycling program, conducted through Chelsea and with help from the company's contract caterers, supports United's Eco-Skies commitment to the environment.

#### **Tech Ops rehearses for 787s**



In one of the final preparatory steps before taking delivery of United's first Boeing 787 Dreamliner, United successfully showed how its training has prepared the company to respond to an assortment of maintenance-related scenarios based on the real-life experiences of early 787 operators.

The system-wide 787 "dry run" exercise included six case studies taken from the logs of airlines that have been flying the 787 since last fall.

"Everything we dealt with during the exercise has already happened to a 787 in service," said IAH Line Maintenance Manager Dave Caster. "What we need to know is exactly how we'll

respond in the same situations."

Dave helped coordinate the drill along with 787 Service Ready Team Manager Ian Hankin, IAH Service Engineering Director Gavin Jones, and representatives from Boeing, General Electric and other business partners.

Dave and three others — Technician Ed Bleakley, Lead Technician Blain Hill and Supervisor John Richardson — ran the operation from the IAH Zone 3 Supervisor's Office and maintained contact with Tech Ops Maintenance Control and the hubs and stations where the scenarios played out. The cases ranged from fuselage damage caused by ground equipment to replacing a gasket to lightning strikes on descent into an airport with no Tech Ops presence.

Overall, Dave said, it was a major success. "We were able to produce an accurate, detailed and timely resolution to all the situations." United also identified a few areas that can use improvement, such as computer support, and will address them before the next drill, which will take place in IAH after delivery of its first 787.

#### Flight "Emmy 1" arrives at LAX



It's that time of year; the <u>64th Primetime Emmy Awards</u>, and once again United proudly flew the famous Emmy Award statuettes from ORD to LAX.

United pulled out all the stops for two very lucky statuettes representing the shipment. The pair got the "star treatment" at ORD, checking in at Global Services, boarding through the Premier Access line and flying to LAX in United First aboard a Boeing 757.

United celebrated the flight, designated "Emmy 1," with a special gate event. Co-workers and customers had the chance to hold an Emmy statuette and snap photos. Members of the media, including Good Morning America, joined the event as well.

ORD Customer Service Representative Sally Warren, who helped check in the statuettes at Global Services, said she was excited to be a part of Emmy 1. "This is probably the most precious "cargo" I've ever worked with," she added. LAX co-workers, customers and photographers greeted Emmy 1 with fanfare upon its arrival.

#### Pilots support military veterans, help award-winning documentary take off

He still smiles and laughs a lot. Right now he thinks I'm his mommy, which is sweet. I know he'd enjoy receiving funny cards, so if you remember Jerry, please let him know.

My wife and I have had a good year, well mostly that is. My wife had a minor stroke in May and after several weeks of in home therapy, she is doing fine.

Since I retired, I have put on a lot of weight. Our daughter, Kirsten went on a diet several years ago; so I decided to give it a try. Over the last year of the same diet and exercise program, I have dropped over 45 pounds. Now I am wearing jean sizes that I have not worn in the last 25 years.

I start my day mostly with whole grain cereal, ½ cup non fat yogurt and ½ cup of some kind of fruit. For lunch I have a garden salad with low-fat dressing or ½ of a sandwich.

For dinner I have no more than 5oz. of meat, a steamed green vegetable and a small starch.

For exercise, I like to walk outdoors as much as possible. I try to go at least four miles a day; this is a great way to keep in touch with the neighbors. On bad weather days, I run the tread mill inside. After dinner and before bedtime, I have nothing but water. It worked so well that it gave me the will power to stick to it. My doctor is impressed. He can't find any reason to put me on any kind of medication. He tells me he could use me in his office to counsel some of his other patients. I think at 71, I am truly blessed.

I thought I could get our house payment back down to the ratio we had with the monthly income back in 2004 with Wells Fargo. My pension got chopped because of what United did. So back in May of this year, we applied through the HARP program to refinance. We are getting a royal runaround. Every couple of weeks we are told that the adjusters have all the information they need and we should get a call in a few days to set up an appointment to sign for the closing. Then the next call we receive is one asking for more documents. It has been over 4 months and just the other day we were led through the same scenario for the sixth time. Now they want a letter of assurance from Met Life that I'll get that annuity for the next three years. I am filing all this stuff and soon I plan to meet with our congress woman here in Martinsburg, WV to get an idea of where to go with this. I believe they are considering our age and thinking that we will just give up.

Now I am wondering if there are other seniors out there that are having the same problem. Wells Fargo tries to assure us that they do not discriminate. But they don't watch the same ABC News that I watch. Diane Sawyer just recently reported that Wells Fargo was fined 35 million dollars by the Federal government for that very reason.

I know of a number of people much younger that my wife and I, who live in the same development, whose requests went through in a matter of weeks without a hitch.

Our daughter tells me she is now being allowed to refinance a second house which she rents out, through the same HARP program.

The way I see this is if it walks like a duck, looks like a duck, quacks like a duck, it most likely is a duck. Keep up the good work on the newsletter. I look forward to it each month.

### **United Airlines Historical Foundation**



"Preserving the Past, Inspiring the Future"

WWII pilots traded their wartime wings for United Air Lines co-pilot wings. Colonels, Captains, Lieutenants and Civilian pilots sat side-by-side in classes at the Denver Flight Training Center.

30 or more pilots graduated each month and were assigned to the line, joining the approximately 1,000 Captains and First Officers already flying United's fleet of Mainliners and Cargoliners.

Bombers, Troop Carriers or Air Transport Hospital and Supply planes and some were former Fighter pilots.

United gave due regard to their wartime experiences in the armed services, however, the company put all through a rigid "airline" training program – and a former colonel wasn't treated differently than a first lieutenant. Following the war, United required its flight personnel applicants to have a CAA Instrument Rating before hire. This rating requirement shortened co-pilot instruction time to five to six weeks, saving four weeks training.

In addition to holding a CAA Instrument Rating and Commercial Pilot's Certificate, the average post-war trainee was a military veteran with 1,500 to 1,600 hours of flying time, was 21 to 29 years of age and was between 5 ft. 7 in. & 6 ft. 2 in. tall. He had to have a mini-

Nearly all of the 300 co-pilots who graduated from the Denver center in the year between Sept. 1, 1945 (V-J Day) and Sept. 1946 had extensive flying experience in war theaters throughout the world. A large percentage had been commanders of aircraft – multi-engined

mum of 1,200 hours in the air, accumulated during night flying, instrument flying or multi-engine operation.

Classroom instruction included Meteorology and Navigation, operation of the DC-3, Flight Operations Procedures & Policies, Civil Air Regulations and a course on the United Air Lines Organization.
