

#### Updated process for reporting pass travel taxes to Retirees and Early Out Participants



Under United's current tax reporting policy, any taxable imputed income resulting from our former employees pass travel and/or that of their eligible pass riders is reported to them and the Internal Revenue Service (IRS) on Form 1099. We are making a change to our process in order to more closely follow tax reporting laws and align the way we report taxable pass travel income for both former employee participants and current employees. For pass travel on or after November 1, 2017, any taxable imputed income will be reported to former employees on Form W-2 and will no longer be reported on

Form 1099. Communication is being sent to retiree and early out participants and outlines the changes to their taxable pass travel reporting process. It includes frequently asked questions and a detailed list of available resources to assist throughout this transition.

- $\checkmark$  This will be emailed and mailed to all travel eligible former employees starting Wednesday, September  $27^{th}$ .
- ✓ This info has been shared with retiree organization leaders and was announced at the RUAEA conference (retiree conference).
- ✓ The dedicated W-2 Pass Travel Tax Reporting page located on the left navigation menu on the Flying Together > Travel homepage will go live and will include this communication, a user guide, contact info and more helpful resources to assist those with questions.

Important note: Although the process for reporting/paying taxes is changing, there is no difference in the amount of taxes being paid.

#### **Enhancement to enrolled friend program for Retirees (Not applicable to Early Outs)**

The above communication will also include an announcement that retirees (only, does not apply to active employees) will have the opportunity to change their enrolled friend(s) twice per calendar year: mid-year and again during year-end open enrollment.

Retirees will continue to have up to two active enrolled friends at one time, but this change will allow retirees to register up to four enrolled friends during different time periods within a calendar year. See Retiree Pass Traveler Enrollment 2018 document for complete details.

Because these changes are specific to former employees, our communication will be targeted to retirees and early outs, as applicable. We do not plan broader communication (i.e. United Daily, etc.) at this time. Feel free to contact us with questions or concerns.

#### **Retiree and Off-Station Parking At SFO Maintenance Base**



Applies to All Retirees and Off Station Personnel ~ Effective October 1, 2017, Retiree Parking will be limited to individuals who retired from the Maintenance Base.

The SFO Maintenance Base will no longer be able to offer parking for SFO Airport Operations Employees and Retirees from Other Stations.

This is due to SFIA constructing the extension of the AirTrain to the Long Term Parking Structure and the loss of about 700 parking spaces in our West Parking Lot.

#### Pass Travel Update by Kirk Moore



<u>Update your contact info NOW!</u> The ETC sent retirees information via email and U.S. mail about pass travel & tax reporting, did you receive it? NO? It's important to update your contact information in 2 places:

- 1. The "Saved employeeRES information" box on your "Employee Travel Profile" in the "Quick Links" tab in "employeeRES" ("Book a Flight" on Flying Together >Travel).
- 2. In "Personal Information" in "Your Profile" (in top menu bar) in "YBR" (Your Benefits Resources) on Flying Together > Employee Services or go to www.ybr.com/united.

Savvy Traveling: Use the United app! Get a KTN! Use the United app for easy booking and flying for both space available and myUAdiscount travel. To learn more, go to Flying Together > Travel > United app & Pass Travel tab (in the left column).

**KTN**: Join a Trusted Traveler Program to obtain a "Known Traveler Number" to be eligible for TSA PreCheck and expedited customs/immigration entry. Visit Flying Together > Travel > "Preparing for Travel" (left column) > "Trusted Traveler Programs". Links on that page will take you directly to sign up on the GOES system. There are various programs with different pricing.

Once signed up online, you will apply for an interview (the first available interview for me was 4 months later!). Revisit the webpage often to try and move up your interview date. Some locations have drop-in wait lists for interviews. Take a good book, you may have to wait awhile!

**IMPORTANT!** After you pass the in-person interview you MUST input your "KTN" (Known Traveler Number) in two places:

- 1. For space available travel go to employeeRES > Quick Links > Employee Travel Profile (click "Add/edit Secure Flight and Travel Contact Information" in the "Saved employeeRES Info" box). If you have more than one Secure Flight Document (i.e. one for passport, one for driver's license) enter your KTN in BOTH documents. Select row, click little pencil icon, input your KTN in the field that says "Global Entry/Known Traveler", then hit "submit".
- 2. For revenue travel (including use of myUAdiscount) go to your MileagePlus account (united.com > MileagePlus > My Account > Profile > Edit Traveler Details > Known Traveler Number). For both space-available and revenue (myUAdiscount) travel: use the United app linked with your Mileage Plus number AND join a Trusted Traveler Program; you will fly like the wind!

#### Discounts on cars, cruises, hotels

The ID90Travel.com website offers discounts for employees and retirees on hotels, cruises, resorts, and rental cars when you travel for leisure. It's easy to book and to save as much as 60 percent off! Simply click on the ID90 Travel banner in employeeRES (you may have already noticed it under 'My ePass Balances') when you make your space available travel plans to see what discounts are available at your destination or search for exclusive rates at more than 380,000 destinations worldwide.

#### Bag tracking now available in the United app



United made a major improvement to the United app, launching the beta version of a bag tracking tool that allows its customers to follow their checked bags along the critical points of their trip, from check-in to arrival.

The new "Track my bags" feature is one of the many ways United is working to improve customers' experience at every stage of their journey and offer them a level of transparency they expect and deserve.

With this functionality, customers can follow along as their bags are scanned during their journey. In the rare case a bag gets rerouted or mishandled, the tracker service will give clear instructions on what to do next. For instance, if a bag arrives on an earlier or later flight than originally scheduled, alerts will tell the customer to go directly to the Baggage Service Office

upon arrival at his or her final destination for assistance.

Customers can access the "Track my bags" feature under the main menu in the app or under their reservation details. A simple set of prompts allows a customer to find his or her item using the itinerary or bag tag number.

With bag-scanning rates at their highest levels and as United heads into fall with 22 of 24 months of record mishandled baggage ratio (MBR) performance, United is ready for a successful rollout.

"The newest update to the United app points to our continued focus on providing innovative tools and resources for our customers to enhance their overall travel experience with us," said Insights, Innovation and Tools Managing Director Maria Walter. "I know our customers are going to appreciate the real-time information and visibility that this tool provides them, and offering them this access is a testament to the excellent work our ramp and baggage teams have done with bag scanning."

United will monitor customer and employee feedback during the beta test, which is available to all, and make refinements as needed. To provide your feedback, please go to the United app main menu, scroll down to App feedback, and under "Select category" choose "Track my bags."

#### Name your price: New volunteer solicitation functionality



As part of United's commitment to further improve the customers' travel experience with United, the company is launching an automated system that will provide customers with the opportunity to voluntarily bid their desired compensation amount in exchange for changing their travel plans in the event of an oversold flight. United has already taken steps to reduce overbooking, resulting in a dramatic year-over-year reduction in involuntary denied boardings this year.

Following a successful beta test of the new volunteer solicitation tool last month, or "reverse auction" process, as <u>Oscar referred to it in a recent video</u>, United is rolling it out to all stations throughout October. This new benefit allows customers who are on a flight that may be oversold to let United know, up to 24 hours prior to departure, at what level of compensation they are willing to give up their seat during check-in within all channels (i.e., airport kiosks, united.com, United mobile app and the mobile web). This new tool provides customers with more control, while simplifying the gate management procedures for customer service representatives working those flights.

Select customers, such as Basic Economy customers without pre-paid bag fees, unaccompanied minors and Global Services members, will not be prompted to opt into the volunteer solicitation list during check-in.

Additional details about the new tool may be found in policy and procedure communications.

#### <u>Torgy's Travel Tips</u> Significant Travel Changes Coming November 2017



Important changes are coming as soon as November 1<sup>st</sup>, 2017 regarding our travel benefits. An email was sent to all retirees who have email capability in late September outlining these changes. More information will be coming to everyone via US mail during the Open Enrollment timeframe. In the meantime, I want to use this month's column to explain as clearly as possible what is changing and what it will mean to you.

**ENROLLED FRIENDS:** Since the merger with Continental, retirees have had the ability to designate up to 2 individuals each year who could share in the retiree's travel benefits. This category of traveler is known as Enrolled Friends. Similar to the pre-merger *Companions*, Enrolled Friends are otherwise non-eligible family or friends whom you can invite to fly with or without you as a non-rev standby traveler.

Until now, the timing and method of naming your 2 chosen Enrolled Friends has coincided with the start of the calendar year. Once a name was "enrolled", it became

unchangeable until the next calendar year. Well, good news, everyone! Effective with the 2018 travel year, retirees will have the ability to change the names of their Enrolled Friends mid-year. Essentially, you can name 2 people to travel January-June and then 2 different people to travel from July-December.

When the system is ready later this year to accept your choices for Enrolled Friends for 2018, you will enroll them via the Travel Tab in <u>Flyingtogether.ual.com</u>. If you already have 2 people enrolled in 2017, they <u>automatically</u> rollover to 2018. You can then replace those names in June for the July-December travel period if you want to. Again, if you do nothing, the existing names will rollover to the next 6 months. As always, you have the option of not designating *anyone* until you are sure of your choice.

Remember, Enrolled Friends share your boarding priority when you travel with them, but they fall to the bottom of the list (just above other-airline non-revs) when they fly alone. If you retired with more than 25 years of Company service, your Enrolled Friends can travel in any class of service at the same fare you pay: zero! If you retired with less than 25 years, the service charge for your Enrolled Friends is the same as you pay. Additionally, as you know, the retiree is liable for imputed income of the value of the segments flown. This calculation is based on a percentage of the ZED medium fare multiplied by the combination of the FICA rate and Federal Tax rate.

Which brings us to the other upcoming significant change:

TAX COMPUTATION AND REPORTING OF IMPUTED INCOME FOR NON-REV TRAVEL: There are 2 things happening with this important topic. The first is the method of reporting taxable travel to the US government and the second is the timing of its implementation.

Effective for travel commencing **November 1**<sup>st</sup>, **2017**, the Company will begin collecting any federal and state withholding taxes that apply to your Enrolled Friends and Domestic Partner pass travel via a <u>quarterly invoice</u> which will be mailed to you. You will need to pay this invoice by check or money order. Invoices will be mailed once each quarter if there is Enrolled Friends /Domestic Partner travel activity during that quarter.

Note: UA's fiscal year is Nov-Oct, therefore invoices will be generated in March, June, September and December.

Then, each January you will receive a W-2 form which will show the imputed income for the value of your Enrolled Friends/Domestic Partner travel AND the amount you have already paid to UA to cover the withholding taxes. The first such W-2 form will cover travel from November 1, 2017 - October 31, 2018. Expect that in January, 2019.

(For Enrolled Friends/Domestic Partner travel prior to November 1<sup>st</sup>, 2017, you will receive the current 1099 form, which only shows the imputed income, but zero withholding taxes paid.)

For planning purposes you can determine of the estimated withholding amount before or during the listing process by using some tools in EmpRes. Use the Pass Travel Calculator located under QuickLinks, or, if you are making a listing, 2 new red areas will be noticeable on the last page of the booking screen. The first one will state "I understand in addition to any current charges that are due today, I will be billed separately for any estimated tax withholdings of \$12.73" (just an example). You will then see an Address Verification paragraph reminding you to update your address, if necessary, to insure timely delivery of your imputed income tax invoice.

Note: These 2 areas are currently displaying on <u>ALL</u> listings but programming is underway to limit their display to applicable taxable travel only.

To sum this all up, pass travel for retirees, their spouses, parents and dependent children under age 26 is still NOT taxable. Pass travel for Enrolled Friends and Domestic Partners IS taxable and withholding taxes will be collected quarterly and reported on a W-2 form.

#### MY UA DISCOUNT PROGRAM

Some good news when flying confirmed space using this 20% discount benefit effective mid-October: We will be allowed to board with Group 3, even if a Basic Economy ticket is purchased, Pet-in-Cabin fees will be waived and Unaccompanied Minor fees will no longer be collected. It just keeps getting better!



There were two interviews and bios done by **Dick Bligh** for the November RUAEA issue, that of **Ralph Brick** and **Joan Brandonisio**. Here they are:

**Ralph Brick**'s Bio ~ Ralph was born in Manitowoc, Wisconsin in 1932. Manitowoc is located on the shores of Lake Michigan 40 miles south of Green Bay and 80 miles north of Milwaukee, WI. Today it has a population of approximately 33 thousand people. Dairy farming is abundant throughout this area and all surrounding counties.

Ralph grew up on a family dairy farm. He attended public school grades 1-4, followed by attending Lutheran parochial school for grades 5-8. He graduated from a public High School in 1950. Later during his United career, he graduated from McHenry County College in 1973 with an Associate degree in Business Management.

In February of 1952 he was drafted into the USAF at 19½ years old (at that time, the military was not an all-volunteer force). He was trained as a cryptographic operator and completed his overseas assignment in the Alaskan Air Command, with a one year assignment to ADAK, in the Aleutian Islands. He was discharged in February of 1956 as a S/Sgt.

After returning to the Midwest he responded to a blind ad in the Milwaukee Sentinel and his United career began as a Customer Service Representative in Milwaukee and went on to also serve, over an eleven-year period, in Youngstown and Tampa Florida, with increasing responsibilities, becoming a Supervisor in the Tampa operation.

In 1967, he moved to Chicago being assigned to System Operations Control as a Controller for 10 years, and then promoted to a Manager of Systems Operations Control. He continued in that position for the next 17 years until he retired in 1993.

Once retired Ralph continued to be active in Church related activities and to play golf several times a week. Along the way he and his wife moved to Virginia and later to Gainesville, Florida where he has remained for almost twenty years. Also, He served as the president of the United Retirees Citrus Groupers of The Villages for approximately five years.

**Joan Brandonisio** Bio ~ Joan was born in Chicago, Illinois and because her father worked on building military bases during World War II, Joan lived in many parts of the country. She attended a total of seven different schools before attending Proviso High School in the Chicago area. After high school, Joan attended Actors Company studying drama and dance. This has given her a life-long interest in the performing arts.

She held positions as a CBS page and was employed by J Walter Thompson Advertising agency - along the way she married and lived in Waynesville while her husband was stationed at Fort Leonard Wood, MO.

Once again returning to Chicago after a period of time she left the work force to raise her son. When he entered school, she took a job with the local school district. Along the way, she interviewed with United and became an employee working in EXOAC (Accounting) where she handled government account details such as arranging for payment when government personnel traveled.

After a while she transferred to EXOGO which provided facilities management for the Headquarters' complex, she did work ensuring that everyone had their EXO ID security pass for entry to the complex. Another responsibility was the support of the various departments when something didn't work.

Transferring to the Purchasing unit EXOPP, Joan worked with external vendors who had contracts which required them to distribute product across the system. She also worked with hotels which had contractual arrangements with United ensuring that services were provided to specification and in a timely manner.

In 1991 Joan retired and in 1993 moved to Daytona Beach Shores with her husband Louis of 57 years. In 2005 a cousin invited them to move to the Villages and they did. After only five years Louis died in 2011. Since then Joan has been active in clubs and wrote a column for local publications on theatre openings. She thoroughly enjoyed her time at United Airlines but as Joan said "Life moves just too fast." Joan has been and is the Treasurer of the Citrus Groupers for four years now.

Janis Robinson, Assistant Port Director of Passenger Processing for PDX, spoke about happenings and changes at PDX. The main topics were:

- 1. Portland International Airport has installed Automated Passport Control kiosks in the PDX Internationals Hall, which effectively reduce waiting times by 25 to 40 percent. Operated by U. S. Customs and Border Protection, the self-service kiosks do not require any pre-registration and are free to use. Instead of completing a declaration card and showing their travel documents to a customs officer, eligible passengers, which include U.S. and Canadian passport holders and U.S. Permanent Resident, have the option of using an Automated Passport kiosk.
- 2. Mobile Passport Control at PDX ~ Mobile Passport Control allows U.S. citizens and Canadian visitors to use the Mobile Passport app to speed up their entry process into the United States. It is the first app authorized by U.S. Customs and Border Protection for eligible travelers with a Smartphone or tablet to submit their passport information and answer Customs and Border Protection related questions before their inspection. This app does not require preapproval and is free to use and it shortens the traveler inspector process.
