Annual Benefits Enrollment begins November 4th



Fall is fast approaching, and you know what that means – it's just about time for 2014 Annual Benefits Enrollment! This year, United benefits-eligible retirees will have the opportunity to enroll from November 4 - 15, 2013.

With the new health care reform laws, United is making a few medical plan updates for its before-Medicare benefits-eligible retirees — the same changes that will apply to active co-workers. You'll see additional medical insurance options available through the new state-run Health Insurance Marketplaces. Although United will continue to offer medical plan options in 2014, you may find more cost-effective coverage through the Marketplaces. As you prepare for Annual Benefits Enrollment, United encourages you to explore all options available to determine which is best for you.

For benefits-eligible retirees with Medicare, your United plans will remain unchanged, they'll just be administered by Aetna. United is also excited to announce that Kaiser will be expanding its Medicare Advantage plan network into the mid-Atlantic and Atlanta, so Medicare-eligible retirees will now have a new option available in those areas.

As previously announced, Aetna will serve as United's primary medical provider for its U.S. medical plans in 2014. The transition to Aetna means access to valuable new tools and resources, including healthy lifestyle coaching, medical concierge services, and a dedicated care advocate team. It's also important to know that United's prescription drug benefits are not changing; they will continue to be provided through Express Scripts. In addition, the behavioral health benefits will remain the same and continue to be provided through Value Options.

For information about your benefits and the new Health Insurance Marketplaces, watch for *Benefit – it's your life* communication in late September. You'll also receive more detailed information and enrollment instructions in the late October enrollment issue.

Flying Together Access Reminder



Keep in mind, that your login password to United's Flying Together website must be refreshed every 90 days. If you do not access the web site very often, here are some steps to resetting your password online.

1. Use Internet Explorer as your browser
2. Go to **flyingtogether.ual.com** website
3. At the login page, select the "password reset"

link in the grey area at the bottom of the login page and follow the prompts to reset your password.

Be alert to phishing scams



In an increasingly complex and connected world, we all need to play our part in keeping United secure and safe. Recently, government agencies have alerted us to a direct threat to our airport locations, which would most likely take the form of a spear phishing attack. Spear phishing is a type of criminal attack that targets a specific organization, seeking unauthorized access to confidential data. Co-workers should be especially cautious when opening emails that appear to be from airline advocacy groups or freight shipping companies.

Phishing emails typically appear to come from a trusted individual or a well-known company or government agency. They entice you to click on a link that will take you to a fraudulent website where you may be asked to provide personal information, such as account usernames and passwords. The websites or the email may also contain malicious code that infects your computer.

To avoid being the victim of a phishing scam, ask yourself:

- ✓ Do I know the sender?
- ✓ Does the content of this message make sense? (You receive a link to get tracking information for a package you're not expecting.)
- ✓ Am I the only recipient? (You get a link to view transaction details for a recent payment, but the email message has 20 recipients with the same first name.)

If you see a link in a suspicious email message, don't click on it. Rest your mouse (but do not click) on the link to see if the address matches the link in the message. If it doesn't, it may be a phishing email.

Prepare a backup plan when pass traveling



With the busy summer travel season winding down, United is still seeing strong load factors in its international locations that may prevent the company from accommodating all

pass riders. UA is seeing more pass riders looking for different routes to and from their final destinations. United strongly encourages all pass riders to prepare alternate routings on United or to secure backup passes for travel on other airlines (OA), if eligible, before departing their originating cities.

Eligible co-workers and retirees may buy electronic Zonal Employee Discount (ZED) tickets on more than 45 OA carriers through the ID90T website, which is available through employeeRES > Quick Links tab and on Travel > Other Airline/Interline Travel.

A number of OA carriers still require a paper ticket for travel. Pass travelers must request ZED and Industry Discount (ID) paper tickets through the New Ticket Requests form available on Travel > Other Airline/Interline Travel > New Ticket Requests. OA paper ticket requests will be processed within four hours and an email with a confirmation code will be sent. Eligible pass riders can then purchase their advance OA paper tickets from their local employee travel offices, most United airport ticket counters or city ticket offices.

When considering OA backup plans, plan accordingly, verify eligibility and review the listing/reservation guidelines in advance of your travel date. To learn which OA carriers with which United has an eTicket agreement and to learn how to list on OA carriers, visit the specific airline's interline agreement information in the drop down menu on the Other Airline/Interline Travel page.

In addition, please respect airport co-workers' need to focus on United's revenue customers during this busy travel period. Please be patient and allow sufficient time at the airport for ticketing assistance.

IRS rules same-sex couples will be treated as married

Benefits Update

On August 29, 2013, the U.S. Department of the Treasury and the Internal Revenue Service (IRS) ruled that same-sex couples, legally married in jurisdictions that recognize their marriages, will be treated as married for federal tax purposes. The ruling applies regardless of whether the couple lives in a jurisdiction that recognizes same-sex marriage or a jurisdiction that does not recognize same-sex marriage. However, the ruling does not apply to registered domestic partnerships, civil unions or similar formal relationships recognized under state law.

In July, the U.S. Supreme Court decision invalidated a key provision of the 1996 Defense of Marriage Act (DOMA), and United awaited additional guidance to know how to implement these changes. A cross-divisional team from legal, payroll, benefits, tax, IT and other departments has been addressing the compliance requirements under this federal ruling. United expects additional guidance later this year in order to inform co-workers in advance of the 2013 year-end tax-filing period. United will provide additional updates as it finalizes the implementation plan.

Flight 93 Memorial Chapel by Frank Egges



A Pennsylvania County is exploring the possibility of extending a public trail system to the Flight 93 National Memorial which honors the passengers and crew of the United Airlines plane which crashed onto the field on September 11th, 2001.

Somerset County will seek proposals for a feasibility study on the best way to extend the Great Allegheny Passage bike trail north of the Memorial. Already, Somerset County has obtained more than \$100,000 in grants and donations for the project.

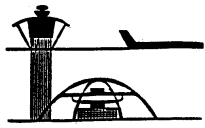

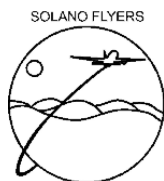

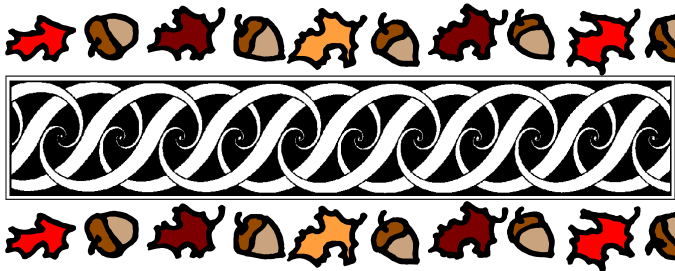
