#### **LETTER FROM THE PRESIDENT - October 2007**

In my July/August letter, I reported to you on enhancements and potential enhancements to United's travel program. I told you of two more carriers that had been added to the ZED fare structure and of changes made to the interline pass request procedure, for those retiring from foreign domiciles who are residents in the U.S. Included in this Newsletter, and, I might add, published over a week ago on our RUAEA Website and on SkyNet, I refer you to announcements of additional carriers added to the ZED structure and overall changes to Employee Travel policies. I think you will agree, that the changes made will make our pleasure travel less stressful. That is not to say that we, United retirees, are not interested in pursuing further enhancements to the program. We intend to continue to provide a voice for issues raised by our members concerning the travel program and any other benefits which concern us.

Now, for the commercial. The company has looked to four of United's unions AND RUAEA for input on how their constituents feel about several of the company policies. While each of the unions represents their retirees as well as their active employees, only RUAEA provides a voice solely for the retiree community. Our voice, responding to the comments received from you, our members, has its impact because of our large membership total, currently around 8,700. While large, the total is only some 20-25% of the total retiree population. The leverage we demonstrate to the company is greater or less depending upon our membership total. I know I am preaching to the choir --- almost all of you reading this are already members. However, many of your friends and former associates are not RUAEA members. It is in their interests, and yours, that they become RUAEA members and enable us to retain the leverage we currently have to make our views known to the company. Yes, our annual dues of \$20 go to the publication of our Newsletter and to our annual Convention, but it is the fact that payment proclaims membership in our vital organization which is more important. Ask your friends and former associates to consider membership. Applications can be found via links on the RUAEA Website, on SkyNet and by request to our Denver office.

### EMPLOYEE TRAVEL POLICY CHANGES BY LINDA LISTER

We have reviewed the employee & retiree travel policies to ensure that the overall travel program is market competitive & aligns with our business and employee program strategy. As a result of this review, travel policy has been revised to leverage program design, delivery & technology to create the greatest value to employees & retirees.

We recognize the importance of pleasure travel programs to all employees and retirees. Feedback from you and employees was given careful consideration in our review process. Our objective is to improve and align the customer and employee travel experience.

Effective November 1, 2007, we will make the following travel policy changes:

- → We will no longer assess domestic and international Economy Class service charges on United Airlines and Ted for travel eligible employees and retirees of United Airlines, United Express and Mileage Plus, Inc. We will continue to waive Economy Class service charges for travel on United Express. Applicable transportation taxes and fees will continue to apply.
- We'll continue to award service-charge waived flight segments when we meet our established goals under the Performance Incentive Travel Program, and we will extend the usage period from one year to two years, to allow employees more time to take advantage of the awards.
  - Any Performance Incentive segments that remain in an employee's "bank" as of 11/1/07 will expire two years after the date of issuance. Employees can click on the My Coupons tab in WebList to view their current available segments.
  - Employees who list themselves in United First or United Business using Performance Incentive segments but who are ultimately seated in service charge-waived United Economy will have their Performance Incentive segments returned to their "bank" of unused segments.
- → United will change the pleasure travel service charge methodology (excluding companion) on United Airlines, Ted and United Express to the Zonal Employee Discount (ZED) service charge methodology, which is currently used on some interline carriers.
  - United Airlines will discount ZED at a level to maintain current pricing on most mainline United Airlines and Ted flight segments, as recognition that travel is on own carrier as follows:
  - ➤ Domestic Premium Class Travel: 65% Dis-

- count 35% of ZED
- ➤ International Premium Cabin Travel: 50% Discount – 50% of ZED
- ➤ First Class, Business Class: ZED Business Low Fare Level will be used
- ➤ First Suite (Sleeperette) Cabin on 3-class aircraft: ZED Business Medium Fare Level will be used.
- Hawaii pricing which has traditionally been priced separately from domestic will be merged into the one domestic pricing entity.
- → United will assess service fees in the First Class cabin on United Express to align premium cabin pricing between mainline and express.
- → In the first quarter of 2008, United employees, retirees and their travel eligibles will board United Express flights based on company hire date or years and months of active service, according to United pleasure travel policy. This will replace the current boarding at BP-8c, same day, time of check-in policy.
- → United Express employees will retain the right to have priority boarding on their company's own aircraft, before a United traveler. For example, when the aircraft is operated by Sky-West, the boarding priority would be the Sky-West traveler, the United traveler, and then other UAX partner travelers. Further information regarding this change is forthcoming.

The pricing of companion travel is being reviewed and any changes or program enhancements will be communicated in the near future.

Employees and retirees will be notified of these changes in a detailed letter which will be sent to their home address beginning in Sept. Apollo employee travel profiles, the travel page and WebList service charge calculator in SkyNet will be updated soon with this information.

We have listened to employees and to you. We believe that these program changes are positive ones that reflect our commitment and significant investment in employees.

#### UNITED & ANA SHARE INFORMATION, BUILD RELATIONSHIPS AT MANAGEMENT EXCHANGE IN JAPAN

United and ANA, one of our key Star Alliance partners in the Pacific, held a "meeting of the minds" in July to foster better understanding of issues that affect our airlines. The objectives of the exchange were to promote learning and build relationships between employees of both companies, to create "best practices" at every level of the organizations.

Seven United employees, representing Airport Operations, Customer Experience and Revenue Management, participated in the event, which was held at ANA headquarters in Tokyo. Flights and visits to Narita, Haneda, Itami and Kansai airports also provided indepth observation of ANA operations.

The exchange included discussions with their counterparts at ANA, an opportunity to view projects and processes, interactions with senior management, as well as cultural experiences.

"The exchange's success is a tribute to the quality of ANA's approach to doing business and the strength of our partnership," said David Johnson, managing director, Alliances and International Affairs.

As a follow-up to this continuing exchange, ANA will be sending a group of employees for a similar program at our corporate headquarters this October.


### SUITE DREAMS BEGIN ON UNITED STARTING OCTOBER 29

United's first international aircraft to complete the company's multi-million dollar product enhancement is scheduled to take flight on Oct. 29, 2007, from Washington Dulles to Frankfurt.

With the inaugural Washington-Frankfurt flight, United will earn the distinction of becoming the first U.S. carrier to offer 180-degree, lie-flat beds in business class on overseas flights.

"The inaugural flight promises to be an exciting occasion for our customers and employees alike," says Graham Atkinson, Executive VP & Chief Customer Officer. "The investments we're making in our international aircraft will give our employees, a product they can be proud of and the tools they need to more easily deliver the high standard of personal service, our top customers expect. We know employees have been looking forward to refreshed cabins for quite some time, and we are delighted to be able to introduce a product that puts us on a footing to compete with the world's best international carriers."

- → The first of the 97 international aircraft that will be modified is a Boeing 767, which after its inaugural flight is scheduled to alternate flying between Washington-Frankfurt and Washington-Zurich. Following the 767 will be a B747 that is scheduled to begin flying in mid-December and a B777 that is scheduled to fly in early February.
- → After these three aircrafts are modified, the rollout schedule will accelerate and run in parallel by aircraft type through fall 2009, with approximately one reconfigured aircraft per week joining the fleet.
- As part of United's international wide body aircraft investment, we will also refresh the premium cabin restrooms, and in the economy cabin, we will add new seat cushions, replace the carpeting and upgrade the inflight entertainment system with digital servers and new LCD screens
- The new international premium cabins are part of United's strategy of providing customers with distinct products and services that they expect and value, with a particular focus on serving more frequent business travelers. United remains the first and only U.S. airline to offer customers 180- degree, lie-flat seats in first and business class cabins on all international wide body aircraft and a choice of four different seating sections United First, United Business, Economy Plus and United Economy.

This Travel Tips by Bob will be a little shorter than usual, but it has some very important information. It speaks to something we all have been informed of and must comply with. Company travel benefits afforded employees and retirees are to be used only within the guidelines specified in company regulations. If you don't know what they are, I strongly recommend that you go to the SkyNet website and access the Travel section and review the pass travel regulations.

The reason, it is timely to mention this, is because I have recently had conversations with some who were unaware of the policy that prohibits the business use, sale or barter of Companion passes. The policy is stated in "Companion Travel Guide" located in the Travel section. The policy is stated below:

Reminder

The travel sponsor providing travel privileges to a companion is responsible for the companion's actions both on the ground and in the air - even if they are not traveling together. Therefore, the dishonest use of companion travel privileges, the sale, barter or transfer of companion travel privileges, inappropriate behavior and or attire of the companion while traveling could

result in revocation of all travel privileges, as well as termination of employment if the travel sponsor is an employee.

Companions should contact the travel sponsor with questions about companion travel, company policy and procedures. Companion travel may be used only for pleasure and is not to be used for business, including self-employment, consulting or commuting to or from work. The Company reserves the right to amend, delete, or modify policies and provisions with or without notice.

Simply stated, passes are for pleasure. Be sure and keep it that way and assure you keep your passes.

Originally, the area was home to over 10,000 Native Americans. When gold was discovered, it was the greatest migration of all time. There were those from various areas all over the world that settled in the area. Colfax was and still is a railroad town. It was first called Camp 20 during the building of the railroad. Our 49ers worked extremely hard under very difficult circumstances. Colfax was established in 1865 after the Speaker of the House was Schuyler Colfax, during President Abraham Lincoln administration. He was sent to California to encourage the building of the railroad. It took him two months to get to California via stagecoach. He was convinced that no-one should have to put up with the stagecoach travel for that long. The Chinese came to work on the railroad and were instrumental in its completion. They were not allowed to have any property or to bring their wives or family. They followed their culture and dress. The city of Colfax burned down three times but fortunately was rebuilt each time. Helen gave several other stories of interest about Colfax.

Requirements of eligible employees or retirees must have volunteered for a U.S. charitable organization or an international charitable organization and have volunteered a minimum of 40 hours during the past year in 2006. United will be awarding 45 individual Grant Awards of \$1,000, randomly drawn from all eligible applicants. In addition, one \$5,000 Chairman's Award for Excellence will be presented to the individual who demonstrated the greatest commitment, compassion and energy to a charitable organization. The Award winners will be held this month at World Headquarters hosted by Chairman Glenn Tilton and other officers. To date, approximately 500 non-profit organizations have benefited from the

Grants Program. "United is proud to recognize and reward individuals who have made outstanding volunteer contributions," said Sonya Jackson, Managing Director-Corporate Social Investment. "Through the Individual Grant Awards, we are able to support our individuals who are helping to build stronger communities."

Volunteers answered telephone pledges, during a 36-hours radio broadcast that included heartbreaking interviews with many families of children, who have received medical assistance from the hospital. It was great seeing these smiling little toddlers with their parents and how so much love being given to these struggling children.

During the program, a generous family whose child is a patient at CMH vowed to donate \$15,000 when the radio broadcast received 150 pledge commitments within a one-hour session. A joy of excitement was demonstrated from the telephone gallery when this goal was reached. It was good to see and hear how people gave during a time of need for many families. This made me feel good that we could help in a small way.

This Radiothon raised over \$1.5M and since its inception, the Eric & Kathy telethon has raised over \$20M for Children's Memorial Hospital. Congratulations to Children's Memorial Hospital, who now have a generous bump in their budget to further help care for Chicago's needy and ailing kids.

More information on the Holiday Children Giving program sponsored through DCFS for tots will appear in our next monthly Skyline report. The monthly trips to the Chicago Food Depository, packing bulk foods for the needy continues the 2<sup>nd</sup> Tues. of each month. Plan some time and join in a group of people who like helping others through out the year.

Hubbard was an Army Pilot Instructor in San Diego during WWI, then an experimental pilot at Boeing from 1917 to 1920.

In 1919, following the first international airmail flight, he began operating a private contract airmail service between Seattle & Victoria, BC. For the next five years he flew under the name of "Seattle-Victoria Air Mail Line", carrying between 25,000 and 50,000
