



#### **LETTER FROM THE PRESIDENT**



In last month's issue of the Newsletter, I wrote to you detailing my visit with Glenn Tilton and other United Airlines senior officers. As I stated Ron Bertacini. Marlin Lade, Ed Tolle and I were all very positive about the outcome of that meeting. We came away with a sense of mutual support and commitment in accomplishing RUAEA's stated objectives.

It was only a few days later, on August 1, that the A-14 Program (BP6A passes for active employees) was announced, without any chance of input from the retirees. At that point, we seemed to be back to square one. I can assure you, that after that announcement, for some of us, August was a very long month. One of the bright spots however, has been my contact and working relationship with **Marc Ugol**, United's Senior Vice President/Human Resources. Marc and I communicated often during this period, looking for the solution to an illadvised program. **Lynn Hughitt**, Vice President of Compensation and Benefits also played an active role in seeking a resolution to the issue.

As most of you know by now, the issue is resolved and we were successful in our stance that the program be modified to honor past travel commitments to retirees and keep seniority intact.

We are also pleased to see the following announcement by **Pete McDonald** indicating the achievement of operational goals, which we all applaud, and the modifications to the incentive program.

In the future, we will continue to meet with the company on a scheduled quarterly basis. **Ed Tolle** and **Mort Wax** will also continue to be active members of the Travel Committee. They will bring to the table comments and concerns of retirees as they meet with United representatives and representatives from other groups.

In summary, I think we have a win-win situation: United has a program to increase operating performance for a very competitive goal by rewarding employees with an extra bonus - and RETIREES retain their historic pass benefits. I especially appreciate your support, patience and understanding as we worked through this issue.

#### <u>United Achieves A-14 Goal for August</u> <u>by United's Chief Administrative Office</u> Pete McDonald

We are pleased to report that our Arrival 14 performance for August came in at 72.9%, exceeding the 72.6% target for the month. These results, which were up more than 4 points from July and 5.8 points year over year, represent a great start toward our goal of moving into the top tier of the DOT-reported statistics by the end of 2008.

Improving our reliability performance is critically important to all of us at United as it is a primary driver of customer satisfaction while also helping us to reduce significant delay and cancellation costs. Of course, one of the other key outcomes of meeting our Arrival 14 goal is that our operations clearly ran more smoothly, greatly enhancing the day-to-day experiences for all of you.

While we had established the new A-14 Recognition Program at the beginning of the month with two BP6A travel segment passes as the incentive award, we have decided to adjust that structure based on feedback we received from many employees and retirees over seniority concerns and the impact the BP6A passes could have on some individuals' historical ability to fly space available. Therefore, for August and the remaining four months of this year when we make goal, all employees will receive four (4) service charge-waived BP8 passes per month.

It is important to note that the original intent of utilizing BP6A passes as part of this important recognition program was to provide the most relevant and cost-effective incentive possible for employees to deliver on our goals. When we informed our union leaders of the idea, there was no specific feedback at that time. After the program was launched, however, we received many comments – both positive and negative – but the concerns expressed by our most senior employees and retirees have been considerable. We met with the Travel Committee, which is comprised of our union representatives and retirees, in mid-August, and the unanimous request was for the company to reconsider the choice of award.

We respect these opinions and recognized that an adjustment in the actual incentive award was necessary and proper. As we look to design additional incentives aligned to our other core performance imperatives going

forward, we will continue to solicit the input of our unions and other stakeholders.

In addition to the previously announced capacity that will begin coming out of the schedule in early September, we are taking several additional steps to further support our collective efforts to improve reliability. Among these actions include adding ground time – for an average of 62 to 63 minutes for domestic mainline systemwide – as well as adding gate rest time, spare aircraft and looking closely at peaking levels throughout the fall.

With these investments and a concerted effort across all teams that have a direct impact on Arrival 14, we should all feel confident that we will continue to see tangible and measurable results – fundamental improvements that will translate into long-term success for our airline.

#### **ASK THE DOCTOR – Let The Buyer Beware**

In most forms of media today, we hear and/or see an individual describe the wonderful, amazing, and pleasurable result he/she achieved from a medication or treatment. The individual is usually smiling and obviously happy with the result and, of course, urges us (the listeners) to try it and get the same result. The testimonial always concludes with a disclaimer from an announcer that contains warnings and admonitions to ask your doctor if this is suitable for you. The announcer delivers the disclaimer in a monotone and generally speaks very rapidly. I am sure we are all familiar with this type of advertising. Are they real? Are they accurate?

In my opinion, a caveat would be to say if the offer sounds too good to be true, then it is. The advertiser is counting on an emotional reaction to the testimonial. The listener will identify with the individual onscreen and proceed to ask (maybe even demand) the same thing from a medical provider. Please, reflect on the testimonial in a more rational manner. The success of any treatment or medication is the result of a complicated testing process involving laboratory animals, human volunteers, and peer review. This process means hundreds, perhaps thousands, of individuals taking the treatment or medication and the results tabulated. The investigators perform biostatistical analyses of the results and then make recommendations. The larger the sample size, the better. There is no place for testimonials in this scenario

Even by taking all appropriate precautions, errors still occur. Sometimes, the errors are unavoidable. Sometimes, the developer of the treatment or medication is too hasty or greedy to maintain a completely unbiased perspective. Thalidomide and Vioxx come to mind. However, in the vast number of situations, the recommended treatment/medication is safe for general use.

Then, comes the hardest part of all.

Individual medical providers become aware of the treatment/medication and have to decide if a particular patient sitting on the examination table should get it. That is a difficult and complicated decision. The provider has received glowing reports from the manufacturer's representative and the patient has heard or seen the testimonial. The issue is whether to recommend the treatment. The pressure is on. The manufacturer wants the provider to give the treatment, and the patient may actually demand the treatment based on the commercial. But is it appropriate?

Each of us is different. We are unique. One person's medicine may be another person's poison. That is the dilemma for the providers. It is always the dilemma. The positive result projected in ONE testimonial is not necessarily the outcome each time. The provider must always weigh the pros and cons for his/her patient. Only then, does the provider make the correct decision. It is the mandate of the patient to follow the recommendation to the letter for the best possible outcome. Even the correct decision to give the treatment at that time does not result in an immediate positive outcome. Full compliance by the patient will most likely result in recovery over an appropriate time.

Of course, while complying with our provider's plan of treatment, a friend or family member will inevitably offer their own recommendation. Be wary of a friend or family member. That testimonial issue again. I recommend firm resistance to these "suggestions". Comply with your provider's plan and adhere to his/her recommendations. That is my advice about medical care to get the best outcome.

We are the "buyer" of medical care that best suits our needs. Yes, we should inform ourselves with information that will help us achieve and sustain good health for the long term. But, we must also guard against the hype of advertising and testimonials. Sometimes a little knowledge is a dangerous thing. Present your questions to your provider, listen to his/her responses, form a team with him/her, and comply with the plan that will lead to your goal of good health.

At a time when medical care is making headlines in the political arena, we must be cautious, informed, alert, and persistent. Be aware of all the opportunities to stabilize your health. Informed patients paired with conscientious providers make an unbeatable combination. Such teams will always provide the best possible defense against illness and injury. This team will provide the best way to help the buyer to beware.

### UNITED LAUNCHES "ENROLLED FRIEND" TRAVEL PROGRAM

United has enhanced travel privileges for employees and retirees who have no spouse or qualified domestic partner; they can now enroll one person in the Enrolled Friend Program for a rolling 12-month period.

This travel program applies to unlimited non-revenue, space-available travel on United and United Express (UAX) flights, and the enrolled friend travel on the same seniority basis as a spouse or a domestic partner. Service charges for the enrolled friend's travel are the same as for a qualified domestic partner. In addition, enrolled friends are eligible to travel on Employer Discount 20 tickets on United and UAX flights.

"We recognize the importance of pleasure travel to our employees, and we are pleased to offer this new travel program," says Marc Ugol, SVP-Human Resources. "While we and the industry are facing challenging times, we recognize the importance of enhancing the travel experience for employees and retirees as we expand their travel privileges."

The enrolled friend travels on the same boarding priority as the employee/retiree and is eligible for interline travel if reciprocal agreements exist on the chosen carriers. The enrolled friend program only applies to travel privileges, not to health and welfare benefits.

Eligible employees and retirees will receive a mailing that includes a letter announcing the program and frequently asked questions. Eligible retirees will be able to enroll a friend using a Family Information Form posted on <a href="https://www.ualretirees.com">www.ualretirees.com</a>; the form will also be mailed to retirees with the announcement letter.

In addition, on SkyNet on the Travel page, you can get both the frequently asked questions and how to enroll a friend using a Family Information Form.

#### FIRST ASIAN IPTE FLIGHT TAKES TO THE SKIES

United's first flight to Asia featuring an aircraft reconfigured with the new lie-flat premium cabin seats and enhanced in-flight entertainment system took off last Thursday from San Francisco to Hong Kong, and then on to Singapore.

United Flight 869 from San Francisco departed Thursday for the 13 hour and 48 minute flight to Hong Kong and the B747 continued on as United Flight 895 to Singapore. The plane will primarily fly between San Francisco, Hong Kong and Singapore.

"Trans-Pacific travel just got even better for our customers, who will now have more ways to relax on long flights," says Graham Atkinson, EVP and chief customer officer. "This flight marks another milestone in United's continuing commitment to invest in products

and services that provide our customers with a more enjoyable travel experience."

### UNITED TESTS FOOD CHOICES IN BUSINESS AND ECONOMY

United is launching a trial during the fourth quarter of food options for both business and economy class.

As part of the trial, on domestic flights with three cabins of service, United will be offering United Business customers complimentary fresh sandwiches, salads, breakfast, snack boxes or snacks, depending on the length of flight and time of departure. The products will be the same as the Buy on Board sandwiches and salads offered in United Economy. Business-class customers will continue to enjoy complimentary beverages, including beer, wine and cocktails. Meals will still be served on United's p.s. transcontinental flights.

"Our industry is changing and we need to tailor products and services to what customers value and provide them with more choice," said Graham Atkinson, executive vice president and chief customer officer. "We are listening to our customers as we test new options in both the business and economy cabins."

For trans-Atlantic flights originating out of and returning to the company's Washington Dulles hub, United will on a trial basis, be offering economy customers fresh Buy on Board options, including sandwiches, salads and snack boxes. There are no changes under way for international business or first-class customers. At the end of the year, United will evaluate the results of the trial and determine next steps.

Here's an outline of the service changes during the test period:

International, United Economy: For flights between IAD and AMS, BRU, CDG, FCO, FRA, LHR, MUC and ZRH, complimentary meal service will be replaced with Buy on Board options. Meal offerings remain the same in all other markets.

Options include snack boxes as well as fresh wraps and salads. The four snack box choices will be freshened with new items, and new sandwich and salad items introduced. The new options will be available on October 1.

Domestic, United Business: Standard meal service will be replaced with a variety of complimentary offerings.

- On flights between two and three hours, customers choose from candy, chips, cookies or nut mix.
- On flights between three and five hours, cus-

- tomers can choose from among four snack boxes.
- ★ For flights longer than five hours, sandwiches, salads, breakfast, if applicable, and snack boxes will be available.

In addition, for domestic United Economy: Starting on September 2, an enhanced snack offering with options of candy, chips, cookies and nut mix will be available to buy for three dollars.

- These a la carte options take the place of complimentary biscotti and pretzels for flights between two and three hours.
- Tests confirmed that customers are willing to pay for snacks of higher value.
- United will continue to test fresh sandwiches and salads for flights between three and five hours.

Effective October 1, prices for snack boxes will be increased to six dollars and prices for fresh food will be nine dollars. The prices are in line with United's competitors' offerings.

Customers are being advised of these changes through <u>united.com</u> and targeted Mileage Plus communications, by reservations service and sales representatives, and through normal gate advisements.

#### NEW SCHEDULE CHANGES INCLUDE SOME ADDITIONAL ROUTES

The fall schedule is in effect this week. It reflects previously announced changes and also includes a new international route from LAX:

- → United begins serving Melbourne (MEL) from LAX on a seasonal basis, with flights beginning December 15 and operating through Jan. 30, 2009. During this period, United will not operate our Sydney (SYD)-MEL tag flight.
- → LAX-Philadelphia (PHL) service will remain year-round rather than converting to seasonal as previously announced.
- On September 2, United began serving Saskatoon, SK, Canada, from Denver. United Express partner SkyWest will operate two daily roundtrips.
- → Service between ORD and Mexico City (MEX) has been restored on a seasonal basis and is scheduled to operate between Dec. 18, 2008, and Jan. 5, 2009, and again between June and August 2009.
- → United has re-instituted the NRT-TPE route, which complements our current code share flight with ANA.

#### TRAVEL TIPS BY BOB

Call your credit card company to see what they would provide for you if your card is lost or stolen, or you forgot it at home. Customer Service numbers are on the back of the card. When you are traveling, this information may be helpful, if you have a health emergency, need a hotel, your billfold/wallet is lost or stolen, etc. Please check NOW to see what they can help you with before it happens.

Also a good idea is to make a copy of all your credit cards and put the toll free numbers on that copy. Make a copy for home and one to keep in your suitcase (similar to losing a passport), so that if you do lose your wallet, you have the credit card numbers and the phone numbers to let them know if they are lost or stolen. If you are uncomfortable about taking them with you, give them to a family member or friend who can call the credit card companies for you, if they are lost or stolen.

Don't wait until you lose it and then try to figure this out!

#### TRAVEL DESK TIPS

The Travel Desks are set up to assist those without computers to list and to assist those that are traveling to have a source of help when needed. The folks that man the travel desks are eager to help when they can. But they are limited on what they can do. We have to remember the Travel Desks aid in the process of NRSA travel, not PS or revenue ticketed/travel. The following is a brief synopsis of what they <u>can</u> and <u>cannot</u> do.

#### Travel Desk can:

- ✓ Check loads on United Airlines and United Express
- ✓ List NRSA employees and retirees on United Airlines and United Express
- ✓ Suggest alternate routes/connections between city pairs on United Airlines and United Express
- ✓ Supply information regarding what carriers fly where

#### Travel Desk *cannot*:

- O Make positive space listing or reservations on United Airlines and United Express
- O Check loads on other airlines
- O List employees and retirees on other airlines
- Obtain reduced fair tickets on United Airlines and United Express or other airlines
- Order letters of employment verification
- Obtain passenger manifest information
- O Handle questions regarding insurance rules

In addition, some of the Travel Desks have people

with the expertise to help with SkyNet procedures. They will try to assist you with your travel needs in whatever way they can, but we have to remember they are limited as to what they can do for us. Therefore if they tell you they cannot help with a specific problem or refer you to SkyNet or the Benefits Service Center, it's because that is where you need to go to get the answer to your particular problem.

The next time you use one of our Travel Desks, be sure to give a hearty "THANK YOU" as the person who served you is a retiree who has volunteered to help make your travel pleasant. They are the "Live voice" at the other end of the line.



He was flying for USAir on September 11, 2001. His flight was scheduled to take off from BOS at 8:00AM. He was headed for EWR on a shuttle flight. You may recall that is about the same time as United flight 175 and American's flight 11 were taking off. His very moving story of his eye witness account of seeing the Trade Center that fateful morning held our group spellbound.

A personal note was included that his family and friends knew that he was scheduled to leave BOS at 8:00AM for New York. Neighbors came over to be with his wife and children. They all were concerned that it was his airplane that hit the World Trade Center. Since the phone system was down, he was unable to contact anyone at home until hours later when he was driving toward his Air National Guard Unit.

His USAir flight was instructed to land in LGA. Steve recalled that they thought the first hit into the Twin Towers might have been an accident, but quickly realized when they saw and heard of the second hit, that America was being attacked on our own soil.

Since Steve is a pilot in the Air National Guard, he knew he had to report to his unit. His harrowing tale of trying to get out of New York City, to get to his fighter squadron was amazing. After showing a guard his military and pilots license, he ended up driving in the incoming traffic lane on the Verrazano Bridge at over 100 MPH. The bridge was backed up for over 2 miles getting out of the city. Fortunately, the bridge was closed to incoming traffic so no one was coming the other way.

Only 12 of his fellow Guardsmen were able to get to the unit so quickly and their F-16s were loaded with ordinance. They all were assigned flying schedules. Steve tried to describe his feelings of flying over his house, over his wife and children and his neighbors in an F-16 loaded with missiles. He was called back into active duty and spent 4 more years flying jets.

Steve remarked that when he was on active duty, the family lives with the notion that you could be killed in the line of duty. It was never considered that he could be killed by the enemy while flying commercial aircraft.

When his tour was up, he made a decision to go to law school. He now has a successful law practice and is a Major, still flying for the Guard.

I am writing about an outstanding man by the name of Emilio Joseph who has been a retiree now, from United Airlines, since December 2003. When I met him in 1964, he was a licensed A&P mechanic, a Commercial pilot and Instructor. I worked with Emilio at United Airlines and I admire him to this day, as a Co-worker, Instructor, Inspector, and as a wonderful human being. He reads, writes and speaks both English and Spanish. He also has his commercial pilot license, instrument multi-engine license, and an instructor rating license. Being able to read, write, and speak both English and Spanish, made him more valuable because he could communicate with more people. Emilio Joseph was born in Panama City, Panama; he came to the United States in 1961 to attend A&P School. In addition to that, he also went to pilot school, in Los Angeles, California, before arriving in San Francisco to work for United Airlines in the jet engine shop.

He started to work for United in 1964, as a mechanic, and became a jet engine parts inspector. Later, he worked on the airplanes, and then became an A&P aircraft inspector in Oakland, California. Emilio worked in San Francisco, in the jet shop for more than 28 years, and in Oakland for 10 years. On one occasion, Emilio was hired to go to Kansas City, Missouri to pick

up a new plane, for a flying school in San Carlos, California. He made all the necessary airplane connections to Kansas City so that he could fly the plane to San Carlos. After take-off from the Kansas City airport, he turned off the boost pump and the engine became rough. Immediately, he said he turned the boost pump switch back on and the engine smoothed out. Then he said he pulled the carburetor heat on and there was no ice; the engine was all clear except when the boost pump was off, the engine was rough. So he said that he turned back and landed the new airplane. He taxied it up to the vendor, but everyone had gone. He searched around and found an emergency phone number. He dialed that number and someone came to check on the new airplane engine. They found a fuel line loose. The fuel line was changed, and after that everything worked okay. He refueled the airplane and was off again to California. Every three hours he said he had to come down for fuel until arriving at San Carlos Airport, slightly late and at night due to the fuel-line overhaul but safe, with the plane in excellent condition. It took three landings for refuel. The whole trip took over twelve hours of flying time from Missouri to California, not counting stops for refueling.

Emilio said that several times he applied to become a pilot for United Airlines and each time he said he was turned down. However, one fellow that he taught how to fly became a United Airline pilot. United would hire people he taught, but did not hire him as a pilot.

Emilio Joseph is retired now. He is happy about his United Airlines experience as a mechanic, instructor, and inspector. He tells me that those years with United were the best years of his life. Flying was always the excellent driving motive to work so hard and go to school.

Emilio and his wife Deloris are well suited to enjoy retired life in sunny Oakland, California and beautiful Lake Don Pedro in La Grange California. Emilio's memories of airplanes, flying and working for United Airlines could fill up two lifetimes.

Retirement is great - almost 10 years now and still going pretty strong. Had a hip replaced June 7 but was dancing by September. I should have done it years ago. The hip was damaged when I was struck by lighting back in '94 but I continued to ignore it. Got so bad it was hurting down to my ankle. The truth is, I was afraid to have it done. What a fool. Now I highly recommend it for anyone with hip problems.

After 9 years, I am still the Maintenance Officer for the Dixie Wing of the Commemorative Air Force in Peachtree City, GA. It's getting to be quite a job now with six aircrafts in flying status and one undergoing restoration. I had to develop all the procedures for the Annual and periodic inspections for each aircraft. Even came up with a form like the old 1338 job card to document non-routine work. (Old time mechanics will remember this). Now have an inspection program going, so all work is double checked and signed off on the job card so nothing is left to chance. Work is under the direction and supervision of an A&P Mechanic, usually the respective Crew Chief. We have a P-51, SBD Dauntless Dive Bomber (only 3 still flying), C-45, PT-26, LT-6 and an Aeronca. It took over 5 years to completely restore our LT-6 and just over a year for the Aeronca. Just finished them up last year and it proved to be quite an experience dealing with the FAA for Certification of our LT-6. But the FAA was very impressed with the maintenance procedures and quality of work they saw, typical Government, always in groups of 2 or 3. The LT-6 won Best of Show at Fun and Sun in Florida this year. It makes one feel proud to have a part in it.

Our restoration project is a P-63 King Cobra. We got this airplane 10 years ago in bushels and boxes after it was salvaged from a flood. Now the wings are just about restored and the fuselage is ready for electrical and plumbing. Just got an oven to heat treat the parts we are fabricating. Still need a lot of parts and working with contacts as far away as Russia to obtain them. It's funny that we gave Russia these aircraft during WWII and now they want an arm and a leg just to get some parts back. I usually spend 3 days a week at the airport. Things are sure different from the old days at United. If I need a part, such as a tail strut for the SBD, or a Merlin V-12 for the P-51, it is not a simple matter to just give a part number to Stores and have them find it. Research and many phone calls are the norm. We now have a small museum with WWII artifacts, which attracts many visitors and school classes. Check out our Web site at www.dixiwing.org and if in the area, stop in to see our facility.

Sure glad I accepted the transfer to ATL. I've been here 19 years and at the most, 7 snow days during this time. Coming from Chicago, it seems strange when schools here are cancelled and businesses are closed with a little snow flurries in the forecast. But they are not prepared for any accumulation of snow in the South. What a place for a Snowman to retire.

UAHF Pursues Archive Collection at UAL

The United Airlines Historical Foundation's mission is "Preserve the Past, Inspire the Future." Living up to its responsibilities, the Foundation's Board of Directors' representatives are currently seeking to meet with officials at United to discuss UAHF's proposal of March 19, 2008 to acquire and manage the archive collection.

This collection consists of documents and memorabilia tracing the history of United Airlines from 1926 to 2005.

We would like to provide the background of how this collection came to be. In the mid-1960s, plans were approved by the UAL board of directors to build a United museum on the grounds of Executive Office (EXO) in suburban Chicago. The museum was to be named after William A. (Pat) Patterson who served as President of United from 1934-1966, leading the company out of its pioneering past to become the world's biggest airline.

United employee Adrian Delfino was selected to head the project and he began collecting memorabilia from early airmail pilots, mechanics, and former employees of United's four predecessor airlines (Boeing, National and Pacific Air Transport and Varney Airlines) in addition to United active and retired employees. The collection was extensive.

UAL President William A. Patterson stepped down in 1966 and George Keck assumed the role of President. The company experienced losses and the museum project was cancelled. Some of the memorabilia was displayed in the lobby for a brief period of time at EXO but most of it was stored in a locked room in the basement of EXO where it remained until 1995 in a state of disarray.

The museum concept was resurrected by strong employee interest in 1995 and United paid for the construction of a mini-museum that was located in the large entry lobby of the Executive Suite and also extended to adjacent hallways.

An archive program was also created and staffed with one United employee who recruited over 15 volunteers in the Chicago area from RUAEA and Clipped Wings. Retired UAL historian Adrian Delfino served as a consultant on many projects. All the memorabilia that was inherited as well as new acquisitions were numbered and logged in a database. Special care was given to protect all of the objects in temperature controlled conditions. A traveling history exhibit was also funded which made the rounds to about five U.S. airports per year during a five year period. The traveling history exhibit was recently moved from Chicago to Denver and is located in the United Airlines Flight Training Center (DENTK) cafeteria. A history website was developed at www.united.com as well as an oral history program. Utilizing the resources of the archives, the Age of Flight book was published in celebration of United's 75<sup>th</sup> anniversary.

In 2005, one year before United Airlines exited bankruptcy, the archive program was eliminated. In 2006, the World Headquarters (WHQ) corporate museum was dismantled. The artifacts were once again placed in storage in the basement of WHQ as they were

prior to 1995.

Since the 1970s, UAHF has mounted displays of its own memorabilia at DENTK (United Airlines Flight Training Center) and it is there that the Foundation shares an office with RUAEA. The UAHF is continuing to mount displays and works in harmony with the United management team at DENTK. They have offered the Foundation sufficient space to store the Chicago area Operations Center (formerly EXO/WHQ) archive collection according to prescribed standards. It is this collection that the Foundation is now seeking to acquire.

The UAHF's position is to bring the remainder of the archival collection into the hands of the Foundation as it has a vested long term interest in the United history, memorabilia and archives. The collection is comprised of the good faith donations from employees and retirees. The Foundation is a 501c3 tax exempt not for profit organizations and has the capability to shelter and assume ownership of the archive collection via a "Deed of Gift" transfer.

RUAEA entered an informal alliance with UAHF in 2005. Since then, the RUPA Retired Pilots, AFA-CWA Retired Members Chapters of Flight Attendants and an IAM group in SFO have also joined the alliance - now, over 17,000 retirees share a desire to preserve United's rich history. The late William A. Patterson's daughter Pat Patterson Dudley and his son William A. Patterson, Jr., recently wrote to the president of United Airlines to support the transfer of the archives at United to the UAHF. In addition, the Foundation has reached out to unions representing workers at United Airlines and their response resulted in a joint letter of support to the UAL Corp. Board of Directors from the Union presidents.

The Foundation is now in a position to utilize the resources of our alliance coalition groups to further our goals to bring the archives at United under the Foundation's care and ownership. 

# United Airlines Historical Foundation

"Preserving the Past, Inspiring the Future"



Joe Ripley was able to get United Airlines off the ground, free of debt and with \$4,000,000 in working capital. The airline division had one-third of the assets of the United Aircraft and Transportation holding company but received more than half of the money.

Ripley also urged Rentschler and other heads of the holding company to name Pat Patterson as Philip Johnson's successor as president of United Airlines. On April 13, 1934 Patterson assumed the presidency of the newly incorporated Delaware Company, United Air Lines Transportation Company.

United bid-for and won-back all of its former routes except the Chicago-Dallas route where Braniff Airlines underbid United. United continued to fly the Chicago-Kansas City segment as a passenger and cargo route.

The Air Mail Act added two more hoops-to-jump-

led to the May 12, 1934 cancellation of the Chicago-Kansas City route.

A last-minute clause in the Air Mail Act forbid any carrier from holding air mail contracts for more than one Primary route and two Secondary routes.

United's Transcontinental route was designated a Primary route as was its Pacific Coast route. United could not keep the old PAT route unless it was split-off into a separate company and was completely independent of United. Faced with protests from Pacific Coast cities, Congress relented and designated it a Secondary route.

through. In addition to the U.S. Post Office, the airlines now had to deal with the Interstate Commerce Commission and the Department of Commerce.

The ICC cut United's average return on air mail from 38 cents to 31 cents per plane mile and also put a 300 pound-per-plane limit on what the Post Office could pay. As a result United had to fly many 300 pound bags of mail for free. This loss of income
