



#### From the Executive Vice President



**Hearing Aids** - Recently, we have received questions about coverage for hearing aids. Checking with our sources at United, we have the following information regarding hearing aid coverage under all the Summary Plan Descriptions or SPDs.

The new SPDs for Medical PPO and for the Health & Wellness PPO will be published later this month reiterating the following coverage for auditory therapy and expenses related to a permanent hearing loss due to bodily injury or severe illness, or a congenital hearing loss, including:

- hearing aid (including replacement due to wear and tear, breakage or change in the patient's condition)
- initial exam and tests
- batteries (including replacement batteries)

However, charges for hearing aids and related charges, which are needed because of the normal aging process or the result of loud noises

(sensorineural hearing loss), are NOT Covered Expenses.


Expenses incurred for hearing exams, hearing aids and batteries are covered up to a lifetime maximum of \$5,000.

It is always wise to check with your Health Care provider for more specific information.

More information is available regarding Summary Plan Descriptions by classification on Skynet. Go to Skynet/EmployeeServicesPeople/Benefits/SPD. Once you are at this page, the various classifications are listed such as Pilots, Flight Attendants; Customer Service; Administration, etc. Each classification has several pages of information including a short summary regarding the Annual Benefits Enrollment that will occur between October 29 and November 19, 2009.


We do need your attendance and support of our annual Conventions to continue offering a chance to meet, renew friendships, make new friends and be

#### United salutes WWII Vets traveling on "Honor Flight"



Reagan Washington National (DCA) welcomed a group of 25 World War II veterans and their escorts to Washington, D.C. recently for their visit to the National WWII Memorial and other points of interest. The trip was organized by the Land of Lincoln Hub of the national group Honor Flight.

The veterans were greeted by the cheers and applause of DCA employees, USO volunteers and customers. As an added tribute, volunteer musicians from the McLean Orchestra Brass Quintet played patriotic American music as the veterans entered the gate room.

Honor Flight Network chapters have several additional trips to the memorial scheduled this year, and we are working with them to continue United's recognition of the veterans making the journey.

#### United completes roll out of new gate information displays at hubs

In July, United completed the roll out of updated Gate Information Display systems, called EasyInfo or GIDS, at all of its hubs. The Denver mainline operations are fully equipped on all of the wide body gates with the units, creating a seamless customer experience throughout the concourse in Denver.

"Although we've already had the GIDs in the United Express terminal in Denver, we are happy to provide the improved customer experience throughout the B Concourse in Denver for our customers," says Edwin Garcia, Concourse Manager in Denver. "Not only do the units help our customers, but they also help our customer service representatives by providing real-time information such as weather conditions, seats available and upgrades. With this information available to customers, our CSRs have more time to focus on the boarding process."

The completion of EasyInfo is another step toward providing new automation to ease United's customers' passage through the airport environment with minimal interruption.

#### **United Cabins Go Cash-Free**



United expanded its popular cash-free cabin environments to a wider international market beginning September 2. As of that date, the company accepts only credit/debit cards as payment onboard flights between the United States and South America and trans-Atlantic destinations. Easy Purchase, the handheld devices flight attendants use to process debit/credit purchases onboard, has proven very successful since April, when United stopped accepting cash on flights within the United States, Canada, Mexico, Central America and the Caribbean.

With EasyPurchase, customers no longer have to produce exact change to buy food or beverages during flight. On international flights, with a higher likelihood of a variety of currencies onboard, it becomes even more critical to provide a more reliable purchase process.

"Our customers have told us they find it easier to use a card, and they appreciate the opportunity to earn additional bonus miles when using their Chase Mileage Plus credit card," said Stuart Benzal, managing director-Onboard Global Product. "In addition, EasyPurchase supplies a receipt, which is very important to our business customers."

"The technology behind EasyPurchase also provides us with a platform for future retail opportunities," said Alex Marren, SVP-Onboard Service. "We continue to look for ways to enhance our customers' flying experience by offering the products and services they value most."

#### A320 Ted -To-Mainline Conversions



The Ted-to-Mainline conversion project resumes on Wednesday, September 2, when the Airbus A320 with nose number 4852 rolls into Dock 2 at the San Francisco Maintenance Center for a four-day extreme makeover.

It was joined on September 4 by another A320 losing its Ted interior in favor of the popular new mainline cabin featuring leather seating and a United First(R) section. Over the next three-and-a-half months, there will be two aircraft modification lines running simultaneously, and each will complete another A320L every two to three days. The target

date to complete the 56<sup>th</sup> and final conversion is mid-December 2009.

The conversions started last spring but were suspended so that all available Airbus planes could be used during the busy summer season. In the first phase, all 18 planes were finished ahead of schedule. All the former Ted liveries were painted over with the new mainline colors by June.

The newly reconfigured A320L aircraft have been well received by United's customers. United Promoters (UP) scores for workability, cleanliness, and condition far surpass the scores for existing mainline A320s.

Also starting this month, the remaining Ted aircraft will be co-mingled in all cities across the network. All domestic stations may see a Ted interior flowing through until completion of the program in December.

Congratulations to everyone involved in the conversion project, which includes 22 departments. So far, it is on schedule and 10 million dollars under budget, says Patsy Di Domenico, senior project manager.

#### ZED Fares in Business & Economy on HA & LX





Swiss International Air Lines Swiss International and Hawaiian Airlines (via SEA) Now Offering ZED Fares to United Employees and Retirees

Effective September 10, United employees, travel eligibles and \*retirees\* will have access to Zonal Employee Discount (ZED) fares for pleasure travel in business and economy on Star Alliance partner Swiss International Air Lines.

This agreement for ZED low fares with the Basel, Switzerland-based carrier -- which serves 90 destinations in 42 countries -- significantly expands the number of destinations available for pleasure travel.

Swiss International is now United's first 100 percent e-ticket partner, eliminating all paper ticketing methods with the carrier for both customers and non-revenue, space-available (NRSA) travelers. The partnership also allows for groups of nine or more customers --including infants, groups and NRSA ID/ZED travelers -- to be ticketed electronically across any United/Swiss International itineraries.

United also recently launched a ZED medium-fare agreement for pleasure travel in business and economy with Hawaiian Airlines, which serves destinations within the Hawaiian Islands as well as to the Western United States and the South Pacific.

Over the past year, United's pleasure travel program for employees and retirees has more than doubled in size. ZED pricing is designed to simplify and significantly reduce the cost of NRSA interline pleasure travel. ZED fares are offered through an interline fare program used by many carriers worldwide for space-available travel, replacing industry discount (ID) 90/95 fares for interline travel on specific carriers.

#### **EASY DOES IT – Croque Monsieur (French Open-Face Sandwich)**



It's October. You'd like to have someone in for an easy and yet attractive lunch but don't have the time to prepare it? Yes, you do! This is a delish "topless" sandwich that I've been making for years. Having lived and worked in Bordeaux, France a few (ha!) years ago when I was 21, gave me some unexpected pleasures. One was learning that I was capable of doing more than just boiling water. Recently, while one of my friends was over for some lunch and camaraderie, I prepared this meal right in front of her ... both of us still able to enjoy our conversation. In other words, this is definitely not a recipe that needs your strict concentration.

To begin:

- So Preheat your oven to 400 degrees F. Preheat broiler, also.
- Place an English muffin half on top of the Swiss cheese slices. Using the muffin as a pattern, with a small sharp knife, cut around the edges. Then

chop only the scraps of cheese into small pieces and put aside. At the very end, you will use these pieces on top of your layered sandwich.

- ⋄ For each sandwich, layer as follows:
  - 1. Half of an English muffin, lightly toasted (in your toaster) and buttered
  - 2. 1 rounded-off slice of Swiss cheese
  - 3. 2 thin slices ham
  - 4. 1 rounded-off slice of Swiss cheese
  - 5. 1 slice of pineapple (drained)
  - 6. \*Swiss cheese pieces
  - 7. A fine dusting of paprika

Shake in oven 8 minutes, and then transfer briefly to broiler just to lightly brown. Be careful, this goes very fast. And now you're finished. Bon appétit!

(I suggest allowing 2 muffin halves, layered as shown above, per person. In other words, for two people, you would need to purchase a total of 2 English muffins, 8 slices of Swiss cheese, 8 thin slices of ham, and 4 pineapple slices.) If preparing for a man with a hearty appetite, you might make "another muffin's worth" of sandwich.

A nice fresh fruit salad (or use canned fruit cocktail in jello) on a bed of lettuce adds a nice touch. (If you'd prefer to make a Croque Madame, use sliced chicken instead of ham.)

#### **ASK THE DOCTOR – Treating Our Bodies**

A recent issue of Time magazine featured a cover story about the state of medicine in America. In many ways, it was not a very positive picture. The most glaring statistic, in my opinion, was the paltry amount of the health dollar devoted to preventive measures that are available to the general public. One could argue that most medical insurance policies cover medical expenses **after** a medical problem arises, not **before** they occur. However, many policies now offer coverage for expenses designed to detect medical problems **before** they occur. Now, you know why I chose the title for this article!

Medical schools do an excellent job of teaching prospective doctors how to evaluate the voluminous number of medical conditions that we can have. The schools spend hours teaching the symptoms, the findings, the evaluation, and the treatment of these conditions. While this is indeed an essential part of medical school training, I submit that much more time devoted to teaching **prevention** is critical. To coin a well-known phrase: It's too late to close the barn door after the horse has escaped. Detecting a medical problem in its infancy is far better than treating that same condition after it has become full-blown. Treat the molehill and the mountain never appears.

Since everyone is facing serious economic challenges during these difficult times, a most important question to ask is the cost of this early detection process. A *partial* list of preventive measures would include blood pressure, Pap smear, mammogram, PSA blood test, lipid blood testing, colonoscopy, stress echo cardiogram, ocular tonometry, Amsler grid screening, blood sugar level, and a good general physical examination. These tests and/or procedures do not come cheap. Further, some insurance policies may not cover all of them. BUT, what is the alternative? Whatever you have done, submit ALL invoices to your insurance company (obviously Medicare first). There may still be a sizable leftover cost for you. BUT, consider the cost of treating advanced heart disease or breast cancer or diabetes or glaucoma. For example, a colonoscopy may cost about \$2000 while lifetime care of a patient with colon cancer may cost in excess of \$100,000. Do the math. OR: It is better to be penny wise rather than pound foolish.

My entire medical career has focused on Prevention and/or Early Detection. Now, Time magazine has indicated we as a country must devote more medical funding to the area of medicine that I have practiced for over 40 years. Oh well, <u>Better late than never</u>. The editors have determined we must pay more attention to preserving and protecting our bodies, rather than taking heroic measures to save them from the jaws of death. **That is nothing new**. Prevention was, is, and always will be, the only way to lower health care costs nationally and personally. I learned that during my training. Now, Time presents it now as one of the main pillars of better medical care in the USA.


We can easily replace the oil, tires, belts, pumps, and brakes on our cars with **no** loss in performance or function. The replacement part works **just** as well as the original. Have you checked the warehouse of replacement human body parts? **None** of them work as well as the original. Some of our body parts have **no** replacements; e.g., the eye, the brain. Even for those parts that are available do **not** function like the original; e.g., knee joint. The bottom line is we have only **one** body that **must** last at least 75 years and **must** work 24/7 during that time. Are there any oil or water pumps that can function 24/7 for 75 years?

We as a country must treat our bodies as an irreplaceable heirloom. We must protect it. We must treat it with respect. We must cherish each body part that enables us to enjoy our spouses, our children, our grandchildren, our friends, and our UAL benefits and travel privileges. Further, we want our health to enjoy sunrises, sunsets, cool ocean breezes, crisp mountain air, and invigorating wind in our faces while surfing or skiing. If we devote more attention to the state of our bodies every day, we will not let molehills become mountains.

N.B. In the article I wrote about immunizations, I need to make a clarification. When getting any immunization from your medical provider, you will need to ask about insurance coverage. There may be certain restrictions about coverage that you should check before proceeding. This insurance restriction should NOT prevent you from obtaining the essential immunizations you need.

#### **Travel Tips by Bob**



In the last couple of weeks, there have been several incidents of problems with Companion Passes reported to me. I would like to suggest some preventive solutions:

Case #1 Mother - NRSA, and a grandchild on a companion pass. Use the sponsor file number to put both travelers in the same passenger name record. Do not make separate records unless the grandchild's companion pass is from another sponsors file number. If you make two records, you will have different Boarding priorities. If listing is done on SkyNet, then issue both boarding passes in SkyNet. If you need help with this, contact one of the Retiree Travel Desks and they will walk you through the process. Most of our Volunteers are familiar with SkyNet. Please **do not** go to "United.Com" to obtain a companion boarding card. Work the system through SkyNet and if you experience problems, contact one of the Retiree travel desks. Also present yourself early to the Gate Agent so they can

work to try to get you seated together, if possible. Do not wait for them to start boarding Standbys. A friendly "thank you" to the gate agent is always helpful. Remember these folks are under a lot of stress to get the trip out on time, with everyone on board in the proper sequential priority.

Another case - Two weeks ago, we received calls from some companion pass sponsors that their standbys were not being rolled over to the next flight, and were being sent back to the ticket counter to be listed. This could have been a communication problem since it was a very busy weekend with students and families with younger school kids. Nearly every flight being full plus they were trying to handle many NRSA folks. The message is, please let your companion friends know that they can use a credit card to enter an open kiosk computer. Students, generally speaking, are computer savvy and they can figure out how to list themselves. We older folks need to learn how it is done also.

A good policy is to make sure your companions know how to conduct themselves. And it's always wise to check the loads early so they can be informed of possible problems and how to handle a situation that may come up. We (retirees) the sponsors, are responsible to make sure our companions understand the system and again, if you need help call a Retiree travel desk.

Two final items, your retiree Travel Card is a valuable thing to have with you when you travel, as it has all the information about you and speeds you along faster with less entries. And a reminder: You must have your bags checked 45 minutes before departure; this is the cut off time.

Other social networking websites can also be valuable to ID thieves who are investing time and resources on social networks, according to writer Sid Kirchheimer in the AARP Bulletin for June 2009. Be careful of the information you place there. If you've put names and photographs of your spouse, children, grandchildren, aunts, uncles, friends, where you went to high school, college, etc. ... you've made it easy for these "socially alert" thieves to act. Do you know ID thieves can even change your password? Be suspicious of anyone, even a "friend" (it might not be) who asks for money over the Internet.

Regarding your personal checks and check fraud: Thieves can take a check out of your mailbox and, leaving the line with your hand-written signature outside, soak it for 3 minutes in a bath of acetone. It takes 20 seconds to dry, then blow on it for another 20 seconds. The check is now ready to accept a new date, addressee and amount. (Your professionally printed name, address and check number remain on.) OK, so I just tried "the bath" and it works! Do you know what acetone is, Ladies? It's your nail polish remover! Through my years of employment, I met the president of United Airlines, William Patterson and some others who followed him. I also met a few celebrities, like Bob Hope. After 8 years with United I was promoted to Station Manager at Bend-Redmond Oregon. The airport there, constructed during World War II, was 7,000 feet and paved.
