RUAEA Centenarian ~ 102-year-old Volunteer
Recognized for Unprecedented Years of Service
We wish Harold Weary a very
Happy 103<sup>rd</sup> Birthday on October 7<sup>th</sup>!

Mount Prospect, IL – On June 15, a small reception was held to honor **Harold Weary** with the Mount Prospect Public Library's Founders' Award. The event was kicked off by State Representative David Harris, who grew up in Mount Prospect. He surprised Mr. Weary with a certificate of recognition that he introduced to the House of Representatives. Harris told Mr. Weary, "your incredible record of over 40 years and 10,000 hours of service to the Library will not be surpassed any time soon or in the foreseeable future."

The presentation by Harris was followed by the Founders' Award proclamation read by Jane Everett, MPPL Board President. The Award, established in 1990 by the Library's Board of Trustees, honors an individual, group, or organization that has provided exceptional support to the Library. Mr. Weary was selected because he exemplifies the type of leadership, dedication, and efforts exhibited by the original group of women who, in 1943 seeing the need for a community library, worked to establish the Mount Prospect Public Library.

"Harold Weary has always supported the Library in a real and tangible way. Harold, you are truly a gift to this library, always ready to work a raffle table, ride a float, or crunch some numbers," added Everett, after reading the proclamation. For 42 years, Mr. Weary has supported the Library with his financial expertise and his commitment to fundraising. At 102 years old, he has logged over 10,000 hours reviewing budgets, drafting tax levies and appropriation requests, analyzing cash flow, campaigning for Library referendums, helping to establish the Library's Foundation, and selling raffle tickets.

Mr. Weary has made a second career of volunteerism. Since retiring from his position in the comptroller's office at United Airlines in 1968, he has spent more of his adult life volunteering at the Library than he did working for Drovers Journal Publishing (7 years) and United Airlines (31 years), combined.

"I owe a big debt to John Parsons and my wife Irene for introducing me to the Library," noted Mr. Weary. "I have had more than 40 years of enjoyable contact with some of the greatest people I have ever worked with. I have seen this Library grow from a few hundred volumes in a small house to the magnificent Library we have here today. I am honored and grateful for this award"

The presentation took place in the Harold Weary Genealogy and Local History Room at the Library. This room was dedicated to Mr. Weary in 1988 who, then 80 years old, had already been volunteering at the Library for 20 years. Mr. Weary has a special place in his heart for both genealogy and local history. He was one of the organizers of the Northwest Suburban Council of Genealogists, serving as its first president, and a longtime director of the Mount Prospect Historical Society. He has done extensive research on his own family's history and mentored many others interested in tracing their roots.

The Founders' Award has been given out on 8 occasions over the last 21 years, honoring a total of 16 individuals as well as the original 1943 Library board. A plaque honoring the recipients hangs in the Library outside its two main meeting rooms.

#### **Letter From The President**



As the merger of United and Continental, reportedly a merger of equals has moved forward, it is apparent that it really is a takeover by Continental but keeping the name of United. Continental Airlines has, and had, little regard for its retirees. Now that culture has permeated the new United Airlines, since most of the new management is from Continental Airlines. Over the past ten years, United and its

retirees had a good relationship and on many occasions, the retirees were able to help the company with grass roots efforts with the likes of new international routes. legislation that might be detrimental to the company and many volunteer opportunities. The new management apparently sees no need for such support in the future as they denigrate the retiree community. The new management knew they had a problem with two very different pass travel programs. They disbanded a successful advisory committee and issued a highly slanted survey. Thousands were excluded from the survey because they either did not have a computer or were not proficient enough to use one for this purpose. Even so, close to 80,000 employees/retirees responded and a very high percentage claimed they were satisfied with their current program. In spite of that, substantial changes were made to the detriment of retirees. Now with the new program to go into effect, thousands again will be left in the dark. Why, because the only way an employee or retiree can find the details is via the internet, specifically Skynet or whatever the new website will be called.

The Director of Employee Pass Travel, Laura Motelet, to her credit, has tried to answer the multitude of questions and concerns about the new pass travel policy. A lot of the answers are simply to support what the survey told the company. We are told that retirees only make a couple a trips per year on average, so that is why there are only eight one-way vacation passes. Also, they say not many retirees use the companion/buddy passes. But the answer as why retirees will not get these passes is that these passes would cost the company money. If that is the case why do 80,000 co-workers get them? Lately the responses have been we should be glad we are getting what has been announced. We should also be excited about all the new routes that will be available. The new policy will go into effect in phases between January and March 2012. No specifics as of yet ... check Skynet!

We have also been told that any further discussion on this issue will be fruitless. Donna Towle, VP-HR Employee Relations, began what was to be a quarterly gathering of the leaders of the different retiree organizations, RUAEA, RUPA, RAFA, Clipped Wings, ARECA and the Golden Penguins. There have been two gatherings and another was scheduled for October. After we questioned the tone and substance of the responses from Laura, the next gathering has been postponed until after the first of the year. Again, we have been told that no further discussion about pass travel is necessary! But the good news is RUAEA, RUPA, RAFA and Clipped Wings have forged a closer relationship that should work well for the future.

So where are we? Several months ago, an anonymous group calling themselves, United Retirees for Action, circulated an online petition that reportedly was given to Mr. Smisek at a meeting in Washington. That group has been rather silent until just recently. Dale

Whitaker, a retiree living in Colorado, has filed an age discrimination complaint to the company and the EEOC. Now a Herbert Woods has developed a website <a href="https://www.unitedretired.com">www.unitedretired.com</a> where he is encouraging retirees to join in the complaint. Just to clarify ... this is a complaint, not a lawsuit. RUAEA's position on this complaint is neutral. We believe that it is up to each retiree to decide what course of action to take. During the bankruptcy, it was determined that RUAEA has no legal standing to represent all retires in such actions. Lastly, there was an article in the Denver Post on Labor Day, highlighting retiree frustration with the new pass policy. This may not make any difference but certainly it is not good PR for the company.

On another issue, for several years RUAEA has been fortunate to have the company provide us with the names and addresses of new retirees on a quarterly basis. We had to sign off on documents that this data would only be used to solicit membership in RUAEA as well as the local chapters. We have stayed faithful to that agreement. Continental retiree organizations were not as fortunate. Now with the new management, that agreement has been terminated. We have been told that the new retirement packages will have information about RUAEA and the other retiree organizations.

One more comment on Medical Insurance. As mentioned last month, the company is required to offer medical insurance to all that retired prior to July 1, 2003. Questions about medical insurance came up at the Portland Convention. We were told at that time that there were to be no changes for 2012 but they could not or would not comment on 2013 and beyond.

Finally, I want to speak about dues. A few years ago we raised our annual dues to \$25.00. That comes to about seven cents a day. For that money you have an excellent website and an excellent monthly newsletter with loads of information, reports from local chapters and letters from members. The newsletter is a great way to stay in touch with what is happening, not only in the company, but with fellow workers from the past. Compared with other retiree organizations, our dues are low; others have dues as much as \$50.00 annually. RUAEA is very fortunate that several members send in contributions over and above their annual dues. Many life-time members contribute and we want to thank all of you that do choose to make such contributions.

In closing, RUAEA is making every effort to keep the benefits we have from United and to make improvements. We want to thank all who continue to support us in these difficult times. Your emails and phone calls are appreciated.

#### **UA** and **CO** combine flight schedules to make pass travel planning easier



Co-workers, retirees and early-out participants can view all of their pass travel flying options in one location through combined UA and CO flight schedules now available

in employeeRES.

In addition to the combined schedule, you will continue to see passenger booking totals (PBTs) and the number of space-available pass riders listed, so you can make informed decisions about your pass travel plans.

The combined schedule is an interim step until UA introduces its integrated Pass Travel program, which will coincide with its single Passenger Service System (PSS) starting next March. (See United Daily - Aug. 11, 2011, for information about PSS.) employeeRES will serve as the foundation for booking pass travel in 2012. You can continue to use WebList during this transition.

To access the combined flight schedules, go to the employeeRES link available under Travel Tools on the Flying Together home page. You also will find questions and answers and other information under ePass News and Announcements on employeeRES.

#### Co-workers can purchase interline tickets on JetBlue



UA and CO co-workers and their eligible pass riders can take advantage of United's first inte-AIRWAYS grated Zonal Employee Discount (ZED) interline

pass travel agreement with JetBlue Airways (B6). Travel is offered in economy class at the low-fare level (ZL). The agreement covers active co-workers who have completed six months of service, eligible retirees, spouses or registered domestic partners, parents and dependent children up through age 18 (or through age 23 if they are full-time students).

These eligible pass riders of both subsidiaries may buy B6 tickets at CO ticket counters, including staff travel offices at IAH, CLE and EWR. UA continues to issue all other interline paper tickets at self-ticketing stations or UA-operated ticket counters. You can create B6 listings and view more information by going to employeeRES on Flying Together or Insidecoair. Select the B6 Online Listing Tool under ePass News and Announcements. Here, you'll access the myIDTravel tool to make a B6 reservation. All separate UA and CO interline pass travel agreements with other airlines remain in place until further notice.

#### Hawaiian, Frontier now offer **ZED** eTicketing for co-workers



UA is introducing Zonal Employee Discount (ZED) eTicketing with Hawaiian (HA) and Frontier (F9) airlines for all eligible UA and CO coworkers, retirees and pass riders.

Eligible pass riders will

be able to buy electronic ZED tickets on HA or F9 for a small processing charge per segment through the ID90T website. All co-workers will be able to access the ID90T site through employeeRES under ePass News and Announcements. employeeRES is available under Travel Tools on the Flying Together homepage.

HA and F9 provide paperless ticketing and no longer will issue paper tickets.

#### iPads enable paperless flight deck



UA announced August 23<sup>rd</sup>, that, by the end of the year, all pilots will have electronic flight bags - iPads that replace paper flight manuals. UA will be the first in the airline

industry with paperless aeronautical navigational charts through an iPad app - Jeppesen Mobile FliteDeck, featuring interactive, data-driven en route navigation information and worldwide geo-referenced terminal charts.

Each iPad, which weighs less than 1.5 pounds, will replace approximately 38 pounds of paper operating manuals, navigation charts, reference handbooks, flight checklists, logbooks and weather information.

"A typical flight bag full of paper has about 12,000 pieces of paper," noted Technology and Flight Test Managing Director Joe Burns. "We expect this will save about 16 million sheets of paper and 326,000 gallons of jet fuel a year."

#### IR department voted best in industry



Institutional Investor magazine recently named United Continental Holdings as having the Best Investor Relations (IR) organization among airlines in their 2011 Investor Perception Study.

Wall Street's top buy-side and sell-

side analysts rated IR organizations on criteria including access to senior management, responsiveness, credibility and candor of IR team, and transparency of financial reporting to determine best in class.

"We're excited to be recognized by the analyst community for all the work the team has done," said Investor Relations Managing Director Tyler Reddien. "The recognition is especially meaningful as we progressed from the merger announcement to transaction close and now through integration."

### Media, customers, co-workers respond to product investment announcement



UA's announcement that the company is investing more than \$550 million to improve its onboard product immediately generated worldwide media coverage and an outpouring of

comments from co-workers and customers on sites such as <u>flyertalk.com</u>.

In Denver August 21, Jeff spoke about UA's investment plans at the annual meeting of the Global Business Travel Association, a large convention of business travel managers. See the Employee Bulletin on Flying Together for more information. Jeff's presentation received major coverage in traditional media including the Associated Press, the Chicago Sun-Times, the Chicago Tribune, the Denver Post, the Houston Business Journal, the Houston Chronicle, the Newark Star-Ledger, Reuters and the Wall Street Journal.

Most articles focused on the announcements of additional lie-flat seating, larger overhead bins and Channel 9. Many reiterated UA's previously announced decision to add Economy Plus seating to the mainline fleet but focused on the new details such as the addition of Economy Plus to the Bombardier O400 fleet. Customer Service Representative Greg Tucker in Tampa (TPA), FL, a 24-year veteran, said the news was welcome as UA approaches the one-year anniversary of its merger closing. "It's important to have a consistent product," Tucker said. "This has been a big concern on the front line, because of the issues caused when we have aircraft substitutions." On Facebook, Twitter and FlyerTalk, there were hundreds of postings within hours of the announcement. "It looks like to me that someone at United has been listening to their customers, and responding," one FlyerTalk member posted. wrote, "If this is a sign of things to come, the frequent flyer program will turn out all right." And another commented, "These improvements are positive indeed, and hope it will carry over to soft products such as inflight meals and service."

On all three, posters overwhelmingly praised the planned expansion of Channel 9 availability.

#### **UA launched United app for Android**



Android users can now download the United app on their mobile devices to book reservations, check in and access mobile boarding passes with a single touch.

The app offers time-saving access to information travelers need, as well as other useful tools such as interactive airport smart maps and flight updates. Additional features include flight status details and access to MileagePlus and OnePass accounts.

As with the iPhone app launched in July, when flying on a pass travel reservation, co-workers who successfully complete check in using their confirmation number can view their location on standby lists. Currently, co-workers flying on CO pass travel reservations or CO and UA revenue flights may check in with the app. The app will direct co-workers flying on a UA pass travel reservation to the <u>mobile.united.com</u> page to check in. UA is developing future enhancements of the app for co-workers.

"We received lots of positive user feedback on the iPhone app," said Self-Service and Emerging Technology Managing Director Jared Miller. "Users especially appreciate the ability to see upgrade standby lists and quick access to paperless boarding passes. We expect the same success with the Android version."

The Android app, similar to the iPhone app, incorporates functionality for both UA and CO and will eventually replace the Continental app currently available in the Android marketplace.

#### United, AFA to try expedited mediation



United and the Association of Flight Attendants (AFA) have agreed on a new expedited mediation process modeled on the National Mediation Board's Expedited Media-

tion Program. The company and the AFA will start an intense mediation focusing on limited issues. The negotiations will aim to reach agreement for a new contract covering approximately 12,000 flight attendants working at the UA subsidiary. An agreement is already in effect covering flight attendants at the CO subsidiary.



#### **UA** will return to negotiations with IBT



United and the International Brother-hood of Teamsters (IBT) have agreed to return to negotiations in advance of mediation scheduled with the National Mediation Board in November.

During these negotiations, the company and IBT will focus on reaching an agreement covering the approxi-

mately 4,700 technicians at the UA subsidiary.

UA and CO employ more than 8,300 technicians represented by IBT. CO technicians ratified their collective bargaining agreement in November 2010.

#### Ramp and fleet service co-workers elect IAM



The National Mediation Board (NMB) announced on August 11<sup>th</sup>, that UA's ramp service and fleet service co-workers have elected the International Association of Machinists

and Aerospace Workers (IAM) to represent them.

UA has a longstanding relationship with the International Association of Machinists, and the company looks forward to focusing on collectively reaching agreements that facilitate its integration.

Of 14,039 eligible employees, 5,568 voted for IAM and 5,257 voted for the International Brotherhood of Teamsters (IBT).

#### UA's newest Boeing 737 made delivery flight



UA welcomed the latest addition to its fleet on August 18<sup>th</sup>, a Boeing 737-800 with the new Boeing Sky Interior. This is UA's last of four Boeing deliveries for 2011,

and seventh since the merger closed. The company will add another 26 new Boeing airplanes by the end of 2012 as part of its fleet renewal program.

This 160-seat aircraft is equipped with a performance improvement package (PIP) that will reduce fuel burn by up to 2 percent. The plane is also notable in that it rolled off the assembly line more than 10 months ago and was used by Boeing's flight test group to test and validate the PIP package. Fleet VP Ron Baur said UA adjusted its delivery schedule so Boeing could use the 737 for PIP testing.

"Our ongoing participation with our partners in efforts to improve performance and reduce fuel consumption makes good business sense," Ron said.

Domestic Scheduling Managing Director Ted Phillips said the 737-800 gives UA efficient coverage on a wide range of routes in a cabin many customers prefer. "The versatility of this aircraft allows us to fly it on most domestic missions with ease," Ted said. "This includes trans-cons, flights between the U.S. and the Caribbean and Mexico, and from the West Coast to Hawaii."

All co-workers may now share in the excitement of the Boeing 737- 800 delivery, through a four-minute video. Look for it at "Video Updates" on the right-hand side of the Flying Together home page - and watch for additional videos in the future. The video, produced by UA's Creative Services department, features many of the co-workers who took part in the delivery flight from Boeing Field near Seattle to ORD.

# Focus On United Hubs No. 1 positions in hub markets give United a key competitive advantage



Being the No. 1 carrier in United's hub markets is one of its key competitive advantages. United will continue to hold those positions even as the company adjusts capacity in

response to the price and volatility of fuel.

In DEN, for example, United serves 120 cities compared to Frontier's 61 and 47 offered by Southwest. In total, United has 418 average daily departures and 36,867 daily seats in the third quarter.

Even though its year-over-year average departures are down by 2 percent in DEN, United remains the clear leader and provides more options for its customers.

New service from DEN includes Texas destinations such as Amarillo (AMA), Dallas (DFW) and Lubbock (LBB) and new international flights to Mexico City (MEX). UA also will return service to Anchorage (ANC), Alaska, and Lihue (LIH), Hawaii, in December.

"We offer almost three times more flights, more seats and more cities than any other carrier out of Denver," said Hub Managing Director Steve Jaquith. "Our co-workers take great pride in being number one in Denver."

From an operational performance standpoint, DEN has been one of UA's leading hubs in 2011 year to date. DEN has achieved 100 percent in the daily STAR D:00 metric 40 percent of the time this year. Here is how UA stacks up against its competition in DEN:

#### More than just fun and sun at LAX



United has hubs that serve the four largest cities in the United States; it is the only airline that can make that claim. Co-workers at Los Angeles Interna-

tional Airport (LAX) are proud of that and of representing United in the second-largest city in America

Home to many of the world's most popular superstars, Los Angeles is surrounded by mountains, desert and the vast Pacific Ocean. The LAX Theme Building is one of the most recognizable airport buildings in the world and is home to the Encounter Restaurant. Beautiful scenery and famous architecture, though, are not all that wow customers in Southern California every day

United has more than 3,500 co-workers at LAX, and many of them have been working for the company for more than 20 years. It is a senior station that prides itself on great on-time numbers, fantastic service and veteran leadership.

LAX handles nearly 60 million passengers every year, and, with our regional flying partners, we offer 213 departures per day to more than 65 destinations out of three terminals (Terminals 6, 7 and 8).

"People from all over the world come through LAX every day, and I know we are all proud of where we can

take our customers," said Customer Service Director Fred Carter. "This airport is like a small city, and we all have to take care of each other. We're like a big family, and with the merger in full swing that family is getting bigger."

LAX is also home to United pilot and flight attendant bases. There is an expansive maintenance facility at the airport, and United Cargo serves Los Angeles, one of the world's premier economic centers.

"I love it here, and I know most of my co-workers feel the same way," said LAX General Manager Mike Hanna. "When our customers fly United to, through or from LAX, we strive to make sure they want to do so again and again."

Did You Know?

- ▲ LAX is the only airport with a hit song. "LA International Airport," written by Leanne Scott, first recorded by David Frizzell in 1970.

#### Alaska to increase frequency to Hawaii



Alaska Airlines (AS) announced it will offer daily service from Oakland (OAK) and San Jose (SJC), Calif., to Kona (KOA) and Lihue (LIH), Hawaii, starting next March 12.

AS now operates those routes with three to four flights a week, in addition to daily non-

stop from both OAK and SJC to Kahului (OGG) on the island of Maui.

United already serves all three of those Hawaiian airports, as well as Honolulu (HNL), with multiple daily nonstops from our hub in SFO and at least one daily flight to each from LAX



#### Ask The Doctor - The Most Dangerous Drug of Abuse In the World Today (Part IV)

To date, we have described the most dangerous drug, Alcohol. We have described who the alcoholic is. We have described the process of Intervention. Now, we must address the evaluation and treatment. This process is by no means an easy one given the current state of medical insurance coverage. I will try to cover the alternatives and outcomes as I see them and let

you reach your own conclusions. Treatment options are Outpatient, Intensive Outpatient, Inpatient, and Extended Inpatient. All of these programs have their pros and cons. As you might guess, Outpatient is the cheapest for insurance, and Extended Inpatient is the most expensive. It is somewhat of an art to pick the right program for each patient. One thing is certain, the patient's situation should determine the choice of treatment. On many occasions, the insurance coverage dictates the treatment program rather than the patient. For example, many insurance plans **insist** on outpatient treatment as the initial program despite the state of the patient's level of addiction. The choice of program should always depend on the extent of the addiction and determined by the addiction specialist/EAP coordinator/facilitator/ personal medical provider. This decision always precedes the actual intervention and arrangements are made well in advance of the intervention.

Outpatient (OP): As the name implies, the patient attends meetings, classes, lectures, etc. for a few hours each day except weekends. These sessions are in the mornings, afternoons, or evenings, so that the patient can schedule their attendance to permit them to work and stay at home. Typically, the sessions last for 4-8weeks. In addition, the patient must attend Alcoholics Anonymous (AA) meetings in the area where they live. This program keeps the patient in touch with his/her family and keeps them in intimate contact with the recovery process. However, if there are strained family relationships, this may not be as effective. If there have been problems at work, the employer may not be cooperative in arranging attendance at the treatment sessions. Because of the low cost, the patient can remain in treatment for a much longer time. The longer treatment may be necessary and useful.

**Intensive Outpatient (IOP)**: This treatment program requires attendance at therapy meetings all day for 5+ days a week. There are random breath alcohol tests and urine drug tests. The family involvement is the same, only more intense. This program is more intense because the patient is sicker and needs the "intensity" of

a full day of care. The cost is higher, the duration is usually longer. Whether the patient gets OP or IOP is a clinical judgment decision made at the time of the intake evaluation by the treatment staff team. All of the other OP modalities of care apply here as well. The patient in this kind of program is in bigger trouble with addiction, thus the need to be more "intense".

**Inpatient (IP)**: This treatment program requires actual admission to a treatment facility similar to any hospitalization. However, there are no TV or phones or cell phones in the patient's room. There are only two patients per room, and every patient has chores on the unit (emptying trash cans, cleaning rest rooms, to name a few). The patients are not segregated by age, sex, choice of drug, or duration of use. All of the patients have deep addiction issues including legal or medical or social or family problems of very significant magnitude. All of the modalities of OP or IOP treatment receive much more intense attention in this treatment program. The meetings with the patients can be very confrontational because the addictions are very deep-seeded and difficult to overcome. To hear older patients confront younger patients, alcoholics confront drug users, women confront men, etc. is very difficult but very therapeutic. The cost is high, in excess of \$30,000 per month at many facilities. Most of the treatment facilities are free standing (not inside an existing hospital). Some of the more famous examples include Hazelton in Minnesota and the Betty Ford Center in California.

**Extended Inpatient (EIP)**: If this program is necessary, the addict is in an extremely dangerous state. For this program, the addict remains in treatment for up to six months. It is usually the treatment for addicts who have relapsed or whose addiction has not responded to any of the other treatment programs. The providers have a real challenge with patients in this category because these addicts know all the tricks of the trade. Manipulating, blaming others, smuggling, outright lying, and any other behavioral maneuver you can imagine are the norm. Addicts in this phase of care are usually very familiar with the protocols used, know the language, know what to say and when to say it, and are skilled in knowing what the counselors want to hear. In this program, the providers usually have to probe and delve into the barriers the addict has erected and break them down slowly and completely. This process is not easy, it can be very frustrating, and requires a huge investment of time and patience from the providers. The addicts in this phase of care are in huge denial, often have medical complications, and are very ill. Addicts in this phase of care are often at the brink of disaster – jail, suicide, organ failure, psychiatric hospitalization. Or, they can achieve a stable recovery. This phase is, by far, the most expensive, and quite honestly is the last chance.

Staffing for all these forms of treatment consists of recovering addicts as counselors, social workers, licensed psychologists, family counselors, psychiatrists, and medical physicians. All of these providers have chosen to specialize in the evaluation and treatment of addicts, whether alcoholics or drug (illegal or legal) users. The team approach to treatment has proven to be the most successful for long term recovery. This formula of evaluation and treatment has been the standard of care for about 35 – 40 years. Notwithstanding the TV shows with Dr. Drew, these treatment programs have a very good record of success. Introducing celebrating patients into the mix makes for good TV and for ratings, but is not the usual manner or outcome in which treatment programs operate or conduct their programs.

Now, the patient who is the addict has had an intervention, the appropriate evaluation and treatment, and is ready for the next phase of treatment. As difficult as this may seem, the next phase is the most difficult and is the phase **most** likely to fail.

We call this phase Aftercare and living a "normal" life. By far, this is where **all** of the treatment pays off, **or** the addict relapses. The treatment may have only lasted 30+ days, but the Aftercare and Recovery must last a lifetime. That is the challenge.
