Being an outdoor person from Wisconsin, I enjoyed growing up with all of the things we could do. On Saturdays, before I could go out and do whatever I wanted, I had to carry buckets of water from the pump outside, up the back stairs, across the back porch and down the stairs to the basement, where I filled a boiler on the stove plus two tubs full. These tubs were what my mother used to wash our clothes with a metal washboard. For this chore my mother would give me a dime.

After this I would canvas the neighborhood to see if anyone needed anything done. One time I did some work for an older gentleman and he gave me an old rifle, a 22 Savage. I took it home and cleaned it up. I learned to hunt squirrels, which I would take home and clean them; then my mother would fry them for supper.

This rifle was much better to hunt with than the "slingshot" I had been using.

Growing up in the "Depression Era", you learned to do a lot of different things. Back then though, going to a movie and popcorn cost 5 cents each. You could have a real good time for a quarter.

Something else we did to get spending money on Saturdays was to canvas the alleys for aluminum, copper and brass. If we found any, we would take it to the junk man; he would weigh them and we would get about a dollar. We would split this three ways; so each of us had enough for a movie with popcorn and even had money enough left to buy a wind up race car from the dime store. Now days, kids have their own cell phones and video players with different games to play.

My career with United started the first part of June, 1953. My wife and I went to San Francisco on our honeymoon. While there I saw an ad that United was hiring, so I went on a Friday, took a test and started my training on the next Monday.

There have been many changes in the airline business since I first started in San Francisco. Back then each airline had its own area and building. United had four gates and all of the planes then were DC 3's, DC 4's and DC 6's. We had passenger stands for the DC 3's, and would have to help the passenger agent push the stand up to the door of the plane. They would then go up and open the door so the passengers could get off. The baggage and cargo was loaded onto metal 3 wheeled carts and taken to the side of the terminal, where it was claimed.

After the outbound flight was loaded, one of us would go to the Load Planner and get a slip of paper, which we put into the rubber end of a metal pole. Then we would hand it up to the cockpit window; this was the information about the number of passengers on board, plus the weight of the luggage and cargo, the pilots needed for flying the next trip.

We saw a lot of people during the day coming and going. We would see celebrities and then tell everyone we could. One day, we saw people getting off of a flight from Vancouver, BC on its way to Los Angeles. While we were unloading it, we noticed a gal being taken down the stairs in a wheelchair. We saw two guys come down the stairs to help the agent with the wheelchair. The gal in the wheelchair was Marilyn Monroe and the guys were Robert Mitchum and Joe DiMaggio who were accompanying her. We heard later that Ms. Monroe had broken her ankle while in Canada filming the movie, "River of No Return". So this was a good day; you never knew what could happen each day when you went to work. It was never a dull job.

When United moved over to the new terminal, we had more crews then because we now had 6 gates to take care of. It was much different then because they

had us working one week on the Ramp, loading and unloading bags and cargo, another week we would be on the "food run", where we picked up the metal containers of trays and food to put on the planes for the next flight. If the flight was an inbound one, we would take off the empty containers and take them back to the kitchen. Then another week, we were in the baggage room under the main terminal. All of the bags were coded with the flight number and destination city code, such as LAX was Los Angeles, SEA was Seattle, NYC was New York City and so on. This was done so that luggage would not be sent to a wrong destination. It did happen a few times. We heard of one bag coded for CAN (Canton, Ohio) that ended up in Canton, China. We couldn't believe it.

For the inbound baggage, it was loaded onto a conveyor belt; the baggage runner would pull it off of this according to the flight number and then take them to the claim area. One day while on a Cargo run, I saw a guy in uniform; as I got closer I recognized John Wayne. When I told the others about this they said they were filming some clips inside an airplane for the movie "The High and The Mighty". I later saw it on TV; it was about a flight from Honolulu to San Francisco, during a severe rainstorm. Robert Stack was the pilot and John Wayne was his co-pilot.

Later when we got the new DC 7's, I got to work the first nonstop flight from SFO to NYC and under 8 hours. For this flight, we had to put down a red carpet. I was getting ready to load bags when the runner came out with a cart full of all white luggages. He told me that it all had to be loaded upstairs because it had to be kept clean. When I got them all loaded and secured, the passenger door opened and a lady appeared. The captain told her to go back to her seat everything was taken care of. I asked him, "*Who was that?*" He said "*that was Marlene Dietrich checking on her luggage.*"

One never knew what was going to happen on flights that came and went. On another flight that came in and after we had unloaded it, I saw that canvas was being put down below the passenger stand. A short time later we saw Carl Malden and Michael Douglas at the top of the stairs. We went out to see what was going on, and were told to stand back because they were filming a segment for the TV series "The Streets of San Francisco".

Later, of course, came the DC 8's and the 727's. The DC 8's had their own jet ways which had to be moved up to the planes for unloading. This was another job that I was trained for; it was scary at first but better when you got the hang of it. On one flight, I moved the jet way into position and opened the plane door. Out came a guy who bumped into me; I said "*Excuse me*"; he said "*Do you know who I am?*" I replied, "*No, Do you know who I am?*", and then he was gone. I asked



the stewardess later, “*Who was that joker?*” She told me he was a state congressman who was late for a meeting in San Francisco.

A funny episode I remember: One day when we were coming out of the baggage room, a PAM driver swerved his cart to miss us. When he did the contents of the cart dumped out. It contained birds in cages; some of them fell onto the ramp and opened. A canary landed by my feet; I picked it up and started to give it to the cart driver but he was gone. So I put it in my pocket and took it home. We had that bird for years. Those were the good old days!

I think the best thing working for United, was that we were able to travel in the summer to different places. My wife was a school teacher and had summers off. One time we went to Disney Land, outside of Los Angeles. Then we got on a flight to New York City where we saw the Statue of Liberty; another trip was to Boston where we saw the house where Paul Revere started his famous ride.

I also got to hunt in several places. One trip I flew to Salt Lake City to hunt deer with a friend; another trip was to Denver to hunt elk. I was lucky on this trip and bagged a 6 point bull.

The frosting on the cake for me was when I was able to fly to Africa and go on a safari hunt. I bagged 5 antelopes and three of them were big enough to be entered into the African Record Books.

### **Annual Benefits Enrollment**



The 2013 Annual Benefits Enrollment is coming soon. Based on feedback, United will provide two separate enrollment periods to better serve retirees and active co-workers. The enrollment period for retirees is October 24 - November 9, and for ac-

tive co-workers October 1 - 23. This will help distribute call volume to the United Airlines Benefits Center so participants receive timely and knowledgeable assistance while selecting benefits. This is your opportunity to view benefit options and make elections that are effective January 1, 2013.

Here are a few highlights:

- ➔ Dates for enrollment are earlier than last year, allowing benefit-eligible participants to compare benefit options with their spouses or domestic partners and ensuring medical ID cards arrive before year-end.
- ➔ Plan costs and details will be available online on the Your Benefits Resources site. However,

retirees will continue to receive their worksheets and annual enrollment guides via mail.

- ➔ Dependent Certification is now a part of this year’s enrollment process. This annual process involves confirming dependent relationships and their eligibility for benefits. Certification will be completed with just one click via Your Benefits Resources, at the “complete enrollment” step of the election process. Co-workers and retirees who do not complete enrollment during the enrollment period will be required to certify dependents at the start of 2013.

### **PBGC to correct UAL pension payments**



Last November, the Pension Benefit Guaranty Corporation (PBGC) issued a report describing errors in the way the agency valued assets in retirement plans it assumed from United during its bankruptcy.

PBGC did the calculations more carefully and found that it had slightly undervalued the UAL pension assets, resulting in small underpayments to fewer than one in five retirees.

### **United invests \$15 million in new ground service equipment**



Supporting the 2012 Go Forward Plan, United has allocated funding and placed orders for an investment of nearly \$15 million in ground service equipment (GSE) supporting

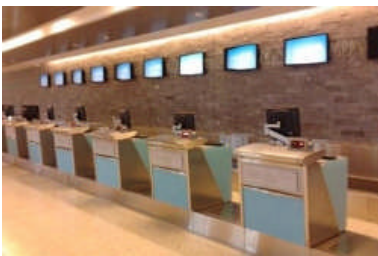
both Airport Operations and Technical Operations. This 2012 investment is part of UAL's objective to establish and maintain a GSE program that is safe, optimized, reliable and supportive of its co-workers.

For Airport Operations, \$6 million of the funding includes towbar-less tractors for BOS (Boston), IAH and LAX; cargo tractors for IAD; container dollies; replacement vans and pick-ups for a number of stations throughout the system; and equipment unique to the Boeing 787. United will spend nearly \$3 million on the deicer fleet to address reliability for the 2012-2013 deicing season.

UAL is also making another \$6 million investment to acquire more than 100 new GSE vehicles for Technical Operations.

Airport Operations and Technical Operations have been working in partnership throughout 2012 to define and develop a GSE replacement strategy that will ensure co-workers have safe and effective tools. As part of that strategy, responsibility for all planning and maintenance support for ground equipment and related facilities will move effective September 1 into a single organization under the leadership of Supply Chain Managing Director Mike Lorenzini.

### **LAS co-workers move to Terminal 3 lobby**



Despite thunderstorms in the area and three diversions, co-workers at LAS (Las Vegas) had a great day on August 22, as they enjoyed their brand-new ticket counter and

lobby operations in Terminal 3. The team relocated from Terminal 1 to a much larger space in the newly constructed Terminal 3.

Terminal 3 opened at the end of June to help ease congestion in the lobby. United's gates will remain in the D concourse.

### **Please pardon the dust at At ORD**



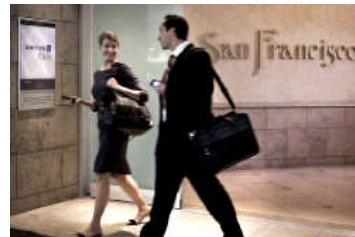
The loading bridge project in Terminal 2 at ORD is under way and will increase the number of passenger loading bridge gates by 10, improving the boarding and de-planing experience for United's

customers. Check out the new loading bridges at gates F12A and F12B; gates F12C and F12D should be ready for operation by mid-September.

Keep an eye out for the new in-line baggage screening facility under the existing B-South checkpoint that should open by third-quarter 2012, subject to TSA certification of the system.

Finally, UAL plans to complete the first new United Club by the end of this year, and the company will use it as the architectural standard for future club projects. Look for this spacious, 12,500-square-foot club on the concourse and mezzanine level of Terminal 2.

### **September schedule to ease gate constraints at SFO**



Since United began using gates in Terminal 1 in June at SFO to augment its operation in Terminal 3 and the International Terminal, customers and co-workers have transferred between terminals

via airside bus links. Soon United Express will operate more than 100 flights from Terminal 1, freeing up gate space in Terminal 3 and reducing peak passenger loads on the buses.

These changes will allow United to more than double the number of flights operating at Terminal 1, reducing aircraft taxi time and gate waits at Terminal 3 for its arriving and connecting customers and crews.

Hub Managing Director Mike Hanna said that the changes in the September schedule that move the majority of United Express flying into one terminal will result in a more constant flow of smaller numbers of customers deplaning from regional jets.

### **Space shuttle Endeavour to visit LAX**

This fall, United's massive hangar at LAX will house the space shuttle Endeavour while engineers work for several weeks to prepare it for the two-day, 12-mile journey to its new home at the California Science Center (CSC). CSC President Jeffrey Rudolph announced details of "Mission 26: The Big Endeavour" in Los Ange-



les, along with LA Mayor Antonio Villaraigosa and Inglewood Mayor James Butts.

NASA's Boeing 747 Shuttle Carrier Aircraft will fly Endeavour to LAX mid-

day on September 20, depending on weather conditions at the Kennedy Space Center, along the flight path and in Los Angeles. United is planning an arrival ceremony, an LAX employee day and a VIP function for major customers, elected officials and prominent civic and business leaders, so look for more details soon.

*"As a proud partner of the California Science Center, we are thrilled to host the shuttle at our facility," said Tech Ops Managing Director Don Wright. "United co-workers are delighted to be a part of this very exciting event for the Los Angeles community."*

### **United announced expedited negotiations with IAM and insourcing at Terminal A in IAH**



UAL has reached an agreement with the International Association of Machinists (IAM), which represents fleet service employees, passenger service employees and certain other work groups, to expedite contract negotiations for joint collective bargaining agreements. With the assistance of the National Mediation Board, the parties agreed to a bargaining process and timeline that is designed to achieve joint collective agreements before year-end.

*"Expediting negotiations will benefit co-workers and the company," said Airport Operations and Cargo SVP Jon Roitman. "Our longstanding relationship with the IAM continues in a positive direction, and this expedited process should assist us in reaching responsible agreements that pay our co-workers competitively."*

In addition, UAL agreed with the IAM to in-source airport operations work at Terminal A at IAH, which third-party suppliers currently handle. As part of the ongoing sourcing review in Airport Operations & Cargo, United is actively discussing with the IAM other opportunities for United co-workers to perform certain customer service work at additional locations that suppliers currently perform.

*"United, the IAM, and our co-workers share common interests in finalizing joint collective agreements that provide improved pay, competitive benefits and competitive work rules," said Labor Relations SVP Doug McKeen.*

### **Latest phase of redeployment opens**



Many of the September schedule changes took effect in August, and, with them, United entered the next big phase of aircraft redeployment. UAL defines a redeployed flight as

one subsidiary aircraft flying to or from the other subsidiary's hub — for example, flying Airbus A320s out of IAH or Boeing B737-900ERs out of SFO. Now, 355 flights a day depart from the other subsidiary's hub, up from 266 the previous week.

Nearly every hub is seeing significant changes compared to the previous week. United increased 737 departures from ORD by 14 and reduced Airbus departures by 13. At IAH, UAL increased Airbus departures by 19 and reduced 737 departures by 30, as the schedule changes also reflected its seasonal capacity reduction. SFO added five departures using CO 757s and dropped 11 using UA 757s.

### **Ask The Doctor – The Big C**

Most of you recognize the title of this article without further explanation. For all the rest, the Big C is, of course, Cancer. A word that always strikes fear in the hearts and minds of all of us. In the following few paragraphs, I will try to put this frightening medical condition in a different perspective.

Because retirees in our age group have only negative memories of Cancer, it is only natural to maintain a very negative concept of Cancer. It is difficult to change one's opinion because most of us have many personal devastating memories of Cancer. Perhaps a parent or sibling or spouse or neighbor or, worse yet, a child succumbed to some form of Cancer. It still remains a frightening diagnosis to almost all of us, and almost always generates very emotional responses to the diagnosis of Cancer.

**But**, there is very strong evidence that **many**, not all, Cancers are amenable to treatment and even cure. More and more Cancers are becoming chronic diseases, like diabetes and high blood pressure, rather than a death sentence. Yes, that is right. Cancer is becoming a chronic disease that more and more people survive because of modern treatment methods. Let me explain.

Most of us are familiar with Pap smears, mammo-



grams, colonoscopies, and other so-called screening tests for Cancer. However, there are other tests that have appeared within the past 10 years that have made early diagnosis routine rather than the exception. Most of us know about the controversial PSA blood test for prostate cancer, the virtual colonoscopy to detect colon cancer, CT scanning for lung cancer and pelvic tumors, to name a few. None of these tests existed 20 years ago. Further, there are more appearing almost every year. Further, when a patient presents with certain symptoms, a physician can order MRI, body scans, isotope studies, or PET scans or order newer blood tests that didn't exist in the past.

If there is a diagnosis of Cancer, the treatment options have changed drastically. Yes, there is surgery but the newer techniques have given more hope to many patients. There is vastly improved radiation treatment protocols that may follow surgery or may even come before surgery. Then, there is the well-known use of chemotherapy, both oral and/or IV medications. The use of brachytherapy, gamma knife, and the DaVinci procedure are making dramatic changes in the outcome of Cancer. Stem-cell research has opened even more exciting avenues of treatment, including the use of vaccines (believe it or not). The revolution of chemotherapy is providing new compounds almost yearly.

Unlike the treatment modalities in the past, the current treatment options are becoming more and more tumor specific and reducing the side effects we are so familiar with. As many of you know, many treatments in the past often cause devastating side effects because they were so broad in their action rather than pinpoint in accuracy. Look for more of these approaches as the side effects become less but the "killing" effect on the Cancer increases.

All of these positive statements do have a down side. Cost and coverage. The tests I mentioned are not cheap and may require prior approval from your medical insurance. Justifying costly tests for the chance of finding a Cancer may not be easy and require persistence and the cooperation of your medical provider. If the test gets approved, then there is the shocking cost of the treatment modalities. Cancer surgery to remove as much tumor as possible, so that radiation and/or chemotherapy are more effective requires a well-trained and experienced surgical team. Such teams are often at large medical centers and/or medical schools in large cities. Smaller cities or towns most often do not have these skilled teams. Radiation oncology is another specialty that requires skilled and experienced physicians who practice in facilities with complex and very costly radiation equipment. Again, such treatment centers are in large medical centers and/or medical schools. Finally, the newest and latest chemotherapeutic agents require a knowledgeable and experienced physician who

are usually part of a vast nationwide network of other physicians in other medical centers that communicate sometimes daily with the latest information about the latest protocols. **None** of this is cheap and requires excellent medical insurance and insurance companies who are willing to cover long-term costly medical treatment. Even drug companies may have to assist patients to pay for the very costly chemotherapeutic agents that can cost thousands of dollars per month.

So, the Big C is still a very frightening medical diagnosis for anyone. In the past, it often was truly a death sentence to the patient. Today, and in the future, there are more and more patients who are living with Cancer rather than succumbing to it. There are more and more patients living productive and happy lives because of treatment modalities that cause fewer side effects but very effectively suppress or cure the Cancer for many years rather than weeks or months. As with any medical condition, an empathetic physician supported by a skilled team, a strong social and family network of support, and a determined patient with a positive attitude are essential ingredients for success.

However, when he received the auditorium estimate, the original cost of \$25,000 has increased to over \$54,000. Needless to say, the auditorium will not be built this year. Bishop Mascherino will not go into debt for that amount. I agree with that decision.

The Clipped Wings flight attendants are there when you need them. They have donated a special magnet which is being distributed and sold as I write. I don't know complete details, so will let you know next month how you can purchase one.

Incidentally we just received a check, \$500.00 from Retired Flight Attendants, The Golden Penguins, Continental Airlines. Thank you all very much for your support.

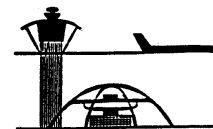

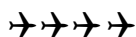
**Rich Bouska**, our Treasurer, presented a thorough recap on our financial status (good news – we are solvent thanks to his great management)!

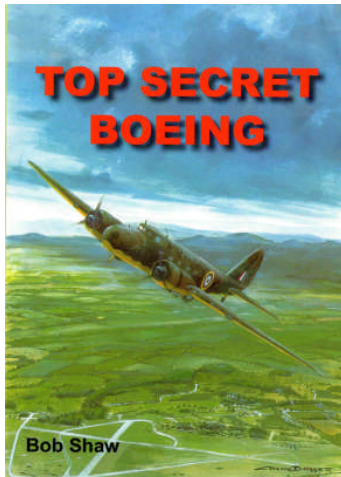
# United Airlines Historical Foundation

From time to time, UAHF receives requests for information from its archives. We have provided photos for the book **"Top Secret Boeing"** by Bob Shaw.

The book is an account of the WWII deployment of an elderly former United Air Lines Boeing 247-D and its role in the development of Airborne Radar during WWII. The development and trials of Airborne Interception (AI), Air Surface Vessel (ASV), "blind bombing" and Auto Approach and Landing in the only Boeing 247 to see RAF (Royal Air Force) service.

It traces 247-D NC13344 through its ownership by UAL/NAT, Pennsylvania

Airlines, Pennsylvania-Central Airlines (PCA), Corporate owners, Wyoming Air Service, the Canadian Government and finally the RAF.

On August 10, 1940 NC13344 was sold to the Canadian Government and was then designated CF-BTA RCAF (Royal Canadian Air Force) Serial Number 7655. The plane was assigned to the RCAF station at Trenton, Ontario to be used as a Navigation Trainer.

The plane arrived at Liverpool, England by ship on July 27, 1941 as a flying demonstrator for the first U.S. 10cm AI radar, built around the British Magnetron.

So important was the Aircraft and its onboard equipment, the first X-band (3cm) radar, that on July 10, 1942 it was declared "Top Secret" and given the designation DZ203/G. The "G" suffix indicated the requirement of an "armed guard" whenever "The Boeing" (as it became known) was on the ground.

In January 1945, the B247-D made the first "Unassisted Approach and Blind Landing" using a combination of U.S. Autopilot and Instrument Landing System (ILS) with British Radar Systems which gave distance to touchdown, controlled orbiting and homing to the airfield.

During landing tests at Defford, England Group Capt. McDonald recalled: *"The Boeing was thus the first aircraft ever to fly on an automatic orbit of the airfield. On one occasion the pilot orbited the airfield and landed off the orbit entirely on automatic control ... and in complete darkness."*
