Employees and retirees are now able to call just one number to reach frequently used employee services. Have your United ID (U-ID) ready when you call 1-877-825-3729 (877-UAL-

ESC9) to reach the Employee Travel Center, United We Care, Employee Information Services, Payroll Care Center, Employee Service Center, Pilot Service Center and Pilot iPad Help Desk. International employees/retirees should call 847-825-3729 (toll call) to reach these services.

The work to consolidate employee service phone

numbers is part of United's Project Quality initiative to take \$2 billion out of the company's annual cost structure by 2017 by improving the quality and efficiency of everything United does. Through Project Quality, United will improve not only its financial results, but also its operational reliability and customer service, for better consistency and less stress for customers and employees.

New TSA fee effective July 21st for some non-revs



From the employeeRES home page: Beginning July 21, the TSA Aviation Security Fee (AY) applied to employee pass travel will change. The current \$2.50 fee per enplanement will increase to \$5.60 per segment and will be assessed on:

- ❖ All service-charge-applicable passes, such as personal ePasses, purchased for premium cabin travel for all employees and retirees with less than 25 years of company service and their eligible pass riders
 - ❖ All buddy ePasses
- The AY fee is not charged on:
- ❖ Positive-space company business
 - ❖ Space-available vacation ePasses
 - ❖ Economy cabin pass travel

We have previously printed articles from Kirk Moore, RAFA and RUAEA regarding internet, computer, smart phone use. Since we have received more questions, we are thankful that he has written a review and hope this clarifies issues for all of us. Thank you very much Kirk for your assistance.

Pass Travel using your computer, Smartphone and/or tablet with website, bookmark, shortcut, app ~ confused?

"Recently I went to Europe and was able to buy ZED tickets on Lufthansa from Italy to Sweden and Germany, and list for my return flight on United, AMS-IAH-SFO, all on my iPhone using the FlyingTogether "full site" and my credit card; cool!" ~ SFOSW retiree

Can you do that? Nope? OK, let's review: Employees and retirees use United's intranet **website**, "FlyingTogether". The general public uses United's public **website**, "united.com", and they can download the United Airlines **app** to their mobile devices, read on.

For non-rev flying, we use the "Flying Together" website (it requires a file number and password). The web address (url) for "Flying Together" is: <https://flyingtogether.ual.com>

Using a computer: If you type that address into your computer's browser (Safari, Firefox, Internet Explorer, Chrome, etc), it will take you to the FlyingTogether "full site".

The "Travel" tab has everything you need to know about non-rev flying (programs, policies, tutorials). You can list for United flights on "employeeRES", buy discounted confirmed seats (myUADiscount) and buy Other Airline (ZED) tickets.

Using a Smartphone/tablet: If you type the address <https://flyingtogether.ual.com> into the browser on your mobile device, it will take you to a different version of Flying Together called "FT Mobile", which is simpler and easier to navigate on smaller screen.

One option on the "FT Mobile" menu is the Travel tab; if you click on that you're taken to "Mobileres" (a simplified version of employeeRES for UA non-rev travel designed for mobile devices). There you can check loads, list and check-in for United flights*.

To access "Mobileres" directly on a smartphone or tablet, use this address: <https://mobileres.ual.com>

***Important note when using Mobileres:** You cannot list for any United flight that incurs service charges, departure taxes or customs fees because Mobileres does not accept credit cards. Likewise, Mobileres cannot be used to buy myUADiscount tickets or tickets on Other Airlines (credit card needed).

However, at the *very bottom* of the Mobileres screen is a link to "Full Site"; click on that to go to the full "Flying Together" website.

You may list and pay for United flights with service charges/taxes/fees using your mobile device by accessing employeeRES via the "Full Site".

You can buy Other Airline tickets and MyUADiscount tickets using a Smartphone/tablet on the "Full Site". Go to the "Travel" tab, "Travel Programs", then go to the "Other Airline" or "myUADiscount" page.

When using a **computer** you should **bookmark** the Flying Together website so you don't have to type the address into your browser again, although you will still log-in every time. If you don't know how to bookmark a website in your computer's browser, ask a kid or Google it.

When using a **Smartphone or tablet**, you should create a **shortcut** icon that appears on your home screen so you don't have to type the url address for FlyingTogether or Mobileres into your browser again. If you don't know how to do that on your mobile device, ask Google.

Note: the **shortcut** icon for Mobileres looks quite similar to the **app** icon for United Airlines, which brings us to the United Airlines app. United Airlines has an award-winning **app** for the general public; no password is required. This is an excellent app for mobile devices and especially for Mileage Plus members.

NOTE: non-rev travel cannot be booked using the United Airlines **app**, HOWEVER, when traveling non-rev, it's *very smart* to have the United Airlines app on your device.

Why? Because the app updates the standby list and seat chart *in real time as the aircraft is being boarded*. Check it out!

Once downloaded, the United Airlines app icon will be added to your mobile device's home screen.

Passport scanning in United mobile app adds convenience for customers



Customers may now scan their passports into the United mobile app to complete their check-in for international itineraries.

"Our industry-first passport scanning function, in combination with the other check-in features on the mobile app, provides customers with more options and helps them save valuable time," said eCommerce Managing Director Mark Nasr. *"As we continue to invest in our digital channels we are focused on providing new technologies that offer choice, control and convenience to our customers and co-workers."*

Nearly all of United's airport kiosks already scan passports; United is extending it to the mobile app for increased convenience for its customers. It works on iOS iPhone, iPad and Android devices.

The app will ask MileagePlus members who have previously scanned their passports at a kiosk to verify their stored passport data and they will not need to scan their passports, unless they need to update the information or add a new passport.

To scan the passport, the app will use the camera on the device, similar to many mobile banking deposit functions. A third party, Jumio, will verify the scanned

passport information for additional security and to help prevent fraudulent activity.

Customers with international itineraries must still travel with their valid passports and any other required documents, and present them at the airport.

"During this trial period, we'll collect customer and co-worker feedback and use it to fine-tune the product," Mark said. "We're also working to expand mobile scanning to credit cards, residency cards and other documents."

United's mobile app is one of the best in the industry, offering customers simplicity and convenience in managing their travel experience. Its success contributed to United's recent selection as an honoree in CIO magazine's annual "CIO 100 Award" for 2014. This prestigious award recognizes 100 organizations worldwide that have distinguished themselves by creating business value through the effective and innovative use of technology.

Danger of Low Blood Sugar



The numbers are astounding - nearly 400 million people worldwide suffer from diabetes, and many patients may not realize they are at risk for hypoglycemia. The condition is characterized as dangerously low blood sugar levels that could cause serious side effects, including hospitalization.

Understanding Hypoglycemia ~ Specialist pharmacists in the Express Scripts Diabetes Therapeutic Resource Center, counsel patients who may not be aware of their risk for hypoglycemia. Normally, our body has a natural response that is triggered when blood sugar levels drop below a normal level. However, in some people with diabetes, this response is impaired. Certain medications used to treat diabetes, such as insulin, can also prevent glucose levels from easily returning to the normal range.

Who Is at Risk? There are certain people at increased risk for hypoglycemia, including those with chronic diabetes and Type 1 diabetes.

People with Type 1 diabetes are at increased risk because they may not show early warning signs of low blood glucose - a condition called hypoglycemia unawareness. This means an individual no longer experiences early warning symptoms - such as shakiness, sweating, anxiety and hunger - raising their risk of lapsing into severe hypoglycemia.

Treating the Condition ~ It's important for all diabetes patients to remember that hypoglycemia is usually mild and can be treated quickly and easily by consuming a small amount of a glucose-rich food or drink. Un-

fortunately the condition can rapidly worsen, causing confusion, clumsiness or fainting. In fact, severe hypoglycemia can lead to seizures, coma and even death.

Tips to Prevent Hypoglycemia:

- ✓ *Timing is everything:* As with all medications, always take your diabetes medications in the recommended dosage and at the recommended times. Some diabetes medications can cause hypoglycemia. If you have questions, talk to your physician or pharmacist, who can help explain how and when to take these medications.
- ✓ *Watch what you eat:* Following a meal plan is important for managing diabetes. Have enough food during each meal; avoid skipping meals and try healthy snacking (if recommended). If you are struggling with your food intake, work with a registered dietitian who can help design a meal plan that fits your personal preferences and lifestyle. Eating right will help you manage your diabetes.
- ✓ *Exercise responsibly:* Check your blood glucose before sports, exercise or other physical activity and adjust medication if necessary. Have a snack handy if your levels fall below 100 milligrams per deciliter (mg/dL). Also, check blood glucose at regular intervals during extended periods of physical activity and periodically after physical activity, and adjust medications if necessary.
- ✓ *Limit alcohol consumption:* Drinking alcoholic beverages, especially on an empty stomach, can cause hypoglycemia. Heavy drinking can be particularly dangerous for people taking insulin or medications that increase insulin production. Only consume alcohol with a snack or meal.

Six Can Chili:

1 pound ground beef
½ cup chopped onion
2 cans (15½ oz) chili beans in sauce, not drained
2 cans (14½ oz.) diced tomatoes, not drained

1 can (15 oz) black beans, drained
1 can (10¾ oz) condensed cream of mushroom soup
1 tsp. chili powder

Brown ground beef and onion. Crumble meat. Mix all remaining ingredients.

Bring to a boil. Reduce heat; simmer uncovered 30 minutes or more.

Stir occasionally.

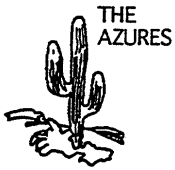

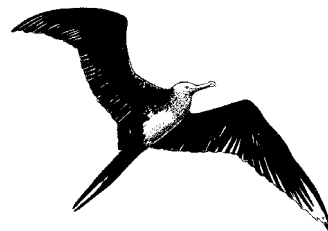

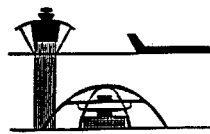

San Diego travel plans are upmost in our thoughts, so it only seems appropriate that our featured RUAEA member for this month is retired Flight Attendant, **Georgia Nielsen**. As we are all aware, the first female Flight Attendant was hired in 1930 by UAL. Flight Attendants' primary role is that of passenger safety, and actions of Flight Attendants in emergencies have long been credited in saving lives. In addition to safety they have the task of Customer Services duties. In the 1970s the gender-neutral term, "Flight Attendant", replaced the term "stewardess". More recently the term "cabin crew" or "cabin staff" has begun to replace the term "Flight Attendant".

Georgia was born **Georgia Panter** in Smith County, Kansas near the site claimed as the "geographical center of the Continental United States". Prior to being hired by United Air Lines (UAL) **Georgia** attended Fort Hays Kansas State College and Colorado State College. She held a Civil Service job at Farmers Home Administration (FHA) in Tribune, Kansas, and also worked as a clerk stenographer at the Denver Research Institute. Several years later she was awarded her MA in History from San Jose State University. **Georgia** was hired by UAL in 1960 and retired from SFOSW in 2002. During these years she had domiciles at Midway/O'Hare in Chicago, Denver, Los Angeles, San Francisco, and New York. In 1968 to 1971 **Georgia** worked trips on the Military Airlift Command (MAC) from the United States to Vietnam. It was during this time when she met her husband, **Dan Nielsen**, a Journalist from Denmark, who was on holiday in Guam. Their relationship began on a *stormy* note. Literally, the storm was called, "Typhoon Yoling"!

Georgia was a Flight Attendant on the combination United-Continental Flights in the years before the United-Continental Merger. (Newsletter December, 2010). You might remember the paint colors with one side of the aircraft painted with Continental colors and the other side painted with UAL colors. **Georgia** was also one of the Flight Attendants on the UAL 747 Hawaiian flight that lost power on all four engines on its approach to Honolulu. As she sat, preparing for an *emergency ocean landing*, she recalls how she could see the white caps on the ocean coming closer and closer. Fortunately the pilots did not have to "ditch", but made it into Honolulu when one of the engines responded. Much investigation was done by UAL, Boeing, Pratt and Whitney and the FAA in this situation.

In addition to **Georgia's** busy work schedule, she became an active union officer for the Association of Flight Attendants in the 1970s and held appointed and elective offices thereafter. She was a member of the Board of Directors for the San Mateo Central Labor Council (AFL-CIO) for a decade. She founded and edited Air Reporter, a newspaper for airline and airport

workers from 1991 to 2001. **Georgia** has authored a book of Flight Attendant History. She received the Ada Brown Greenfield Lifetime Achievement Award conferred by the Association of Flight Attendants. She holds a Unity Award from the San Mateo Central Labor Council, and is a Fellow of The San Francisco Aeronautic Society.

Since retirement **Georgia** and her husband, **Dan**, often work on writing projects together. She has also continued to be active in professional organizations. She is an organizer for Retired Flight Attendants, and has been a Founder, Facilitator, President and International Historian of the Retiree Association of Flight Attendants (RAFA) and Communication Workers of America (CWA). She is Secretary of (UAHF) United Airlines Historical Foundation (Newsletter July 2013) as well as an active member of our RUAEA group. (Newsletter June 2014)

Georgia & Dan have shared their home with nephews from Denmark for the "American Experience". Two nephews attended Piedmont Hill High School in San Jose. Presently, one nephew is an Intern at the US Embassy in Copenhagen and one holds a position in the Danish Finance Ministry. **Georgia** has a nephew who is a mechanic at UAL/SFO, and a nephew who is a Pilot for Express Jet at Dulles (IAD). **Georgia's** late sister and late brother-in-law were a Flight Attendant and a Pilot for UAL.

In addition to all of their other activities, and journeys within the United States, **Georgia & Dan** take yearly trips to Europe. No doubt Denmark is at the top of their itinerary. They also enjoy walking/hiking, and they cultivate and harvest a small vegetable garden in their back yard.
