

A Message From Oscar Munoz, New CEO of United, September 8, 2015



Today we are announcing a series of executive changes, which are effective immediately. I recognize that this news is unexpected, and I want you to hear it directly from me, as United's new CEO.

Jeff Smisek, Nene Foxhall, EVP of communications and government affairs, and Mark Anderson, SVP of corporate and government affairs, have stepped down from their roles. These departures are in connection with United's previously disclosed internal investigation related to the federal investigation associated with the Port Authority of New York and New Jersey.

In addition, the company announced Henry L. Meyer III, a current United director and the lead independent director, has been named non-executive chairman of the board.

As we move forward, let me take a moment to tell you a little bit about myself. As you may know, I have been on the board of directors of United, and previously Continental, for more than a decade. I am also a longtime United customer. Before today, I was the president and COO of CSX, one of the largest railroads in North America. Prior to that, I worked for several well-known consumer brands including AT&T, Pepsico, and The Coca-Cola Company.

I took this job because I am excited by what we can do together. There is incredible opportunity for innovation, for earnings growth, and for improving an experience that is essential to the vitality of global business and to the personal lives of millions of people. I will be relentless in pursuing these goals, and I hope and expect that all of you will share that same passion.

In the coming weeks, I will be making my first visits around the system. I want to talk to as many of you as possible because I want to get to know you and what you think about how things are going. How can we operate better? How can we better serve our customers? What support do you need to deliver that? You'll be seeing me frequently; I intend to regularly travel the system to hear about our operations directly from you - and you can hold me accountable for that.

In my career, I've found that three things are critical to any successful business. First, we must focus on customers and what we can to do help them. In the telecommunications, consumer products and railway businesses, there are very real consequences if you don't meet the consumer's needs and desires. There are also

substantive rewards for doing so, and especially for exceeding customer expectations. Every day, you win or lose customers based on the slightest change in value and quality.

As you know, in the airline business, this is especially critical. Getting people where they want to go, reliably and happily, can make or break their ability to succeed in a work endeavor or to hug a family member at an important moment.

At United, I will dedicate myself to making our airline flyer-friendly.

Second, in any organization, especially a great airline, it's all about teamwork. I like to refer to this as "shared purpose". We are in a service business, and the thousands of people who work here are the key ingredient determining our success. To get our passengers where they want to go safely and happily requires thousands of us working together with a shared purpose of supporting each other in serving our customers. Third, I am excited to be a part of a company and industry that demands innovation. The world around us is changing. At United, we will embrace this change, and make this an energized and exciting place to work.

Above all, my career has taught me that safety is paramount. Our passion for the safety of our people and our customers must be at the core of everything we do.

As we bring this airline forward, I promise to hold true to these principles of customer focus, teamwork through our shared purpose, continual innovation, and of course, safety.

I want our customers, my fellow workers, and our communities to respect each other and take pride in our accomplishments. Thank you for your dedication to our customers and to United, and I look forward to meeting you soon.

Hut, hut, fly: More football teams fly us than ever before

Football season has begun for both the NFL and college football, and United is playing its biggest role ever in getting teams where they need to be.



United is flying 38 teams this season - the most the company has ever flown - up from last season's record number. United is flying 23 college football teams and 15 NFL teams, more than any other carrier. In addition, United is also flying one trip for the Army football team this season.

"Our list of charter clients continues to grow, which is a testament to the exceptional product we are delivering," Charters Managing Director Kevin Ross said. "This is a fun and highly profitable part of our business."

Travel Advisory from Kirk Moore



Cannot log into Flying Together with Firefox or IE ~ United's IT Service Desk sent RAFA this message "That is a known issue with Firefox. The only available workaround has been halted as it makes the workstation vulnerable to viruses. They will need to use IE. Internet Explorer is United's primary browser". If you cannot log into Flying Together with Internet Explorer, add coair.com and ual.com to IE's compatibility view. Here are instructions:

- 1. Open IE; press the Alt key, click "Tools" on the menu bar, and then click "Compatibility View settings". You may also find the same info on the settings (gear icon) on the top right of the menu bar.
- 2. In the "Add this website box", first type coair.com, then ual.com and then click
- the "Add" button.
- 3. Retirees who still cannot access Flying Together with I.E. can call the IT Service Desk. Please call after 6 PM Central time: 800-255-5801.
- 4. Several retirees report they can still use Firefox version 38.0.5 with Flying Together, but newer versions like Firefox 39.0 or 40.0.3 will not work.

Retirees use Chrome to access Flying Together ~ Several retirees are successfully using Google's Chrome browser with Flying Together. If IE and Firefox aren't working for you, try Chrome; apparently the latest version (44.0.2403.157) works fine.

However, keep in mind, United does not support Chrome. Here is a message from the IT Service Desk: "Yes (let retirees know about using Chrome) and that if they have issues, we do not support Chrome so a call into us would do no good".

iPad users, take note ~ Several iPad users report they can access FlyingTogether but not employeeRES. The IT Svc Desk says: "If they can't access employeeRES on their iPads and their home computers, call the IT Service Desk as we need more information to open a ticket".

Other iPad users report they can access FlyingTogether and can run a Pass Travel Report, but only the first page of the report is visible; they cannot swipe/scroll to the other pages. The IT Svc Desk says: "If they can't view the report successfully on their iPads and on their home computers, call the IT Service Desk as we need more information to open a ticket."

The IT Service Desk is best reached after 6 PM Central time: 800-255-5801.

United joined S&P 500 in September



United Continental Holdings joined the S&P 500 stock index after the close of trading on September 2. Companies included in the S&P 500 have demonstrated through a number of measures, like financial viability and strong liquidity, that they belong in the top tier of publicly traded companies.

Personal device entertainment communication efforts continue to ramp up

Customers who use United Private Screening's <u>personal device entertainment</u> are more satisfied with their flight experience, so United is improving awareness of the service throughout the summer.

United will promote personal device entertainment on economy-seat tray tables on all Airbus planes and Boeing 777s that fly primarily between the mainland U.S. and HNL (Honolulu). The tray tables feature cityscape images with simple, visual messaging about how to access the free streaming service.



"We believe that this subtle yet visible message will help inform customers about the entertainment for their flight," said Product Development and Brand Management Managing Director Maria Walter.

The tray table messaging supplements United's pre-flight efforts to help ensure customers are prepared for the service by downloading the United app, charging their device and bringing headphones. Customers who are booked on flights with <u>United Private Screening</u> receive a pre-flight email with information about the service. They can also learn about the service through <u>amenity</u> information on united.com and the app, gate messaging,

announcements and dedicated gate personnel at hubs who communicate to and assist customers.

United now offers personal device entertainment on more than 300 aircraft, more free streaming entertainment than any airline. And, there are more choices than ever before with expanded HBO programming, Tribeca Film Festival selections and exclusively curated content from Vevo, the world's leading all-premium music video and entertainment platform. United plans to install personal device entertainment on more than 650 mainline and regional aircraft, including United's international fleet.

United launched new ground handling business



United launched United Ground Express, a wholly owned subsidiary of United Airlines that will provide cost effective ground handling services at traditionally outsourced locations. "With approximately 150 outsourced stations within the U.S., we believe we have a great opportunity to take on some work that was previously handled by business partners," said United Ground Express President Lynda Coffman. "United Ground Express, while being a separate company from United Airlines, will allow us to mirror United's flyer friendly service philosophy, providing customers with a seamless travel

experience."

United Ground Express will provide customer service, station operations, ramp, baggage handling and cargo service. The company will launch service later this year in select stations where United's business partner Envoy is exiting and will also provide ground handling for United's new service to and from AZO (Kalamazoo, Michigan) starting Dec. 9, 2015. It will expand to more locations in 2016. United will continue to use ground handling business partners in markets where it makes financial and logistical sense to do so.

United Ground Express began recruiting to place qualified applicants in available positions and launched a new website with additional information, unitedgroundexpress.com.

New Cargo deal gives us an industry 1st



United Cargo recently announced the signing of a global rental agreement with va-Q-tec, a provider of high-performance units for temperature-controlled transport of pharmaceuticals. This agreement makes us the first North American carrier to announce the availability of va-O-tainer rentals directly through the airline.

"These va-Q-tainer units allow us to transport shipments at temperatures from -50 Celsius up to 25 Celsius - the widest range we have ever offered," said TempControl Product Development and Marketing Manager Krisha Kucharski.

TempControl is the industry-leading service for commodities

requiring temperature-controlled transport.

United Cargo's centralized 24/7 Control Tower team, the experts who manage every process throughout the life cycle of each TempControl shipment, will handle all va-Q-tainer rentals.

These units will enable United to better utilize its narrowbody fleet. Previously, units leased for cool chain transport fit on widebodies only. Using narrowbodies will greatly expand the number of cities TempControl can serve - a key benefit as the bio-pharma transport industry expands into new markets. These units are also much easier for United's field teams to handle as they eliminate the need for batteries, dry ice and plug-in power.

United plans to begin va-Q-tainer rentals in the fourth quarter of this year.



The 1964 Democratic convention in Atlantic City New Jersey, from my memories ~ There are two events that come to mind, one is November 1963, and the other is September 1964. Both of these have lasting memories, with both Violet and me. In 1963 President Kennedy was assassinated, and like all events of major importance, people tend to remember where they were and what they were doing. I was no different, as a mechanic for United Airlines, I was working out of the old North terminal at Newark airport, and I had just finished dispatching a DC 6 onto its next destination. When I returned to the mechanics ready room, I saw a lot of people listening to the radio and waiting for more dispatches coming from Dallas, Texas on the condition of President Kennedy. It was there that I found out that the President had been shot and killed. My mechanic

friends who can be pretty tough guys were now in tears, handkerchiefs were coming out and it was a general outpouring of sorrow and sympathy. I remember opening the door to the long hallway with passengers came down to the Gates for departure. There I saw people crying and gathering of small groups all in the state of shock. The trauma, that the country was in, was now engaged in the preparation for his burial. I myself was no different than many other people who thought that this was a senseless act by some demented person. Yes I did have feeling of sadness but as in all things it did pass.

Why this is important at least in my memory, is that the VP Lyndon Johnson was sworn in as the new president with a wave of goodwill that came over the country in the hopes that he would succeed. That leads me to the next part of my memories, and that is the Democratic convention in Atlantic City in September 1964. Violet and I were given passes by one of our elected officials to attend the convention as observers for the first day of its opening. We went to Atlantic City and made a day of it, no, there were no casinos at the time. However we did have a nice time on the boardwalk. About 7 PM, the doors of the convention center opened. Now I have seen some large places but this auditorium could fit about 6000 people. Our passes took us on the floor right behind the Pennsylvania delegation. We had some small talk with these people and then the chairman came into view and said that the convention is now open. There was so much noise in that place that you hardly hear a word spoken. Then the chairman introduced the keynote speaker, a gentleman by the name of Senator Pastore from Rhode Island. He took to the podium and started to speak. However when he started to talk, slowly the noise in this great assembly died down, and you can hear that he was delivering a eulogy to the late President Kennedy. This vast auditorium now subsided almost to an eerie silence. The Senator continued for about 20 minutes and then stopped. The nearly 5000 people in this auditorium where electrified by his oratory and you could hear a pin drop it became so quiet. Suddenly somewhere someone started to clap, then more people clapped, that crescendo grew even louder and no matter how hard the chairman tried to quiet the audience they would not stop. Not only people were clapping they were getting up on the chairs shouting, whistling and making all kinds of noises just to be heard. As for me I've always considered myself pretty cool about things of this nature and yet I was roused enough to jump up on the chair and start clapping and whistling like everybody else. I have been around politics for many years and have seen many things, and met many big dignitaries, but never in my life have I ever witnessed anything so inspiring as that speech, and the audience reaction that followed.

That convention nominated Lyndon Johnson for President and Hubert Humphrey for VP. The Republicans, in turn nominated Barry Goldwater for President and William Miller for VP. That general election in November carried Lyndon Johnson and Hubert Humphrey to an overwhelming victory, unprecedented in American politics. The Democratic ticket won by over 16 million popular votes and I doubt I will live to see another election like that today. While the flow of history goes on every day on a daily basis, being part of it and remembering what it was really like, makes the difference between fiction and fact. Yes Violet and I talked about our shared experience in Atlantic City for many years.
