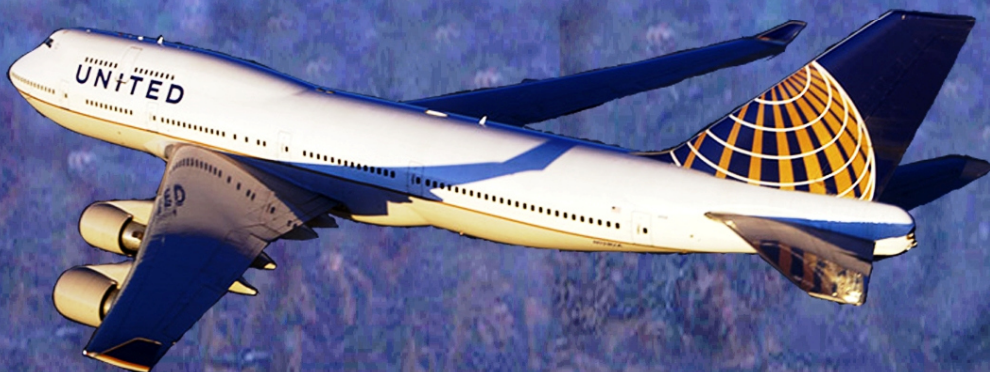

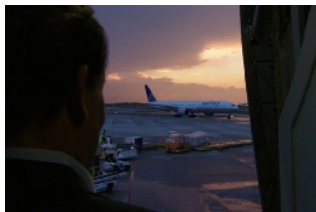

**An update from Oscar on United's response to Harvey, posted August 31, 2017**



Dear United family,  
First, I want to thank all of you for the incredible efforts you've displayed in response to Harvey. To witness how so many of you leapt into action, bringing the full range of your skills and expertise across our operations to bear on this crisis, giving so much of yourselves without having to be asked - all of it has truly been something to behold. I have never been prouder to call myself a member of the United family.

I will be traveling to Houston in the next few days to visit with our folks, see what still needs to be done and, above all, make sure they know that we will be with them every step of the way to help them rebuild, stronger than ever.

We have made one of our hangars at IAH available for use by FEMA to use as a base of operations from which to manage the crisis. IAH opened yesterday, with three arrivals and three departures. Today, we are planning more than two dozen mainline departures and operated another relief flight originating from ORD. Meanwhile we expect United Express flights to begin operating tomorrow.

As we gradually resume normal operations, we must remember that a sense of normalcy remains far, far away for so many of our colleagues and their families who have been impacted by Harvey. That's why even as the waters recede, our commitment will remain firm, both in the short term as we continue to provide immediate relief and assistance, as well as long into the future.

The Emergency Operations Center has activated Family Assistance Representatives to work with employees to support their needs, and we hope to have a large team set up and operating in Houston by Friday.

I encourage everyone still impacted by the storm to continue to access United We Care. And I trust that everyone will continue to contribute to our relief fund in the days and weeks to come. The United We Care Fund has launched the Harvey Emergency Relief Fund to cover employees and retirees impacted by the storm. This fund will provide up to \$3,000 in immediate cash for basic living expenses. Additionally, the Fund is set up to cover as much as \$10,000 in total in relation to this event, waiving the usual \$7,500 lifetime limit. So far, we've transported more than 1,156 coworkers between IAH and ORD. We've operated 37 humanitarian and relief flights since Sunday and shipped more than a quarter million pounds of vital supplies, including water, shelf-stable food products, baby formula and medical supplies. We have partnered with Managed Care to transport doctors and nurses from around the country to staff the IAH medical clinic throughout the week.

During these hectic days we will also be observing Labor Day and dealing with a busy travel weekend. It will be a travel period made more difficult by the lack of connectivity through IAH, and the knock-on effects throughout the system. I know you will be prepared for that inevitability, and I have no doubt that you will manage through it admirably, efficiently and - above all - safely. The spirit of solidarity and camaraderie that we've seen exemplified throughout this crisis embodies what Labor Day is all about: a bond between colleagues that always exists, but shines brightest when times are darkest. This is one of those times.

I look forward to touching down at IAH in the coming days. I will be bringing with me the fond wishes of the entire United family, 90,000 strong. Houston is more than just a hub, it is our home. We will be in this for the long haul during the rebuilding process. That's what we mean when we say "We Fly Together."

## **United We Care cash available for employees in need**



The United We Care Employee Relief Fund is launching a new program called the Harvey Emergency Relief Fund to cover employees impacted by the storm in Southeast Texas and Louisiana.

The new fund will cover disbursement of up to \$3,000 in cash to cover basic living expenses of those affected by Tropical Storm Harvey, based on situational need. If you need that assistance, click here for a link to [United Service Anywhere > Harvey Emergency Relief Fund](#). *"We know people are suffering, and there's an immediate need for cash, as we've had more than 100 people reach out to United We Care already,"* said HR Services VP Kirk Limacher. *"We are targeting employees with urgent need for temporary lodging, transportation, food and other immediate needs and who do not have access to cash."*

For this event, United We Care is doing away with gift cards and plans instead to deposit cash directly into employees' bank accounts if they are set up with direct deposit. For those who aren't signed up for direct deposit but have a bank account or those who receive paper checks, United We Care has established an alternate process for disbursement.

For those who may need more than the \$3,000 made available through the United Service Anywhere link, you may fill out the [United We Care assistance form](#). The United We Care Employee Relief Fund will grant up to \$10,000 in total in relation to this event, waiving the usual \$7,500 lifetime limit. Previous awards will not factor into this temporary grant program. All active, regular United Airlines employees and United Ground Express employees and retirees may apply, regardless of seniority.

If you need assistance and have no access to a computer, please contact HR Operations at 1-877-825-3729. We are working as quickly as we can to provide support, but please be patient. It may take up to three business days to review applications and transfer money to you.

If you are not affected by the floods but you wish to help, you can ensure all of the dollars you donate to United We Care go to the fund by choosing payroll deduction or making a recurring donation -- those methods do not take out credit card fees. Visit [United We Care](#).

## **Cyber thieves up the deceit level with 'vishing' and 'smishing'**

First there was phishing, and now you can add "vishing" and "smishing" to the list of ways that cyber criminals are attempting to steal your sensitive data.

Vishing and Smishing (short for "voice phishing" and "SMS/text phishing") occur when scammers approach



victims by phone. In one scenario in which some of United's employees were recently targeted, thieves posing as IT support technicians called requesting device information and passwords to assist with "trouble shooting."

This type of attempt is known as social engineering, where attackers seek to mislead you into handing over data. It's a very clever and effective way for criminals to get what they want.

You should question any unsolicited phone call or text message that you receive from anyone asking for personal information or promising you something that seems too good to be true, such as a prize or reward in exchange for your personal details. If a call or text appears suspicious, it's best to err on the side of caution and report it to United's Cyber Security team by emailing them at [protect@united.com](mailto:protect@united.com).

Many wing recipes are rather spicy so this is a nice change. Have fun cheering on your favorite team and enjoy your wings.

#### **BAKED CHICKEN WINGS**

3 pounds frozen chicken wings

1 c. soy sauce

1 c. brown sugar

½ c. butter

1 tsp. dry mustard

¾ c. water

Arrange chicken wings in shallow baking dish. Combine remaining ingredients and heat until sugar and butter dissolve.

Cool and pour over wings. Marinate at least 2 hours, turning occasionally. Without removing sauce, place in 350 degree oven and bake 1 hour, turning once, and spooning sauce over chicken a couple of times. You may want to serve with blue cheese or ranch dressing and celery and carrot sticks.

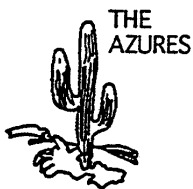

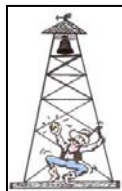
**Francis Domaratius** asked members to please renew their RUAEA membership if it has expired.

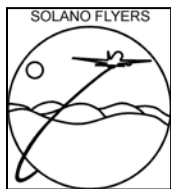

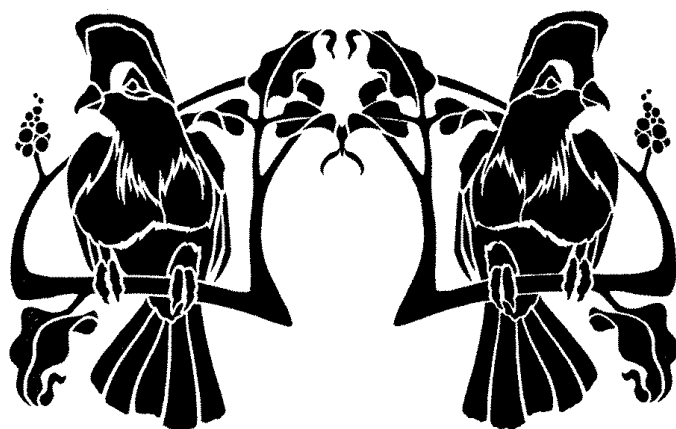

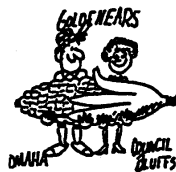

The next "queen" was the DC 8. It had four fan-jet engines and took four hours from ORD/West Coast, eight hours ORD/HNL. It set a record at one time HNL/ORD taking 6.5 hours. Then next came the 747. What a beautiful, lovely and majestic "queen". She caught the eyes of everyone. When UAL first got the 747's, we were not allowed to fly on them with our passes. I had some friends at ORDCOS and finagled a couple of passes on the 747. My first flight on a 747 was ORD/LAX/ORD. The first class service was absolutely amazing. The upper deck lounge was exquisite. I remember flying back from HNL one night, sitting in the upstairs lounge and watching the Northern Lights; what an amazing show.

The Smithsonian Channel had a two hour program on how the 747 was developed and built; very, very interesting.

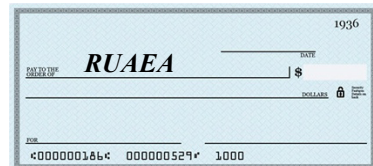

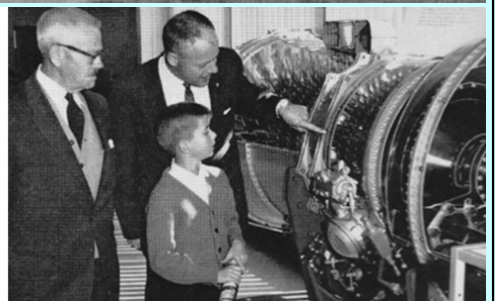
