Some, but not all retirees are entitled to a life insurance policy from United. We have been told that the United Retiree Facebook page states that United carries a \$10,000 life insurance policy on all retirees who retired after 2003. **Ed Tolle, RUAEA Corporate Liaison,** investigated this matter and received the following response from **Donna Towle, Vice President, HR - Employee Relations**.

The rumor that surfaced on Facebook is not true for all retirees. Retirees should refer to their labor contracts at the time of their retirement and also the 1114 Agreement between United Air Lines, Inc and the Retiree Collation.

During bankruptcy in 2003, the \$10,000 benefit was eliminated for some groups. United's retiree Life Insurance benefits are determined by the Collective Bargaining Agreements for applicable work groups in which the year the co-worker retires and the 1114 Agreement.

The current work groups that do still have the \$10,000 benefit are (CBA Contract 2005 – current) and outlined in the Summary Plan Descriptions (Subsidiary United Only):

- Flight Attendants
- ❖ IAM Ramp, Stores, Food Service and Security Workers
- ♣ PCF
- **❖** *Mechanics*

As a reminder, numerous retirees forfeited the life benefit in the 1114 agreement in exchange for other benefits. AnnHewitt is aware of this communication and they are taking beneficiary elections telephonically if the retiree does indeed have a retirement benefit. We are working on a project to add the online beneficiary designation to YBR.

Obviously, this is a very individual situation. Don't let that 2003 date deter you. From fellow members, we have learned some who retired before 2003 do have insurance while others do not. The amount of the insurance varies. We suggest you take the time and call the United benefit center, 800-651-1007. Your beneficiary may be very happy you took the time to do this.

#### United partners with Aetna to administer its U.S. medical plans in 2014

Nearly every day, some aspect of health care is in the news. It's a hot topic for us, too, because we know you value the medical benefits we provide to you and your family. That's why we review our benefits annually to ensure we offer the highest-quality health care plans at a price that is affordable for you and the company over the long term.

# Benefits Update

We have chosen Aetna as our primary benefit provider for our U.S. medical plans beginning in 2014 and will no longer offer medical PPO and Medicare supplement plans through Blue Cross Blue Shield (BCBS) and United Healthcare (UHC). (This change will not impact HMOs offered by BCBS and UHC for active co-workers and retirees.)

For most co-workers in United's medical plans, the change to Aetna will be seamless. You'll use the same providers you see today, but Aetna will administer your health care claims. Express Scripts will continue to be our

prescription drug provider and ValueOptions will continue to be our behavioral health provider.

Most co-workers' doctors are already in Aetna's network, but, if your doctor is not, you may nominate him or her to be included. Nominated providers will need to meet the Aetna certification requirements and agree to join the network. Transition of care benefits will be provided for co-workers who are in the middle of a medical treatment with a provider that is not in the Aetna network.

For more about the change to Aetna, go to the <u>Benefits</u> page on the Employees Services tab. We're still working on the details of the transition and will continue to post information on whom to call if you have questions, determining if your provider is in the Aetna network and what you need to do to avoid disruption of current treatment for yourself or family members.

Annual Benefits Enrollment information about our 2014 benefits will be available in late September. This year, benefits enrollment for 2014 benefits will begin in mid-October.





As of mid-July, United modified 118 of 152 of the narrowbody planes and are on track to complete the project this fall.

The existing bins on the A319s and A320s get new latches, hinges and doors, which create more useable space, deep enough for stowing standard, 22-inch rolling suitcases wheels-first and side by side. This nearly doubles carry-on capacity, resulting in quicker boarding and deplaning and higher customer satisfaction.

Line Maintenance co-workers are doing many of the modifications during Airbus visits to DEN and SFO, and United's business partners perform some.

#### United is making investments in baggage service equipment



With each passing month, United's baggage performance continues to trend in the right direction.

Through June, the company's mishandled baggage rate was 6.7 percent better year-over-year, and United continues to move up in the DOT rankings.

United will roll out \$3.5 million in new equipment system-wide later this year to enhance its baggage performance even more. Some of the upcoming investments include:

➤ In August, United distributed 1,073 handheld bag scanners with 305 cradles and 69 chargers to hub, line, international and United Express stations.

➤ In October, United will send 46 new computers and 180 mobile printers with Wi-Fi to hubs.

"We also will be deploying new radios, software enhancements and upgraded re-route technology," Baggage Resolution Service Center Director Brian Keene said. "The new equipment will enable us to track baggage movement to ensure that bags travel with customers, especially when we experience irregular operations."

#### **United starts weekly service to UVF**



In July, United launched weekly nonstop service to UVF (St. Lucia) from EWR. United operates the flights using Boeing 737-800 aircraft with 16 United Business seats, 48 United Economy Plus seats and 90 United Economy seats.

St. Lucia, United's 17<sup>th</sup> destination in the Caribbean, is a very welcome addition to its network.

#### Marriott Rewards and MileagePlus launch RewardsPlus



MileagePlus and Marriott Rewards announced a partnership that will provide United's most loyal members with unprecedented travel benefits. RewardsPlus offers Marriott Rewards Platinum Elite members MileagePlus Premier Silver status, featuring some of United's most popular Premier perks, and gives United Global Services, Premier 1K, Premier Platinum and Premier Gold members Marriott Rewards Gold Elite status and all of the benefits that come with it.

RewardsPlus, which brings together the world's leading hotel and airline loyalty programs, will soon include other features as well. Beginning in August, Marriott Rewards and United MileagePlus members will receive added value when transferring points into miles and will get additional miles for travel packages. Also, for the first time, MileagePlus Premier members will be able to convert their miles into Marriott Rewards points.

#### United announced second-quarter 2013 profit



United reported July 25<sup>th</sup>, second-quarter 2013 net income of \$521 million, or \$1.35 per diluted share, excluding \$52 million of special charges. Including special charges, United reported second-quarter 2013 net income of \$469 million, an increase of 38 percent year-over-year, or \$1.21 per diluted share.

In news release, Jeff thanked co-workers for providing great customer service and contributing to the progress the company made in the second quarter - both financially and operationally.

United generated \$10 billion of revenue, Jeff noted - the highest

second-quarter revenue the company ever earned. In addition, United led the U.S. airline industry in year-over-year passenger revenue per available seat mile (PRASM) growth for the second consecutive quarter. The consolidated PRASM increased 1.0 percent over the second quarter of 2012.

"Our top financial priorities for 2013 are to operate more efficiently and to meet our return-on-invested-capital target, and our performance in the second quarter puts us in good position to achieve these goals," said EVP and Chief Financial Officer John Rainey.

Unfortunately, non-fuel unit costs grew at a rate faster than many of United's competitors' this quarter. Excluding special charges and third-party business expense and holding fuel rate and profit sharing constant, United's consolidated cost per available seat mile (CASM) increased 4.5 percent compared to the results for the second quarter of 2012. Second-quarter 2013 consolidated CASM increased 0.7 percent year-over-year.

Throughout most of the quarter, co-workers faced challenging weather and high load factors yet delivered competitive on-time performance and customer service. "For the second straight quarter, our unit revenue outperformed the industry," said Vice Chairman and Chief Revenue Officer Jim Compton. "Our investments in customer service training and in our product are paying off."

#### Star Alliance has an app for that



Star Alliance recently introduced a customized application for iPad users called Navigator. When you're thinking about a taking a trip with one of the Star Alliance partners, check out the app for variety of travel services, including flight search, flight status, lounge finder and airport information. Also, the "My Trip" feature is unique to the Navigator iPad app and allows you to store and monitor your flight itineraries.

The app also features an interactive 3D globe, which illustrates the 28-airline network of more than 21,900 daily flights covering 1,328 destinations worldwide. When you enter your flight itinerary

details, enjoy an entertaining and interactive journey across the digital globe. Users also can explore frequent flyer benefits information and Star Alliance Gold and Silver privileges.

The app recently won the 2013 Red Dot Award: Communication Design for setting an industry benchmark for design, customer experience and technology, highlighted by the 3D globe feature.

#### Early out program details available for IAM-represented co-workers



United announced early out program for IAM-represented coworkers. United is introducing a voluntary early out program to eligible IAM-represented frontline co-workers in airports, reservations and stores. The program gives co-workers flexibility in choosing the options that are right for them and their families, such as early out payment and the opportunity to purchase early out travel privileges. The payment amount that program participants may receive varies depending upon the number of participants in the applicable employee group.

Eligible co-workers may apply through Sept. 5.

#### **Torgy's Travel Tips**

Destinations ~ in this industry, it's all about destinations. While we were working, we were surrounded by lots of information about where the Company flew and how we could get there. We had access to knowledgeable employees and/or had direct access to Apollo or Unimatic. Now that we're retired and the merger has grown our route structure, it's hard to be sure where all those destinations are. So I have some tips on how to solve the mystery of "Where does United fly?"

The easiest way to determine the up-to-the-minute destination list is to access the website used by regular United customers: <a href="www.united.com">www.united.com</a>. Directly under the United logo is a blue bar with several drop-down menu choices: <a href="Home, Reservations">Home, Reservations</a>, <a href="Travel Information">Travel Information</a>, <a href="Destination">Deals and Offers</a>, <a href="etc.">etc.</a>. Hold your cursor over <a href="Travel Information">Travel Information</a> and you will see a gray box drop down. Click on <a href="Destination Information">Destination Information</a>. To see all the cities

where your passes are valid, click on the circle titled Show Only Destinations Served by United Airlines or



<u>United Express</u>. You will receive an alphabetical listing of cities along with their airport code and if the city is served by a United Express carrier, the name of that carrier will be displayed. Once you have this information you can begin planning your pass travel back at the <u>flyingtogether.ual.com</u> website.

If the city you desire to visit is not listed in the table just described above, you may need to find another airline who offers a reduced rate ticket such as a ZED or ID90 fare. In that case, there is a marvelous tool on the Flying Together website called the <u>ID90T Research Tool</u>. Not only can you find out which airlines fly there but you also get a fare quote! From the <u>FlyingTogether.ual.com</u> home page, select *Employee Res* from the left hand column. Do not fill out the Flight Search boxes, but scroll down instead until you see the blue words *Quick Links* located just below the search and reset boxes. Once you click Quick Links, select *ID90T Research* 

*Tool.* From here, you simply fill out the desired city pairs, dates you wish to travel and select what kind of travelers will by flying. You will receive a schedule and fare for each airline who offers UA retirees discount tickets. Hold your cursor over the carrier code and it will give you the English name of the airline. If you click on the fare, it breaks down the taxes for you. I recently found that Emirates Airlines flies between Sydney and Auckland – a real surprise when Qantas and Air New Zealand are carriers who normally come to mind. As the title says, this is a research tool, not the place to purchase tickets.

<u>Note</u>: If you have never accessed an ID90T website before, you will be automatically directed to their login page for verification of eligibility. Simply select United Airlines as the employing airline, your 6 digit file number (without the "u") for your user name. Your password for this one-time only process is the first letter of your first name and your full last name, all in lower case. You can select a permanent password after this. If you have any problems call the ID90T help desk at 877 298-5233.

Old Business ~ Are you ready? Retiree Badges Are Here! Well, kind of. You may be wondering if you really need one of these badges. Well, the answer is yes. If you want to get that discount with FedEx - you will need one and it may assist in obtaining discounts for off-line travel, hotels, cruises and many of the other discounts found on the Employee Discounts page in Flying Together. There will be a fee of \$35.00 for the initial retiree badge. You will need to go online to the EmployeeRES. The link can be found by selecting "Quick Links" then "Employee Profile" and finally "Click here to obtain your Retiree Badge". At this point, the retiree will be provided with the opportunity to submit payment and are given the instructions for submitting your picture/information to the Badging Office. Once the payment/order has been received, the badging office will verify the information, create the badge and send it to the retiree via Federal Express or certified mail.

New Business / RUAEA ~ Rudy had some interesting items for us this month ~ Be aware and on guard when traveling overseas if a local sales clerk or merchant offers, as a gesture of goodwill, to make out the bill in "your own local currency", namely US dollars, rather than in Euros, pounds or yen. Just say "no". Require that the bill be written on the credit card slip in Euros, pounds, or yen. If you permit them to convert that sum into dollars, they will use an exchange rate so poor that you will automatically pay 15% to 20% more than you should have. And even though you have paid the badly adjusted bill in dollars, the fact that you have made the purchase overseas also will cause your credit card company to add a 3% surcharge to the bill you receive (a foreign transaction fee). So, have the merchant place the very same sum on the bill as appears on the menu. As for that transaction fee, it's already bad enough that every credit card company other than Capital One (and most credit unions) adds a 3% foreign transaction fee to the bill you receive each month. You can avoid that wholly unnecessary charge by obtaining a Capital One credit card, A USAA MasterCard, a British Airways Chase Visa, a credit card issued by your local credit union, or a number of other cards listed in any good search engine.

There's the nagging problem of retirees being charged for their baggage. **Bill Dinette** has provided a code for you to give to the ticket agent. The baggage code is **GGBAGEMP**. Should you have trouble with baggage charges, give this code to the agent and it will explain how to waive the baggage charge for employee travel. Sounds good to me!



outside air and compressing it into atmosphere that passengers could comfortably breathe. The superchargers changed the cockpit and cabin air every five minutes and teamed with a heater that maintained comfortable temperatures even at high altitude.

The pressurized DC-6s flew well above the loftiest mountain peaks at an altitude of three to four miles above sea level. The "Sixes" manufactured their own cabin climate with the aid of "Superchargers", bringing in the thin than 10,000 total seats. These planes flew an average of 2000 miles per day.

In 1956, 37 percent of United's mainland traffic and over half of its Honolulu flights were Coach passengers. The Coach passenger business was very seasonal, booming in the summer when seats were already in great demand. In the passengers view, there was too little difference in service to justify paying 30 percent more for a First Class seat.
